The directory will include numbers of phones installed up to July 5. Many changes in numbers will be found but will not be put in force until Sunday morning, when the new exchange will be in use.

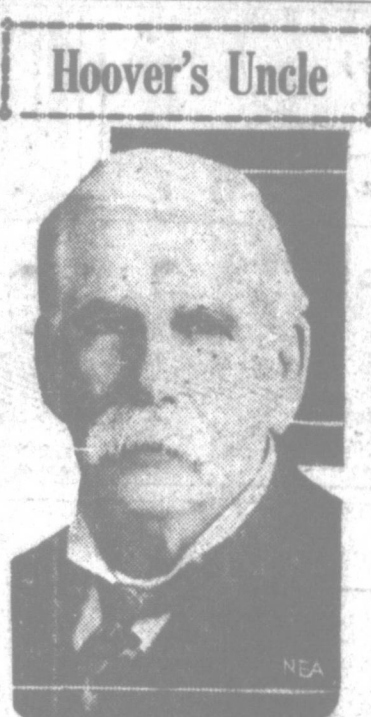

KANSAS CITY, July 24.—(P)—Fifty head of Hereford cattle stampeded through the streets here early today following the midnight wreck of a Santa Fe freight train two blocks from the union station. Police and motorists staged many exciting impromptu rodeos in the downtown district.

Nine cars were piled up when the train's locomotive left the rails, and three cattle cars were wrecked open. The frightened stock scattered in all directions, and soon the police were deluged with telephone calls from excited residents.

Only a few of the cattle had been rounded up at an early hour, and reports indicated the excited animals had reached the outlying residence sections.

Two steers were captured in the vicinity of the Muehlebach hotel at twelfth and Baltimore streets, after they had fallen on the sidewalk, exhausted by the chase. Several others were herded into vacant lots in that section, and guards posted to keep them from escaping.

Shouts of motorists and strains of police cars added to the panic of the fleeing Herefords as the few pedestrians downtown scattered to elevated points of vantage to watch the pursuit.

NEW PROCESS DEVELOPED ON CARBON BLACK

Atlas Company's Unit Near Pampa Is Smokeless

ONE BUILDING INSTEAD OF 40

Secrecy Veils Operation and False Ideas Prevail

Often mistaken for a gasoline manufacturing plant, the Atlas Chemical company's new process carbon black plant, three miles west of here on the Santa Fe railway main line, is a place of unusual interest. The company employs fifteen men for the operation of the plant. Frank M. Perry is in charge.

A new process of making carbon black is used and is closely guarded by the discoverer and manufacturer. Instead of dense clouds of black smoke issuing from 40 or more small tin houses, a single smoke stack issues a small amount of white smoke. A single building, probably 50 feet wide and 100 feet long, shaped like a grain elevator, composes the manufacturing plant proper. A store room, dynamo room, and small office comprise the rest of the buildings.

Two Large Markets The chief market for the new product is in the manufacture of tires and printer's ink. The company headquarters is in New York.

Dense clouds of smoke issue from the smoke houses of ordinary carbon black plants. A unit is composed of 40 tin houses about twelve feet wide, 120 feet long, and ten feet high. The plan for the long houses was made necessary as long steel slips the length of the building are placed over a series of gas jets on which the carbon black is collected.

No Fact Given Out Much speculation has been caused by the secrecy with which the local plant is surrounded, and many erroneous descriptions have been printed recently. Newspaper men and trade journal writers have made trips to the plant, but the information obtained was largely limited to what could be seen from the exterior of the buildings.

Gray county has two large plants of the ordinary variety in operation, another under construction, and plans under way for still another.

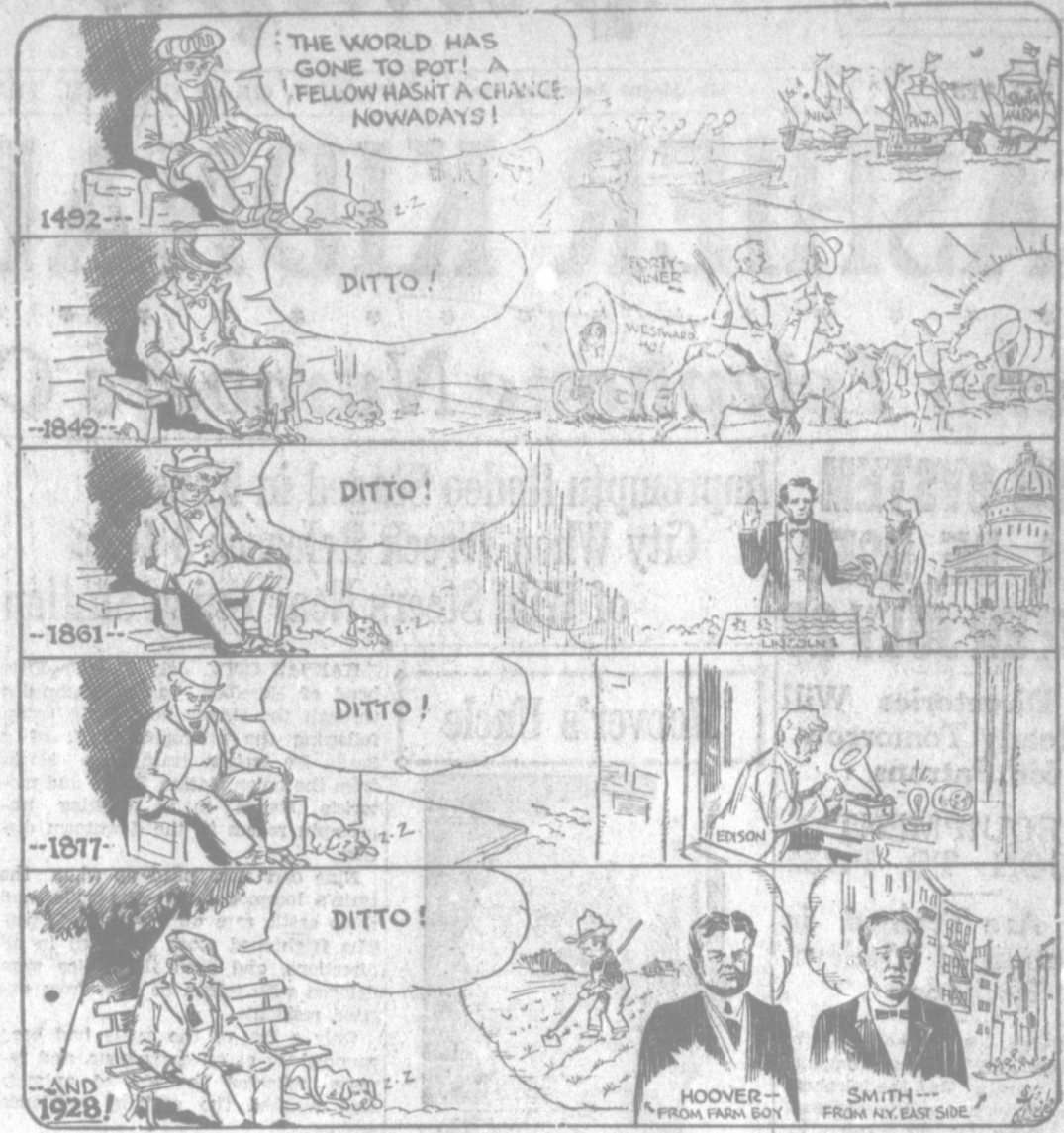

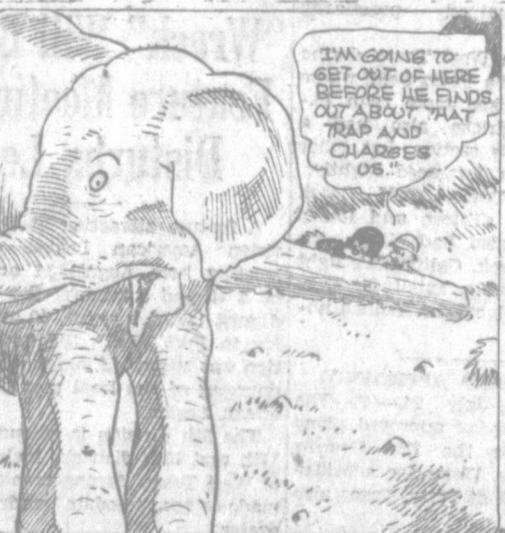
It is to be hoped that election judges will choose competent assistants and speed up the counting of votes in Saturday's primary election.

The public is entitled to receive the returns as rapidly as they may be compiled. The interest in the results is keen. Thousands will be impatiently waiting for news from the counting rooms.

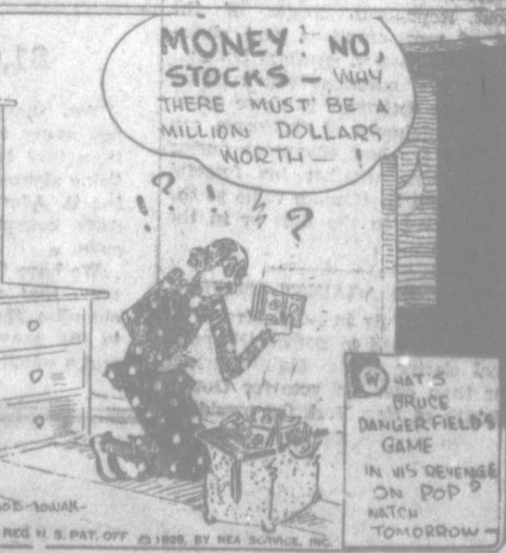
In Pampa, however, complete returns will not be available for many hours after the polls close.

Tunney Resorts to "Horse Play" With Gibson as Target

SPECULATOR, N. Y., July 24.—(P)—Though the supreme test of his championship career is but 48 hours away, Gene Tunney has yet to reach the irritated stage which tradition demands of a prize fighter on edge.

This unique ruler of fistiana, now self-strained to the last muscle for the defense of his crown against Tom Heeney, New Zealand challenger, in the Yankee stadium on Thursday night, has turned to horse play to divert his mind from the contest. His victim was Billy Gibson, his manager.

Knowing Gibson's aversion to flying, Tunney caused a fake telegram to be sent to his manager containing a famous aviator's offer to make a special flight up here to carry him back to New York as a reward for his deep interest in aviation.

Gibson was flustered when he received the bogus invitation. He deliberated over the message for many minutes before showing it to Tunney, who, in urging him to accept the offer, pointed out that it would be the height of discretion to decline the invitation of a national hero.

This argument finally overcame Gibson's objections and he composed a wire of acceptance which delighted Tunney and his assistant jesters.

Gibson planned to leave the training camp for New York this afternoon after Tunney best through his final workout, which was to be for the sole benefit of the newspaper men. The champion, who has never been in better shape, planned to go through his usual punching bag exercises and then take on his sporting partners, Harold May and Billy Vidaback, for three rounds each.

This Gene Tunney will taper off until Thursday morning at 10 o'clock, when he will take off from Lake Pleasant in a dual motored Sikorsky amphibian piloted by Bill Winston. 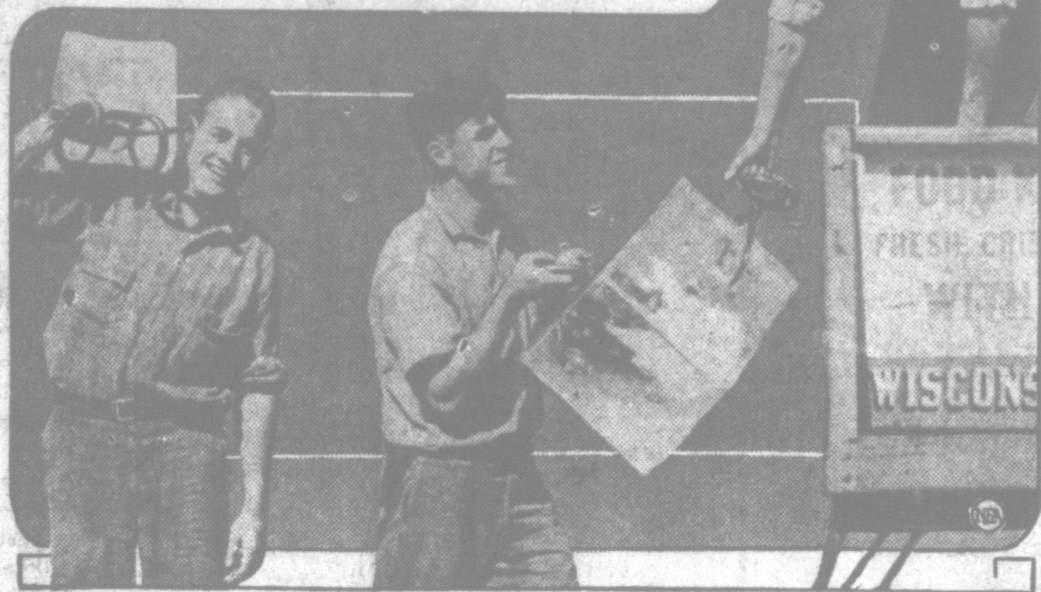

Heeney Is Cheered By Letter Received From Tom Gibbons

FAIRHAVEN, N. J., July 24.—(P)—Blunt Tom Heeney, unaccustomed to camouflaging his thoughts when interviewed, frankly admitted today that he is in the best condition of his fighting career, ready and eager to give Gene Tunney the battle of his life when they meet in the Yankee stadium Thursday night for the world's heavyweight championship.

The six-week training campaign of this good natured, rock-ribbed New Zealander is over. He is glad of it. He finished boxing yesterday. Today there was nothing for him to do but take a 15-minute workout in the gymnasium with no more work with the gloves. Tomorrow will be a day of complete relaxation with not even a gesture of training.

Heeney was in good humor. He had a cherry "oh hello hello," for everybody and a grin that was infectious. His easy going disposition had returned, following the mental strain of Sunday, when he boxed before Jack Dempsey, promoter Tex Rickard and others. These mental clouds were swept away by the thoughts of no more training, which he regards tougher than the fight itself. He planned to go sailing on a private yacht along the New Jersey shore today.

Heeney cherishes a letter received from Tom Gibbons, once a contender for the heavyweight title, the only man besides Tunney to face Dempsey as champion and be on his feet at the finish. It will be no surprise to Gibbons if Heeney defeats Tunney. He worked with the New Zealander while in London four years ago preparing a fight with Jack Bloomfield. "Believe me you have a good chance," Gibbons wrote. "I'm kidding you, you won't find Tunney the greatest champion of all time. I know that when it is all over he will know that he has been in a fight."

A 2 to 1 victory over the Brooklyn Dodgers in the league's only game Monday put the Pirates only five percentage points back of the Dodgers who are at the top of the second division. Fred Fussell, young Corsair southpaw, and Doug McWeeney, most effective of Uncle Robbie's pitchers in recent weeks, hooked up in a hurling duel that went Fussell's way only because the Dodgers and McWeeney elected to get all the bad baseball out of their system in the sixth. In that frame, an error by Harvey Hendrick, a misjudged fly ball by Babe Herman, a balk by McWeeney and Oranithan's single gave the Corsairs two runs and the game Bressler's double and Bancroft's single gave the Robins their only tally in the second inning.

Babe Ruth's fourth home run of the season failed to save the Yankees from a decisive defeat at the hands of the Boston Red Sox 9 to 3. Danny MacFayden, young blue-speckled right hander, was strong in the pinches and the Red Sox coasted in to an easy triumph. The Babe's drive put him 28 games, 30 days, and ten homers ahead of his record-breaking pace of 1927.

The Yankees retained their 10 1-2 game lead on the American league field, however, for the Athletics were blanked by Mill Gaston and the Washington Senators, 5 to 0. It was the A's first defeat in eight starts.

George Blaholder pitched the St. Louis Browns to a 10 to 0 victory over the Double Indians of Cleveland. The Browns pounded out 16 hits off three Cleveland hurlers and took occasion at the same time to equal the major league record for sacrifices. The Browns committed the outside act eight times during the game, a mark held by several major league clubs in past years but never bettered.

Jones is also getting a reputation as an "amender." It is unusual for a democrat to have any considerable voice in the shaping of legislation during a Republican administration. However, Representative Jones has the distinction of having secured more amendments during the last three years too pending legislation than any other Democratic member.—The Houston Post.

Smith Is Holding Conferences to Minimum Now

ALBANY, N. Y., July 24.—(AP)—Deviating from the customary course of presidential nominees, Governor Smith has kept pretty much to himself since his selection as the Democratic standard bearer nearly four weeks ago, and since then has held relatively few political conferences of importance. It has been his wish that for the present at least he be held to a minimum, almost daily he is in contact with old friends, advisers of long standing, and from time to time he has talked over the outlook with some party leader. There have been none of the pilgrimages to the home of the nominee as usually is the case after a political convention.

Scholastic Transfers Unusually Few in Independent District

There have been only thirteen scholastic transfers in Gray county thus far, the lowest number in many years, says county Judge T. M. Wolfe. Two pupils were transferred from the Scribner school, No. 10, to the Grandview school; two were transferred from Pampa to Wayside; six were transferred from Alanreed to McLean; and two were transferred from LeFors to Pampa independent district. The proposed consolidation of the Bohr school, No. 5, with Groom independent district accounts to some extent for this low number. Fifteen pupils of the Bohr school will be transferred later, if the consolidation is not effected. All transfers must be made before August 1, in order that county and state school funds may be re-appropriated. Statement Against Catholics to Be Withdrawn Soon

MEXICO CITY, July 24.—(AP)—A statement by Police Chief General Antonio Rios Zertuche was regarded in some quarters today as possibly the way for an official statement withdrawing the sting of the recent assertion that the Catholic clergy were to blame for the assassination of General Alvaro Obregon. The statement said that the clergy were cooperating in investigation of the slaying. Last week General Zertuche announced that "responsibility for the crime lies with the Catholic clergy." It was thought today that this first assertion might be modified to apply to some individual or group instead of the clergy as a whole. The latest police statement served to further lessen the tension in Mexico City. In religious circles a feeling of optimism concerning the future was manifested. General Zertuche also stated that Jose de Leon Toral, the art student who killed Obregon, had made a complete confession but he did not reveal its contents.

Fliers Prepare for Hop to New York

HORTA, Island of Fayal, Azores, July 24.—(AP)—Three French airmen, who hope to complete a roundtrip flight between Brest and New York by seaplane, waited today while minor repairs were being made to their plane. The plane La Fregate (The Frigate Bird) was hoisted on the breakwater

so it could be groomed for the next leg of its flight to Bermuda. If they find their fuel supply sufficient on reaching there, the fliers, Lieutenant Paulin Louis Jerome of Paris, radio pilot Marcel Bonin, and mechanic Louis Henri Cadon, will continue their New York without stopping.

Morones Was Wounded Recently Reports Reveal

NEW YORK, July 24 (AP)—Apparently new reports reaching New York today state that Luis Morones, former minister of labor, was fired upon as he was leaving a theatre the Sunday before the assassination of President-elect Obregon and was wounded in the thigh.

Delayed advices understood to have come from Pueblo also stated that a train bearing Agrarians to Mexico City to participate in a demonstration in General Obregon's behalf on July 15 was fired upon by workers in a textile affiliated with the Mexican regional confederation of workers, General Baragon, an Agrarian leader, was reported to have been killed.

DEMAND JUSTICE
"We regard Obregon's assassin as a personage who was controlled by superior outside forces," said Manrique today. "We do not demand his death but we do demand justice and we believe this can be achieved most quickly by removal from the government of those Labor leaders whose anti-Obregon activities created the atmosphere for the lead set of the assassin. The influence led by those Labor leaders must be wiped out of Mexican public affairs."

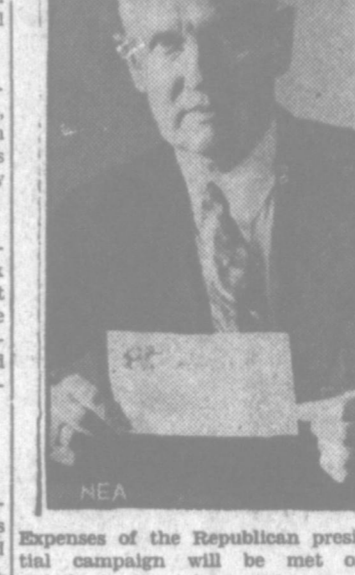
Hexter Test Now Down 2,240 Feet
