

HOW TO KEEP YOUR MOBILE HOME COOL

Having a cooler mobile home is mostly a matter of keeping the sun off it. There are several ways to reduce, shade and deflect sun rays from a manufactured home.

Ideally, the home should be positioned so the long sides face north and south. Then less of the home is exposed to the hot afternoon sun in the west.

Some homes also can be placed so large shade trees block out some sun. Trees or other kinds of overhead protection can cut energy costs by one half.

If you can't shade the roof of your mobile home, try cooling it with water. A simple device made of perforated plastic pipe and thermostatic timer will sprary the roof of the mobile home with water when it goes above a set temperature and then shut off the water when the temperature goes doen. These devices can be made by a do it yourselfer or purchased through mobil home catalogs.

To shade the sides of the home, install arbors and trelises for vining plants. These plants will be most effective on east and west facing walls where the summer sun is intense.

Keep the sun away from windows too. Awnings are best because they keep the sun from even striking the windows. A less effective option is to use light coeglored or reflective drapes or a reflective film adhered to the glass.

Using electrical appliances sparingly can help mobile homes stay cooler. Electrical appliances and lights add heat to the home, so shut them off when not in use. Save heat producing activities, like washing clothes or baking, for early morning or evening.

ing back on air ner use will also save ng costs. If security ecaustions allow it, turn off the air conditioner and open windows when going out for several hours. Most omobile homes can be cooled quickly when residents return.

Substituting fans for air conditioning can also save money. On cool nights, use a large capacity window fan to pull air through the entire mobile

Neewer mobile homes have energy saving features, such as extra insulation, that will keep cooling costs down. These include homes build in 1976 or later. Before then, federal energy standards for manufactured homes were less stringent.

**GRAZING AND HAYING ACR** 

Rember, you can graze or hay crops growing on ACR--BUT before you hay or graze your ACR (lay out land), you need to come to the ASCS office and sign a request register giving livestock numbers owned as of April 17th and the farm number you wish to hay or graze. You CANNOT lease the grazing, sell the hay, give the hay away or have the crop cut for a percentage under this program.

## **FAILED CROP ACRES**

It is important that you file a "574" prior to the destruction of any crop. Failure to report these acres will result in the loss of history credit and could effect your yield.

### CROP CERTIFICATION MEASURING SERVICE

## Be Cautious **During Snake** Season

Summer is snakebite season and time to exercise caution. Even so, the odds are 50-50 that most poisonous snake bites won't be fatal.

Chances are only four in ten that a poisonous snake will release venom when it bites, but that's no excuse not to be cautious.

The fatality rate from snake bite is extremely low. Less than one percent of the victims who are struck die from the 2,000 plus bites annually reported nationwide.

If you do enocunter a snake, simply walk away. Most snakes are not aggressive and most man-snake encounters go unnoticed by man. In any case, an average person can outrun a snake

# **PUBLIC NOTICE**

AT&T Communications has filed with the Public Utility Commission (PUC) of Texas to introduce a new intrastate, optional long distance service to begin August 1, 1984, the same date "Reach Out® America" plan will be available for interstate calls.\*

A new service designed to give customers the opportunity to reduce the cost of long distance in Texas has been filed with the state PUC by AT&T Communications of the Southwest, Inc.

"Reach Out® Texas" is an optional calling plan which will provide additional discounts on long distance rates for Texas customers who frequently

place calls in the evening, weekend, and night time calling periods.

The new "Reach Out® Texas" plan for the first time extends the benefits of competition to many Texas consumers who previously have not had any discounted long distance service available to them. AT&T Communications customers who choose this new optional service

will pay a monthly charge of \$14 which entitles them to one hour of intrastate "Direct Dialed" (1+) calling during the weekend and night rate period. An additional customer savings for those participating in the plan will be that any Direct Dialed calls placed during the weekend and night rate period that exceeds the one hour period will be charged at an hourly rate of

\$12, or \$ .20 per minute. Customers selecting this option also receive an additional 15 percent discount for intrastate Direct Dialed calls during the evening discount rate period for a total savings of approximately 38 percent.

A one-time charge of \$6 is billed when a customer orders the "Reach Outs Texas" plan. The \$6 is collected by AT&T Communications and paid to the local telephone company to establish the service. This charge will be waived during the first 90 days that the offering is available.

AT&T Communications is proud to offer this optional service for its Texas long distance customers and will in the future continue to introduce

cost cutting programs to help Texans reduce their long distance bills.

A complete copy of the "Reach Out" Texas" tariff and rate schedule is on file with the Texas Public Utility Commission at Austin, Texas.

AT&T Communications estimates that the revenue impact of this new ser-

\*Customer billing for the optional calling plan will be provided for AT&T Communications through billing contracts with the local telephone companies.
