



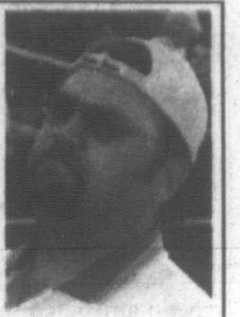

## Wildfires rage across Panhandle

Smoke hung in the air over Pampa this morning as wildfires continued to burn in the area.

A fire in southern Roberts County, near the Little Red Schoolhouse on Highway 70, was headed south toward Pampa at 10:30 a.m. this morning, said Hoover Volunteer Fire Department Chief Joe Millican.

Pampa Police Department had blocked Price Road north of 23rd Avenue in response to the blaze, according to emergency services radio broadcasts.

A resident of the area near the schoolhouse reported seeing flames this morning near Walnut Creek Estates, which had been evacuated at 7:55 p.m. Sunday when fire approached the homes which are located about two miles north of Pampa off Highway 70.

Another report at 11 a.m. was received by

Gray County Sheriff's Office concerning flames seen north of Alanreed near County Road Y.

High winds and dry conditions combined to make Sunday a dangerous day for Panhandle residents, as fires burned in several areas, including portions of Carson, Donley, Gray, Hutchinson, Randall, Roberts and Wheeler counties.

"We've been busy for about 24 hours now," Millican said at 10:30 this morning.

Pampa Fire Department responded to structure fires at 719 E. Browning at 11:41 a.m. and 525 S. Somerville at 11:53 a.m. Sunday. PFD assisted with grass fires on Highway 152 West and the area of 23rd Avenue and Price Road Sunday afternoon and evening, according to emergency services reports.

## Tornadoes rip across Midwest, killing 10 and destroying homes

SPRINGFIELD, Ill. (AP) — Swarms of tornadoes killed at least 10 people across the Midwest, shut down the University of Kansas and caused so much damage in Springfield that the mayor compared it to the aftermath of Hurricane Katrina.

The violent weather started during the weekend with a line of storms that spawned tornadoes and downpours from the southern Plains to the Ohio Valley.

On Monday, a second line of storms raked the region, with rain, hail and fierce wind tearing up

trees and homes from Kansas through Indiana. To the northwest, the vast weather system pulled cold air in Canada, generating snowstorms that cut off power to thousands and shut down schools in South Dakota, Minnesota and Wisconsin.

## Planning session set following city meeting

Two bids, a seal coat program and the library loan policy will be decided by the Pampa City Commission Tuesday afternoon.

When the commission meets in the commission chambers at City Hall at 4 p.m. Tuesday, they will consider bids for the HVAC Project at M.K. Brown Auditorium and bids on a sideloader truck and packer body.

The city has received bids on three different truck chassis from two Amarillo truck dealers and bids from two companies on the packer body. The city has budgeted \$110,000 for the truck and body.

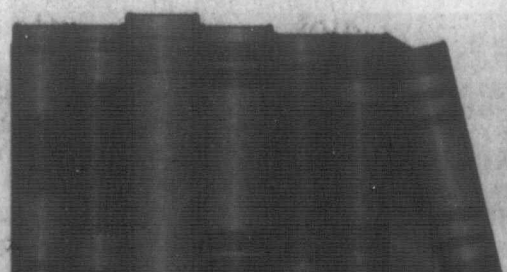
The commission will also consider authorizing an additional \$100,000 for the 2006 seal coat project. That would bring the seal coating project costs up to \$250,000. Initially, \$150,000 had been budgeted for the project.

The city commission will also take action to correct a reference in the city's ordinances concerning the International Residential Code.

Ann Stobbe, librarian at Lovett Memorial Library, said the library has borrowed and lent materials from and to other area libraries for 20 years but has no written policy. She is requesting the approval of a written policy passed by the Pampa Library Advisory Board in February. A written policy is required by the Texas State Library and Archives Commission for state certification.

Several fatalities have been attributed to Sunday's blazes. A nine-vehicle pile-up on Interstate 40 15 miles east of Groom at 1:30 p.m. Sunday killed four and injured six, according to Trooper Wayne Beigle of the Texas Department of Public Safety's Amarillo office.

Low visibility due to blowing smoke and dust were contributing factors in the pileup, Beigle said.

A large fire that began south of Borger Sunday burned more than 211,000 acres, according to Beigle. The fire, 30 miles long and 11 miles wide, has been blamed for three deaths in Hutchinson County.

Another fire began near Groom and burned over 432,000 acres. That fire was 45 miles long and 15 miles wide, Beigle said.

"The hardest hit county appears to be Hutchinson County," Beigle said in a news release at 9:51 p.m. Sunday.

Twenty-five structures were destroyed in the Hutchinson County fire, and a number of oil field fires were burning in the county Sunday evening.

Skellytown was evacuated around 5 p.m. Sunday as flames marched toward the Carson County town. At 5:20 p.m., the fire was about three-quarters of a mile from Skellytown, according to observers.

Highway 152 from Price Road to Skellytown was closed as the fire burned westward and smoke obscured visibility.

Lefors was also evacuated Sunday afternoon, along with southern Roberts County residents. Miami residents were evacuated about 6:10 p.m. Other evacuations Sunday included Old and New Mobeetie, Wheeler and McLean, as wildfires threatened those towns. Emergency sirens sounded in McLean at 7:10 p.m., according to emergency radio broadcasts.

Pampa's First Baptist

Church, Mary Ellen and Harvester Church of Christ, First Presbyterian Church, First Christian Church and the National Guard Army were all opened for evacuees from neighboring areas. Sacred Heart Catholic Church of White Deer also offered shelter to those fleeing the flames.

Three firefighters were injured Sunday afternoon when their three-ton truck rolled over near the Bowers City highway outside Pampa. Lefors Volunteer Ambulance responded and had to drive a circuitous route away from the wreck with the victims due to heavy smoke obscuring vision, according to emergency radio broadcasts.

It was not known as of press time today to which fire department the three firefighters belonged, or their identities or conditions.

Two Donley County firefighters were reportedly injured when their fire department vehicle was involved in a one-vehicle accident in that county. No further information was available as of press time today.

Highway closures contributed to a 700-vehicle backup at Clarendon as I-40 was closed for a time due to low visibility. At various times, Highway 70, Highway 152 and Farm to Market Roads 767, 283, 354 and 722 were closed due to the fires.

Volunteers with the Pampa Salvation Army and Red Cross provided refreshments to firefighters Sunday.

Assistance from neighboring entities included Celanese, Pantex, Collingsworth County and the cities of Stratford and Dalhart, as well as equipment such as maintainers provided by local businesses.

Skellytown residents were released to return to their homes at about 8 p.m. Sunday. Preliminary reports indicated only one building lost to the flames at Skellytown, which lost electricity as a result of the fire. Hot spots continued to re-ignite late Sunday near the town.

At 5:45 p.m. Sunday, a Gray County deputy reported four houses 10 miles north of McLean on fire. Fire was also crossing I-40 just east of the Johnson Ranch Road exit. A house on the north side of I-40 near the 138 mile marker was burning at about 6:40 p.m., according to emergency radio broadcasts.

"We have dead cattle in the middle of the highway, trees down and fences down," radioed one deputy who was north of McLean on FM 273 around 6:45 p.m.

At the Texas Department of Criminal Justice facilities outside Pampa, no hallway traffic was allowed as the prisons took precautions during the threat of fire, according to emergency radio broadcasts.

Water from the city's waste water ponds, water treatment plant and Recreation Park Lake were made available for use in fighting the fires if needed.

Flames had approached to three miles north and one mile west of Pampa as darkness fell Sunday. Traffic at 23rd and Price Road was closed off, and a mandatory evacuation of Walnut Creek Estates was ordered at 7:55 p.m., after the fire had crossed Price Road headed east.

"It's humongous," one Pampa Police Department officer commented on emergency radio concerning the Price Road fire.

Highway 70 north out of Pampa was closed at 8:35 p.m. by PPD. Wal-Mart Supercenter closed as a precautionary measure around 8:40 p.m., according to one observer.

Wheeler residents were allowed to return to their homes at 8:30 p.m., followed by Lefors residents at 8:45 p.m.

A mandatory evacuation of Keller Estates near Loop 171 was ordered at 9 p.m. as fire continued to burn around Pampa's perimeter. Loop 171 from Browning Street to Highway 70 was closed at 9:20 p.m.

Firefighters continued to battle hot spots and new blazes this morning in various locations around the area.

### Actress Maureen Stapleton dies at 80

LENOX, Mass. (AP) — Maureen Stapleton, the Oscar-winning character actress whose subtle vulnerability and down-to-earth toughness earned her dramatic and comedic roles on stage, screen, and television, died Monday. She was 80.

Stapleton, a longtime smoker who had been living in Lenox, died from chronic pulmonary disease, said her son, Daniel Allentuck.

Stapleton, whose unremarkable, matronly appearance belied her star personality and talent, won an Academy Award in 1981 for her supporting role as anarchist-writer Emma Goldman in Warren Beatty's "Reds," about a left-wing American journalist who journeys to Russia to cover the Bolshevik Revolution.

To prepare for the role, Stapleton said she tried reading Goldman's autobiography, but soon chucked it out of boredom.

"There are many roads to good acting," Stapleton, known for her straightforwardness, said in her 1995 autobiography, "Hell of a Life." "I've been asked repeatedly what the 'key' to acting is, and as far as I'm concerned,

the main thing is to keep the audience awake."

Stapleton was nominated several times for a supporting actress Oscar, including for her first film role in 1958's "Lonelyhearts"; "Airport" in 1970; and Woody Allen's "Interiors" in 1978.

Her other film credits include the 1963 musical "Bye Bye Birdie" opposite Ann-Margret and Dick Van Dyke, "Johnny Dangerously," "Cocoon," "The Money Pit" and "Addicted to Love."

In television, she earned an Emmy for "Among the Paths to Eden" in 1967. She was nominated for "Queen of the Stardust Ballroom" in 1975; "The Gathering" in 1977; and "Miss Rose White" in 1992.

Brought up in a strict Irish Catholic family with an alcoholic father, Stapleton left home in Troy, N.Y., right after high school. With \$100 to her name, she came to New York and began studying at the Herbert Berghof Acting School and later at the Actor's Studio, which turned out the likes of Marlon Brando, Paul Newman and Julia Roberts.

## Maryland man accused of starving woman

ELKTON, Md. (AP) — Weighing just 81 pounds, Mary Elizabeth Kilrain was found dead in a sparsely furnished, filthy room that was outfitted with a doorknob locking it from the outside.

Authorities say the 46-year-old woman was starved to death by her longtime partner, John Joseph Dougherty, who took care of her after an aneurism in 1999 left her unable to work.

"It was just deplorable conditions, to say the least," said Sgt. Bernard Chiominto, a detective for the Cecil County Sheriff's Department. "Just the stench alone coming from the room. It was one of the worst ones I'd ever seen."

Dougherty faces trial Monday on charges of neglect, involuntary manslaughter and second-degree murder. If convicted, he could go to prison for more than 30 years.

Attorney William Riddle is expected to argue that kidney disease caused Kilrain's dangerous weight loss and that she never was deprived of food before her death in February 2005.

Riddle said Dougherty took almost two years off work to care for Kilrain after her aneurism. When the credit

card bills got too high, he went back to work as a mechanic and never made enough to hire the nursing assistance she needed.

Calls to the state for help from social services went unanswered, Riddle said.

"He found himself in an unfortunate situation, and when he reached out for help, he was denied," Riddle said. "He did the best he could right up until the last day Ms. Kilrain died."

The case has garnered so much

attention that the trial was moved 45 miles south to Centreville, where prosecutors plan to describe to jurors in specific detail the kind of filth Kilrain lived in, down to an old pancake on the floor and a cup of urine on the windowsill. Black marks on the wall show where Kilrain banged with her cane.

Family members are expected to describe Kilrain as a woman who became angry and violent, sometimes hitting her three daughters with her cane.

They say the marks on the wall came from her becoming agitated after watching daytime television — not from Kilrain's attempts to get out of the room.

Free on a \$350,000 bond while he awaits trial, Dougherty declined an interview through his lawyer.

"I see this as a chance for vindication, a chance to finally get the truth out there," Dougherty told the Cecil Whig newspaper of his trial.

After the aneurism, Dougherty started a relationship with a woman 20 years his junior, and 33-year-old Kathleen Zeman was living in the house with two of her own children when Kilrain died.

## Two embark on crime spree after fleeing courthouse

ANADARKO, Okla. (AP) — One of two inmates who escaped from the Caddo County Courthouse after a Sunday church service and went on a crime spree across several counties has been captured, authorities said.

Lewis Petee, 26, was found in Texas around midnight, Oklahoma Highway Patrol Trooper Kera Philippi said Monday.

He and Eli Dominique

Edwards, 28, were inside a judge's chambers at the courthouse when they pushed out a window and escaped on foot about 12:45 p.m. Sunday, Philippi said.

"Within a 30-minute period, they stole three different cars," Philippi said. "They're definitely armed and dangerous."

Police suspect the two broke into a Gracemont home, stole guns and a car,

and kidnapped Jamie Allen. The woman was locked in the trunk of her car, but managed to get out and flag down a passing motorist in Wheeler, Texas, Philippi said.

Philippi said the two men also stole a pickup truck at gunpoint earlier in the day from a man south of Apache.

A Texas state trooper spotted the stolen car near Canadian, Texas, and the

two men tried to flee on foot after the car hit a chunk of concrete in the road.

Edwards is 5-foot-9, 180 pounds, with a missing finger on his left hand, authorities said.

Peteet was being held on charges of unauthorized use of a motor vehicle, and Edwards was sentenced on drug and weapons charges, Philippi said.

## 'Da Vinci Code' author accused of lifting ideas from other work

LONDON (AP) — Almost three years to the day that "The Da Vinci Code" was first published, American author Dan Brown found himself on a witness stand in courtroom 61 of London's High Court on Monday, denying accusations he copied from others to produce his huge best-seller.

Authors Michael Baigent and Richard Leigh are suing "Da Vinci Code" publisher Random House for copyright infringement, claiming Brown "appropriated the architecture" of their 1982 nonfiction book "The Holy Blood and the Holy Grail."

Both books explore theories that Jesus married Mary Magdalene, the couple had a child and the bloodline survives.

If the writers succeed in securing an injunction to bar the use of their material, they could hold up the scheduled May 19 release of "The Da Vinci Code" film starring Tom Hanks and Ian McKellen.

With his book an international sensation, Brown has rarely spoken to the media over the past couple of years and has made few public appearances, spending much of his time in his rural New Hampshire home, working on a new novel.

Over the past couple of weeks, the 41-year-old author has watched lawyers dissect accounts of the medieval Knights Templar, the secretive Priory of Sion and the Merovingian royal line allegedly descended from Jesus.

## Global security begins at our own borders

The idea "Think Globally, Act Locally" has influenced many decisions since its first use at an international conference in 1972. It conveys the idea that effective solutions to large problems often begin with steps taken in your backyard.

Today, keeping America safe requires the same concept. While our federal government protects us by meeting global threats abroad, we also need to act locally, addressing the potential security threats posed by illegal immigration.

We are all aware that important military missions are ongoing in dangerous parts of the world, and we are grateful for the courage of our military men and women. However, it would be a dishonor to their service if we did not protect our interests at home with the same dedication and vigor that they show overseas.

Domestic security requires our attention and cannot be overlooked. We must devote additional resources to securing our nation's borders. Our southern border has become

a sieve, and protecting Texas's border with Mexico is one way that we can fight the war on terror at home.

Monitoring Texas' border with Mexico is no easy task. It spans 1,248 miles — about the distance from Houston to Washington, D.C. But just because something is difficult does not mean it cannot be done. We have to do whatever it takes to secure our borders because the alternative is simply not an option.

Securing the Texas-Mexico border is also critical to our economy, because illegal immigrants can become a serious expense to local communities in the form of overwhelmed emergency rooms and overburdened schools.

President Bush's recent budget request is a good first step toward dealing with some of the immigration problems facing our state. The president requested \$450 million to provide 1,500 new border patrol agents. While this increase is a step in the right direction, it is not enough.

Terrorists are counting on southern border policy to be

weak, and we cannot allow that to happen. The 9-11 Commission recommended adding 2,000 new border patrol agents a year each year from 2006 to 2010 — at a minimum. This increase was

also recommended in the National Intelligence Reform Act that became law in December 2004.

Additional funding will help accomplish the Department of Homeland Security's goal of eliminating, by October, the catch and release program in place for

OTMs. Of the 160,000 OTMs caught and released, only 30,000 (under 20 percent) showed for their court hearings. That is unacceptable. I have urged the department to use temporary facilities to begin detaining non-Mexican illegal entrants immediately instead of releasing them until new facilities are prepared.

I have worked in Congress to increase immigration-related funding, and last fall we passed over \$31 billion for the Department of Homeland Security, providing \$9 billion for Customs and Border Protection,

Immigration & Customs Enforcement, and related activities, 250 criminal investigators (for a total of 6,000), and 20,000 detention beds.

During the previous Congress, I cosponsored legislation in the Senate reimbursing Texas hospitals approximately \$47 million a year for the cost of treating illegal immigrants.

Yet immigration reform requires more than just funding. Last year a community in New Hampshire attempted to prosecute illegal immigrants, but it was thwarted when a judge ruled the federal government has exclusive jurisdiction on civil immigration issues. Other communities around the country have faced similar legal obstacles in their attempts to stem the flow of illegal immigrants.

In response, I proposed the Illegal Immigration Enforcement and Empowerment Act. This bill would allow state and local law enforcement to become more involved in the process of catching illegal immigrants. State and local gov-

ernments should be permitted to pass their own laws so they can prosecute all immigration violations, both civil and criminal.

The Illegal Immigration Enforcement and Empowerment Act would allow states to enforce federal immigration law and to create state immigration enforcement provisions in accordance with federal law. It would also authorize the Department of Homeland Security to create a Volunteer Border Marshall Program that would use trained, volunteer, state-licensed peace officers on temporary missions on the border to assist the Border Patrol.

This program would provide temporary help to identify and control illegal immigration. It would also supply extra support to stop human and drug trafficking. This is a sensible option for communities that are looking for broader capability.

Security at our borders is an investment in national security, and we must attack the problem at every level.

Bill is, after all, a regular in Dubai. The crown prince — that is, the government — contributed to his presidential library and pays him \$300,000 per speech. Recently, Yucaipa, an American company that has Bill Clinton as a "senior adviser" and pays him a percentage of its profits, formed a partnership with the Dubai Investment Group to form DIGL Inc., a company dedicated to managing the sheik's personal investments.

## Losing our country to foreign investors

For those of you with computers, I have a Web site to recommend. It's www.economyincrisis.org. I don't know who is behind it, but it raises a most important question. Our country is in grave danger of being sold out from under us. What are we going to do about it?

We have all been sold rancid baloney about so-called free trade. This misnamed version of managed trade has not produced more jobs in America. It has cost us jobs. It has eroded our manufacturing base. It has empowered foreign countries to exert more and more control over our destiny.

According to this site, foreigners own 27 percent of our mining industry; 24 percent of our information industry; 20 percent of what's left of our manufacturing industry; 20 percent of professional, scientific and technical services; and 11 percent of our finance

and insurance industries. Furthermore, 45 percent of U.S. government debt is foreign-owned.

Trade deficits don't get much play in the news, but they are important. When we buy more from a country than it buys from us, that foreign country ends up with a stack of dollars. Foreign countries have been using these dollars to buy American businesses and natural resources. Last year's trade deficit was \$700 billion and change.

But why, you might ask, does it matter who owns an industry as long as it's located in the U.S.? Well, the answer is profit. An American-owned industry would invest its profits in America and in the communities where it is located.

Profits in a foreign-owned industry flow back to the foreign country. The profits earned by Chrysler, now a German-owned firm, flow back to Germany.

Profits from Honda and Toyota flow back to Japan.

When President

Bush, in pushing yet another free-trade agreement, claims that Americans can compete, he's either showing his ignorance or he is lying. How can you compete with somebody willing to do the same work for \$4 a day? Labor is the main ingredient in manufacturing. That's why so many American manufacturers have moved their manufacturing operations to cheap-labor countries. They are now beginning to outsource their service sectors. We have lost

whole industries, and we're in the process of losing more.

The standard argument for people who profit from the status quo is that you can't do anything about it. That's the message of Tom Friedman's book "The World Is Flat." Don't try to stop globalization — it's inevitable, there's nothing you can do to change it, etc., and so forth.

Bull. Elect a decent Congress, and you can change it overnight. What is needed is fair trade. If the labor cost for a pair of bluejeans in the U.S. is \$20 and the labor cost for a pair of bluejeans in Honduras is \$3, then you slap a \$17 tariff on the jeans from Honduras. That's how you level the playing field. That's how Americans can compete on a fair basis.

This country did not grow rich on free trade. Even before protective tariffs were adopt-

**DEAR KATHERINE:** Every year, when tax season rolls around, there are always lots of questions. Some of them come in January, but most arise just before April 15. The good news is, help is now available for military service and family members at no cost. This year, the Department of Defense is providing free access to the popular TurboTax filing program to all active duty guard and reserves (regardless of their activation status) and their family members via the Web site [www.militaryonesource.com](http://www.militaryonesource.com). This free program serves as an online "tax mentor" and helps in the preparation and filing of both federal and state taxes. Military OneSource can also refer you to certified financial counselors, tax experts and public accountants who can answer questions, also at no charge, by calling toll-free: (800) 342-9647. (To access the numbers for overseas, Spanish language and hearing-impaired tax filers, log onto [www.militaryonesource.com](http://www.militaryonesource.com).) Katherine, I'd like to personally thank you for establishing a support group for the spouses in your husband's unit because I am sure that at least some of them may feel isolated from one another while their loved ones are

away. If you haven't already considered it, you might want to check with your nearest military installation family readiness group, state coordinator or family program director. Military OneSource's 24/7 readiness counselors can also connect you to whatever information or support services you need. Please convey my appreciation to your unit and the members of your new spouse group. I salute you.

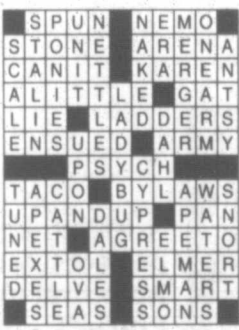

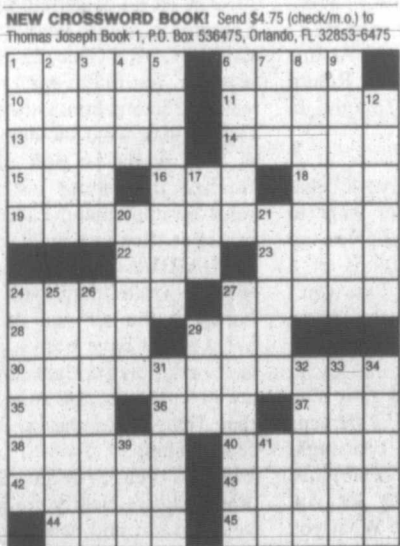

## IT IS ALL ABOUT THE A'S

## Weekend Sports Briefs

**INDIANAPOLIS (AP)** — Duke, Connecticut, Villanova and Memphis were selected Sunday as No. 1 seeds for the NCAA tournament.

This is Duke's 10th No. 1 seed, matching North Carolina for the most ever. It is Connecticut's fourth top seeding and the first time for both Villanova and Memphis.

The Big East set a record with eight schools selected for the 65-team field, while the Big Ten and Southeastern Conference each had six. The Atlantic Coast, Big 12, Missouri Valley and Pac-10 each had four teams chosen.

The previous record was seven teams. The Big Ten did that four times in 1990, 1994, 1999 and 2001, while the Big East did it in 1991.

Among the teams which had been mentioned as possible at-large teams but weren't selected were Cincinnati, Creighton, Florida State, Hofstra, Maryland, Michigan and Missouri State.

**VILLANOVA, Pa. (AP)** — Villanova guard Allan Ray was cleared to participate in non-contact basketball drills Sunday, two days after he was hit in the right eye at the Big East tournament.

**PRO FOOTBALL**  
**PHOENIX (AP)** — Edgerrin James ran off to the Arizona Cardinals on Sunday, agreeing to a four-year, \$30 million contract.

Last month, Colts president Bill Polian admitted he was taking a gamble by letting the seven-year veteran hit the free-agent market. And now James is gone after setting team records for rushing attempts (2,188), yards (9,226) and touchdowns (64).

James joins a franchise that has had one winning season since coming to Arizona in 1988, but the Cardinals will move into their long-awaited new stadium — with

a retractable roof — this fall.

**WASHINGTON (AP)** — The Washington Redskins snagged their second receiver in two days Sunday, signing Antwaan Randle El to a seven-year contract that could be worth up to \$31 million.

On Saturday, the Redskins sent a third-round pick in this year's draft and a fourth-round selection in 2007 to San Francisco for Brandon Lloyd.

Washington also signed tight end Christian Fauria, who spent the last four years with New England.

**CLEVELAND (AP)** — Punter Dave Zastudil signed a five-year contract Sunday with the Cleveland Browns, the third free agent with Ohio football roots to sign with the club in the past two days.

On Saturday, the club signed center LeCharles Bentley and wide receiver Joe Jurevicius, who both grew up in the Cleveland area, and offensive lineman Jeff Shaffer.

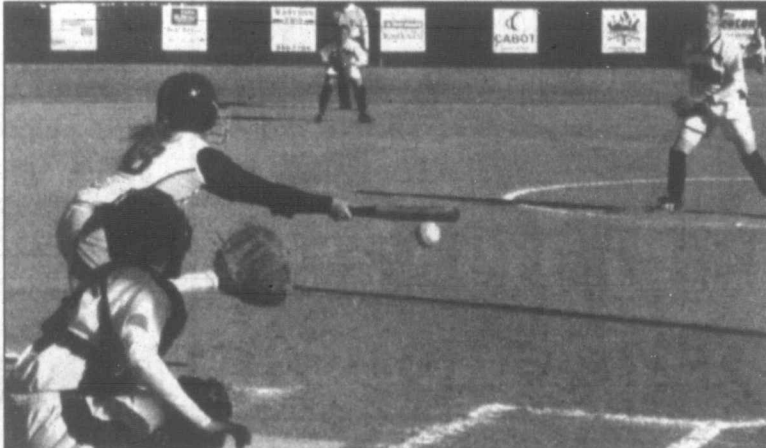
**GOLF**

# Drive for lobbying reform stalled by indecision, politics

WASHINGTON (AP) — In January, within days of the breaking of the worst lobbying scandal in decades, congressional leaders pledged swift and bold reform. That hasn't happened, and Congress may be months away from coming together on the issue.

The Senate, within sight last week of passing a tough lobbying and ethics bill, got sidetracked by the Dubai port-management controversy and has moved on to other topics. House Republicans, at odds over such issues as whether to ban privately funded travel, have yet to introduce a bill.

"It is disappointing that the Senate is not completing action this week," Sen. Susan Collins, R-Maine, said Friday after a Democratic attempt to attach an amendment killing the port deal brought floor action to a discordant halt.

"I fear this delay could jeopardize this important bill and that it could become a casualty of a crowded calendar," she said.

The Senate bill, which has bipartisan support, would require greater disclosure of lobbyists' activities, prohibit senators from accepting meals from lobbyists, introduce greater scrutiny of trips paid for by provide sponsors and slow the movement of lawmakers to lobbying jobs.

It also provides a way to kill pet projects, known as earmarks, that lawmakers sneak into larger bills.

It's unclear when the Senate will return to the ethics measure. This week it will turn to the 2007 budget bill. The following week, Congress is in spring recess. When it returns,

leaders say they want to start debate on the highly contentious issue of immigration reform.

"I'm not going to let it slide off the table," Sen. Barack Obama, D-Ill., who has championed ethics reform, said Sunday on CBS' "Face the Nation." "We're going to try and see if we can ban some of the corporate jets and perks."

But Obama added: "I'm a little bit concerned on the House side. There seems to be a lot of backpedaling."

House leaders were quick off the mark after lobbyist Jack Abramoff pleaded guilty in early January as part of a federal influence-peddling investigation. In one of its first acts of the new year, the House banned former members-turned-lobbyists from access to the House floor and gym.

House Speaker Dennis Hastert, R-Ill., saying that Congress must act to restore its tainted reputation, proposed a total ban on privately funded travel and asked Rules Committee

Chairman David Dreier, R-Calif., to lead the reform effort with a goal of passing legislation by the end of February.

The goal now is to move a bill before the Easter recess in April. It likely will contain a temporary ban on privately funded travel, until the end of the year, to give lawmakers more time to figure out how to separate legitimate fact-finding tours from the tropical island-and-golfing outings made infamous by the Abramoff scandal.

Hastert and other Republicans have also indicated the bill could include new campaign spending controls on tax-exempt partisan groups, nicknamed for a section of the tax code. In the 2004 elections, such groups spent \$544 million, by one estimate, and tended to favor Democrats.

But Sen. Christopher Dodd, D-Conn., a main sponsor of the Senate bill, and other Democrats stress that while campaign finance reform is more important than cleaning up lobbying rules, it should be dealt with separately and that inclusion in the lobbying bill could be fatal.

"We must not slow lobbying reform by tacking on unrelated campaign finance measures, which many on both sides would see as a poison pill," Dodd said in a floor speech.

Government reform groups say they are still confident that members of Congress, frightened by voter disgust at the lobbying scandal, will come through with a bill. Whether it contains some of the more substantive changes they want, such as a new independent office of integrity to oversee congressional ethics and lobbying matters, is another question.

MIAMI BEACH, Fla. (AP) — Young Jeezy was arrested after an alleged shootout in South Beach involving some of his friends, police said.

The 28-year-old rapper, born Jay Jenkins, was charged early Saturday with two counts of carrying a concealed firearm without a permit, police said.

Jenkins was with a group of men involved in a fight around 5:30 a.m. Friday, according to a police report.

When a passer-by filming the fight refused to hand over his video camera, one of the men in the group began shooting, the report stated.

Jenkins and about nine men fled the scene in two separate sport utility vehicles, police spokesman Robert Hernandez told The Miami Herald.

Officers stopped both vehicles, and found a semiautomatic firearm under Jenkins' seat and another gun near the armrest when they searched his SUV.

Two members of Jenkins' group also were arrested. Tramiel De Juan Golden was charged with strong armed robbery, and Steven Lesly Savain of Kendall was taken into custody on trespassing charges stemming from previous warrant for his arrest.

Young Jeezy's album "Let's Get It" was released in July.

BOGOTA, Colombia (AP) — Colombia's ambassador to the United States is criticizing Bruce Willis for comments he made during a press conference to promote his new film, "16 Blocks."

The actor said the United States should consider "going to Colombia and doing whatever it takes to end the cocaine trade."

In a harshly worded letter made public, Andres Pastrana told the actor that the source of the lucrative cocaine trade was an "enormous appetite for drugs, in particular in the United States and Europe."

Pastrana, who as president in 2000 launched an anti-drug effort with billions in aid from the United States, added that no country has sacrificed more than his own to rein in drug trafficking. Every year, he said, thousands of innocent civilians are killed as a result of anti-drug efforts.

Inviting Willis to visit Colombia, Pastrana said "if you accept, you will see that, beyond Hollywood cliches, 44 million Colombians are waging a real war against drugs."
