# County gives blessing to airport taxiway expansion

Perry LeFors Airport's planned expansion of a taxiway received official support by Gray County Commissioners in the form of a resolution at commissioners' 9 a.m. meeting today in the second-floor courtroom of the county courthouse at 205 N. Russell.

The 300-foot expansion of the airport's southernmost taxiway, its widest and biggest, will extend to the east and allow for three to five more hangars to be built, said Paul Loyd,

president of the airport board of directors.

The project will be funded with 90 percent federal and state funds and the remaining 10 percent from the airport budget.

"The actual estimated cost is about \$375,000, but TxDOT is using maximum dollars available," Loyd said this morning concerning the funding.

Cost of the project was projected to be \$374,410 at commissioners' Jan. 15 meeting. Commissioners approved the taxiway expansion at

that meeting.

Texas Department of Transportation's Aviation Division, which distributes the state and federal funds for airport projects around the state, noted in correspondence with County Judge Richard Peet that the total amount of funding available for the Perry LeFors project is \$466,149, of which \$419,534 is federal and \$46,615 is local funding.

The expansion project is not expected to begin until this fall, Peet said at the Jan. 15 meeting, with completion some time in 2008.

No action was taken on whether to hire an election administrator, and the issue was tabled until the next commissioners' meeting. County Clerk Susan Winborne, whose office provides electronic voting machines for all elections held within the county, said that from November 2007 through November 2008, there are 13 elections scheduled within the

"The work load is just phenomenal," she said of the elections.



Dog owners may wish to take their canine companions for "A Dip in the Park" which will be from noon to 3 p.m. Saturday at Hobart Street Park.

There will be no charge for the dipping, provided by Pampa Animal Control, according to Sandy Burns, animal control supervisor. Donations to Fund 12, which provides food and needed items for animals at Pampa's animal shelter, will be accepted

The dip is effective against fleas and ticks, Burns said. Animal Control officers will


perform the dipping.

Another service available during the Dip in the Park will be microchip implantation. A fee of \$15 will be charged per pet for the service.

Information on the pet's rabies tag is placed on a microchip which is then implanted under the skin of the animal. If the animal is lost and subsequently taken to an animal shelter, a scanner at shelters nationwide would be able to read the microchip information and enable personnel to get the pet returned to its owner, Burns said.

# Nifong resigns again

DURHAM, N.C. (AP) — Disgraced prosecutor Mike Nifong submitted a new letter of resignation today, agreeing to leave office immediately.

The letter is a formality Nifong has already been disbarred, suspended from office and replaced by his old boss as Durham County district attorney for his handling of the discredited Duke lacrosse rape case. He had also submitted a resignation letter last month that was to take effect July 13.

Superior Court Judge Orlando Hudson moved

ahead last week with an effort to remove Nifong from office under a rarely used process established in state law. But he held off booting Nifong from office until today, allowing Nifong time to send Gov. Mike Easley a new letter of resig-

Betty Lawrence, an attorney for the Durham resident who filed a petition in February asking Hudson to remove Nifong, pressed the judge to do so in spite of the revised resignation. Without such an order, she said, Nifong could potentially get his law license back and again run for office.

It was a suggestion Hudson dismissed without much of a discussion.

The county has the option of hiring an elections administrator who would be paid exclusively by the county to handle county elections, entering into an agreement with one or more of the other governing bodies in the county to fund a joint election administrator, or continuing the current practice of having county clerk staff handle the elections in addition to their current work load, with the possibility of adding a staff member to that office.

Estimated annual cost of having an elections administrator is \$51,770.46, Winborne said, including salary, benefits, training and office supplies. The county would also provide office

space, equipment storage and adminis-

If a joint administrator is chosen, Gray County would pay 50 percent of that total, with the City of Pampa and Pampa Independent School District paying 20 percent each and the remaining amount to be divided among the other school districts and cities within the county who choose to

participate. Each of the school districts and cities would pay a 10 percent administrative fee in addition to the cost of their elections if an elections administrator is chosen but is funded solely by the county, Winborne said. If a joint administrator is chosen, the 10 percent would not be charged.

"I think one person can do the job," Winborne said of the election work

## Benoit's doctor surrenders

ATLANTA (AP) — The personal doctor of pro wrestler Chris Benoit surrendered today to face a federal charge in connection with a drug probe, the physician's attorney said.

Attorney Manny Arora said Dr. Phil Astin will face a single charge involving improperly prescribing medication at a hearing later Monday.

Federal drug agents have taken over the probe into whether Astin improperly prescribed testosterone and other drugs to Benoit before he killed his wife and son and committed suicide in his suburban Atlanta home last month. State prosecutors and sheriff's officials are overseeing the death investigation.

Crosby, Patrick spokesman for the U.S. attorney's office, said he expected to have a criminal complaint and an indictment in hand Monday afternoon.



The most important safety tip is simple: parents must be involved with their child's Internet habits. Parents should educate themselves about cyber safety and speak openly with family members about online activities. Children and teens are more likely to come to an adult that they

feel is calm and comfortable discussing the subject matter. Parents can contact

the Office of the Attorney General for a copy of our Cyber Safety Brochure, which offers valuable information on chat room "lingo" and provides online security tips for both children and adults.

Parents with teens who visit social networking sites should be especially cautious. Our investigators encourage parents to have the passwords necessary to

regularly monitor their child's account. According to the National Center for Missing and Exploited Children, teenagers are more likely than younger children to get into trouble online. Teens are more likely to explore and reach out to strangers. Sadly, sex predators often exploit the anxiety and confusion that comes with adolescence.

Parents should keep the computer in a common room and limit the use of Web cameras. Digital images are easily captured online and are difficult, if not impossible, to retrieve once they are

circulated on the Internet. Teens and children who are approached by a stranger online should immediately inform a parent, guardian or any other trusted adult. They must not reveal personal information, including photos, video, last names or telephone numbers to strangers. Teens should never, under any circumstance, arrange a

June 24 The Dallas Morning News on Guantanamo Bay:

The war on terrorism since 9/11 has raised persistent legal problems for the Bush administration, particularly regarding the makeshift prison at Guantánamo.

The president declared war knowing this was not a traditional nation-versusnation conflict but a fight against an amorphous band of non-state actors.

Ever since the CIA and military began seizing enemy combatants, debate has centered on whether prisoner-of-war rights under the Geneva Conventions should apply to them.

We believe they should. The Bush administration has spent far too much energy devising convoluted legal arguments to justify imprisoning hundreds of suspects at Guantánamo but denying them all of the protections of Geneva.

Now the administration is considering Guantánamo's closure, but this won't solve the broader problem. The issue isn't Guantánamo. It's human rights and the rule of law, and it won't disappear just because the prisoners are moved to other venues.

To sidestep Geneva, the administration labeled detainees as "unlawful enemy combatants" and argued that international human-rights obligations apply only to lawful (that is, statesponsored) fighters.

Unlawful combatants qualify for heinous interrogation methods, including the simulated drowning technique known as "waterboarding." But this is not torture, the White House insists. The Pentagon describes the conditions at Guantánamo as exemplary and complying with the "spirit" of Geneva, as if this were sufficient to answer humanrights concerns.

Enough.

This is a war, and these are prisoners

What we're fighting for goes to the heart of who we are as a nation. Do we abide by a system of laws? Do we honor our treaty obligations? Do we follow a code of conduct regarding the

treatment of fellow human beings,

inconvenient as that might be? Applying the Geneva Conventions does not increase the vulnerability of U.S. personnel to war-crimes prosecution. In the Military Commissions Act of 2006, Congress decriminalized forms of degrading or humiliating treatment. But it retains Geneva's "cruel and inhuman" torture prohibitions. Geneva applies in those cases,

like it or not. Some say the Guantánamo prisoners don't deserve Geneva protections because al-Qaeda uses swords to lop off the heads of its detainees.

Nobody expects model behavior from al-Qaeda. The world is, however, watching us.

Our behavior sets the standard. The torture methods America uses today will be revisited upon our captured troops in future wars. Washington has lost the moral high ground to lecture China, Cuba, Syria and Zimbabwe about human rights.

We are troubled by the administration's record at Guantánamo. Some prisoners are being held on flimsy legal evidence. Others have been flown to countries willing to torture on

our behalf. The Pentagon deems 50 to 75 detainees to be hardened, committed al-Qaeda members who are so dangerous they cannot be freed or imprisoned elsewhere. Fine. The reality is, this group isn't going anywhere and probably will never see the inside of a

Under U.S. law, their status will be subject to constant challenge because our legal system cannot permit indefinite detention without trial. But the Geneva Conventions do. Simply stated, Geneva allows nations at war to keep POWs until hostilities officially

end. In this case, it could take decades. We cannot simply take it on faith, because a few military and civilian officials say so, that the current process humanely dispenses justice to the guilty and grants freedom to the

innocent. The state of limbo at Guantánamo is unacceptable. It violates what this country stands for.

According to Alan Liotta, the Pentagon official in charge of detainee affairs, about 380 prisoners remain at Guantánamo out of the 800 detained since 9/11. Not all were captured on the battlefield, and some are accused merely of having associated with terrorists. There are three major detainee

Was my husband out of line for asking her to move? What would you have done in that situation? - UNSURE OF WORRIED DAUGHTER, FAYET-THE RULES, BEASLEY, TEXAS

**DEAR UNSURE:** Your husband was not out of line in asking the woman to move. She was nervy and wrong to block traffic and take advantage. And if the police had been summoned, they probably would have backed you up. What would I have done in that situation? Had I been behind the wheel, I would have been tempted to very ... slowly ... continue ... parking my car ... until she either moved or I squashed her like a bug against the wall or the car in front. (That's why my husband does most of the driving when we're together.)

DEAR ABBY: My mother is 68, financially stable and living alone. She has had emotional problems throughout her life and has ended up alienating most of her

children. I'm the only one who checks on her regularly, and I'm worried sick.

Mom is withering away. She's 4 foot 11 and admits to weighing only 76 pounds. She's not eating right, and a lifetime of smoking has caught up with her. She has difficulty breathing, but won't see the doctor. Most days she doesn't have the strength to even carry in a bag of groceries. I call her often, and the neighbors watch out for her, but her house is falling down around her, trash is piling up, and it's not a healthy place to be. I have never gone against my mother. I tried an intervention with one of my sisters; it only alienated Mother. Someone has to step in before the fire department has to break in and finds her dead on the floor. Can I legally step in and take care of her? We have an extra room she could live in. We could move her to assisted living. No one wants to make the first move, and if I don't do this right, Mother may never speak to me again. --TEVILLE, N.C.

DEAR WORRIED DAUGHTER: Which would be worse -- a miffed mother or one dead from neglect? Contact your nearest senior services center and talk to a social worker who has geriatric training. In many communities, these social workers can contact and befriend isolated seniors, and see they get the help they need to remain independent as long as possible. If the senior citizen centers can't help you, get in touch with your local Area Agency on Aging to determine what other services might be available to help your mother. Only as a last resort should you try to become her conservator because the process can be difficult, and you might not







# Venus Williams rallies to win

WIMBLEDON, England (AP) — Venus Williams made it to the fourth round at Wimbledon despite a performance so filled with errors she drew criticism from her father.

The three-time champion rallied past Akiko Morigami 6-2, 3-6, 7-5 Monday in a match suspended Saturday. And she did it even though she faced 23 break points, double faulted 14 times and trailed 3-5 in the third set.

Williams will next go against 2004 champion Maria Sharapova, one of only two players to win Saturday in the rain-plagued tournament. Williams trailed 1-4 in the second set when her match was halted, and when it resumed two days later she struggled from the start, losing the first seven

"If Venus moves up to the ball and takes it off the bounce instead of waiting behind the baseline, she'll be the only one here, including Sharapova," said Williams' father and coach, Richard. "She's not going to beat anyone if she's not moving into the ball."

Venus saw the match as a positive.

"When it was time, I did what it took. I definitely would like to do what it takes earlier," she said. "But I think on the other hand,

that kind of competition is invaluable in this kind of tournament. So either way it's good for me."

Top-ranked Justine Henin, seeking the only Grand Slam title she has yet to win, became the first woman to reach the quarterfinals by beating No. 15-seeded Patty Schnyder in 56 minutes, 6-2,

"I was a little bit surprised that the match was that quick," Henin said. "I was ready to have a good fight."

Henin has lost 15 games in four rounds.

I did my job perfectly until now," she said.

# Baseball managers: one is burned out, another is fired Narron fired by struggling Reds Hargrove walks away in Seattle

SEATTLE (AP) - One of the most bizarre days in Seattle Mariners history ended with Mike Hargrove heading into sudden retirement while in search of a new, red pickup truck to drive down the Pacific Coast.

Hargrove, 57, left in the rear view mirror as many conspiracy theories as questions as to why he had resigned as manager Sunday while peaked at Seattle's highest point in more than four years.

"I don't expect people to understand it, I really don't, because at times I don't understand it myself," said Hargrove, who's been in major league baseball since 1972.

As Hargrove abruptly and stunningly resigned - citing an inability to muster the daily dedication he has demanded from players for his 15 1/2 seasons as a major league manager - his Mariners won their eighth consecutive game, 2-1 over Toronto on

Sunday. He became the first big league manager since at least 1900 to depart while on a winning streak of more than seven games, according to the Elias Sports Bureau.

Seattle was soaring at 12 games over .500 entering Monday night's debut of new manager John McLaren, Hargrove's bench coach, at Kansas City. The 55-year-old McLaren, who said the startling events were tough for him to comprehend, hasn't been a full-time manager since 1985, when he was at Knoxville in the Southern League. He rejoined the Mariners this season, after 15 years working on the staffs of manager Lou Piniella that included 1993-2002 in Seattle.

"This is not a perfect scenario to take over a ballclub," the 12th manager in Mariners history said, his right arm in a sling following rotator cuff surgery last week. "But I'll run with it."

CINCINNATI (AP) — Jerry Narron's final act as the Cincinnati Reds' manager was to change relief pitchers. Again.

Ultimately, he knew all those trips to the mound could be his downfall.

The Reds fired Narron on Sunday night, a few hours after an 11-7 loss to the St. Louis Cardinals left them with the worst record in the major leagues at 31-51 and convinced ownership that change was needed.

Although ownership and general manager Wayne Krivsky declined comment after the firing was announced late Sunday, Narron had already singled out the bottom line during the weekend series.

"We feel like we're in every ballgame," he said, after the Reds' only victory of the series on Saturday. "It comes down to if we can get some outs after our starters come out of the

Most often, they couldn't. And that's the biggest reason why Narron was gone.

Advance scout Pete Mackanin, who managed the Reds' Triple-A team in Nashville from 1990-92, was chosen interim manager. He was the Pirates' interim manager for the final 26 games of the 2005 season after Lloyd McClendon was fired.

The switch came a few hours after Seattle's Mike Hargrove resigned, saying he no longer had a passion for the job.

Narron was the second big league manager to be fired this season. Baltimore's Sam Perlozzo lost his job on June 18 after the last-place Orioles couldn't shake another losing streak.

The Reds have been far worse, setting a pace for their first 100-loss season since 1982. With no improvement in sight and attendance starting to lag, the club decided to

# Kerr finally wins a major on LPGA tour; Ochoa waits her turn

SOUTHERN PINES, N.C. (AP) Cristie Kerr can finally relax. She isn't 0-for-the-majors any-

Meanwhile, Lorena Ochoa can only look to her next chance to snap her string of major futility.

Kerr had just two bogeys during her final 45 holes and had only one three-putt all week in claiming her first Open title at Pine Needles, where she has played well in two previous Opens. The high amateur

in its first visit in 1996, Kerr was 3 over and tied for fourth in 2001.

"I knew since the last time I came here ... it was going to be my week," Kerr said. "When I stepped on the grounds this week it was just magic."

Ochoa was left with a familiar feeling, too.

With a chance to capture her first major and remove any doubt about who's the best in her sport, Ochoa struggled again with a quick swing under pressure and failed to hit a green in regulation over the final five holes.

"For sure, you don't want to be

Why would Hargrove leave after enduring six consecutive losing seasons in Baltimore and Seattle, just when his last three years of growth and teaching and roster purging were paying dividends?

-Did Hargrove get forced out by Ichiro Suzuki as a condition set by the superstar to ownership, a prerequisite to the seven-time All-Star staying in Seattle beyond this final season of his contract?

"Please don't ask questions about that right now," Suzuki said, with a stare, through a translator.

The two then agreed to wait and see if Hargrove's inability to muster motivation for the game continued for a couple of weeks.

Narron couldn't do much about a bullpen that led the NL in losses and repeatedly failed to hold leads in the late innings. Reds relievers have lost 18 games, most in the

With the franchise headed for its seventh straight losing season — its deepest slump in a half-century — the Reds made another move to shake things up. They've had three general managers and now four managers in the past five years, an instability that makes it difficult to succeed.

Since winning the World Series in 1990, the Reds have had seven managers and made only one playoff appearance - in 1995 under Davey Johnson.

The Reds expected a return to prominence when they moved into Great American Ball Park in 2003, but it didn't happen. They fired general manager Jim Bowden and manager Bob Boone midway through the season.

Dave Miley got the next chance, but was fired midway through the 2005 season. Narron, his bench coach, took over on an interim basis and kept the job after leading the team to a 46-46 finish the rest of that

The Reds went 80-82 last year, their first under owner Bob Castellini. It was their best result since 2000 and earned Narron a two-year extension through 2008.

Castellini allowed the payroll to rise \$10 million to \$69 million this year, hoping to contend in the weak NL Central. He also allowed Krivsky to give \$71 million in contract extensions to starting pitchers Aaron Harang and Bronson Arroyo, the franchise's biggest spending splurge since it brought Griffey home in 2000.

It all fell apart fast.

The rotation started strong but faded. Arroyo has yet to win a game since May 6, left-hander Eric Milton has had reconstructive elbow surgery, and highly acclaimed rookie Homer Bailey has been roughed up in his last two starts.

Bailey failed to make it through the fourth inning of Sunday's loss that highlighted the Reds' shortcomings. They made three more errors and their bullpen turned a close game into another drubbing.

It became the prelude to Narron's firing.


