Fourth of July celebrations abounded in the area for Independence Day.

Pampa hosted its annual fireworks display at dusk on Friday, July 4, 2008.

Earlier in the day, United Supermarket hosted its second annual Firecracker Car Show. Jimmie Clark won first place with his red Thunderbird. Lonnie Shelton placed second with his black Pontiac GTO, and Ron Knipp was third with his gray and maroon Chevy pickup.

Wheeler started the Fourth of July with their third annual benefit fun run and walk followed by a parade, water polo and games on the square and a dance and fireworks in the evening.

Canadian had not just one, but two rodeos. They held their official 120th annual rodeo and then staged a new ranch rodeo amid a parade, arts and craft show, duck race, turtle race, old-timers' barbecue and dances.

Siv Sichan, former U.S. Ambassador to the United Nations, was on hand at the Canadian celebration. Earlier in the week he was at Hastings in Amarillo and Pampa

City may join coalition to keep utility regulations

The Pampa City Commission will consider joining 78 other communities in the Texas Panhandle to battle a move to ease electric utility regulations.

The city commission will meet at noon, Tuesday, Dec. 30, in the commission chambers of City Hall.

American Electric Power, an electric holding company, is urging the Texas Public Utility Commission to consider changing ratemaking methodology. Opponents to the proposal said it would diminish review of costs and expenses of monopoly utilities like Southwestern Public Service, a subsidiary of Xcel Energy.

Pampa is part of the Alliance of Xcel Municipalities, a coalition that will be joining with two other coalition of communities in the state to hire a law firm that will file a brief with the PUC in opposition to the change in rules.

The estimated legal cost is \$60,000 to \$70,000. Each community in a coalition will pay a portion of the cost based on population.

Each of the coalitions is expected to pay about \$20,000 of the total cost.

Pampa's portion will be \$832.02.

Amarillo will pay \$8,513.28. Borger will pay \$665.26. Canadian will pay \$105.03. Lefors will pay \$26. McLean will pay \$38.61. Miami will pay \$27.35. Mobeetie will pay \$4.83. Skellytown is on the hook for \$28.37. Wheeler will pay \$64.80. White Deer will

Four die in July crashes on area roads

Four people lost their lives on area roads just in the month of July.

July
 Accident (July 10) Two Pampa women died in a two-vehicle accident which occurred at the intersection of Texas Highway 70 and U.S. Highway 83 in Ochiltree County.

Bethany Caviness, 18, and Diana Castillo, 19, were pronounced dead early by Ochiltree County Justice of the Peace Braden Karber after the accident happened around midnight.

Caviness' 2-year-old daughter, a third occupant in the women's vehicle,

was also injured.

Caviness did not stop at the stop sign on Texas Highway 70 and entered the intersection of U.S. 83, according to DPS reports. HER car was struck by a Mack truck driven by Juan Arjona, 32, of Raymondville. Arjona was taken to Ochiltree County Hospital with injuries and is in stable condition, Hawthorne said.

"The car burst into flames after impact," Hawthorne said. "A Good Samaritan stopped and got the 2-year-old out of the car before it was engulfed in flames."

Accident (July 12) Former Pampa resident Christopher Dean

Brumley, 35, was pronounced dead by Hardeman County Justice of the Peace Linda Hollenbaugh after a motorcycle accident on U.S. Highway 287, 1.2 miles west of Quanah took his life.

The 2004 Aih motorcycle Brumley was driving struck a Texas Department of Transportation truck at 12:46 p.m. The TxDOT vehicle was legally blocking the road at the time of the accident.

Brumley did not have his helmet on at the time, according to Texas Department of Public Safety Trooper Daniel Hawthorne, public infor-

Search continues for soldier in Texas bay

McALLEN, Texas (AP) — Searchers continued combing a South Texas bay Sunday for a soldier who authorities believe drove his car off the end of a pier the day after Christmas.

Pfc. Jamie Wagner Sengvanhpheng, 21, was home on leave from Fort Bragg, N.C. and visiting family in Rockport when he disappeared after hanging out with friends at a bar late Christmas night.

His 2004 Acura was found submerged in Copano Bay Friday, but Sengvanhpheng was not inside.

A body had not been recovered so the search

continued, a dispatcher with the Aransas County Sheriff's Office said Sunday.

Older brother James Sengvanhpheng said there were no developments and declined to say more while his brother remained missing.

Authorities first got the call about someone driving on the pier around 1:50 a.m. Friday. At daybreak they found the car in the bay and saw it was registered to Sengvanhpheng. Investigators do not believe anyone else was in the car when it entered the bay.

Gattis joins crowded race for Texas speaker

AUSTIN (AP) — Georgetown Rep. Dan Gattis is the 12th candidate to declare he'll seek to unseat Republican House Speaker Tom Craddick next month.

Gattis told the Austin American-Statesman on Sunday his intentions to challenge Craddick, who is seeking a fourth term as speaker after a raucous

effort to overthrow him during last year's session.

Gattis, a Republican, had been a Craddick loyalist. The 150-member chamber will elect a speaker to a two-year term when they convene on Jan. 13.

Republicans have a slim 76-74 majority in the House.

mation officer in the Childress DPS office.

Crime (July 15) A Pampa woman was arrested and had a \$39,000 bond set after she was arrested on 15 counts of forgery of a financial instrument.

Claudia Renate Frame, 43, was arrested by Gray County sheriff's deputies at her home in the 1300 block of West Kentucky. She was released on bond from Gray County Jail, according to jail records.

The 15 forgeries occurred when checks were written to local businesses, said GCSO Lt. Joe B. Hoard. The checks were written on a closed account, he said, and one victim is the source of all the forged checks.

Crime (July 16) Gray County deputies returned Levi A. King, 26, to the Texas Panhandle over the weekend from a Missouri prison where he is serving two consecutive life without parole sentences after pleading guilty to the Sept. 29, 2005, murders of Orlie McCool, 70, and McCool's daughter-in-law, Laura Dawn McCool, 47, at Orlie McCool's Pineville, Mo., home.

King is accused of killing the Brian Conrad family south of Pampa in the early morning hours of Sept. 30, 2005. He was indicted on four counts of murder by a Gray County grand jury in March, 2006.

King was extradited from Missouri to Texas to stand trial for the deaths of Brian Conrad, 31; Mitchell Conrad, 35; Mitchell Conrad's 14-year-old son Zachary Doan and Mitchell Conrad's unborn child.

King pleaded guilty to the Missouri murders in a Waynesville courtroom on April 18.

Accident (July 19) A Pampa man was injured and a Longview man was killed in a two-vehicle accident which occurred at the intersection of Farm to Market Roads 293 and 2300 in Gray County.

Collin Lackey Bowers, 22, a Pampa rancher, was transported to Northwest Texas Hospital in Amarillo where he was treated and released after the crash.

Randall L. Newman, 53, of Longview was pronounced dead at the scene by Precincts 1 and 3 Justice of the Peace Joe Martinez.

Crime (July 26) Four persons were served with papers notifying them of indictments against them for criminally negligent homicide in connection with the death of Cody Randall Best, 17, of Pampa in 2005, according to Gray County Sheriff's office records.

Best was taken to Pampa Regional Medical Center on Sept. 13, 2005, while he was unconscious from a drug overdose, according to a Pampa Police Department news release at the time. He died the following day.

The four named in the indictments for criminally negligent homicide in connection with the incident involving Best were originally indicted Feb. 9, 2006, by a Gray County grand jury in 31st District Court for manslaughter, a second-degree felony punishable by up to 20 years in prison.

Indicted on Feb. 9, 2006, were Matthew Wade Hopkins, then 37; Penny June Summers, then 25; Terry Glenn Honeycutt, then 37; and Kylie J'nae Winegeart, then 18. All four were

Pampa residents at the time of the incident and the manslaughter indictments. They were arrested and booked into Gray County Jail on Feb. 13, 2006, in connection with the manslaughter charges.

The manslaughter indictments stated that on Sept. 13, 2005, each of the four recklessly caused the death of Best by failing to seek medical attention for him in a timely manner.

An autopsy performed in Lubbock after Best's death showed that he had died of a lethal amount of methamphetamine.

August
Fire (Aug. 5) A structure fire at White Deer caused Highway 60 to be closed for a time due to smoke and flames, according to Darell Luster of White Deer Police Department.

"The building was fully engulfed in flames when the fire departments got on scene," Luster said.

The fire was reported at 10:15 a.m. and involved a building on the south side of Highway 60, west of Main Street. The building had previously been a restaurant known as The Green Punkin and had then been an antique store before being vacated, Luster said.

Crime (Aug 16) A Booker woman was sentenced to 10 years in a Texas Department of Criminal Justice facility after being found guilty of aggravated sexual assault of a child.

Ginger Brown, 33, was found guilty of the first-degree felony in 31st District Court in Lipscomb County Courthouse. Jury selection had begun Monday morning, with a jury seated by 2 p.m., said Evelyn Rutherford, a paralegal in 31st District Attorney Lynn Switzer's office.

"The offense occurred in March 2002, but was not reported and investigated until four years later," Rutherford said. The victim was 8 years old at the time of the incident.

A co-defendant, Jimmy Brown, who is Brown's husband, is already serving a sentence in a TDCJ prison after he pleaded guilty to injury to a child and aggravated sexual assault of a child. Jimmy Brown was sentenced to five years for the injury charge and 18 years for the sexual assault charge. The sentences are to run concurrently.

Police (Aug 27) Pampa Police Department was named a "Recognized Law Enforcement Agency" by the Texas Police Chief Association Law Enforcement Recognition Program.

The department received the honor on Aug. 3, when it became only the sixth agency in the state to be thus recognized.

September
Accident- One McLean man was killed and two others were taken to the hospital as a result of a one-vehicle rollover accident which occurred at in Wheeler County.

Frank Saunders, 18, was pronounced dead by Wheeler County Justice of the Peace Rick Walden at the scene of the accident, according to Trooper Daniel Hawthorne, Texas Department of Public Safety public information officer in the Childress DPS office.

The accident occurred at the intersection of County Road CC and the County Line Road in Wheeler County, according to the DPS accident report.

Isbell Wade, 19, was driving his 1997 Chevrolet pickup along County Road CC, with

Saunders and another occupant, Larry Lusk, 18, in the vehicle.

"As he approached the intersection of County Road CC and County Line Road, he could not negotiate the turn due to his speed," Hawthorne said.

The pickup slid sideways through a fence and overturned. Wade and Lusk were taken to Northwest Texas Hospital in Amarillo with unspecified injuries.

None of the three occupants of the pickup were wearing seat belts at the time of the accident, Hawthorne said.

Robbery- An armed robbery in McLean netted two men approximately \$500, according to Gray County Sheriff's Office reports.

Sheriff's deputies were dispatched to the Cactus Inn Motel, located at Pine and Hindman streets in McLean, at about 11:30 p.m. Wednesday concerning a report of an armed robbery there.

"The clerk claimed that two males walked into the motel office, both wearing black clothing and gauze around their faces," said GCSO Lt. Joe B. Hoard. The white gauze was wrapped around their heads and faces, with only their eyes exposed, he said.

"One held the clerk at gunpoint while the other took the money out of the cash drawer," Hoard said. "They left in a newer-model light tan vehicle."

No further description was available concerning the vehicle, he said. Both men were described as being over 6 feet tall and slender.

The two men headed west on Hindman Street, or Business I-40, when they left the scene.

Drug Arrests-Sheriff's deputies discovered what appeared to be two clandestine methamphetamine labs at two locations in McLean.

The first arrest was made after deputies who were on patrol in the 300 block of East 7th Street detected a strong odor of a hazardous chemical at about 11:15 p.m., said GCSO Lt. Joe B. Hoard.

"They checked the area and found it was coming from a house," Hoard said. "They kept the house under surveillance for a time and then approached it."

The occupant of the house stepped outside to meet the deputies. One of the deputies told the man they were there to investigate a chemical order.

"The owner told them he had a pistol in his pocket," Hoard said. "The deputies took the pistol and during a search of the man, they found a small container with a brown substance believed to be methamphetamine."

The search of the man

and the residence resulted in the arrest of Michael R. Bybee, 46. He was booked into Gray County Jail on charges of possession of less than one gram of a controlled substance and possession/transport of certain chemicals with intent to manufacture a controlled substance.

Two more arrests occurred Tuesday after a deputy stopped at about 1:08 p.m. that day in the 500 block of Walnut Street to visit with a person about a complaint the person had made, Hoard said.

The deputy asked permission to search the structure, and the man, who is the owner of the property, consented, Hoard said. He unlocked the garage and the deputy entered and found what appeared to be a clandestine meth lab, according to sheriff's office reports.

"Upon investigation, he determined that it was an active meth lab," Hoard said. "He found several items."

Kenneth George Hipp, 53, and David Ray Burrow, 28, were arrested and were each charged with possession/transport of certain chemicals to manufacture a controlled substance and possession of less than one gram of a controlled substance.

Arrests- One Pampa man was pronounced dead and another was arrested on a charge of murder after an apparent stabbing which occurred on Brunow Avenue.

Pampa police officers were dispatched to 731 E. Brunow at about 4:19 p.m. concerning a victim of a stabbing, said Pampa Police Department Sgt. Donny Brown.

Upon their arrival at the house, Guardian EMS personnel who were at the scene directed officers to the east side of the residence. There, they found Luis G. Acosta, 48, of 939 Brunow, lying face down in the yard with what appeared to be several stab wounds to the upper portion of his body, Brown said.

Officers took Ronnie Gene Carter, 45, of 731 Brunow, into custody and booked him into Gray County Jail on a charge of murder.

Precinct 2 Justice of the Peace Kurt Curfman pronounced Acosta dead at the scene and ordered an autopsy. The victim was transported to Lubbock for the autopsy. No preliminary autopsy results had been received by Curfman as of press time.

Accident- A 15-month-old child was struck by a vehicle at a residence in the 1000 block of Prairie Drive.

Pampa police officers, Guardian EMS and Pampa Fire Department personnel were dispatched to the Guardian

EMS office in the 1000 block of South Barnes at about 12:20 p.m. Friday concerning the accident, according to police records.

"Officers were advised that a family member had backed over the child in the 1000 block of Prairie Drive, and the family had taken the child to the EMS building for medical attention," said Pampa Police Department Sgt. Donny Brown. "Unfortunately, at the time, there was no one at the building because the ambulance was out on another emergency."

Pampa PD Lt. Kenneth Hopson located the family's vehicle as it was traveling northbound in the 600 block of North Cuyler. He made contact with the family and was also met by Pampa FD and Guardian EMS personnel there, Brown said.

The child was trans-

ported by ambulance and then airlifted to Northwest Texas Hospital in Amarillo, where emergency surgery was performed, Brown said.

Shooting- The victim of a shooting which occurred at a Pampa address has died of his injuries, and the charge against the alleged shooter was upgraded to murder, according to Det. Casey Ingersoll of Pampa Police Department.

Carlos A. Hernandez, 19, of 115 N. Starkweather, died at about 10 p.m. Monday as a result of the injuries sustained in the shooting, Ingersoll said in a press release. Juan D. Cano, 25, of 514 N. Warren, who was already in Gray County Jail on a charge of aggravated assault with a deadly weapon in connection with the shooting, has been charged with murder. Bond on the murder charge has been set at



Today's Highlight in History:

Two hundred years ago, on Dec. 29, 1808, the 17th president of the United States, Andrew Johnson, was born in Raleigh, N.C.

On this date:

In 1170, Thomas Becket, the Archbishop of Canterbury, was murdered in Canterbury Cathedral by knights loyal to King Henry II.

In 1845, Texas was admitted as the 28th state.

In 1851, the first American Young Men's Christian Association was organized, in Boston.

In 1890, the Wounded Knee massacre took place in South Dakota as an estimated 300 Sioux

Indians were killed by U.S. troops sent to disarm them.

In 1940, during World War II, Germany dropped incendiary bombs on London, setting off what came to be known as "The Second Great Fire of London."

In 1975, a bomb exploded in the main terminal of New York's LaGuardia Airport, killing 11 people.

In 1978, during the Gator Bowl, Ohio State University coach Woody Hayes punched Clemson player Charlie Bauman, who'd intercepted an Ohio pass. (Hayes was fired by Ohio State the next day.)

Ten years ago: Two top Khmer Rouge leaders apologized for the deaths of as many as two million people during their regime in the 1970s, and asked Cambodians to forget the past.

Five years ago: Monsignor Michael Courtney, Pope John Paul II's ambassador in Burundi, was shot and killed by unidentified gunmen. Actor Earl Hindman, who'd played the mostly unseen neighbor Wilson on "Home Improvement," died in Stamford, Conn., at age 61.

One year ago: The New England Patriots ended their regular season with a remarkable 16-0 record following a thrilling 38-35 comeback victory over the New York Giants.

Panel report shows need for education improvement

In a highly competitive global economy, the skills of the next generation of Americans will be the prime engine for our country's economic growth. Yet compared with children in other nations, U.S. students are underperforming in the vitally important fields of science, technology, engineering, and math (STEM). In 2005, the National Academies released an eye-opening report called "Rising Above the Gathering Storm," which identified alarming trends in America's STEM education. Their conclusion was clear: if we want to remain the undisputed leader of the global economy, we need to improve our STEM abilities, and we need to do it urgently.

In response to "Rising Above the Gathering Storm," I charged The Academy of Medicine, Engineering, and Science of Texas (TAMEST) with forming a panel to study ways to improve STEM education in Texas. TAMEST is the perfect organization to help lead this mission. In 2004, I co-founded TAMEST with Nobel laureates Dr. Michael Brown and the late Dr. Richard Smalley to bring together the state's top scientific minds to further position Texas as a national research leader. On December 9, the TAMEST Education Steering Committee

released its much-anticipated report, "The Next Frontier: World-Class Science and Math Education in Texas," which includes recommendations that should be read by Texas parents, teachers, principals, and especially policy makers.

In the words of Education Steering Committee Co-chair Dr. William Brinkley, who is also the Senior Vice President for Graduate Sciences and the Dean of the Graduate School of Biomedical Science at Baylor College of Medicine - Houston, "the United States is being left behind...In China today, over 40 percent of college undergraduates earn engineering and science degrees, while in the U.S., only 5 percent of students do, and Texas is in the bottom half among the states - our students consistently score lower than the national average on math and science proficiency tests. This is simply unacceptable."

Even now, American companies have to recruit heavily from overseas to fill job positions in highly technical fields such as computer engineering and medical science. And whenever possible, U.S. companies simply move overseas to find the necessary workers. This "outsourcing" is one of the key reasons China has displaced the U.S. as the world's largest exporter of IT products (while the U.S. has become a net

importer of those products).

According to "The Next Frontier," two of the best ways to improve STEM education are to expand Advanced Placement (A.P.) programs and strengthen the quality of teachers in STEM fields.

I supported authorization of the first federal grants for A.P. programs, and since 1998, their funding has grown from \$3 million to \$43.5 million per year. In 2007, I cosponsored and helped pass the America Competes Act, which increases the number of A.P. courses in underprivileged schools and bolsters the supply of teachers for A.P. math, science, and foreign language courses.

"Great teachers are the foundation upon which we will build world-class science and math education here in Texas," observed Committee member Kurt Swogger, Executive Vice President of Investments at the Planned Innovation Institute. As other organizations have pointed out, the most consistent and powerful predictor of student achievement in STEM is the presence of teachers who are fully certified and have at least a bachelor's degree in the subjects they teach.

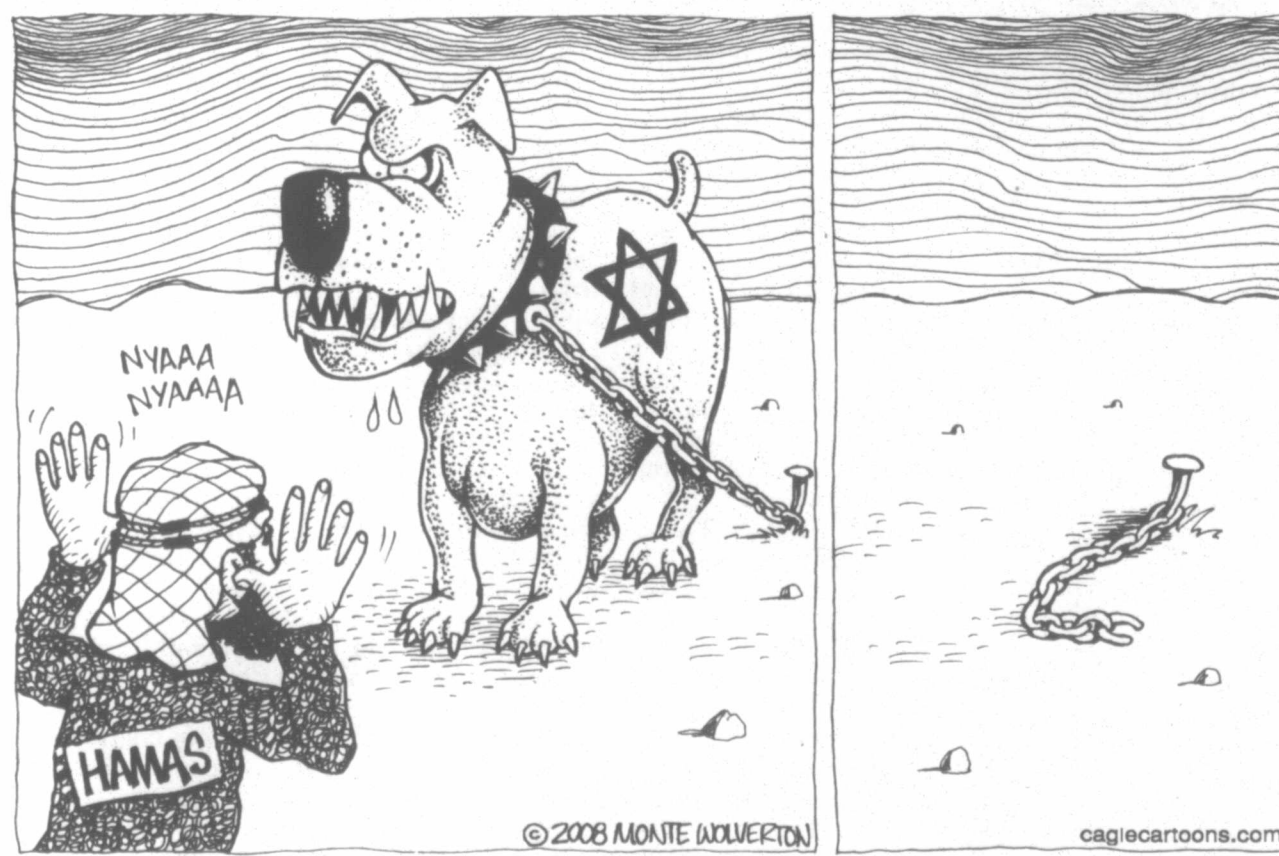
That's why I've been a strong advocate for Teachers for a Competitive Tomorrow, a project in which colleges and universities encourage undergraduate students to



gain degrees in their STEM fields of study with teacher certification obtained through required electives. This grant program is modeled after the UTeach program at the University of Texas at Austin. The "Next Frontier" report cited the innovative UTeach program as a model for improving STEM education. Nationwide, only 50 percent of new teachers are still teaching after three years, while 80 percent of UTeach graduates are still teaching after five years. UTeach is now being replicated as a national standard for science and math teacher preparation by the National Math and Science Initiative.

Through TAMEST, our state's brightest science and math academics have created a bold plan to address one of the greatest challenges facing our country. Now it is our responsibility - as citizens and legislators - to act on their proposals and renew our commitment to a better and more prosperous future.

Editorial Thoughts

San Antonio Express-News on flying shoes:

The flying shoes will go down in presidential lore.

President Bush, in the crosshairs of two leather missiles, ducked both during a recent press conference in Baghdad.

Condemned by many, both here and abroad, for his foreign policy, the president was widely applauded for his grace and agility.

The bizarre incident led to an outpouring of satirical skits on the comedy and late-night shows up and down the cable dial, but Iraqi officials saw nothing funny in the spectacle.

During a recent session in the Parliament to discuss the withdrawal of U.S. troops from Iraq, legislators interrupted the

debate to focus on the fate of the journalist who hurled the shoes at the president, Muntadhar al-Zeidi.

The session became so turbulent, the Associated Press reported, that the speaker announced his resignation.

Much of the controversy centers on reports, so far unconfirmed, that the journalist was beaten by members of the security detail assigned to Prime Minister Nouri Kamal al-Maliki, who was present during the press conference.

The speaker, Mahmoud al-Mashadani, raised questions about the detention of the journalist.

"... We also must condemn the fact that he was beaten," he said, according to the New York

Times.

The incident, so comical to some Americans, is generating a furor in Iraq.

After the assault, President Bush remained calm and collected, an attitude that must now be duplicated by Iraqi officials.

The controversy has polarized the Parliament, with some members supporting the journalist and others pushing for harsh

punishment.

What seemed comical before has suddenly become serious, and the fledgling democracy will face a crucial test that it must handle with a deft hand, exercising its legal authority without overstepping it.

The last thing the Parliament needs is to turn the journalist into an even more potent symbol than he already is.

There was no shortage of other authors throughout the summer in the panhandle.

Pampa native Jerry Heasley, who came out last year with a coffee table book on Corvettes, came out this year with another on Mustangs.

Pam Martin Kanaly, who grew up in Pampa, is the author of a Christian book titled "Will the Real Me Please Stand Up."

T.R. Oatman, who works at Pantex and lives in Pampa, had a book signing at Hastings on July 5, for the release of his second book, "River Rose."

By August, Bud Wyatt would have a publisher's contract in hand for his novel, "Lee's Valley," the story of a frontiersman journey through the Texas Panhandle and Rocky Mountains.

At the county level, Gray County Clerk Susan Winbourne's office began accepting debit and credit cards in payment for birth and marriage certificates.

The Gray County Commissioner's Court began looking at combining voting precinct three with voting precinct seven. When Elections Administrator Linda Lewis presented the slate of election judges, alternates and workers to the commission at their July 1 meeting, no one was listed for voting precinct three. Lewis said that the precinct had not had election officers for the last five elections. In the most recent election, May 10, only vote had been cast at the Grandview-Hopkins School, the precinct's polling place.

The Pampa Regional Medical Center established a scholarship honoring Dr. Vijay K. Mohan, who has practiced medicine in Pampa since 1978. The first scholarship will be awarded in the spring of 2009.

Former Pampa Police Chief Trevlyn Pitner, who had been named interim city manager with the retirement of John Horst in April, was officially appointed city manager in July.

Pitner told the commission that there was a growing need to expand the city's infrastructure and added expense in maintaining the long ignored existing infrastructure.

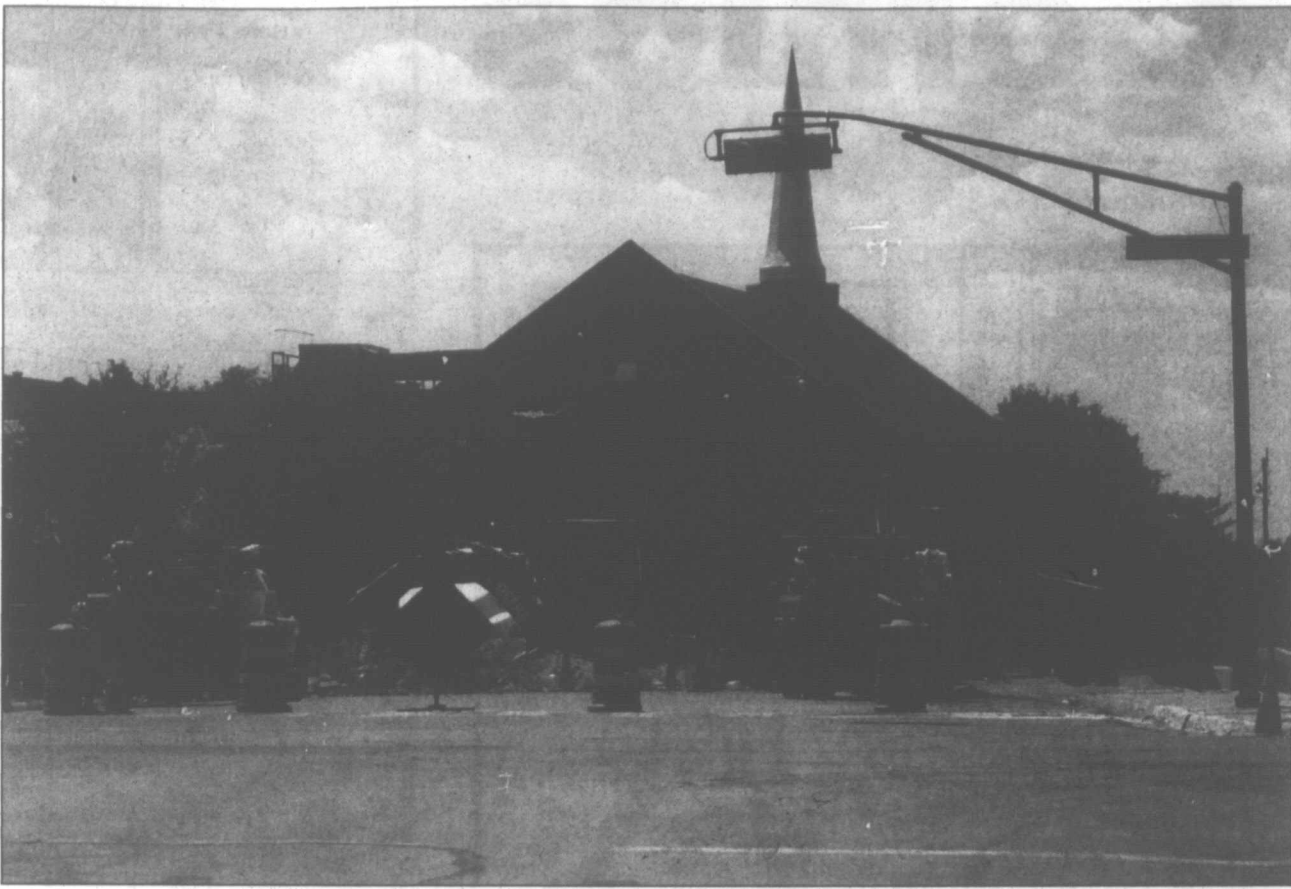
By the end of the month, the city commission wasn't so nice.

He was building a dozen houses on Crane Street with a price tag of about \$160,000.

I'm worried his behavior will get worse. Other neigh-

bors have seen him abuse his dog and other animals. His parents never watch him. What do we do? I'm worried about my children's safety. — **AFRAID IN WISCONSIN**

DEAR AFRAID: You have described a child who is emotionally disturbed and parents who are in denial. Because the neighbors have seen him abuse animals, a report should be made to the police and the department of animal welfare in your community. This boy has no empathy for others and needs professional help. Until he gets it, you are wise to be concerned about your children. Keep a watchful eye.

DEAR ABBY: I lost my father a few months ago after his long battle with cancer. We were very close, and I miss him terribly. My ex-husband and I are not on good terms, despite the fact

that we have children together. He asked our kids -- not me -- if it was OK if he attended the funeral. I told them I didn't want him there. I just wanted to grieve in peace. A few minutes after Dad's funeral service began, my ex walked in the back door. My sister knew he had been asked not to attend, so she asked him to please leave. I am so disgusted. My former in-laws, whom I didn't get along with either, sent flowers. I would have preferred they keep their flowers -- but at least they didn't show up. My children are now mad at me because their father was asked to leave. I just wanted to be left alone. I don't understand why this was so hard for everyone to understand. It was my father, not his, and I just wanted to grieve in peace. — **MOURNING FOR MY DAD IN MISSOURI**

Please accept my condolences for the loss of your father. Your children may have wanted their father there because they were grieving the loss of their grandfather. According to Emily Post: "If there was ill feeling between the ex-spouse and the deceased," and I assume your father felt about your ex as you do, "the ex should not attend the funeral; instead, he (or she) sends flowers and a sympathy note." However, your wishes should not have been ignored. The new year has begun, and the less baggage you carry into it, the better off you will be. Please try to forgive your ex for his insensitivity and get on with your life. If you can manage that, it will be less painful for you and your children. If you can't, then counseling may help you to let go of some of your anger, and I recommend it.

Plane accidentally starts with girl, 6, inside

PALESTINE, Texas (AP) — Federal investigators will look into an accident involving a small plane at an East Texas airfield that injured a 6-year-old girl.

Palestine fire officials say the girl was alone in the 1966 Cessna 150 when her 81-year-old grandfather, Virgil Fielden of Fairfield, manually started the engine of the two-seat plane about 4:15 p.m. Sunday.

Palestine fire Capt. Kyle Betterton says the plane began rolling unexpectedly and crashed into some nearby woods, but never left the grounds of Palestine Municipal Airport. Betterton says the girl wasn't seriously injured but airlifted to Children's Medical Center at Dallas as a precaution.

Fielden was treated for minor injuries at a Palestine hospital and discharged. Palestine is about 100 miles southeast of Dallas.


