Coyotes Host Scrimmage Meet the Coyotes followed Great-grandson of founder is

The Borden County Coyote football team hosted its first scrimmage of the year last Saturday evening. Klondike and New Home were the other teams participating in the scrimmage. The Coyotes looked a little frustrated during their first 15 plays against New Home scoring only once, from 13 yards out. Garrett Thomas carried the ball over for the TD. The touchdown came on the 11th play of the drive and it was set up by Andrew Lamming catching a 46-yard pass from Pinkerton. Coyotes moved the ball well but because of early season mistakes only found the end zone one time during this set.

When the Coyotes had the ball against Klondike there were 5 touchdowns scored in 15 plays. On the first play of this offensive set Thomas carried the ball 60 yards for a TD. Thomas scored the next TD from 32-yards out. Then Brad Tatum caught a pass from Pinkerton for a 60-yard touchdown for the next score, and on the next play Michael Bullinger scored on a 60-yard pass reception. For the fifth TD of this set Pinkerton hit Bullinger on a 25-yard bootleg pass for a score.

Center Trey Soto caught 4 passes for good yardage and

quar'er back Clint Chapman did a good job executing plays offensively.

To end the scrimmage New Home wanted to go 10 plays against the Coyotes again. In this scrimmage, the Coyotes moved the ball well and capped off a 7 play drive with a touchdown from 6-yards out by Tatum. The Leopards of New Home did not get in the end zone on their 10 plays and they did not have much success moving the ball against the Coyote defense.

The Coyote defense did have a good night allowing only one touchdown scored against us in 40 plays ran. Key defensive players were Soto, Lamming, Tatum, Bullinger, Thomas, Chapman and Pinkerton.

The JV also did a good job on both sides of the ball. Defensively they looked better than they offensively but that will improve as they get more Booklet time in practice on the offensive side of the ball.

The Coyotes travel to Asperment this Friday for their second scrimmage. It will start at 6:00p.m. and Bryson and Motley County will also be there.

Letter to the Parents

All Parents From: Borden County ISD Date: August 17, 2005

Subject: Notification to Parents of Teacher Qualifications

As a parent of a student at Borden County ISD, you have the right to know the professional qualifications of the classroom teachers who instruct your child, and Federal law requires the school district to provide you this information in a timely manner if you request it. Specifically, you have the right to request the following information about each of your child's classroom teachers:

- Whether the teacher meets the state qualifications and licensing criteria for the grades and subjects he or she
- Whether the teacher is teaching under emergency or provisional status because of special circumstances.
- The teacher's college major, whether the teacher has any advanced degrees, and the field of discipline of the certification or degree.
- Whether paraprofessionals provide services to your child and, if so their qualifications.

Teachers Should Save Receipts for **Educator Expense Deduction**

WASHINGTON - With back-to-school sales in full swing, the Internal Revenue Service reminds teachers and other educators to save their receipts for purchases of and classroom books supplies. These out-of-pocket expenses may lower their 2005 taxes.

The deduction is available to eligible educators in public or private elementary or secondary schools. To be eligible, a person must work at least 900 hours during a school year as a teacher, instructor, counselor, principal or aide.

Educators may subtract up to \$250 of qualified expenses when figuring their adjusted gross income (AGI) for 2005. This deduction is available whether or not the taxpayer

deductions itemizes Schedule A.

The IRS suggests that educators keep records of qualifying expenses in a folder or envelope with a label such as, "Educator Expense Deduction," noting the date, amount and purpose of each purchase. This will help prevent a missed deduction at tax time.

Under current law, this deduction is scheduled to expire at the end of 2005. In tax year 2003, the most recent year for which figures available, educator expense deductions totaling almost \$814 million were claimed on nearly 3.3 million individual income tax returns.

Germany Journal

Part Two

This is the second part of my Germany journal. For those who don't remember or who are just now beginning to read, I am at Base Camp (preparation for ministry) at this point. All of the students are supposedly in a country called iGosia, where the currency is the iGo, the strange people are iGosians, and anything can happen. Everything is designed to prepare us for whatever we encounter overseas.

July 21

This morning we woke up at about eight. They didn't tell anyone where the Market (where we were supposed to buy breakfast) was last night, and said we would have to find it! We were supposed to be there at 8:30, but my roommates and I didn't even leave the dorm until then. It was a lucky thing, too, because we got to follow some iGosians to the place and didn't have to look for it ourselves. I got there broke. I was watching people eat cucumbers, oranges, and other things that didn't look very filling...I asked some about it and they said that "it was all they could afford". My prospects for breakfast looked very bleak indeed.

This really nice however, gave me 20 iGos (iGosian currency) because he had been smart in Customs and was still loaded. However, it turned out that I didn't need them that badly.

The iGosians came in many forms this morning: beggars, pickpockets, salespeople, and police officers. I was wandering around, trying to

figure out what I wanted to buy, when a lady came up and stole my envelope which had my passport in it. I gave up getting it back after chasing her for a minute. I then went to a booth and they'd said they'd give me two powdered donuts and a cucumber for eating a sardine. I did it. I'm a sucker for powdered donuts.

Well, I was then very thirsty,

so I haggled until I got a Coke for fifteen iGos. Then I tried again to get my envelope back from the girl who had taken it. She told me she would give it back if I rounded up a group of people to sing "I'm A Little Teapot" opera-style while doing the hula. However, she went back on her word and we all just ended up looking dumb. My friend Bryan ran up behind her, tried to get my passport, and got arrested for assaulting a woman. I said, "I made him do it. Don't arrest him, arrest me." Then I joked, "I'll hit you with a cucumber if I don't get my passport back!" So I got arrested too for my threat. When we got to jail, Lindsey was in there too for not having her passport (which had been stolen, as she'd tried to tell them). A group came up and sang "I Feel Pretty" to get Bryan out of jail. They let Lindsey out and while the jailer was distracted I just walked off. I found that two guys in my group trek had gotten back my passport for me! Everyone was starting to bond.

After breakfast we split up into pairs and prayer walked around the campus. We then had worship and a lesson.

God is really challenging me big-time with these lessons. He deserves to have His name shouted at the top of my lungs - anything less is Whatever is in robbery. store, God has been preparing me for it through events this year. The same goes for the people I will talk to or affect in some other way.

We then split up into games. My Silver group went to the Cave Game. We were blindfolded and told to follow the rope they placed our hands on. A leader said repeatedly, "Listen carefully. Hold on to the rope with your right hand at all times. Do not let go of the rope. There is one way in and one way out. We will let you know when you have found the way out. If you need help, raise your hand." I followed the rope around and around. Finally, frustrated, I raised my hand. The blindfold was taken off. I had found the way out. The point was that in Germany we didn't need to rely on ourselves, but ask each other for assistance.

Then we went to eat lunch. Of course there was a trick. A girl in my group named Jordan and I had to tie our hands together like this: my right to her left, her right to my left. We had to not only make sandwiches that way, but eat them still tied together! Our Dr. Pepper was warm too because we had to get used to having no ice in our drinks because Germans don't use ice. Actually, if you ask for ice there they'll give you ice cream, because their word for ice cream is "eis".

Just now my silver group had house church, which is any body of believers gathering together without a sanctuary. I was dealing with a temptation, and just then my group "dad", named Junior, said we should journal for ten minutes and just let out our thoughts, because he could feel that there were some things we didn't need/want to share. It was so cool. Lord, please help me deal with temptation and find joy in You in my frustration. Help me think no bad thoughts about any team members, and keep Satan out of my heart. I how BIG you are.

Then we played two other games and ate pizza (thankfully without any members shared about how she wasn't feeling like God was listening in her quiet time. As we were discussing God always listens even when we don't feel like it, we all fell silent. We suddenly the bells outside. We all just smiled and praised God, it was just so cool.

We just had worship and a lesson again. It was the most amazing worship I have ever experienced. God was right there with us. When we were singing a song, one of my good friends stood up and started reading Scripture in the middle of it, shouting praise to God. It was so powerful. Then I started realizing I was distracted, and I felt horrible. One thing led to another, and before long I was beating myself up about how God could show himself to me and I was still distracted by other things. I also felt like I wasn't loving enough, and that I needed to be a more loving person. So I felt even worse by the end of worship.

Then as we were going back to our group tables, one of my friends just came up and hugged me out of nowhere. It was the sweetest gesture ever, and it was like he knew that was exactly what I needed. We then had communion at our group tables, and by then I was tearing up. As we took communion, our trek "mom" and "dad" laid their hands on each one of us in turn and prayed aloud for us. All the

other tables were doing the same thing. At this point I was still thinking how unloving I was compared to all these wonderful people. My "mom" then came up and love you and praise you for laid her hands on my shoulders and said, "Lord, I feel compelled right now to pray that Becky will realize that you love her just the way she is, and she doesn't need tricks) and had house church to compare herself to others. One of our team Help her realize what a caring person she is and that You love her like Your other children." Okay, I just lost it. I started crying. Anyway, it and trying to tell her that this same thing happened three other times! I would be thinking about something and someone would come up and realized that "Great Is Thy pray behind me about the Faithfulness" was playing on very thing I was thinking about. It was so crazy, and so awesome. Also I prayed that something would happen for one of my friends and that very night it did. It had taken four years, but it did. And as I was sitting there, I suddenly realized the room had gotten louder. I looked up and saw that everyone was shouting their prayers, and all these prayers were being said at once out loud in unison. A lot of groups had stood up and linked arms around their tables. It wasn't planned, it wasn't rehearsed. But in those moments I could hear over a hundred saints' voices all at once. It was such a blessing. Then all of a sudden it hushed, and everyone at the same time started singing "Sanctuary" all together. In this hour, I saw what the Body of Christ is, what it is supposed to be like. Everyone was so tuned into God that He couldn't help but feel welcome. Tonight, God showed me real love. His love for us, our love for each other, our love for the lost. It was all combined and I got to experience all three tonight in worship. He gave us His very presence, the greatest thing we could ever ask for. Tons of prayers were answered because they were



This notice concerns Borden County property tax rates for 2005.

It presents information about three tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes last year. This year's effective tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's rollback tax rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollback procedures.
