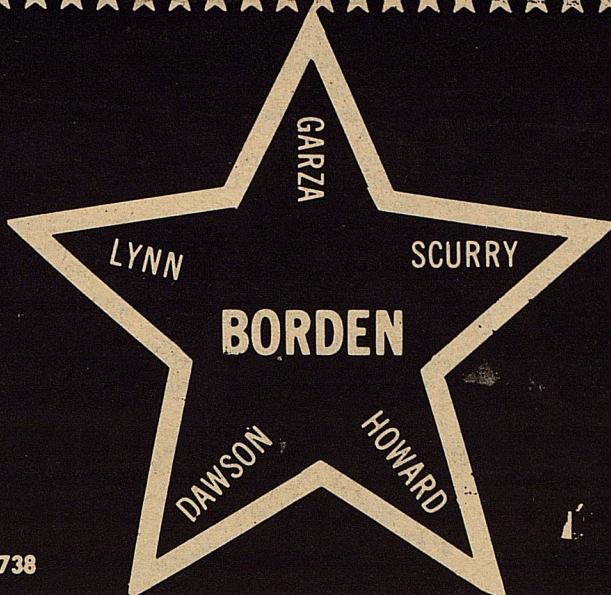

## Building Proposal Passes

The Board of Trustees of the Borden County Independent School District convened in Special session on August 14, 1976 for the purpose of canvassing the votes concerning the School Bond Election held on August 14.

Voters overwhelmingly passed the proposed school improvement program 3 to 1 at the polls Saturday, August 14.

Bonds will be sold and work will begin on the 1 million dollar structure as soon as possible.

The Maintenance Tax proposal carried by 182 for to 69 against. The issuance of bond proposal carried by 184 for and 6 against.

## Resolution Canvassing Returns And Declaring Result Of Election

THE STATE OF TEXAS  
COUNTIES OF BORDEN  
AND HOWARD

WHEREAS, this Board of Trustees resolved and ordered that an election be held within this District on the 14th day of August, 1976, for the purpose of submitting certain propositions to establish a maintenance tax and issue bonds under the provisions of Chapter 20 of the Texas Education Code to the resident qualified electors of the District; and

WHEREAS, it is hereby found and determined that said election was held in accordance with the authorizing proceedings, that notice of the election was duly given in the form, manner and time required by law, and that said election was in all respects legally held and conducted in accordance with the laws of the State of Texas applicable thereto; and

WHEREAS, the returns of said election have been made to this Board of Trustees and said returns, duly and legally made, show the following votes were cast on the propositions submitted at said election, to wit:

PROPOSITION NUMBER 1  
Maintenance Tax  
"For" 182 votes  
"Against" 69 votes  
Total Votes Cast 251 votes

PROPOSITION NUMBER 2  
"For" 184 votes  
"Against" 67 votes  
Total Votes Cast 251 votes

THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF BORDEN COUNTY INDEPENDENT

SCHOOL DISTRICT:

SECTION 1: That all of the recitals contained in the preamble of this resolution are found to be true and are adopted as findings of fact by this Board and as part of its judgment.

SECTION 2; That it is further found and determined that the results of the election as canvassed and tabulated in the preamble hereof properly represents the desires of those persons voting at said election.

SECTION 3: That a majority of the resident qualified electors voting at said election having voted in favor of the propositions numbered 1 and 2, the Board of Trustees of said District is authorized and empowered to establish a maintenance tax and issue the bonds on behalf of said District in the amount and for the purpose mentioned in the propositions, as set forth in the proceedings calling the election.

## School Board Meeting

A regular School Board Meeting was held in the Borden County Independent School District on Monday, August 16, 1976 at 8:00 p.m. After routine business of minutes and bills, bids were opened as follows for the 1976-Ford LTD school car:

Mickey Mcmeans \$4100.00  
Don Cox 3928.00

The bid from Mickey McMeans of \$4100.00 was accepted by the Board.

The Board accepted the bid on milk for the Lunchroom from the Gandy Dairies at 11 1/2¢ for white milk, 12¢ combination, and 12 1/2¢ for chocolate.

The Board issued invitations to bid on gasoline, butane, an automobile, and water line from the city tank.

A year-to-date financial report was given by the Superintendent and the budget amended for the 1976-1977 year.

The bus routes for the 1976-1977 school year were approved by the Board.

Superintendent McLeroy reviewed with the Board the schedule of classes for the coming school year.

Mr. Jack Hataway was hired as math teacher and coach, and Mr. Fred Ridenour (formally of Fluvanna) was hired as Elementary and Junior High teacher.

The following report was given by the Superintendent on the annexation meeting:

The Borden County Commissioners Court met with the Scurry County School Board on Monday, August 16, 1976 for the purpose of annexing the Fluvanna School District with Borden and Scurry County School Districts. The election held by Fluvanna and Borden County on Saturday, August 14 passed in Borden County but failed in Fluvanna so plans for annexation were immediately underway.

The following resolution was approved unanimously at the meeting on August 16.:

Be it resolved as of August 16, 1976, the Fluvanna School District shall be annexed to the Borden County and Snyder Independent School districts. All of the former Fluvanna District properties lying in Borden County will be annexed to the Borden County School District. All former Fluvanna School District properties lying in Scurry County will be annexed to the Snyder School District.

The indebtedness and cash assets of the Fluvanna School District will be divided proportionally to the taxable evaluations as of this date as determined by these joint boards-10,3, Borden County and 89.7, Snyder.

Fluvanna School physical properties and school records shall become the property of the Snyder School District, excluding 6 teacherages. Snyder will have first choice on teacherages, the custodians home, Borden County will have second choice, Snyder, third choice, and Borden County, the remainder. Individual school records will be made available to the Borden County Schools as needed.

Teacher contracts (Mrs. Mills and Mrs. Rundell) become the responsibilities of the Snyder School District and Mr. Ridenour's shall become the property of Borden County Schools. Pupils shall attend the school in the district where they reside after annexation. Transfer procedures shall be followed in accord with the policies of the Texas Education Agency which has extended the deadline to accommodate circumstances relating to this annexation. Students wishing to transfer from either district should contact the Superintendent of the re-

ceiving district to receive further information.

The resolution was signed by Jim Burkett, County Judge of Borden County and Marvin Hanson, President of Scurry County School Board.

Permission was given by The Board to apply for membership to an organization called Texas for Equitable Taxation in support of favorable tax legislation for West Texas.

There being no further business, the meeting was adjourned.

Borden County teachers are involved in in-service training this week. Monday, and Tuesday August 16 and 17 were involved with Individualized Instruction under direction of three consultants from Texas Tech University. Consultants were Dr. Bill Askins, Dr. Gerald Skoog, and Dr. Shamus Mehaffie. Wednesday, Thursday, and Friday, teachers will be preparing for the beginning of school. Classes will get underway August 23, at 8:20 a.m.

Students will begin registration on Friday. Seniors will register from 9:00 to 10:30 Juniors, from 10:30-12:00; Sophomores, from 1:00 to 2:30; Freshmen from 2:30-4:00.

### CINNAMON SURPRISE BUNS

- |                            |                        |
|----------------------------|------------------------|
| 1 pkg. dry yeast           | 2 eggs, beaten         |
| 1/4 cup warm water         | 1/2 tsp. vanilla       |
| 1 cup milk, scalded        | 24 large marshmallows  |
| 1/4 cup sugar              | 1/2 cup chopped pecans |
| 1/4 cup butter             | 1/4 cup melted butter  |
| 1 tsp. salt                | 1/2 cup sugar          |
| 3-4 cups all-purpose flour | 1-1/2 tsp. cinnamon    |

Dissolve yeast in warm water. Add milk, 1/4 cup sugar, butter, salt, eggs, vanilla and 1-1/2 cups flour. Mix well. Add enough of remaining flour to make a soft dough. Turn out onto floured surface and knead about five minutes. Place dough in oiled bowl; cover and let rise until double in bulk, about one hour. Punch down dough; place on floured surface and roll out 1/4-inch thick. Cut into 4-inch circles. Combine 1/2 cup sugar, cinnamon and pecans. Dip marshmallows into 1/4 cup melted butter, then into sugar mixture. Place marshmallow in center of each circle of dough. Wrap dough around marshmallow, pinching together securely at bottom. Dip top of roll into butter and then into sugar mixture. Place in greased muffin tins, cover and let rise until doubled. Bake at 350 degrees for 20 minutes or until lightly browned. The marshmallow will melt, leaving the center of the bun hollow and coated with syrup. Yield: approximately 24 buns.

# Kiker's Kolumn

Screwworms have mounted a siege on the Lone Star State this spring and summer, and the coming months hold little promise for relief.

Virtually all of Texas is now subject to the menacing flesh-eating livestock pest, points out Earnest Kiker, county agent for the Texas Agricultural Extension Service.

Recent cases in Montague county in North Texas and in Baylor, Cottle, Kent and Motley counties in the Rolling Plains mean that screwworms are now within striking distance of all livestock in the state. Therefore, it's vital that producers check their livestock regularly, spray for flies, treat any wounds, and send any worms found in wounds to the Mission Lab for identification emphasizes Kiker.

If the worms are identified as larvae of the screwworm fly, then action will immediately be taken to bombard the area where the case was reported with sterile flies reared at the Mission Lab. Sterile flies will breed with wild screwworm flies, rendering any eggs that they may lay as sterile. Thus the eggs won't hatch. Of course, the screwworm fly dies after mating, so the mating process with the sterile flies breaks the reproductive cycle of the screwworm.

Texas screwworm cases in June totaled 2,306 and were double those recorded in June of 1975, points out Kiker. That makes this June the third worst on record since the screwworm eradication program got under way in 1962. Through July 28 a total of 6,398 screwworm cases have been confirmed in Texas this year.

With the recent wet weather in South Texas, a letup in the screwworm siege is not likely. And, traditionally, screwworm cases have been high during the fall months. So, the outlook isn't good, surmises Kiker.

However, a new effort that may eventually keep the screwworm out of Texas will be kicked off in late August when the first screwworm eradication program begins in Mexico. That's when the first consignment of flies from the new insectary at Tuxtla Gutierrez is scheduled for delivery to Baja, California.

# Tejas 1876

FORT WORTH—Today is Sunday and the farmer, the mechanic, the editor, the merchant, the artisan, the teacher, the barber, the tailor and the lawyer can rest—but the saloon keeper has to work all day, the same as if it was not Sunday. Ought not some law be passed for their protection?

FORT WORTH—our city prisoners are furnished two good square meals per day at about 13 cents apiece per meal.

SAN ANTONIO—Ladies now hang their fans by a two-inch wide cardinal ribbon, caught at the waist on the left side. The bright color of the ribbon, with a flashy fan, form a pretty contrast with both light and dark dresses.

SAN ANTONIO - Col. Shafter, commanding a scouting party on the Staked Plains, reports finding an Indian camp recently abandoned. Shafter says the camp was destroyed and the Indians escaped with only the horses they rode. He regrets that no Indians were killed.

GRIFFIN—The buffalo trade is somewhat depressed, although there are more hunters than at any former period. The hides are now being poisoned on the range, and but few will be brought in before October. It is thought that fully 100,000 hides will be shipped from this point next season. But a few years will suffice to exterminate the buffalo, and thus prevent the Indians from living in a savage state to depredate on the frontier.

GALVESTON—The heated term of weather seems to have increased the potency of the reign of King Alcohol, and likewise the pugilistic qualities of his subjects. The slightest provocation is the signal for a resort to blows, and six arrests were made by the police from 3 pm to midnight on a charge of fighting.

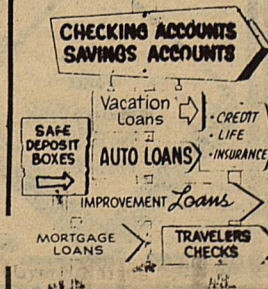
