Borden County Swimming Pool

The school board of Borden County I.S.D. proposes to build a swimming pool near the new school plant. The proposed pool would be 30 ft. X 50 ft. with concrete decking all around, diving boards, boys and girls separate dressing facilities, heater, filters and etc. The pool would be protected by a 6 ft. chain link fence.

The commissioners court of Borden County has agreed to pay the operating costs during the summer months when the public would be using the pool.

The school plans to establish a swimming instruction program for the kids, and adults of Borden County.

The preliminary cost estimate for the pool is \$81,950.00, but the school board set aside .03 cents per \$100 valuation in 1979-80 for swimming pool construction, therefore no increase in this year's tax rate over last year will be necessary to provide sufficient funds to complete the project. In fact, the tax rate for the Borden County I.S.D. was cut a total of .6 cents per one hundred dollar value for 1980.

The school board and commissioners would like to have opinions from the citizens of Borden County on the swimming pool project.

Drive 55 Over Labor Day

Texas Safety Association's vice president for traffic, James R. Halverson, today urged motorists to drive 55 over the Labor Day weekend, August 29 - September 1, because "driving unhurried most often means arriving unhurt."

"Driving 55 will improve your chances of reaching your destination safely, and you can enjoy the ride more knowing you're traveling at a safe speed," Halverson said.

Halverson noted that the chance of fatal accident at 55 mph is 1 in 33, while at 70 mph the risk is 50-50, or 1 in 2. Over the 1979 Labor Day weekend, 45 fatal accidents caused 49 deaths, according to Texas Department of Public Safety statistics.

Traveling 55 mph will also get you where you're going in a reasonable

length of time, Halverson pointed out.

"55 mph is not slow. A 100-mile trip at 65 mph takes one hour, 32 minutes. At 55, it takes one hour, 49 minutes--a cost of 17 minutes. It seems to me that a 17-minute delay that greatly increases one's chances of arriving safely is acceptable," he said.

Touching on the economic practicalities of the 55 mph speed limit, Halverson reminded drivers that it is cheaper to drive 55.

"Department of Transportation studies show that cars get 17-40 percent better gas mileage at 55 than at 70 mph. For the average car, that translates into approximately 50 more miles per tankful. Smaller, fuel efficient cars get even better fuel savings," he

explained.

Slower, safer speeds also save money in other ways besides reducing gasoline costs, Halverson continued. For instance, the New England Mutual and John Hancock insurance companies both report reduced life insurance premiums due to a significantly lower highway death rate - 40 percent lower according to the National Safety Council.

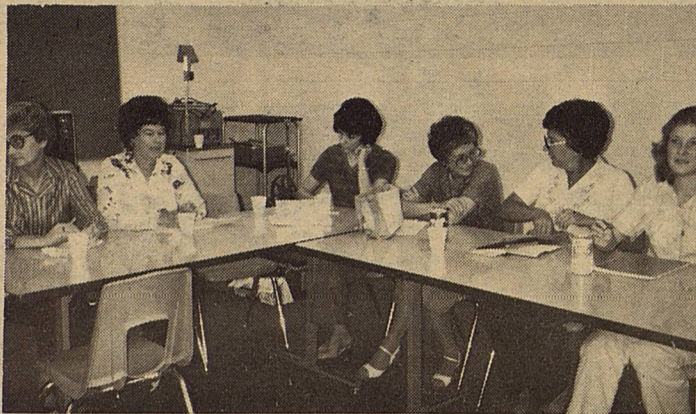
Furthermore, in Texas, the 55 mph speed limit has reduced accidents to the extent that residents save \$2 billion annually in hospitalization, loss of income and medical care, Halverson said.

"55 is the smart speed to drive over the Labor Day holiday--and everyday-- if you're interested in saving lives, gasoline and money," Halverson reiterated.

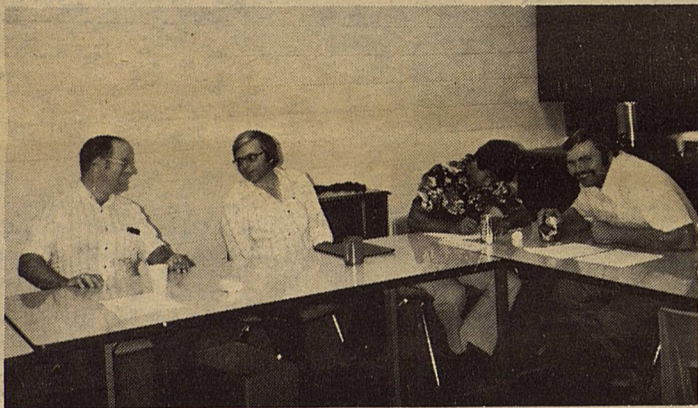

Borden County School News

School Board Meeting

The Borden County School Board met in regular session on August 25, 1980 at 8:00 p.m. Following routine business of minutes and bills, the Board opened bids on school insurance. Due to deductible clauses and dividends, Superintendent McLeroy suggested that the bids be studied more closely and reported on at the next board meeting. The Board concurred.

In compliance with the directive from the last board meeting, Jack McPhaul and Ralph Miller met with the Commissioners Court and reported their findings to the Board regarding the swimming pool. The Board tentatively approved construction of a swimming pool according to the plans from Esmond-Haner with the final vote on the issue to be taken at the regular school board meeting in September after the facts concerning this project have been published in the Borden Star for two weeks minimum, to give the citizens a chance to voice their opinions to school board members.

The tax rate was set at \$1.41 in the Local Maintenance Fund and \$.16 in the Interest and Sinking Fund. This tax rate being cut by a total of \$.06.

The Board voted to amend the budget for the 1979-1980 school year.

The Superintendent gave a year-to-date financial report.

It was reported that due to the fact that we were unable to attain a librarian, a plan was proposed to release Peggy Westbrook from several classes to supervise the library with the use of aids.

Janet Floyd was hired as a teacher aide.

The bleachers are being painted and aluminum benches are being placed on

stadium seats.

The bid was accepted from Arrtco Tennis Systems to Lay-Kold and line the two tennis courts and construct windscreens.

A motion carried to contract film service from the Education Service Center in Lubbock for the 1980-1981 school year.

It was reported by the Superintendent that the old Glenn Creek school building built in 1952 is not being used. The Board gave the Superintendent permission to check into the situation and take appropriate action.

There being no further business, the meeting was adjourned.

School Lunch Program

The Borden County School serves nutritious meals every school day. Students may buy lunch for 30 and 35 cents and breakfast for 25 cents.

Children from families whose income is at or below levels shown on the scale below are eligible for free or reduced-price meals. The reduced price for lunch is 10 cents and for breakfast 10 cents. If medical bills, shelter costs in excess of 30 percent of your income, special education expenses due to the mental or physical condition of a child, or disaster or casualty losses, your children may still be eligible.

The school children of parents or guardians who become unemployed are eligible for free or reduced-price lunches and free milk during the period

of unemployment, provided that the loss or income causes the family income during the period of unemployment to be at or below the levels shown on the scale.

To apply at any time during the year for free lunches and free milk or reduced-price meals for your children, complete the attached application and return it to the school. The information given on the application is confidential and will be used only for the purpose of determining eligibility for free lunches and milk or reduced-price lunches. Within ten days of receiving your application, the school will let you know whether or not your children are eligible. If you do not agree with the school's decision, you have a right to a fair hearing. This can be done by calling

or writing James McLeroy, Box 95, Gail, Texas 79738. The phone number is (915) 856-4262.

In certain cases foster children are eligible for these benefits. If you have foster children living with you and wish to apply for such lunches and milk for them, please notify us or indicate it on the application.

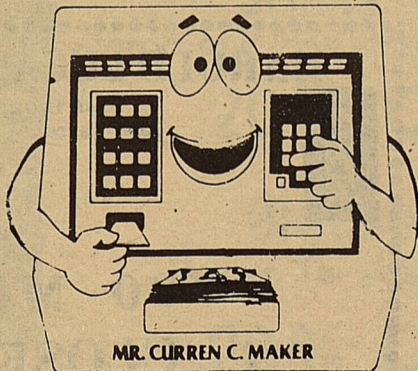
All children are treated the same regardless of ability to pay. In the operation of child feeding programs, no child will be discriminated against because of race, sex, color, or national origin.

Tech Registration To Begin

Registration for the 1980 fall semester at Texas Tech University will be August 28-29 in the Lubbock Municipal Coliseum.

Registration packets and schedules of classes have been mailed to all students enrolled at Texas Tech during the 1980 spring semester or summer session, registration officials said.

Students will register from 8 a.m. to 5 p.m. August 28 and from 8 a.m. to 6 p.m. August 29. Entering freshmen who have been admitted to the university but did not attend a pre-registration conference can pick up registration packets from 8 a.m. to 5 p.m.

August 28-29 in the Conference Room, West Hall. Packets will enable entering freshmen to register at their convenience on either of those days.

Students planning to register for the fall semester must consult their advisors and have schedule cards approved before entering the Coliseum.

Late registration will be Sept 2-7. Students registering Sept. 10-17 must have prior approval of their academic dean. Students can register on these dates through their department and the Office of this Registrar, 107 West Hall.

Continuing Education registration for students planning to enroll in six hours or less of night courses will be Aug. 22-23 and 25-26. Registration will be from noon to 8 p.m. on all of the days except Aug. 23 when registration will be from 8 a.m. to noon in Building X-15, Texas Tech Campus.

Enrollment for fall 1979 reached 23,129 students, a record. Enrollment for this fall at Texas Tech will be "about the same with no tremendous increase or decrease", said Don Wickard, registrar.

Classes begin Sept. 2.

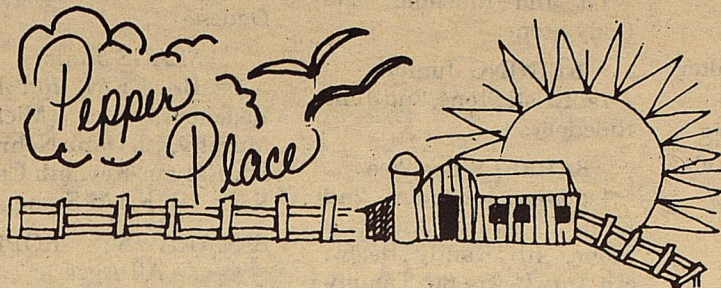

Better Business Bureau Alert

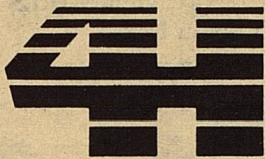
The Better Business Bureau of the South Plains has been receiving calls from South Plains residents concerning a magazine-encyclopedia sales crew representing themselves as being with NATIONAL PRESS ASSOCIATION out of Florida.

The BBB advises caution in dealing with these salespeople as it has been reported to the Bureau that they are using misleading and possibly deceptive sales practices. They are alleging that they are in a contest and they are promising some consumers that they will hold their check for so many days, but instead, are cashing the checks immediately.

If you are approached by a door-to-door solicitor, ask to see his license to peddle, if he does not have one, call the sheriff or your local police immediately. Only buy magazines or encyclopedias because you want them, not because you think you are helping the salesperson win a contest or whatever. Wait at least 90 days before delivery of magazines and REMEMBER, you have 3 business days to cancel if your order is over \$25.00. The salesperson is required by law to explain this cooling-off period to you. If

in doubt, don't buy. Don't be high-pressured, call the police or sheriff if the salesperson won't leave.

The Williamson gang is back in the South Plains. This gypsy band has caused untold misery and grief to consumers. They are in the home repair-improvement business and show no mercy to any particular consumer group. They sell roofing, paving, and siding jobs to consumers, door to door. The jobs are of poor quality and the amount charged is excessive. Be leary of anyone coming to your door and saying your "roof needs repair" or asking you if you need any work done. Always get at least three estimates before deciding to do business. If you are a victim of this gang, please call the Attorney General's office 806-747-5238, or the BBB office at 800-692-4466.

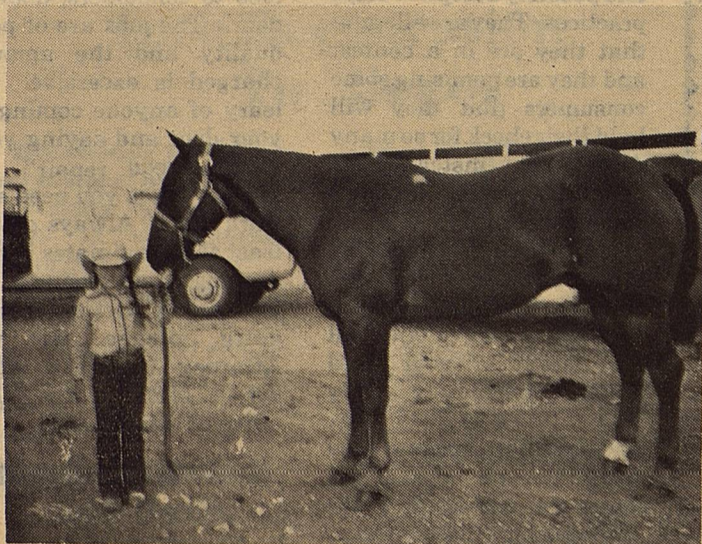

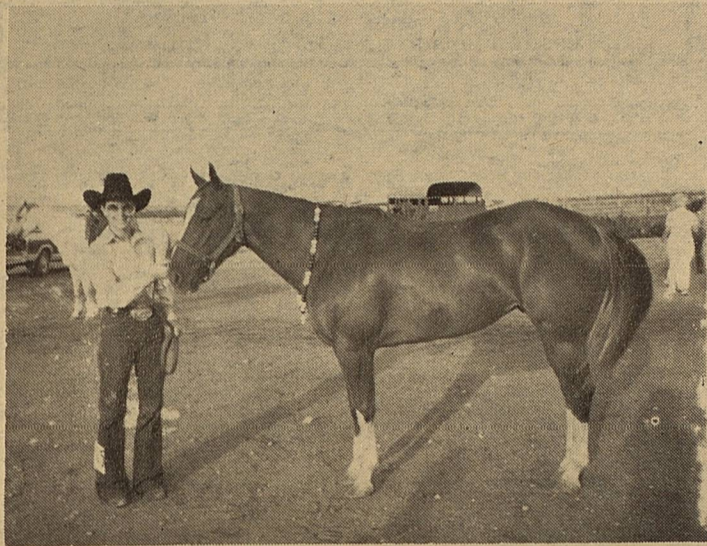

EMERGENCY FEED PROGRAM

Livestock producers who have suffered a loss of 40 percent or more in the production of livestock feed and who are presently feeding in amounts above normal may file a request for feed assistance.

Any feed purchased and still on hand on the date of application is eligible for cost-share assistance. If you are not presently feeding purchased feed, you should not file an application for feed assistance. In other words, you should file an application only when you begin buying and feeding purchased feed. Feed which you purchase and store for winter use will be eligible for cost-share assistance when you begin feeding such feed provided an eligible application is filed by that date.

Cost-share assistance is limited to the smaller of 50 percent of the actual cost of feed purchased or three cents per pound.

If you have questions concerning the Livestock Feed Program, then please contact the County Office.

FAILED ACREAGE

The hot, dry weather has taken its toll on most cotton and grain sorghum acreage in the county. Producers desiring to make other use of the crop acreage must file a form ASCS-574, Request For Disaster Credit, before making any other use of the affected acreage.

If the crop acreage is destroyed, baled, or grazed before filing a disaster application you will be ineligible for disaster payments on that commodity.

If you plan to carry your crop on to harvest and produce less than 75 percent

of your established yield for cotton and 60 percent of the established yield for feed grain, you need to file your request for low yield disaster credit within 15 days from the date harvest is complete on each farm, while evidence of the crop is still apparent.

ENERGY EFFICIENCY

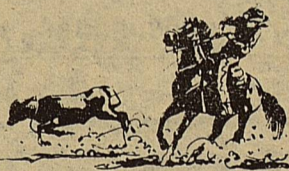

STATE CAPITAL HIGHLIGHTS

AUSTIN — Pretrial hearings in the Texas Brilab investigation opened in Houston last week, a rough-and-tumble judicial football game played in a political windstorm.

While House Speaker Bill Clayton's lawyers fight for his political life, the campaign season winds are beginning to build from a whistle to loud hum.

Clayton, along with others, faces charges of extortion, racketeering, fraud and conspiracy in connection with an alleged scheme to award a lucrative state insurance contract in exchange for campaign contributions.

Clayton's lawyers sought to have the case thrown out of federal court into a state court on jurisdictional grounds last week, and several of the "Brilab tapes" of conversations with Clayton and other key figures were played in the courtroom.

Among other revelations, the press learned that the FBI informant in the case, Joseph Hauser, was paid \$65,000 by the government for his role in the sting.

The federal judge, upon ending the pretrial hearings Friday, was expected to rule with little delay on whether the case should be dismissed on the grounds of entrapment, federal government misconduct, or artificially created federal jurisdiction.

Skeletons, Closed Doors

founded or not, as opposing political forces try to discredit one another. It is a season when rivals begin to fire their best shots.

One of the men running for Clayton's seat, should Clayton be forced to step down, is Rep. Gib Lewis of Fort Worth, who last week answered to charges he took \$500 from a lobbyist to buy gift watches for a legislative committee.

The lobbyist produced a \$500 check, which Lewis discredited, saying he paid for the watches in 1977 with his own personal check. Unable to find his personal check, Lewis later admitted the lobbyist check was probably raised by the horse-betting lobby to help raise money for the expenses of the traditional, end-of-session committee dinner.

The horse-race gambling bill in 1977 was referred by committee chairman Lewis to a subcommittee where it died.

Bullock Subpoenaed

State Comptroller Bob Bullock was subpoenaed last week to testify Sept. 3 before a Travis County grand jury probing charges his former chief deputy used state employees and equipment to conduct private business.

Bullock himself is not a target in the investigation into the activities of former Bullock top aide Ralph Wayne.

Two grand juries have already probed the allegations within the past two years, and Bullock has labeled the action a political witchhunt. He and District Attorney Ronald Earle, both former state legislators, have waged colorful, verbal media exchanges since the first investigation.

Medicaid Insurance

A New York insurance firm may launch a lawsuit if

a Texas state agency reneges, as expected, on its award of the lucrative state Medicaid insurance contract.

The 3-member state Human Resources Board was to have met Monday to reconsider previous action giving the contract to Bradford National Corp. of New York, and award it, instead, to a company owned by Dallas millionaire H. Ross Perot.

Perot's company held the contract last year but lost it last month to low-bidder Bradford. Perot then met privately with each of board members, who later agreed to reconsider the award and publicly indicated it would go to Perot's company. Perot, who gained fame with a daring rescue raid into Iran two years ago, heads the Governor's task force against drug abuse.

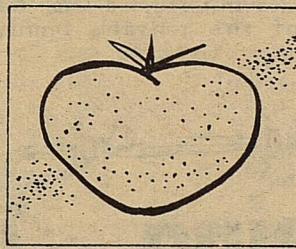
Labor Day Roping
