

Bush emphasizes less regulation

Speaking before 2,500 Texas Cattle Raisers convening in Ft Worth last week, Vice President George Bush drew the following sketch of President Reagans farm bill proposals: agriculture with few or no direct subsidies to farmers, perhaps a leftover disaster subsidy for livestock producers and more reliance on domestic and export marketplaces.

Prior to Monday's shooting tragedy and the wounding of the president Bush vowed that the administration would give Texas businessmen what they need "to put jobless Americans back to work and to stimulate industrial expansion and private investment."

What that need is, Bush told the Texas and Southwestern Cattle Raisers Association (TSCRA), is what the ranchers have been preaching for years, less government regulation, less government spending and less taxation.

Bush spoke at the noon luncheon of TSCRA's 104th annual convention in Tarrant County Convention Center. He also spoke briefly to reporters, but he had little to say about federal agricultural policies and even less to say about the issues affecting ranchers directly, other than inflation.

However, a sketchy sneak preview of the administration's 1981 farm bill proposal began to form when Bush's comments were combined with those of U.S. Rep. E. "Kika" de la Garza, D-Texas and House Agriculture Committee

chairman, and C. W. "Bill" McMillan, assistant secretary of the U. S. Department of Agriculture.

"The best thing that can happen to a young dairyman is to get this economy turned around and healthy," Bush said in response to a question about the bypass of the April 1 milk price support adjustment.

"Everybody's going to have to take some of the burden," he said.

Reagan's tightly budgeted farm bill"will not take away all of the price supports and loan levels" offered farmers in commodity programs, Bush said.

He said the administration will push for more sales of food and fiber abroad, raising the question of the Soviet grain embargo.

Bush said Reagan does not think the embargo is fair to farmers because it does not extend across all economic segments. But the question of extending or lifting the embargo cannot yet be answered and cannot be "separated out" of the nation's foreign policies toward the Soviet Union, he said.

By lifting the embargo, Bush said, Reagan would appear to "be rewarding somebody" for potentially creating an "elevated crisis situation."

Bush said Reagan's farm policy will aim to end the target price system for the nation's major crops. The target prices are used to compute direct subsidies to farmers when the marketplace fails to give Con't on P. 5

Instead, we sat mismerized, for the rest of the afternoon as did the Nation, on the turn of events and Bush's hasty return to Washington.

"It's unreal"--"I can't believe it"--"What is the answer--".

Like most of you since that time, I have read every report I could get my hands on, including synopsis of 16 editorials published across the nation.

In analyzing these editorials I found: Fourteen out of the sixteen, if not demanding strict handgun control, were simply rhetoric "---something must be done for our sick society---" The Corpus Christi Caller said "---Until we get serious about separating the potential assassins from the hardware they need ---" Well, how many gun dealers can recognize a potential assassin? OTHER U.I.L. CHANGES MADE RECENTLY

Other U.I.L. legislation recently dealt with the removal of the out-of state competition rule, to allow a student to compete as an individual or as a member of a team in an out-of-state contest in an activity offered by the League without approval of the State Executive Committee.

Effective in 1982-83. For 592 Against 43

Item number two was the creation of a committee to hear protests for district assignments. The Athletic Committee of Legislative Council will hear appeals which are received by the U.I.L. athletic director within seven days of the release date. Final appeals will go to the State Executive Committee. Effective for the 1981-82 school year. For 984 Against-70

Item number 3 Raised the major award from 32 dollars to 40 dollars and the additional symbolic award from \$4 TO \$6. Effective for the 1981-82 school year. For 971-Against -85

Item number 4 reduced loss of school time by setting 2:30 p.m. on any school day as the starting time for track meets for eighth grade and below. Effective for the 1981-82 school year. For 932-Against-118

Item number 5 began the

1982-83 basketball season two weeks later by allowing practice outside the school day to begin November 1. Teams may scrimmage once per week November 8-20. The first day for interschool games will be November 22. For 792-Against 286

Item number 6 reduced in number of basketball games to 22 in a regular season plus games played in three invitational tournaments. Effective for the 1982-83 school year. For 850-Against 211

Items Number 7 and 8 pretain to volleyball and baseball. No 9 was the adoption of alternate transfer rule already discussed.

Items 10, 11, and 12 changed the cross country, track and field, and swim plans to read: "Any student who is absent from school to attend a non-school sponsored competition shall have the meet or tournament count as one of his-her eight meets or tournaments allowed during the year. Effective for the 1981-82 school year.

Item 16 allows eighth grade and below to play a maximum of three basketball tournaments plus 14 games. This rule eliminates the one-game rule restriction, allowing greater scheduling

flexibility. Effective 1981-82. FOOTBALL

Item 17 revised the Football Plan to read: "Site and Day Game--Non-district games: Mutual agreement, District games: District schedules, unless unanimously agreeable otherwise, shall be made by a draw for a two-year period. Home team may designate the day of the game. Exception: When a school district has more than one home game per week and only one stadium, the day of the game shall be determined by a draw unless mutually agreeable otherwise. Starting time will be set by the district executive committee, unless mutually

agreeable otherwise. Item 18 revised the football plan so that, in a playoff game, unless mutually agreeable otherwise, the site for playing a playoff game shall be determined on the "home and home" basis for the past six years. The team that was the visiting team the last time the two teams met on a home field in a post-district playoff game may insist upon the game being played on its home field. The home team may designate the day for the

disagreement between two teams who have not played a post-district playoff game during the past six years, the game site shall be determined by a coin toss.

Item 19, 20, 21, and 22 revised the football, basketball, volleyball and baseball playoff structures to allow the first and second place teams in each district to advance to the state playoffs.

In football, 10 regular season games would be played in 10 weeks, rather than the current 11 weeks.

Teams that advance from the same district would meet in the quarterfinals. The state championship game would be played before Christmas.

In basketball and volleyball, teams that advance from the same district would meet in the regional tournament finals. District certification would be three to five days earlier than the present to allow for an additional playoff game in each conference.

Those items that have omitted from this article did not affect us locally.



Post would have "--the damnable firearms put out of reach of every *criminal*." That criminal shouldn't be out on the streets any way.


I was pleasantly surprised to see the New York Times print "--A gun law might only be a temporary obstacle to anyone with such demented business in mind---" That's reality.

Cattlemen Converge On Cowtown For Cattle Raisers Convention

For 104 years, cattlemen from Texas and surrounding states have made the annual trek to the Texas and Southwestern Cattle Raisers Association convention. It is a habit and as natural as spring roundup or going to the auction barn for these men and women.

This year, more than 2,500 cattlemen and their families converged on Fort Worth for the annual convention, trade show, Heritage Sale and formal dedication of the Association's new home offices Sunday, March 29, through Wednesday, April

A new administration, an uncertain economy in transition, lagging consumer demand for beef and depressed cattle market were all concerns the ranchers discussed during the meeting.

Heading the slate of nationally known speakers was U.S. Vice President George Bush, who delivered the keynote address at the kickoff luncheon Monday, March 30, in Tarrent County Convention Center.

Other speakers included C. W. "Bill" McMillan, soon to be confirmed as assistant secretary of agriculture and former vice president of government affairs in Washington for the Nation Cattlemen's Association and J. W. "Bill" Swan, NCA president from Rogerson, Idaho. Also speaking were John Huston, president of the National Livestock and Meat Board; Congressman E."Kika" de la Garza, D-Tx, chairman of the House Agriculture committee; Texas Governor William P. Clements Jr.; and Mrs. Ann Woolley, president of the National CowBelles.

Complimenting the impressive lineup of speakers was the annual trade show and Heritage Sale. The convention opened with the 150 exhibit

trade show at 1 p.m. Sunday. A welcome social hour for all convention registrants was held at 4 p.m.


The trade show got things warmed up for the star attraction of the evening the TSCRA Heritage Sale. This auction featured 15 royally bred Quarter horses, 15 registered bulls of all breeds and 15 pieces of Western art and sculpture. The sale netted \$193,000 for the cattle raisers.

Tours of the new TSCR foundation headquarters were held each day of the convention with formal dedication set for Monday afternoon. All registrants were invited to burn their brands into the walls of the training center in the headquarters. E. L. Farmer was the first to put a brand on the Borden County panel with the Rafter Cross. This was followed by Barbara Anderson branding the Muleshoe and John Ragan the J R. The Rafter F was burned on the panel also.

The new headquarters building, in which TSCRA has offices, also contains western museum, training center and research library open to the public.

Experts Say Movies Are Able To Incite Distrubed Persons

Could a movie trigger a person to attempt such a violent act as assassinating a President?

Given a person with the right, or rather wrong, type of personality, this very likely could happen, say psychiatrists and psychologists who have studied the matter. They say that in general, movies, television and publicity could be the catalysts for certain types of aggressive or mentally disturbed persons to carry out violent acts.

"Everyone watching a film tends to get involved in it at the time," says Dr. Harvey Greenberg, associate clinical professor of psychiatry ot New York's Albert Einstein college of Medicine and author of the book, "Movies on Your Mind," a psychological study of motion pictures.

For most people, Dr. Greenberg says, the involvement ends shortly after the movie is over. But for others it is longer lasting, "I've seen people who become very involved, and they're not crazy people," he says. Some people even mold their lives around the personalities of such stars as Humphrey Bogart or Bette Davis.

"For more troubled people, this involvement with the movies can merge into reality and it becomes real life," he says.

To social psychologist Leonard Berkowitz at the University of Wisconsin, any kind of publicity about violent acts can stimulate aggressive behavior, even in normal people. For a few people who already have aggressive tendencies, he suggests, the publicity, whether it be a movie or news stories, can implant violent notions.

To certain personalities, "A movie can act as an instigator or a model for certain behavior," says clinical psychologist Leonard Eron at the University of Illinois in Chicago. Prof. Eron has studied children who watch violent television programs, and has found that they have an increased tendency to violence or aggression that appears to last into at least the teen-age years.

Exactly what goes on in a person's mind to translate a movie into violent reality isn't known, Dr. Schneider says. "We psychiatrists aren't very good at predicting violence," he concedes.

To New York's Dr. Greenberg, who has just completed a study of the current genre of horror movies, the movies are more a reflection of what is going on in the society's collective mind than a cause of behavior.

"Movies are like an extreme Rorchach test," he says. "The movies pick up on our preoccupations and broadcast them back to us." For this reason, he explains, he is concerned about the new horror movies. "In the last 10 years, the horror movies have become more explicit, more traumatizing," he observes.

The speculation connecting a movie with an attempted Presidential assassination, if such is the case, if "fascinating but scary," Dr. Greenberg says.

them profitable prices. Bush said the Reagan move will bring less government intervention into the marketplace and rely more on stimulating demand abroad.

TSCRA President John Cargile told Bush and the crowd to "tell the president we are behind him 100 percent. We are willing to take our budget cuts, and we don't want to be part of the problem."

Bush was asked whether Reagan's farm billwill seek to end the one direct disaster subsity ranchers and other livestock producers qualify for when drought wrecks their pastures, grain crops or grasslands for cattle or other livestock production.

He said he did not know the details of the emergency livestock feeding program, but said he would find out.

For each of the most recent drought years, 1978 and last year, Texas livestock producers alone will have received more than \$20 million in direct payments via USDA's Agricultural and Stabilization Service. Since Oct. 1, 1980, for the fiscal year, producers nationwide have received in excess of \$120 million in the subsidy.

McMillan and Dela Garza also said they do not know what position the administration will take on all such direct subsidies.

McMillan outlined what he perceives will be general USDA policies in his duty areas. More common sense and caution will be applies in nutrition food safety directives. "The jury is still out on cholesterol, protein" and other nutrition issues, he said.

McMillan also said nobody has the answer, either on whether abandoned, rural railroad lines can be brought back into service for farmers or anyone.

REMOVING YELLOW HERBICIDE STAINS

Last week I was able to visit with a representative from one of the company that sells preplant yellow herbicides. The subject of removing stains from clothing and skin was brought up. The representative whipped out an information sheet that gave directions for removing thse stains. Here it is:

His comes in contact with clothing, light mineral oil may be used to remove most of the chemical from the cloth. Use Spray & Wash to remove the mineral oil when washing. On colored clothes, sunlight will usually bleach out any remaining stain. On white or very light clothes, it is virtually impossible to remove all the stain though it may fade in time.

To clean hands, use light mineral oil followed by a cleaner such as mechanics use to cut grease.

You might want to try and see how it works.


CHECK YOUR COTTON SEED


If you purchased your cottonseed from a dealer, there will be an official seed germination test on the label. This test is conducted on all seed that is to be or has been delinted. This test is done under fairly optimum conditions and is intended to provide a measure of percent live seed. But this test does not indicate deed vigor.

The Texas Cool Germination test is procedure used to test seed vigor. The conditions under which they are tested are much harsher and seed must germinate and produce seedlings of a prescribed length within a standard length of time. Many delinting plants are equipped to do this test as well as the Texas Department of Agriculture.


Free fatty acid level, a by-product of deterioration, should also be checked. If the seed sustained prolonged periods of wet weather on the stalk or in the module, it is possible that the free fatty acid level may exceed one percent. If this level is achieved, you should question the value of the seed.


