
KRISTI STONE CROWNED LAMESA RODEO QUEEN



Parents Club Brunch







Doing home canning this spring? Make sure your jars seal properly. Sealing failures in home canning can result from some common mistakes. Avoid making mistakes in home canning by following these suggestions:

1. Read and follow package instructions for using caps and lids. Don't take it for granted that all home canning caps are alike and are used exactly the same way

2. Leave the correct amount of head space when filling jars.

3. Take time to "knife out" air bubbles before sealing the jar.

Remove particles of 4. food, seeds or seasonings from jar top or threads with a damp cloth before putting on the lid. Particles left on jar rim can cause lid to seal, then, loosen.

5. Screwing band too tight can cause the lid to buckle. A band must be tight enough to hold the rubber sealing compound closely against the jar top.

However, if the band is forced as far as it can be turned with a strong hand, the jar cannot vent. When the jar cannot vent, pressure withing the jar causes the lid to buckle.

Therefore, tighten bands only comfortably tight to prevent buckled lids.

Always heat jars sufficiently to seal the lid. Follow recommended processing times and methods.

6. Exhaust or vent the pressure canner for a full 10 minutes, or until a stream of "blue steam" is visible, before closing the petcock.

If steam is not exhausted. there is an uneven amount of steam pressure in the cnaner. As a result, some lids may seal while others in the same canner load may not.

7. Don't let pressure in canner fluctuate. This can cause food particles to be forced between the jar and lid which will cause sealing failure.

The same thing may happen if steam is released too quickly after processing. Let pressure in the canner reach zero degrees naturally before removing cover. Do not run cold water over the canner to reduce pressure. 8. Don't reuse jars in which commercial foods are sold. These jars are designed for use on high speed packing machines and with caps developed especially for that product, but not for home canning. 9. Don't use warped, rusty, worn bands, or old commercial caps.

10. Don't reuse lids. The lid of a two-piece metal cap should not be used more than once. This applies to all brands

The compound is not guaranteed to seal a second time and the lid itself is often bent or warped when removed the first time. Also the sealing compound may harden and not soften sufficiently to obtain a good seal.

It is preferable to use jar lids the same year as purchased.

When kept longer, they often stick together and must be heated in boiling water to separate them.

If jars do not seal, you may reheat and process over again.

However, the product will be over-cooked and lose food value, flavor and texture.

You may keep a few jars in the refrigerator and use them within a short time instead of reprocessing.

This team lacked only 13 targets from winning the 5-man sub-junior trap competition. Kate Porter also competed in sub-junior trap. David and Lance teamed up in skeet and placed 1st in 2-man skeet. Patrick and Armando placed 5th in 2-man skeet.

David also ended up 6th high overall in the shoot with a score of 88 out of a possible 100 targets. Due to his fine shooting, he was named to the Winchester-Western

All-State Trap Team and received a very handsome plaque and cap for his efforts.







USDA REOPENS AND REVISES UPLAND PURCHASE COTTON **PROGRAM:**

Beginning Aug. 8, the U.S. Department of Agriculture will offer to acquire 1980, 1981, and 1982-crop upland cotton from farmers who have cotton pledged as collateral for outstanding Commodity **Credit Corporation price** support loans.

The new purchase program, which is authorized by recent legislation, will allow CCC to acquire cotton to fulfill obligations under the payment-in-kind program.

Farmers with cotton pledged as collateral for a CCC-loan may submit offers to sell their cotton to CCC Aug. 8-24 at the county office of USDA's Agricultural Stabilization and Conservation Service where the loan was obtained. The offer must specify the quantity of cotton the farmer offers to sell to CCC and the number of bales of cotton CCC must pay the farmer as in-kind compensation.

Offers to sell cotton to CCC may be submitted without regard to any maximum bid percentage of the total quantity of cotton offered for sale to CCC. CCC will accept all zero bids.

The factors in determining bid acceptance include the date the bid was offered, the bid percentage, the crop year of cotton offered 1981 and (1980, 1982-crop cotton will be reviewed and evaluated separately) and the quantities needed to satisfy **PIK** obligations.

Producers who have previously submitted bids to sell 1982-crop cotton to CCC which were accepted

under the previous cotton purchase program may submit a new bid. The new bid will nullify the previous bid.

The previously announced requirement that some producers obtain loans on their 1983 crop cotton production has been suspended. However, if a sufficient quantity of cotton is not acquired under this cotton purchase program to satisfy PIK obligations, producers may be required to obtain a loan on their 1983 crop production for **PIK purposes.**

The suspension of the "harvest for PIK" requirement combined with the new purchase program will delay the Pik availability for some producers, since CCC cannot determine how much cotton will be available until after the bids have been evaluated. The processing of the purchased cotton into CCC inventory will also result in some delay. These delays should not affect producers with whole base bids or producers with sufficient cotton to satisfy PIK from loans.
