

Now is the time to begin to plan any landscaping. Trees and shrubs should best be planted in December or January. Before they are put out, the ground should be made ready and exact plans should be made. It is a good idea to get plants and trees on order. Every year some people are unable to do what they would like to do because they have not previously booked the trees and plants they need. As soon as trees go dormant they should be planted. They will be ahead of those planted in March or April. The same is true of shrubs.

BIZZELL-MEYER WED


The wedding of Miss Cecilia Bizzell and August Meyer really happened August 15, 1976 by Rev. Joe Townsend at the Flower Shoppe.

TELEPHONE RATES

The City was notified by the Texas Municipal League today that on Sept. 1, 1976 the Public Utility Commission will assume rate making over all Telephone Co. in Texas. as of that date, Municipal jurisdiction over rates charged by Telephone Co. will be completely terminated.

It is anticipated that immediately after September 1st, Southwestern Bell and other Companies will file applications with PUC to raise the rates of virtually every telephone used within their system.

The Texas Public Utility Commission has adopted new procedual rules which will severely limit Municipal participation and may preclude any City participation whatsoever in telephone rate cases handled by the commission. Objections and compromise proposals of TML and others were rejected.

CP&L TO ASK RATE RAISE

Central Power & Light Co. has asked to be placed on the Agenda for the regular meeting of the City Council on the 13th of Sept. in order to request a rate increase.

The increase data and information has been handed the City for their study.

Although the City can refuse to grant the rate increase, it would only be for a period of 90 days at which time the City would have to appear before the Utility Commission to show cause why the request was not granted.
