### AREA DOGS WIN TROPIES

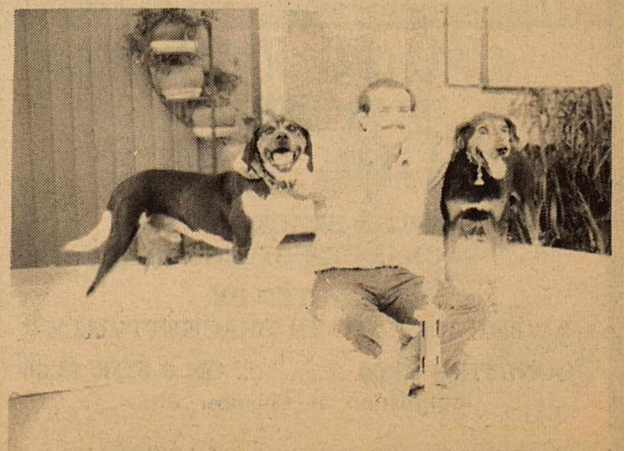

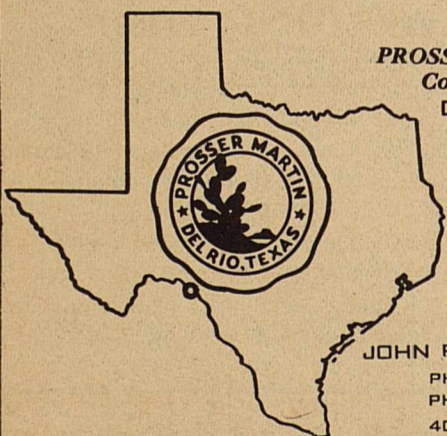

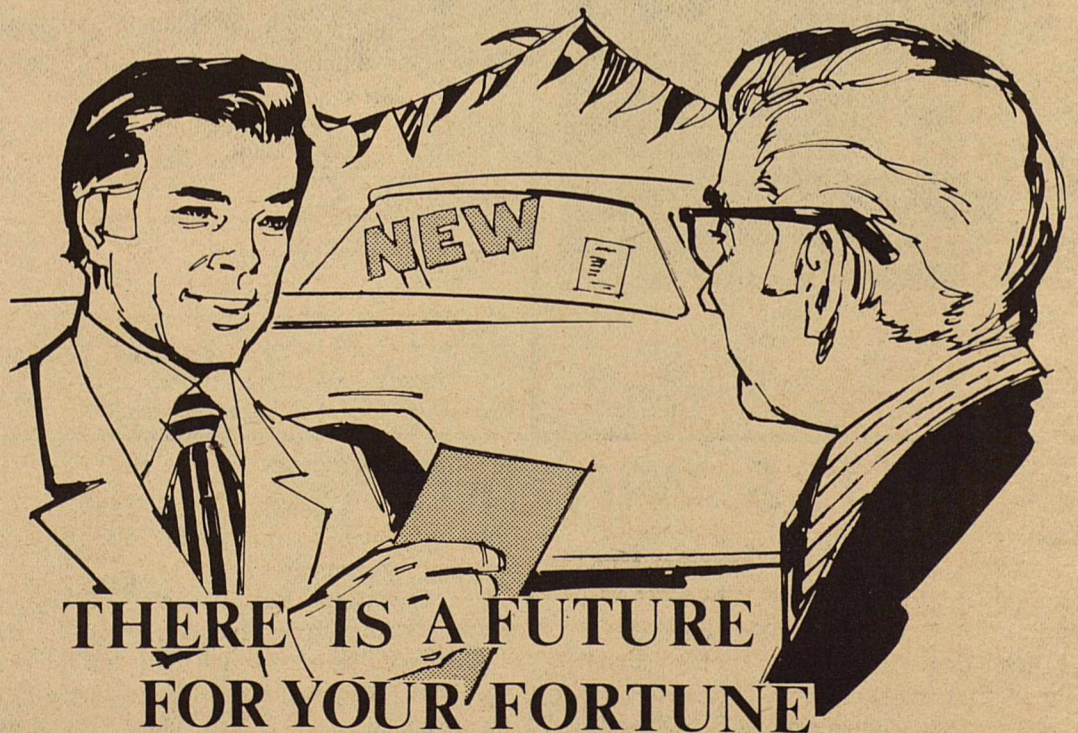
LAST RITES CONDUCTED

**BRACKETT FFA REPORT**



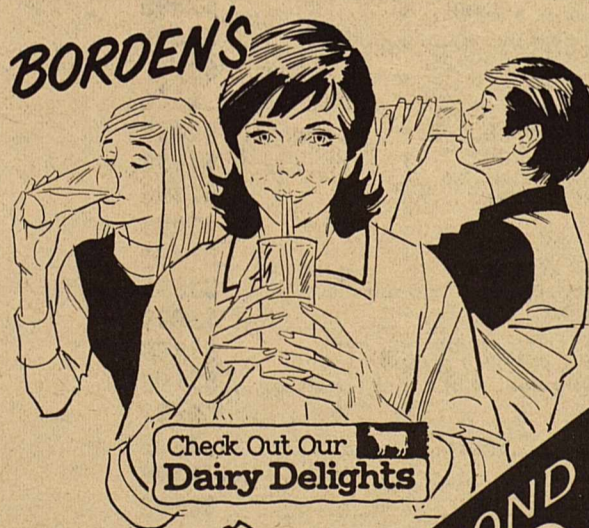

## COUNTY AGENT COMPLETES COURSE

UVALDE--Carl Esser, Kinney County Extension Agent, is among 15 agricultural workers completing a graduate level course in plant pathology at the Texas A & M University Agricultural Research and Extension Center.

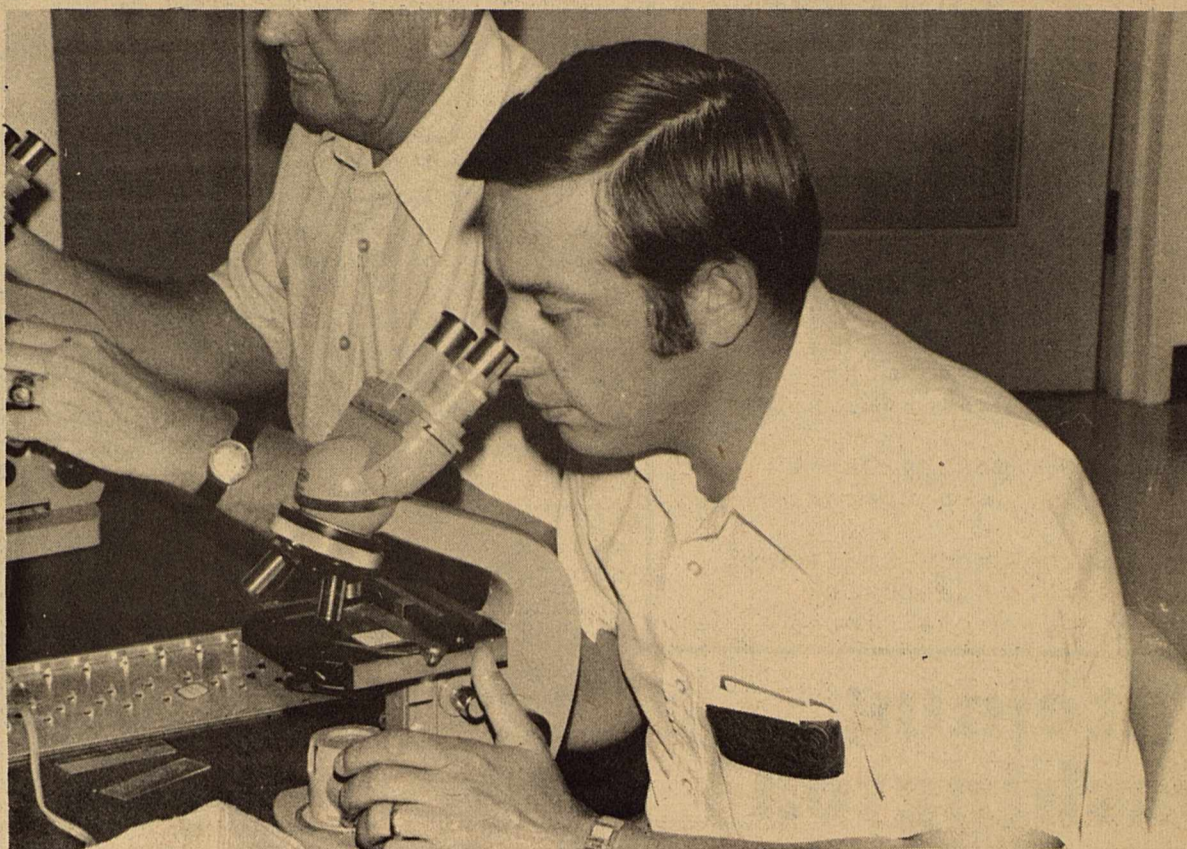
The course, offered by Texas A&M University, is part of a continuing effort to provide people serving agriculture in Southwest Texas an opportunity to review the latest knowledge and improve their professional competency in the field. This also marks the first time a graduate-level course in plant pathology has been offered outside the main campus at College Station.

"Since this is a major vegetable and crop producing area of Texas, plant diseases are of prime importance to commercial farmers and home gardeners here," said Doyle Moore, a District Extension Agent headquartered at Uvalde.

"A course in plant pathology is something our agents and others have requested for more than two years."

Moore said agents and representatives of commercial firms serving the area are now being provided with the technical information which they will later have an opportunity to view from a practical standpoint on farms and around homes in the district.

The course was designed to provide an overview of plant pathology covering the nature of organisms which cause plant disease and methods of control.

"We set up a laboratory exercise each day to help participants recognize structures of the disease-causing organisms and to identify symptoms of diseased plants," said Dr. Stuart Lyda, an associate professor in soil

microbiology at College Station. The 3-week course also includes two field trips providing participants an opportunity to observe diseased plants in the field."

Other course instructors were Dr. Bob Halliwell, a professor of plant virology at College Station; and Dr. Jerral Johnson, an Extension plant pathologist. Johnson coordinated the off-campus course.

#### CONSTITUTIONAL AMENDMENTS GENERAL ELECTION NOV. 2, 1976

##### NUMBER ONE ON THE BALLOT (S.J.R. 49)

Repealing Sections 49-d and 49-d-1 of Article III of the Texas Constitution, S.J.R. 49 amends Section 49-c of Article III of the Texas Constitution to provide for and authorize an additional \$400 million in Texas water development bonds that may be issued on approval of two-thirds of the members of each house of the Legislature for such water development purposes as the Legislature may prescribe.

The amendment contains a specific prohibition against the use of state funds for the development of water resources from the Mississippi River and also requires that before any single water development project may be undertaken requiring the expenditure of more than \$35 million in bond proceeds, it must be approved by resolution of the Legislature.

The amendment removes the constitutional requirement that certain revenues must be used to retire water development and water quality enhancement bonds and removes the constitutional interest rate limit on such bonds.

The wording of the proposed amendment as it will appear on the ballot is as follows:

"The constitutional amendment authorizing an increase of \$400 million in the amount of Texas Water Development Bonds that may be issued on approval of two-thirds of the legislature; amending and consolidating provisions of Sections 49-c, 49-d and 49-d-1 of Article III of the Texas Constitution; and repealing Sections 49-d and 49-d-1 of Article III of the Texas Constitution."

##### NUMBER TWO ON THE BALLOT (H.J.R. 99)

H.J.R. 99 proposes an amendment to the Texas Constitution to increase from \$100 million to \$200 million the aggregate principle amount of Texas water development bonds which may be issued and outstanding by the Texas Water Development Board to provide grants and loans for water quality enhancement purposes as established by the Legislature.

The wording of the proposed amendment as it will appear on the ballot is as follows:

"A constitutional amendment to increase from \$100 million to \$200 million the amount of Texas Water Development Bonds that may be issued for water quality enhancement purposes."

##### NUMERO UNO EN LA BOLETA (S.J.R. 49)

Revocando Secciones 49-d and 49-d-1 del Artículo III de la Constitución de Tejas, S.J.R. 49 enmienda Sección 49-c del Artículo III de la Constitución de Tejas para disponer y autorizar \$400 millones adicionales de bonos para el desarrollo de agua en Tejas que se puede emitir a la aprobación de dos terceras partes de los miembros de cada cámara de la Legislatura para tales fines de desarrollo del agua que la Legislatura pueda prescribir.

La enmienda contiene prohibición específica contra el uso de fondos del estado para el desarrollo de recursos acuáticos del Río Mississippi y también requiere que antes de que pueda encargarse de cualquier proyecto particular para el desarrollo de agua que requiere un gasto de mas de \$35 millones de producto de los bonos, debe de ser aprobado por resolución de la Legislatura.

La enmienda remueva el requerimiento constitucional que ciertas rentas deben de ser usadas para retirar bonos para el desarrollo de agua y el encarecimiento de la calidad de agua y remueva el límite constitucional de la tasa de interés en tales bonos.

La fraseología de la enmienda propuesta tal como aparecerá en la

boleta es lo siguiente: "La enmienda constitucional autorizando un incremento de \$400 millones de la cantidad de Bonos del Desarrollo de Agua en Tejas que podrán emitirse al ser aprobada por dos terceras partes de la legislatura; enmendando y consolidando disposiciones de Secciones 49-c, 49-d, y 49-d-1 del Artículo III de la Constitución de Tejas; y revocando Secciones 49-d y 49-d-1 del Artículo III de la Constitución de Tejas."

##### NUMERO DOS EN LA BOLETA (H.J.R. 99)

"The constitutional amendment authorizing an increase of \$400 million in the amount of Texas Water Development Bonds that may be issued on approval of two-thirds of the legislature; amending and consolidating provisions of Sections 49-c, 49-d and 49-d-1 of Article III of the Texas Constitution; and repealing Sections 49-d and 49-d-1 of Article III of the Texas Constitution."

##### NUMBER TWO ON THE BALLOT (H.J.R. 99)

H.J.R. 99 proposes an amendment to the Texas Constitution to increase from \$100 million to \$200 million the aggregate principle amount of Texas water development bonds which may be issued and outstanding by the Texas Water Development Board to provide grants and loans for water quality enhancement purposes as established by the Legislature.

The wording of the proposed amendment as it will appear on the ballot is as follows:

"A constitutional amendment to increase from \$100 million to \$200 million the amount of Texas Water Development Bonds that may be issued for water quality enhancement purposes."

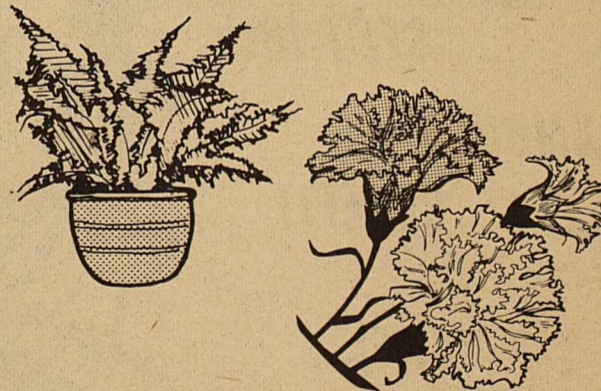

it more each year after that until \$175,000 is reached in 1981. The House version of the tax bill included no changes in the estate tax.

"I would have preferred the full \$200,000 exemption that we approved in the Senate but the changes that were made are a vast improvement over the situation that now exists," Senator Bentsen said.

"Everything has gone up in the 34 years since the exemption was set, except for the exemption itself. Experts estimate that a farmer earning some \$10,000 a year will leave an estate valued at \$320,000. The \$60,000 inheritance exemption for him meant that his widow and his sons and daughters had to sell off their land."

The tax bill also includes a proposal by Bentsen barring artificially high land valuations that drive up the estate tax. It prohibits an existing practice by the Internal Revenue Service of assessing some farm land at its commercial value rather than its agricultural value for estate tax purposes.

## Watching Washington

Senator Lloyd Bentsen Friday said the new tax bill includes provisions that will, in effect, gradually increase the estate tax exemption to more than \$175,000 over the next five years.

"This is a welcome change and one I had fought for. The old \$60,000 exemption set back in World War II, was forcing the widows and children of farmers, ranchers and small businessmen in Texas to sell off their properties to pay the tax," Bentsen said.

Bentsen, a member of the Senate Finance Committee, had introduced legislation increasing the exemption to \$200,000, an exemption approved by the committee and later by the full Senate.

The \$175,000 exemption -- achieved through a series of tax credits -- was agreed to during a conference between the Senate and the House of Representatives on the tax bill. The compromise legislation increases the exemption to \$120,000 next year and boosts

## FIREMEN PLAN HISTORICAL MUSEUM

The State Firemen's and Fire Marshals' Association of Texas has purchased the Sports World building in Grand Prairie, according to an announcement made by association president Bob O'Burke of Duncanville.

The 24,000 sq. ft. structure, located in the heart of the metroplex entertainment area, was purchased from Gulf Western, parent organization of Paramount Pictures.

Assisting the firemen's association in negotiating the purchase was Grand Prairie City Manager, Cliff Johnson and Dallas County Commissioner, Roy Orr.

The property is in the area of Six Flags, Texas Stadium, Arlington Stadium, the Wax Museum, Lion Country Safari, and Hawaii Kai. Money to pay for the building will be raised by the 760 member fire departments of the statewide organization, through donations from insurance companies, oil companies, industry, etc.

Spokesmen for the association said that the building will be used for a museum of antique fire-fighting apparatus and will probably include a Firemen's Hall of Fame. Officials plan to have the building remodeled and open by January.

"We have been looking for a building to house a museum for over five years", O'Burke said, and added, "This building is ideal for our purpose and we feel it was a tremendous purchase".

## COUNTY AGENT REPORTS BY CARL ESSER

UVALDE---Many people (tourist and natives) traveling through this area of the country may have happened upon the bumper sticker which reads, "EAT AMERICAN LAMB, Ten Million Coyotes Can't Be Wrong!"

That slogan probably sums up in as few words as possible the frustration felt by Southwest Texas Live-stock producers in their never-ending struggle against predators.

The coyote is chief among the animals which plague commercial live-stock operators and considerable time and expense is spent each year in efforts to hold down populations of this predatory creature.

Management techniques for these predators are numerous and include methods such as trapping, snaring, aerial gunning, calling, sport hunting and M-44 with cyanide, but choosing a method is only one of many steps in managing coyotes and other predator populations.

"A farmer or rancher must secure a broad knowledge of the animal he wants to manage as well as become familiar with his habits in order to make an effective decision on what kind of method he wants to use on his farm or ranch," said Dr. Milo Shult, a wildlife specialist with the Texas Agricultural Extension Service in Uvalde.

"The method used can vary with each operation, and some kind of training will be necessary for many farmers and ranchers to make effective use of recommended control measures."

A tremendous amount of help in managing predators has been provided by the Texas Predator and Rodent Control Service, but Dr. Shult says another important long-term management effort will have to be carried out by the individual farmer and rancher.

Last week at the Texas A&M University Agricultural Research and Extension Center here, Dr. Shult working in cooperation with Jim Beavers, a Uvalde supervisor for the Predator and Rodent Control Service, began final preparations of educational materials for predator management training state-wide.

The training for farmers and ranchers will be conducted by Texas Agricultural Extension Service County Agents, and should begin sometime this fall. "The materials will be segmented by method so that County Agents can select and provide training based on methods appropriate in their particular county." Dr. Shult said.

Last week Dr. Shult and Beavers, working on a Uvalde area ranch, began work on color slide visuals to be used in the training effort. The slide visuals taken in this area were aimed at basic demonstration of how to follow predator signs, select sites and set both traps and snares. Sites were selected, traps set and all photographed for viewing later on in a training situation.

"We feel training is necessary for success in this kind of management program, but even with training and increased knowledge, carrying on such a program on a farm and ranch will remain a tedious task requiring a strong commitment to holding predator populations in check," Dr. Shult said.

## ENROLLMENT SOARS AT JUNIOR COLLEGE

Uvalde--Enrollment figures at Southwest Texas Junior College here climbed to 2,057 Friday and set a new fall registration record for the 30-year-old college.

"These figures show us to be ahead of last year's fall figures," explained John Allen Davis, dean of student personnel services. "But an unusual situation occurred last year when our spring enrollment exceeded the fall registration."

Davis said nearly 2,300 students registered at the college last spring, which is the highest enrollment ever recorded at the college.

In 1946 the college registered only 69 students in its first year of operation, but the head count grew steadily to 818 in 1966 and 2,039 in the fall of 1975.

Twelve foreign countries are represented at the college this year as students traveled to Uvalde from Hong Kong, Thailand, Japan, Mexico, Ecuador, Guatemala, Brazil, Iran, Saudi Arabia, Nigeria, Costa Rica and India.

More than 400 students are registered at the college outreach center in DelRio, according to Davis, and about 300 students have enrolled in extension courses at Eagle Pass. Other college extension centers are located in Dilley, Carrizo Springs and Hondo.

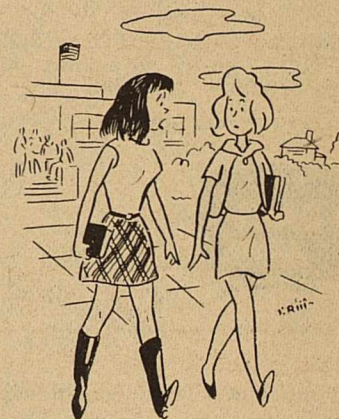
