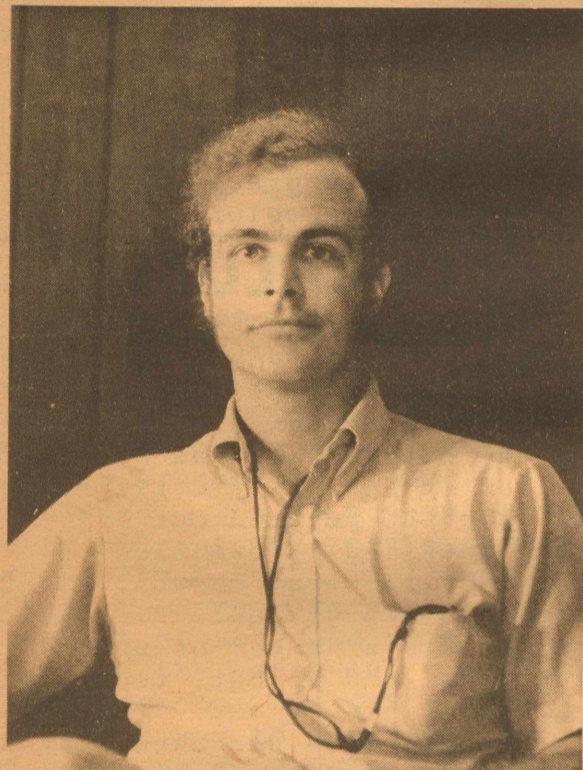

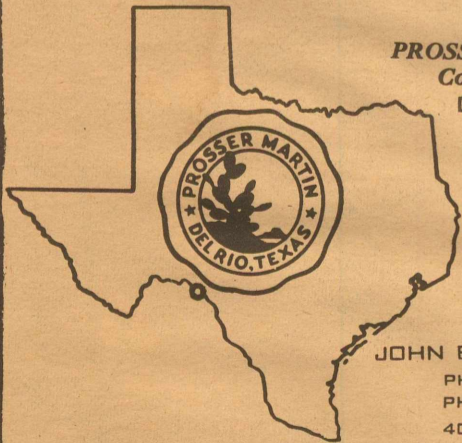

It might be helpful to say why it is good to fertilize your yard in the fall. Nights are longer so the time of growing is shorter than in summer, hence, there is less growth by the grass. In the summer so much of the spring fertilizer is used in producing grass that little is left for extension of the root system. In the winter while there is little growing done by the grass, the fertilizer is utilized by developing a stronger and better root system so that when spring comes the grass can be healthier and grow even better.

When you fertilize don't forget to use some good lawn fertilizer with iron added. This will give you healthy grass and that grass will have a richer green color.

A tour through the garden at the C.L. Orr home highlighted the September 21st meeting of the Retama Garden Club.

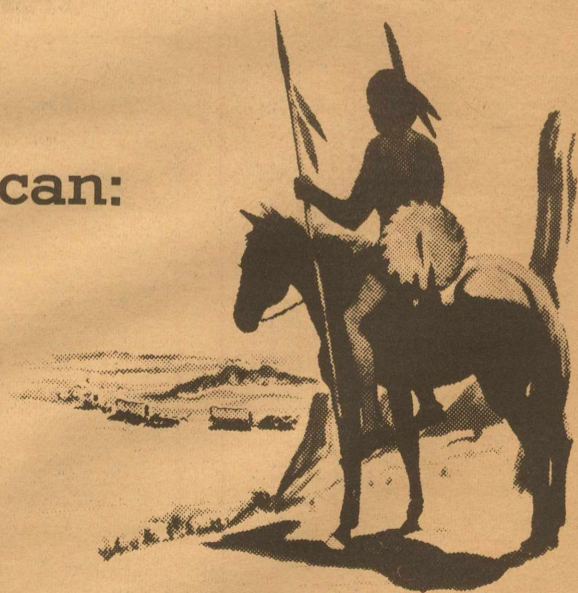

Neville Smart, Jr., John M. Davis, Jr., and P. H. Coates, III directors from the West Nueces-Las Moras Soil and Water Conservation District will be in McAllen October 12-14 to attend the Thirty-sixth Annual State Meeting of Texas Soil and Water Conservation District Directors.

Also attending from the local district is Howard Ragsdale, District Conservationist.

The theme of this year's meeting is "Resource Management-Present and Future." Approximately 800 are expected to attend.

The purpose of the meeting is to review developments effecting conservation programs and to plan future conservation district programs and activities. Dignitaries to address the

group include: U.S. Senator Lloyd Bentsen, Jr.; Representative Bill Clayton, Speaker of the Texas House of Representatives; General James M. Rose, executive director, Texas Water Development Board; David A. Witts, attorney and general counsel, Texas and Southwestern Cattle Raisers Association; Mel Davis, administrator of the U.S. Soil Conservation Service, Washington, D.C. and Dee Brune, president, Association of Texas Soil and Water Conservation Districts.

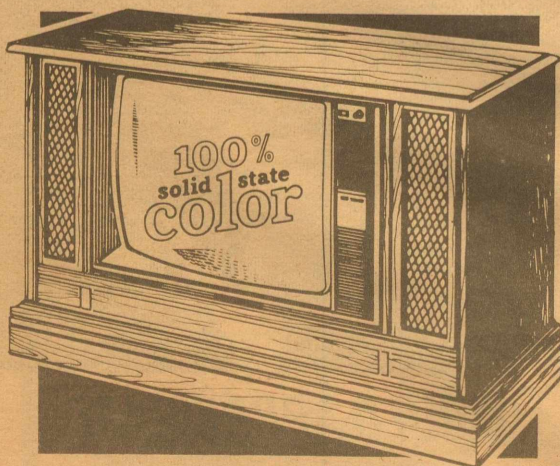

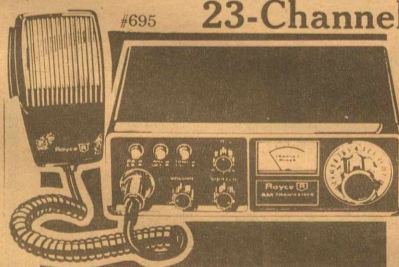

# PREDATOR CONTROL



County Extension Agents serving this area of Texas covered by District 13 of the Texas Agricultural Extension Service visited the Texas A&M University Agricultural Research and Extension Center in Uvalde recently for an in-depth training session on predator management. When training materials are complete later this fall, these 21 agents, serving 19 counties, will begin training farmers and ranchers in their counties on how to successfully manage predator populations. Jim Beavers of Uvalde, demonstrated to the agents how to set a trap site utilizing the M-44, a device which delivers a toxic substance into the animal's mouth. The device, disguised by bait, is triggered when the animal pulls upward.

## ELECTIONS COMMITTEE

On May 1st Texas' voters had their first opportunity to directly indicate just which of the various contenders they thought should be the Democratic and Republican parties' presidential nominees this year. They got that opportunity because the 64th Texas Legislature passed a law creating the first Texas Presidential Preference Election to be held in conjunction with the regular party primaries.

Most Texans seemed to like having a presidential primary, even if some did not like the format under which this first one was held. However, the law creating the presidential primary was not a permanent one. In fact, if Texas is going to have a presidential preference primary in future presidential election years, the 65th Legislature is going to have to pass a new law authorizing such an election.

To assist the Legislature in deciding whether we should have more presidential primaries and, if so, what kind they should be, I, as Chairman of the Committee on Elections of the Texas House of Representatives, recently appointed a special subcommittee and instructed it to draft recommendations to be submitted to the Legislature when it convenes in January of next year.

The first meeting of that sub-committee, to be headed by State Rep. Sarah Weddington of Austin, has been scheduled for 10:30 a.m. Friday, September 24, 1976, in the Old Supreme Court Room on the third floor of the State Capitol Building in Austin.

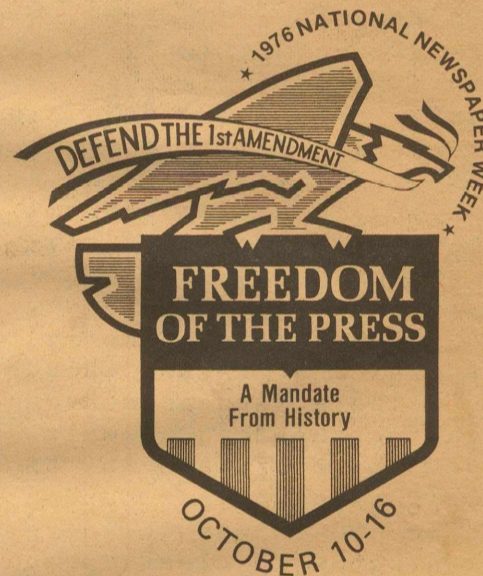

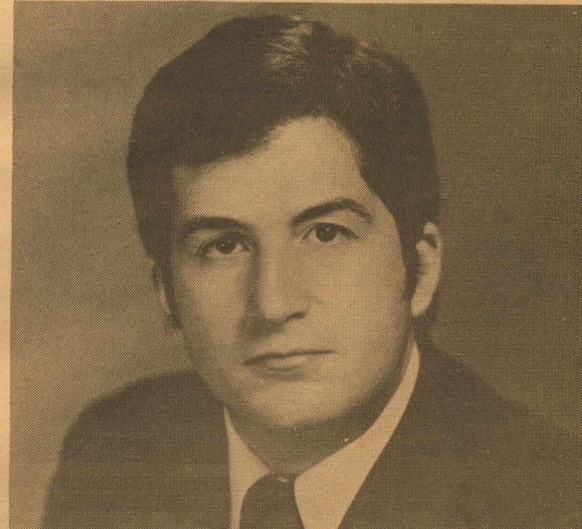
I hope you will be able to attend this meeting, however, if you can not, please do not hesitate to send your written comments to me so that I can forward them to the subcommittee members.

Three young men of the Knights of the Altar of St. Mary Magdalene Church received the Grand Cross for the Knights of the Altar from the hand of the Rev. Edward B. Postert, O.M.I., pastor in the presence of a packed church at the 10:00 mass on October 3. The three young men receiving the Grand Cross are Ruben Esparza, son of Mr. and Mrs. Chuy Esparza; Oscar Pena, son of Mr. and Mrs. Alfredo Pena; and Daniel Samaniego, son of Mr. and Mrs. Placido Samaniego.

In the ceremony, after the procession into the Church and the reading of the Scriptures, each candidate for the Grand Cross approached the Altar accompanied by his father and mother where he was vested with the red cincture, Grand Cross and Grand Cross ring, which were previously blessed by the pastor. The Grand Cross is presented only to Knights of the Altar who are in the ninth grade in school. Those receiving this distinguished award must have been Knights of the Altar for at least three years. Their character must be attested to by the pastor, his parents and teachers. The final and more difficult re-

quirement is a two-thirds favorable vote of the local members of the Knights of the Altar.

Father Postert is the originator of the Grand Cross. He did this 22 years ago in Edinburg, to encourage boys to remain as servers at the Altar during their High School years. "It has proven to be just that," said Father Postert.

Following the Mass of the investiture, a banquet was served the new Grand Cross holders and their parents. Also attending the banquet were all the Altar Servers together with the Grand Cross holders of previous years. Mr. Charles Koch, president of the parish Confraternity of Christian Doctrine was the principal speaker at the banquet. Three Grand Cross Holders from Kingsville, Ernesto Lozano, Carlos Lozano and Joe Torres, assisted at the Mass and Presentation of the Grand Cross, and joined in the banquet.

### SHAHAN RE-ELECTED

The Texas Tourist Council meeting in Fort Worth, re-elected Happy Shahan, president of Alamo Village, Brackettville, as a director.

The Council is a private enterprise state-wide organization whose purpose is to support and supplement state efforts to attract more visitors to Texas.

Ward Wilkinson of Southwestern Bell Telephone Co., and newly elected president of the Council, told the board of the economic importance of the tourist industry. He reported that 21.8 million out-of-state visitors last year spent \$3.5 billion in Texas. Of this amount, \$312 million went into the state treasury as direct taxes from lodging, gasoline, sales and excise taxes.

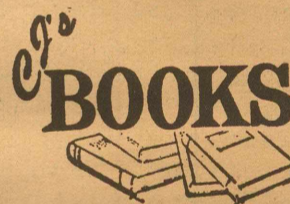

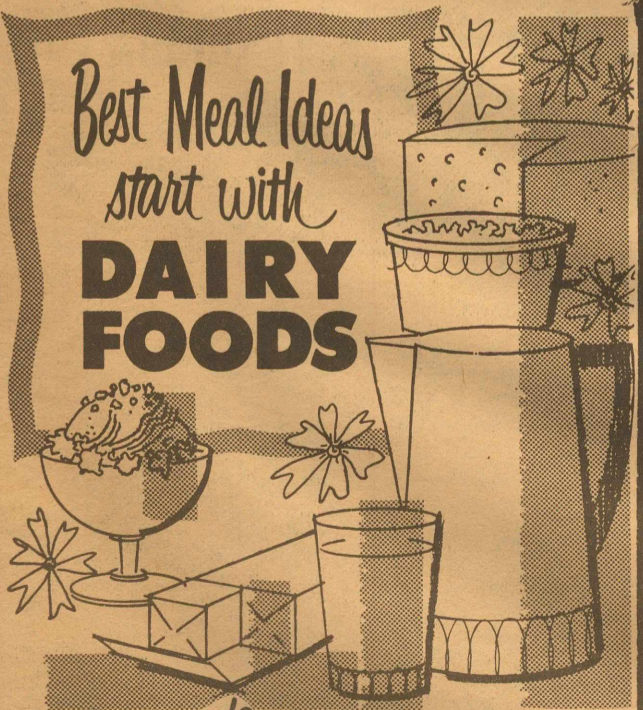

## YOUR REPRESENTATIVE REPORTS

Washington, D.C. -- Congress late Thursday gave final approval to a proposal by Senator Lloyd Bentsen that will speed the prosecution of hardened criminals by weeding out weak cases before they clog court dockets. The legislation is based on pilot programs being operated successfully in Dallas, Houston and other cities around the nation.

The Bentsen bill, adopted as an amendment to the Law Enforcement Assistance Administration authorization bill, encourages County Attorneys and District Attorneys to establish Early Case Assessment offices staffed by experienced assistants who would screen cases shortly after charges are filed.

"Houston District Attorney Carol Vance reports a decline in armed robberies in the first seven months after his Early Case Assessment office went into operation." Senator Bentsen said in a statement.

"There were monthly decreases in reported robberies ranging from eight to 30 percent. In addition, the average time from arrest to indictment under the program is nine days, compared with 42 days for other cases. And the average time from arrest to trial is 119 days, compared to 152 days for other cases."

"This program tries to make certain that cases involving violent crimes or repeat offenders are given a high priority, brought to justice early and not left out on bail for a long time," the Senator said.

"The success of the program in Houston shows we can do this by having experienced prosecutors examine all cases at an early stage of the proceedings, dismiss those that make it to trial and schedule court action for all the rest."

The amendment proposed by Bentsen encourages LEAA funding of Early Case Assessment offices.

"I am pleased that the Senate has approved my legislation. It will help insure that the guilty are quickly convicted and, equally important, that the innocent are protected," Bentsen said.

"Justice delayed is justice denied. I might add that it is also crime undeterred. Delays too often mean that witnesses move or become lost or their memories grow dim," Senator Bentsen said.

## SWTJC

Uvalde - Southwest Texas Junior College here has been selected as one of six locations throughout the nation to host two-day regional meets to qualify pilots for the 1977 U.S. Precision Flight Team Championships.

Finalists in the Uvalde regional meet October 30-31 will be eligible for the national try-outs which will lead to membership on the official U.S. team to compete in the World Precision Flight Championships in Linz, Austria, during August.

According to officials of the National Pilots Association and the National Intercollegiate Flying Association,

regional meets also will be conducted in Delaware, California, Ohio, Florida and Illinois.

This is the second time that the United States will participate in the World Championships of Precision Flight. In 1975 the U.S. fielded its first precision flight team which finished seventh in the world championships in Gavle, Sweden.

The five top-scoring pilots from each region will participate in national fly-offs where the final official four-member team will be selected.

Precision flight competition is intended for solo pilots flying single-engine light aircraft. Events to be flown during competition are scored according to the accuracy and degree of skill displayed by competing pilots in flight planning, navigation and landing events.

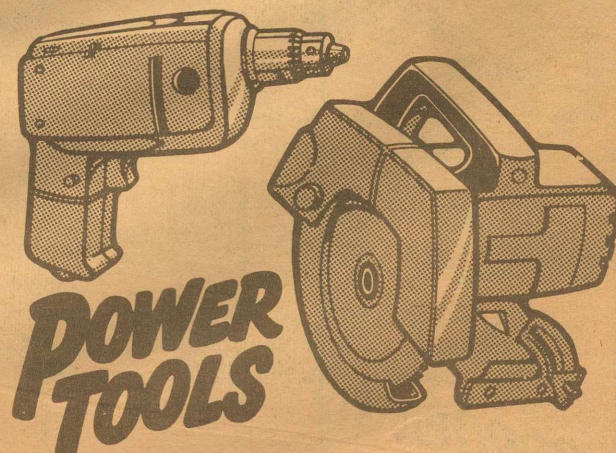

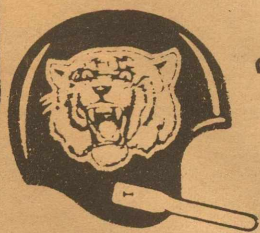
