
If a group would get organized and restore an old building, I doubt if it would stay vacant long.



This is in regard to the letter published in the CAVALRY-MAN, November 12th, concerning the Athletic Complex on the Camp Wood road.

The main purpose in answering the letter in question is to clarify certain remarks in the letter that do not state the true facts.

On November 4,1975, there was a public meeting held at the Civic Center to discuss the possibility of building the new athletic facilities. The results of that meeting were published in this newspaper on November 7, 1975. The following meeting of the Booster Club was also held at the Civic Center to further discuss this project, and at that time was no opposition to said project and the Booster Club took over the sponsorship.

The Booster Club appeared at several service clubs to present the project as well as talking to individuals and groups of people on what plans were being made to develop the athletic facilities. Also a scale model was put on display at business places. During this time we did not receive any critizism or opposition as to what was being planned.

During this planning stage, the pros and cons were discussed so that everyone would be informed as to the purpose and needs as well as short comings to moving these facilities.

As to the other statements made in the letter published November 12th, we feel that every one is entitled to his opinion and should feel free to express it.

Our only concern is to state the facts as to what steps were taken to inform the public before the project was started.

At any time we would be more than happy to answer anyone's question concerning the new athletic facilities. It is not a secret project, nor is it for "a half dozen" affluent few.

## **GARDEN CLUB**

The November meeting of the Retama Garden Club was held at the home of Mrs. Paul O'Rourke, with Mrs. David Blair and Mrs. Ralph Blahnik assisting.

Mrs. Elizabeth B. Armijo, Park Naturalist, assisted by Barbara J. Voss of the National Park and Wildlife Service, Amistad Area, Del Rio, presented the program "Plants and Their Use," explaining plant changes from ten thousand years ago to the present time on some of our native plants, and how man, from the beginning of his time to the present, has used these plants for food medicine, and material. One of these plants is the familiar Century plant. In Mexico and Central America where it is known as Maguey, the sap is fermented to make the well known tequila. The root is said to taste like sweet potatoes.

Among many other interesting and useful plants of our area were mentioned: Mesquire bean for calcium and also good in treating diabetes. The bark can be used for paint. Prickly Pear, vitamin C, for salads, vegetable, and the bud for



jelly. Cattails also have edible parts.

If he disregards good taste and uses words or says things that are not in good taste, he reveals himself as a rebellious smart aleck, immature person. If he allows his talking to interfere with the talking and listening of others, he reveals himself to be a spoiled insecure person who intentionally or carelessly reveals his lack of courtesy and considerations for other's privileges. No one has the right to infringe on the privileges of others. This is why the FCC sets out limitations. Generally, however, is one would infringe on others, he could not care less what the law says. He governs himself on the basis of what he can get by with. This type of CB'er will eventually be taken care of by other CB'ers. Be courteous, considerate and gracious; you will not only enjoy your CB, but will make others "on the air" appreciate you.

Because the "bear" is a benefactor he deserves cooperation of every CB'er. Despite the use of CB's to locate the "bears" traffic generally is much slower under the 55 mph speed limit. CB's can be very useful to the Highway Patrol and other officers, but there must be a feeling of respect and cooperation on the part of both the officer and CB'er. There is no effective way to get a drunk driver off the highway than effective use of CB's. Helpful traffic information regarding weather, wrecks, stray animals, can easily be passed by CB's than any other way. Soon there should be a loose joined "organization" nation wide of CB operators working with law enforcement officers for the benefit of all -- this is as it should be. 

We are having ideal weather for plants, trees, and lawns. There is enough moisture to save watering. There is enough warmth to prevent losing plants by frost or freeze. As the ground becomes dry enough, now is the time to prepare flower beds for spring planting. It is a good idea to mix heavily into the soil some course ground bark mulch. This will keep the soil loose and yet will retain moisture. By spring planting time, the bed should be in ideal condition. Then just before planting, work some good all purpose fertilizer into the soil. If proper watering is done and the proper plants are selected for the bed, you can be guaranteed beautiful flowers in spring and summer. Half the battle is to be fought now. A little time, energy, and money spent now will pay beautiful dividends in the months ahead



## <u>Carl Esser Reports:</u> CATTLE MARKETINGSEMINAR SLATED

San Antonio--Producing cattle for a particular segment of the beef market is one way Southwest Texas cattle producers can increase income.

Learning what types and grades of animals the various segments of the market are favoring could help cattlemen gear their management in the direction of producing those kinds of animals. With this goal in mind, people representing Texas feedlots, western feedlots, and packers will be present for a one-day Beef Cattle Marketing Workshop here Dec. 3.

The workshop will be held in the Auction Building at the San Antonio Union Stock Yards beginning at 1 p.m.

"We are going to have a grade, type, and pricing demonstration utilizing live animals," said Dr. LeRoy Hoermann, an area livestock specialist with the Texas Agricultural Extension Service in Uvalde.

"We think this kind of knowledge will assist our Southwest Texas producers in making management decisions which will lead to the production of calves for a particular segment of the market. We think this is one way to maximize income within the depressed cattle business."

During the demonstration, representatives of the various markets will tell producers what type of animal they favor and what they would pay for that animal. A federal inspector also will grade the animal during the demonstration.

"It is hoped that this demonstration will give our producers some hints as to what these various buyers are looking for in terms of types and grades of cattle," Dr. Hoermann said. The livestock specialist said this is not an easy subject to deal with, especially since two distinctly different types of cattle might grade the same. "It boils down to what the particular market is looking for in terms of cattle," he said. "Knowing this will help producers decide what market they would like to aim for in their production arrangement."

The panel discussion will be moderated by Dr. O.D. Butler, head of the animal science department at Texas A&M University. Panel participants will include Leon Miller, president of Alta Verde Industries in Eagle Pass; Maurice Harrell, owner of the Harrell Cattle Co. in Gonzales Dudley Campbell, president of Chaparrosa Agri-Services Inc. of San Antonio; Joe Bray, officer-in-charge of the Texas Federal Marketing News Service in San Antonio and Dave Folger, a buyer for Swift and Co. in San Antonio.

Other participants will include Lewis Watson, chairman of the Southwest Texas Agricultural Resources (STAR) program; and Willie Mund, chairman of the STAR Beef Cattle Task Force.

Sponsors for the workshop, in addition to STAR, include the Texas Agricultural Extension Service and the Union Stock Yards.




