

Many are working at starting lawns. Of course, the type of lawn you have is a matter of personal taste. The most carefree lawn in this area is bermuda grass. It takes less water, much more free of disease, insects, and fungus infection. It can well be a beautiful lawn if proper care is given. If a lawn of carpet grass is desired this is best accomplished by planting blocks, chunks or sprigs of carpet grass. If bermuda is desired it is best done by seed. For bermuda grass have the surface of the soil smooth and loose. Broadcast the seed onto moist ground, either by hand or with a spreader. Keep the soil moist with fine spray which is not strong enough to puddle or wash for at least three or four days. By this time the grass should be up. It is then necessary to keep the soil damp but not as moist as when seeking to sprout the seed. This should be done the first part of April. It needs to be a warm time with little wind. If this is done properly you can have a good cover of grass by late summer that will stay green till freeze and if

fertilized in the fall be a beautiful lawn the second year. To get cover with carpet grass depends entirely on how thickly the sprigs or blocks are planted. It too requires much water when planted and considerable water all through the summer. If planted thickly enough and properly watered it tco will cover the first summer. This should be done when it is warm enough that carpet grass

is green and growing lustily. This usually is the last of April or first of May. Lawns require work to start and work to maintain. The beauty and sucess of them depends on the work put in and the care taken.







With Members of the New World Study Club, the Retama Garden Club toured the northeast part of Kinney County and the northwest corner of Uvalde County to observe the natural environment and subsequently the historical points along the way. Miss Else Sauer, Kinney County Librarian was the tour guide and commentor.

The group of 28 members left the Kinney County Library at 9:00 am going on the Rock Springs road to the Cedar Creek Road, past the Sights Ranch to the Henley Ranch. Here they had the good fortune to see the spring shearing of the Angora goats, a first time sight for many of the members. From the Henley Ranch they continued to the state road 55, to Barksdale, on to Camp Wood, where a picnic lunch was enjoyed by the cool lake in the Camp Wood Park on the Nueces River.

From Camp Wood they continued to Montell to the Episcopal Church (Church of the Ascension). Mr. and Mrs. John G. Dooley, ranchers who live nearby, conducted the group through the church, and told of its history. The congregation was organized in 1883 by English settlers of this locality. The Church was built by donations received from English people all over the world, including Australia, New Zealand, and Canada. In the late 1880's the church was sturdily built by country carpenters and finished in December 1889. The first services were held on Christmas Day, 1889. The pews and some of the furnishings are hand made. Everything in the church is original except the lights and floor.

Many local people were Christened here in this church. Mrs. Roy Coston, Sr., was christened here and so were her children.

Mrs. John Jacob Astor contributed to the church a beautiful, large leaded, stained glass window. This donation was received through the efforts of Miss Baylor, a local Texas poetess, who was in New York arranging to have her poems published by Lipincott.

The window was shipped in one piece by boat and train to San Antonio and brought from there overland by wagon. The country carpenters knowing the large dimensions of the window, cut the opening in advance when the window arrived it fit perfectly. This remarkable window is still in excellent condition having had but one small pane broken in the 1930's, when the window was releaded

From here, the group returned to Brackettville

Some changes have been made in your GPL bill. Now, fuel costs will be shown as a separate item.

The electric bill you receive from Central Power and Light Company has been designed so that it will meet new requirements of the Public Utility Commission of Texas.

The fuel charge you have been paying is now shown as a separate item on your bill from CPL. The money from this charge is used for only one purpose — to pay for the fuels needed to produce your electricity. None of this money is used for profits or for any other expenses.

Your bill will be similar to the one shown here with base rate and fuel cost charges included among the separately listed items. We've prepared a line-by-line guide that should make these items clear:


LINE ONE — is the base rate portion of the monthly bill. The sample bill shows: Rate 11 (a residential rate); the previous meter reading of 6974, and the latest meter reading of 7974, the KWH (kilowatt hours) used (7974, less 6974), for total KWH use of 1000, and the amount of this portion of the bill.

LINE TWO — shows the fuel cost you have been paying as part of your old total bill, but which is now broken out separately. Your fuel charge is based on the total kilowatt hours you use each month. The eight-digit number shown to the right of the word FUEL is the fuel cost factor. It is determined by dividing the amount of money CPL spent for fuel by the kilowatt hours the company sold. This fuel cost factor is then multiplied by the number of kilowatt hours used by you, the individual customer.

LINE THREE — is PREVIOUS FUEL. Because of the time lag between the date CPL bills you, and the date our fuel suppliers bill us each month, we have to estimate a small part of the fuel expense. The PREVIOUS FUEL line allows us to make an adjustment as needed — either lower, or higher — to adjust the previous month's fuel cost estimate to actual cost.

LINE FOUR — shows the amount of SALES TAX. This tax is collected for, and remitted to the State of Texas.

LINE FIVE — indicates the due date and total amount you owe.

I have a couple of calves. They are good sized calves, about 500 pounds a piece. One is a steer calf and the other a heifer. I go over to the pasture where I keep them to feed them every morning and every evening. If they aren't standing waiting when I drive up they come on the run. keep the feed in the van. When I open the door the red steer calf sticks his head across the fence and will hardly let me across the fence till I feed him a hand full of pellets out of my hand. The little black heifer is the independent one. I can hold out a handful of pellets and she'll ease up and touch my hand with her nose and then back off, toss her head around, stomp and fuss. She'll not eat abite until it is put in the trough. Reminds me of some people I know.

Some are friendly and easy to get along with while others are fussy and demanding. The heifer wants just as much as the steer but I truly believe would do without until I hand fed the steer all the feed rather than eat out of my hand. Usually animals are some what prone to follow the actions of other like animals. But that black heifer is not about to be taught anything by that red steer. Again how much like some people. When feed is placed in the trough that black heifer would quickly gobble it all up rather than share it except the steer is big enough to get his share. When all the feed is gone the steer slowly makes his way back down into the grassy area. When I drive away the black heifer is still standing at the fence wanting more. some people -- never satisfied -always wanting more--always on

Y.C.C. AT AMISTAD

Superintendent Edward C. Rodriguez, Jr., Amistad Recreation Area, National Park Service, has announced that a non-resident Youth Conservation Corp. camp will be held again this year at Amistad Recreation area with fifty (50) positions available.

Applications have been received

by the Park and all interested youths age 15-18, male or female, interested in gainful summer employmnet should apply at National Parks Service Headquarters Building, Highway 90 West. Applications must be completed and returned by April 8, 1977, and a Social Security number will be required before termination of the program in August. Applications will be chosen on a random basis and notified of selection or non-selection by an Austin office. The program will begain on Monday, June 6, 1977, and end on August 5, 1977.

Young adults who participated in the 1976 Y.C.C. Program will not necessarily be allowed to participate automatically. However, those desiring to be onsidered should apply at Park Headquarters.

The Youth Conservation Corp Program provides an opportunity



for area youth to take an active part in improving the quality of the natural environment through a well-balanced earn-

work-learn experience. a conservation work program and not a summer recreation camp. The intent of the program is to develop an understanding and appreciation in participating youths of the Nation's natural environment and heritage.

The National Park Service will also accept applications for Camp Director, Environmental Awareness Coordinator, Work Coordinator, Park Aid (Administration), and Work Leaders. Application forms are available at Amistad Recreation Area Headquarters. Applications will be accepted only through Friday, March 25, 1977.
