## BORDER RALLY HERE SATURDAY



Members of the San Antonio Radio Club will supply communications from San Antonio to Del Rio for the San Antonio Sports Car Association's Annual Border Rally this weekend. This group of radio amateurs will operate under simulated emergency conditions as a training exercise. In the past they have supplied communications during hurricanes, floods, and other disasters when all other commercial communications have been in-operative.

The radio amateurs work closely with the Red Cross and Civil Defense authorities supplying vital communications in times of emergencies. They are equipped with portable repeater stations and gasoline powered generators that can be moved into a disaster area on short notice.

Dr. Larry Higgins, chairman of the operations, stated: "Supplying uninterrupted communications over a approximate 200 mile route such as this allows us to be prepared for any communications emergency that may happen."

The Annual "Border Rally" is sponsored by the San Antonio Sports Car Association and the San Antonio Jaycees. Proceeds of the Rally will go to the Muscular Dystrophy Foundation. Approximately 200 people will participate in the Rally that will pass thru Brackettville, Saturday. Winner of the event will receive an all expense paid vacation for two in Monterey, Mexico.

## city hall

At their meeting August 8, 1977, the council passed and adopted the budget for the year 1977-78.

The General fund was set at \$78,567.70 an increase of \$10,144.42 over the 1976-77 budget.

The Utility budget was set at \$161,031.03 an increase of \$39.49 over last year.

There was no change in the tax rate for the year as the Council set the rate at \$1.50 per hundred at 40% assessed value.

Mr. Jerry Simpton from Central Power and Light appeared before the Council to explain the high increase in the City pumping rates. Up until April the City had not been charged a fuel cost which is now accounting for the high rates.

Among other things the new S.B. 411 passed by this year's Legislature which has to do with firemen retirement funds were discussed. Unless by resolution the council rejects the bill the City will have to pay \$12.00 per month per fireman, which at this time would amount to \$4,320.00 per year. No such amount was included in the budget which was shaved as much as possible to prevent having to raise taxes. The subject was tabled for a special meeting sometime this week.

Solid Waste was again discussed but as no further word has arrived from Austin on the Status of the Permit Application there was little to say.

A protest of zoning violations was received by the Council and the secretary was told to inform the violator that he had 60 days to conform to his zoning regulations.

All members were present at the meeting which was adjourned at 11:00 p.m.

Dear Editor:

Last week's vote by the U.S. House  
of Representatives against the de-

regulation of natural gas prices was  
a vote against the American Consumer  
and against jobs for Texans. Because  
of the great amount of confusion and  
misinformation surrounding last week's  
vote and the entire issue of the de-  
regulation of natural gas prices, I  
felt that it was important that an  
attempt be made to set the record  
straight.

The nation and Texas both lost in  
the vote against deregulation of na-  
tural gas prices. It was a vote to  
give the power to federal bureaucrats  
not just to set prices for energy but  
to allocate energy supplies and jobs  
to other states.

In the winters ahead, as the dwind-  
ling supply of natural gas fails to  
meet our nation's needs, as Texas  
loses jobs and economic growth, I hope  
we will remember the circumstances  
that caused opponents of deregulation  
to reach the conclusion reflected in  
today's vote.

Our losses might very well have  
been prevented, I believe, if two  
things had happened:

---if the Administration had offered a  
better, more realistic gas pricing  
policy; and  
---if the issue had remained non-  
partisan, as it ought to have. Instead  
people put obligation to party ahead  
of obligation to country.

For weeks, I had sought a method  
of compromise in implementing a plan  
that would hold true to two essential  
principles:

-----eventual removal of federal price  
controls, or deregulation, and  
-----the denial of federal authority  
over our state's intrastate gas sup-  
plies.

Both those principles were served  
in my deregulation bill in 1976, which  
lost only 205-201. At that time, many  
Democrats, including myself, worked  
with a Republican President to fashion  
non-partisan energy policy. Today,  
partisanship on both sides prevailed  
and the loss was substantial.

TIPS FOR GREEN THUMBS

It will be time to fertilize lawns. In the heat of this weather the grass extends itself in production of grass. When the weather cools and as nights grow shorter the above ground production slows. When this happens it is time to fertilize the lawn. This will make it possible for the grass to extend and enlarge its root systems so it will be able to produce a deeper sod and more and better grass next spring. It is best to use a lawn fertilizer containing iron in this area. This will help prevent a yellowing of the grass. Between now and time of fertilizing the grass needs water--water--lots of water. When fertilizer is applied it then should be heavily watered.

After the initial Kruger bill to deregulate natural gas won in subcommittee, by a vote of 12-10, I knew that it would be harder to win in full committee. I felt that by phasing out price controls, over several years, however, we would win deregulation in full committee.

But the Republican leadership instead upon holding to the official Republican policy of immediate deregulation of new natural gas, coupled with windfall profits taxes. That strategy lost by a vote of 23-20.

I then negotiated with Republicans and Democrats, seeking to offer phased out price controls before the full House of Representatives. That seemed to me the only strategy capable of victory.

Unfortunately, in the Rules Committee the Republican leadership combined with Democratic supporters of the Administration's policy to deny me the opportunity to offer the only amendment that would have won. In my judgement, the Republican leadership consciously offered a losing strategy so that they could blame President Carter for the defeat of deregulation.

In so doing, they allowed partisanship to overrule wise policy. The House became polarized on a highly complex issue and people tended to take the easy way of voting a party line as Republicans versus Democrats instead of working together as public officials to fashion non-partisan energy policy, as had hoped we might. Thus, we are all losers and we must hope that the Senate will not act in partisan fashion, that it can repair the divisions created in the House, which have cost all Americans their hopes of our best possible energy policy.

Since Texas is by far the largest consumer of natural gas---consuming more than all of New England, New York, New Jersey, Pennsylvania, Ohio, Indiana, Illinois, Michigan, California, Oregon, and Washington combined---if we have a very cold winter this year, Texas stands to lose thousands of jobs if natural gas is allocated, as allowed by this bill, to other states. If that happens, the Texas Consumer and Wage Earner will be the ones to suffer.

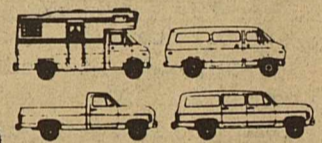
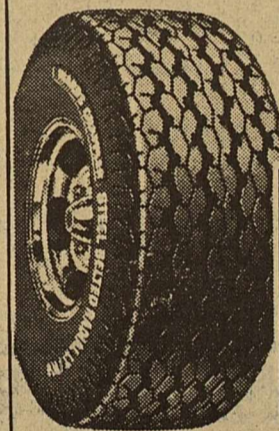

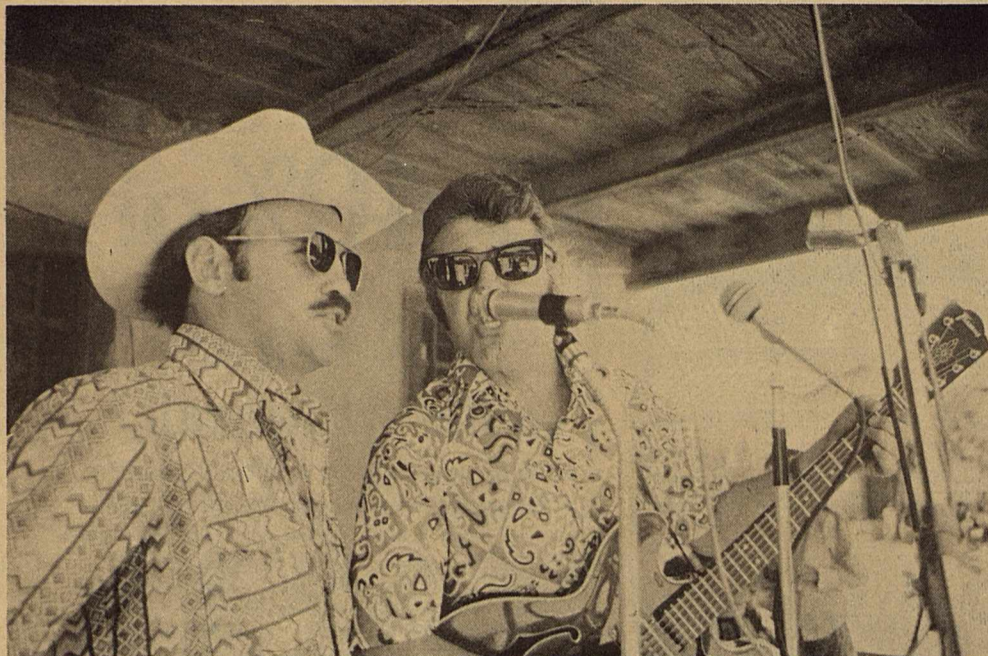

Lo-Vaca Gathering Company ("Lo-Vaca") and Coastal States Gas Producing Company ("Coastal"), pursuant to the requirements of Section 43(a) of the Public Utility Regulatory Act (1446c, T.R.C.S.), files this statement of intent to change rates, effective September 1, 1977, the rates they are charging all customers on the Lo-Vaca system for the purchase of natural gas to a uniform rate applicable to each customer on the system, which rate consists of 100% of Lo-Vaca's weighted average cost of gas plus 16.70 cents per Mcf. The cost of gas is to be adjusted each month in accordance with Lo-Vaca's billing procedure, which is Lo-Vaca Exhibit KLH #515, filed with the Railroad Commission of Texas ("Commission") in Gas Utilities Docket No. 500 on June 13, 1977.

The present rate charged by Lo-Vaca for the sale of natural gas to nearly all Texas customers is 100% of Lo-Vaca's weighted average cost of gas (determined in accordance with the billing procedure set forth in Lo-Vaca Exhibit WKA #17 in Gas Utilities Docket No. 500) plus 5 cents per Mcf.

The new rate is anticipated to increase Lo-Vaca's revenues by \$60,196,106 in calendar year 1978. This is an increase of 5.61% over total revenues which would have been received if the present rate were continued in effect for that year.

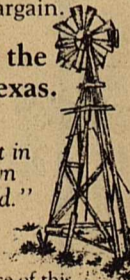

Rousselot served as chairman of the Wool & Mohair Promotion Committee and on the Miss Wool of America Pageant Board.

Wardlaw has raised sheep, goats, and cattle since 1966 and is a director of the Devil's River Soil and Water Conservation District, as well as a member of the Val Verde County Commissioners' Court.

Predator-related resolutions accepted at the convention include one commending Roy McBride, Alpine, for his work developing the toxic collar for predator control, and also urging that a program be developed in order to register Compound 1080 for use in the collar.

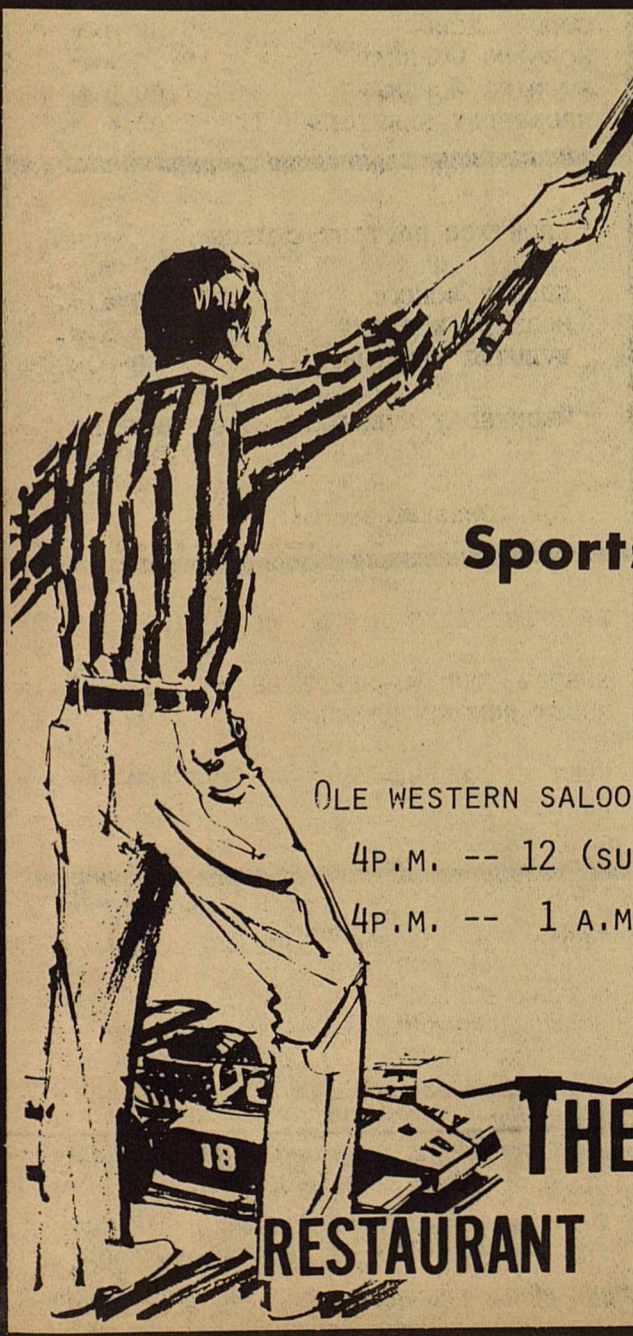
A related resolution requests that the president of the National Wool Growers meet with President Carter to seek modification of the Executive Order of 1972, which banned the use of chemical toxicants. Still another measure

calls on the Texas Agriculture Commissioner to authorize the Rodent and Predatory Animal Control Service to rewrite regulations determining the ability of predatory animal hunters to handle restricted pesticides. It was also requested that this authority be granted immediately so that testing and certification could be completed prior to institution of pesticide controls October 21.

The Association also commended U. S. Congressman Bob Poage "for his invaluable assistance in working for extension and renewal of the National Wool Act." It was requested that sheep producers write Poage to express their appreciation of his contribution.

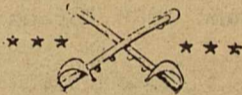
