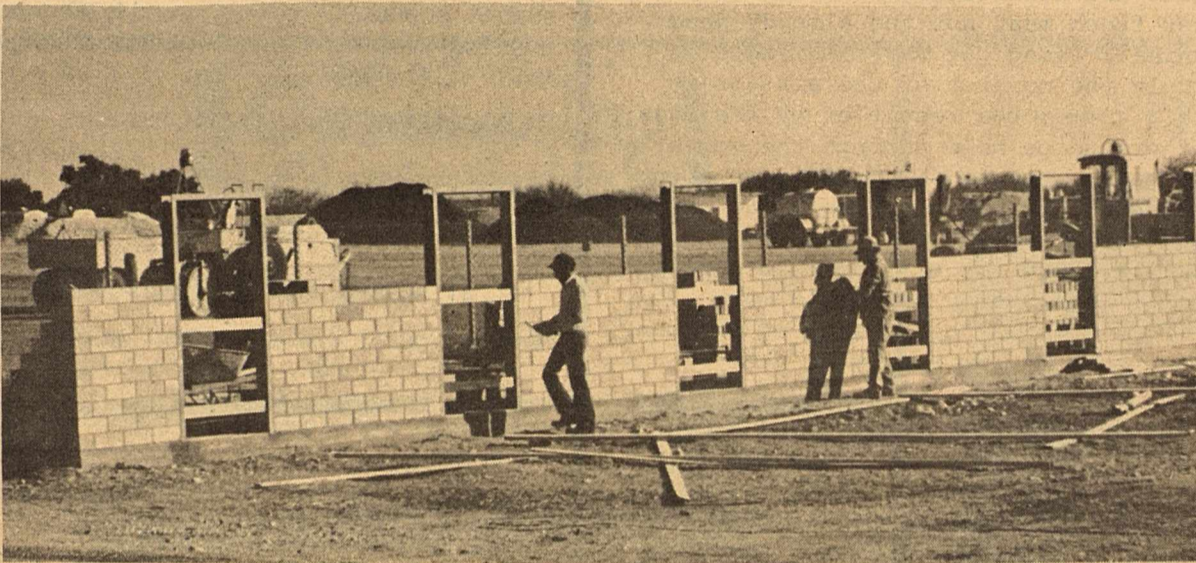

### COMMISSIONERS' COURT

EXCERPTS FROM COUNTY COMMISSIONERS MEETING

FEBRUARY 13, 1978

#### KINNEY COUNTY CHILD WELFARE BOARD

Mrs. Cindy Cauthorn employed by the Texas Department of Human Resources, met with the Court and discussed the possibility of forming a County Child Welfare Board for Kinney County. Mrs. Cauthorn said that her office has worked with six cases of abused or neglected children in Kinney County and only two children have been removed from their home and put into foster home. Mrs. Cauthorn said that a contract between the State and Commissioners' Court would be necessary to form a Child Welfare Board. The Board would consist of seven to fifteen members appointed by Commissioners' Court and that she recommended a board of seven persons. Judge Seargeant recommended that the Court defer action until Wednesday, February 15, 1978.

#### BRACKETTVILLE VOLUNTEER FIRE DEPARTMENT

Mr. Eloy Garcia, chief of the Brackettville Volunteer Fire Department, met with the Court and requested the County pay \$600 toward the purchase of a new pump for the rural fire truck. Mr. Garcia said that the City had contributed \$500 and the total cost was \$1100.00 for the new pump. Mr. Garcia also stated the Fort Clark Springs Association had contributed \$300 to the Fire Department which was needed for installation of the new pump and repairs to the rural fire truck.

Commissioner David G. Luna moved that Kinney County pay the \$600 toward the purchase of a new pump for the rural fire truck. Commissioner G.C. Talamantez duly seconded the motion which passed unanimously.

After Presentation of the testimony, evidence and argument of counsel, the court finds that RALPH GONZALEZ is the Constable of Precinct 1 of Kinney County, Texas and has been such since January 1, 1977, that as such constable he is entitled to a salary of \$3,300.00 per year.

IT IS THEREFORE ADJUDGED

1. That Plaintiff, RALPH GONZALEZ, recover from the Kinney County, Texas, Commissioners'

Needless to say that Mr. Starzel and the Band Boosters were excited at the announcement time and very proud to present these to the Brackett Band.

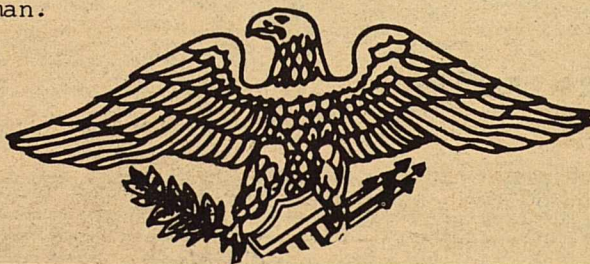

The annual Solo Ensemble Contest was held yesterday, February 16th in Uvalde at the Southwest Texas Junior College. The results will be reported next week.

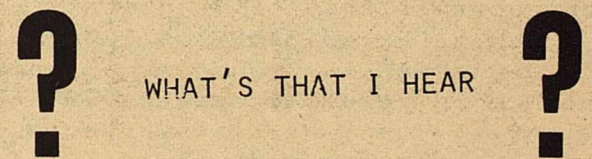


TIPS FOR GREEN THUMBS

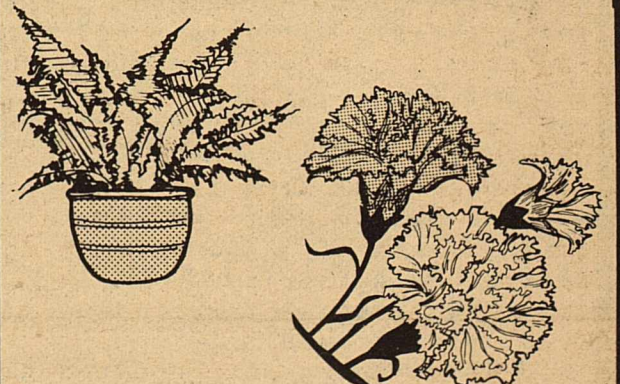

Court the sum of \$3,440.18 with interest thereon at the rate of 9% per annum from the date of rendition of this Judgement until paid.

2. That the Commissioners' Court of Kinney County, Texas pay such judgement forthwith from an current finds from which such a payment be legally made.

3. If there are no current funds available from which such payment can be made legally it is ordered that a peremptory writ of mandamus issue directing and commanding Defendant, Kinney County Commissioners' Court to perform immediately the following acts:

To levy and collect a tax sufficient to discharge this judgement and interest thereon.

4. That a peremptory writ of mandamus issue directing and commanding the defendant, Kinney County Commissioners' Court to pay RALPH GONZALEZ the salary of \$275.00 per month as and when it becomes due for the remainder of this term of office and until such salary is lawfully changed.

5. All costs are adjusted against the Defendant.

Mr. Robert Hutchinson and Mr. Don Frails, Texas Parks & Wildlife conservationists, met with the Court to go over possible changes in the hunting and fishing regulations for Kinney County in the coming year. Judge Seargeant reported that he had visited with County Agent Carl Esser and Mr. Esser said that 60% of the Kinney County 4-H lambs placed in the San Antonio Livestock Show. Judge Seargeant said that Mr. Esser was doing a fine job with the young people of Kinney County in 4-H work.

Judge Seargeant reported that Dr. Tat, a doctor from Vietnam, met with the Clinic Committee and expressed an interest in coming to Brackettville to practice when he gets a Texas medical license.

A dance and bingo are in the planning stages to be held in conjunction with the fair.

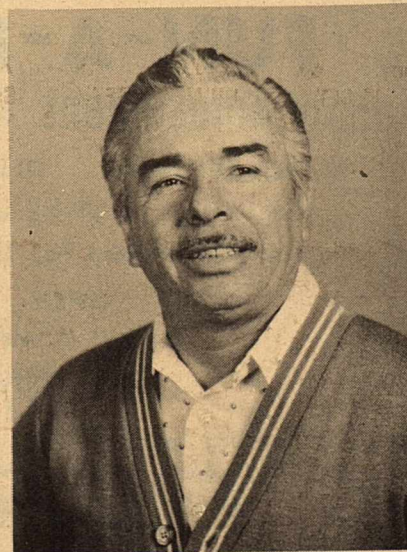

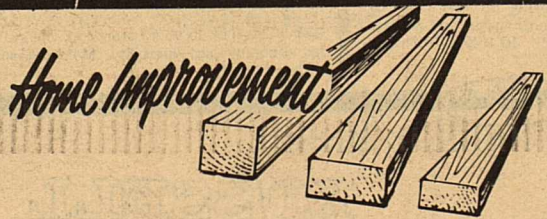
