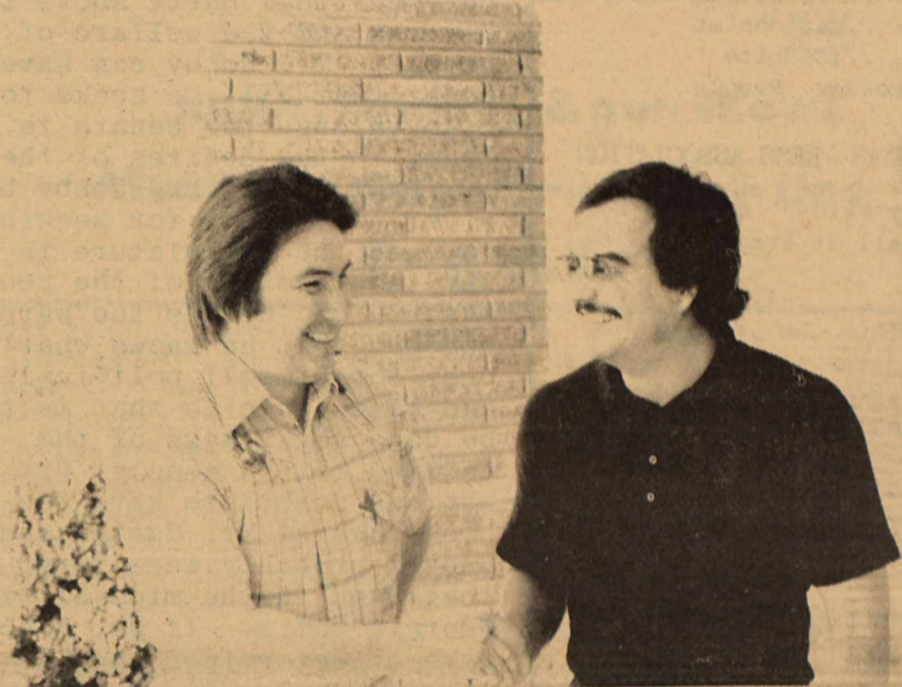

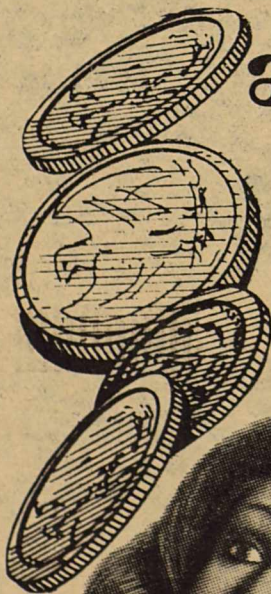

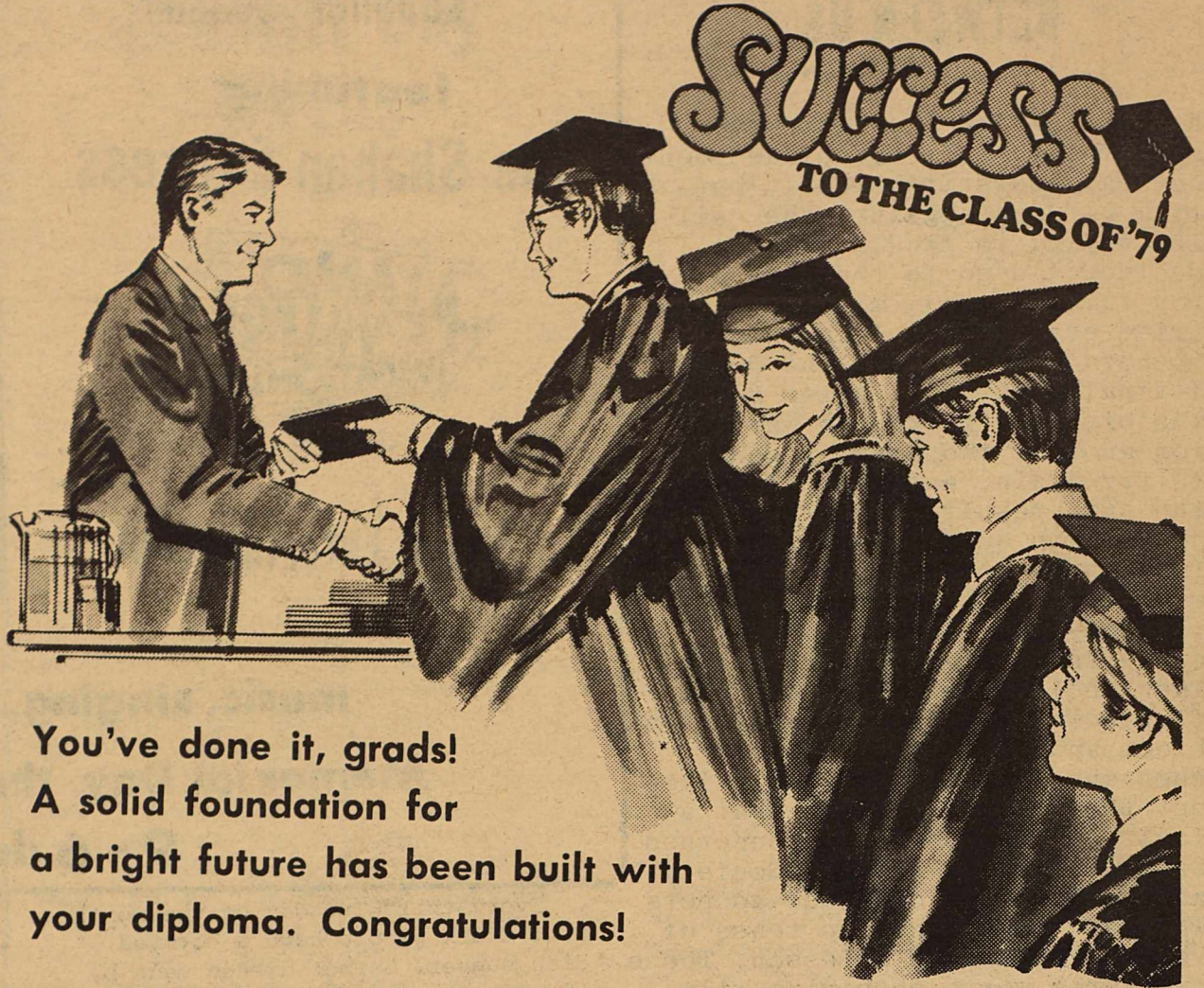

**FOREIGNERS OWNING U.S. FARMS
STIRS FUROR**

UVALDE--Except for farm prices, probably no other issue in modern agriculture is as emotion-charged as the furor over foreign investments in U.S. Farmland.

The apparent fear that Middle Eastern sheiks, laden with oil dollars, are gobbling up great chunks of land that produces our food has led many state legislatures to study this issue and pass legislation.
During is current session, the

Texas Legislature is considering several laws on the subject, the strongest of which would prohibit foreign investment in fam land entirely.

In debates over the issue, farmers generally oppose foreign transactions arguing that it bids yp the price of farm and ranch land and deters domestic farm expansion. Bankers, on the other hand, support the idea as a means to bring in additional dollars into the U.S.Economy.

The U.S.Senate Committee on Agriculture, Nutrition and Forestry, chaired by Sen. Herman Talmadge (D.Ga) joined the fracas this year by releasing results from a study the committee conducted in 1977-78.

The senate study sought information from all the states on several facets of the issue. Among the facets studied were the extent of foreign ownership causes of foreign investment; consequences of foreign investment and policy alternatives.

Although the study has been completed information on the extent of foreign ownership is still far from complete.

"Data available to us does inductate that many exaggerated misstatements about foreign ownership have been made," said Dr. Richard Floyd, a Texas Agricultural Extension Service econoist for real estate.

"The best information available on foreign owership indicates that in 1975, 4.9 million acres of land in plots of more than 200 acres were owned by foreign firms and individuals,"Dr.

Floyd said. "This was less than 0.5 percent of the 1.3 billion acres of private land in the U.S."

"There is no doubt that substantial foreign investment has occurred in this country sine 1975," Dr. Floyd siad. From January 1977 to June, 1978, 826,000 acres were sold to foreign investors nationwide.

"This reporesented 2.25 percent of the toal land sold during this 18-month period," the real estate economist said. "If we can assume that this 1977-78 period is representative of transactions from 1975 to the present, it means the in 1979, about 6.3 million acres of U.S.fland were owned by foreign interests. This is still less that one percent of private U.S. land holdings."

Dr. Floyd said that if projections were made at that same rate annually into the future," itwould take more than 20 years for foreigners to acquire ownership of an additional one percent of U.S. croplands."

The real estate specialist said foreign investors are favoring the Southern United States in their investment purchases. Based on the Senate Agriculture Committee study, 50 percent of the farmland purchased in this country in the 180month period under the study was bought in the South and Southwest.

"This still accounted for only 0.15 percent of the total farmland in this region," Dr. Floyd said.

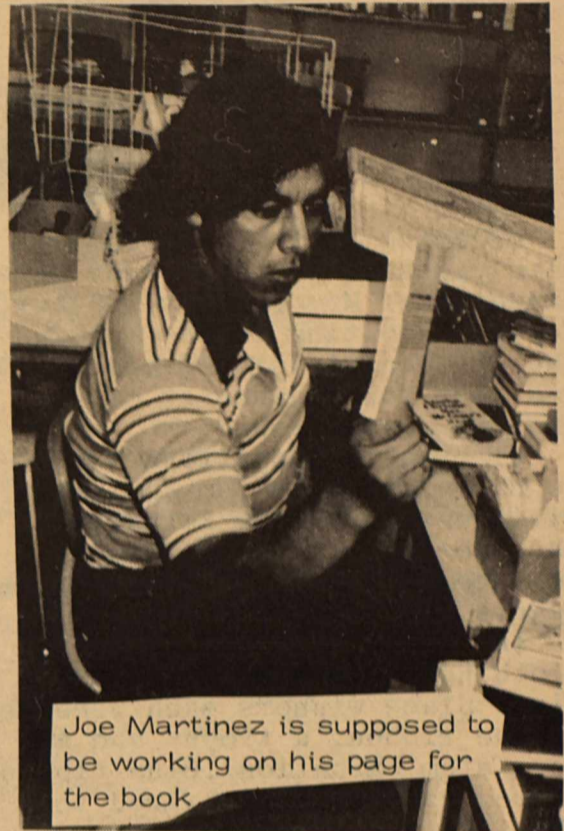

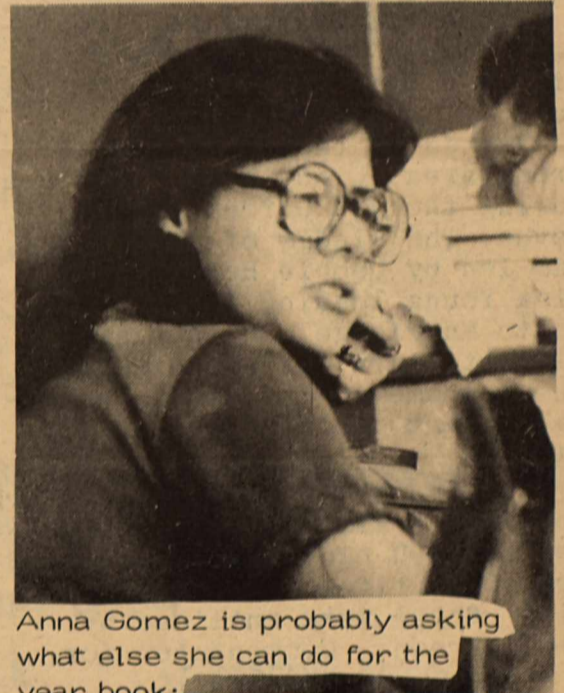

A barbecue will be served at the Southwest Livestock Exchange, and members will conduct a short business meeting at that time.

STAR was organized in 1973, as a volunteer development group interested in agricultural and family living problems and potential problems in the 19-county area generally known as Southwest Texas. 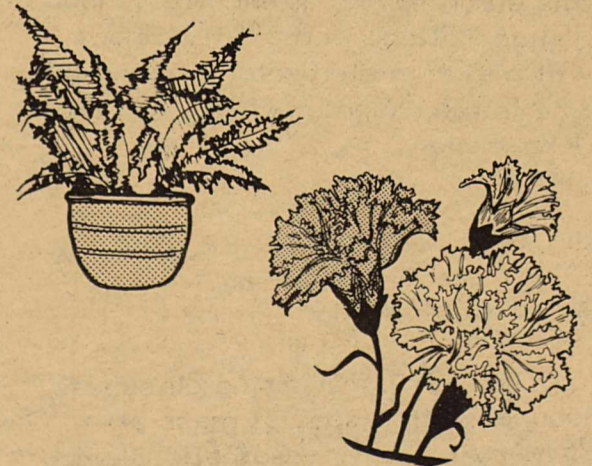

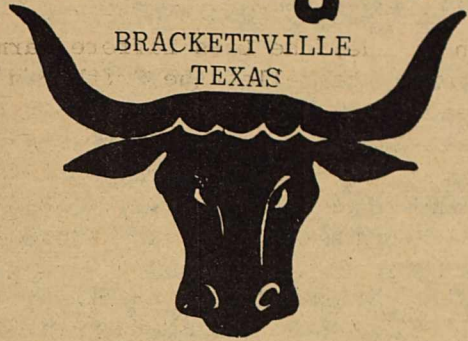


