The Brackett Independent School District will begin its new school year with the following:

Teachers will begin with a week of inservice and workdays starting August 27th, and concluding on August 31st. This week will include two days of inservice in cooperation with othe Community schools at Sabinal, Texas on Aug. 29th and 30th. Sabinal I.S.D. will play host to 14 other school districts.

Dear Mr. Chaulker,

As City Manager of The City of Brackettville, I have been instructed by the City Council to request a review of a recent decision by your company to remove your service representative from our City. Although this decision has been defended as an economic measure, we fail to see the economy in a 65 mile round-trip from Del Rio to Brackettville for a service call.

Our City is the County Seat of Kinney County with approximately 660 accounts within in the City limits and 140 accounts outside the City limits. We are a growing community, with a great need for "first class service," as an incentive for prospective industries and families to locate in our community. However, with the removal of a service representative from our community and county we feel that the impact from this move will be very detrimental to our progress.

Enclosed is a copy of a resolution adopted by the Brackettville City Council in January of 1976 concerning a proposed pull-out of your company personnel at that time. Shortly after this action our City was notified that there would be no pull-out of personnel then or in the near future.

At this time we respectfully request that this decision be reviewed and that we be notified officially concerning your decision. Thanking you in advance for your assistance. I am,

WHEREAS, Central Power & Light Company has heretofore contracted to provide "first class" service to the City of Brackettville and its inhabitants which will not be physically possible in the event such facilities are removed from the city, and

WHEREAS, the removal of such personnel and facilities will result in a deterioration of electric service to the City of Brackettville and will present a threat to the health, safety and welfare of the reseidnets of the City of Brackettville.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Brackettville:

1. That the City Council of the City of Brackettville is unalterable opposed to the physical removal of personnel and facilities of Central Power & Light Company from the City of Brackettville.

3. That a delegation of the City Council be directed to personally deliver an executed copy of this resolution to the management of Central Power & Light Company.
4. That copies hereof be forwarded to appropriate members of the State Legislature and United States Congress.

You can depend on the word of your utility company. This is one of the most blatant myths in current days. Not long back CP&L committed the company to maintaining an office and service man in Brackettville. Now the company says (according to Mr. John Crutchfield-Del Rio Manager) that there is no way CP&L will be "intimidated" and there definitely will "not" be a service man here. He avows this will be no problem because service will be maintained at the same level as though there were a service man stationed here. Just this week another glaring example giving the lie to these promises. A customer installed a meter loop and needed service to be connected. It was a simple matter of splicing three wires. The task would take no more than fifteen minutes at the most. He was first told it would be done "after" two days. After some rather straight talk it was done after a day and a half. It is a sad day when it takes two days to get a fifteen minute job done. However, when we must depend on service men from Del Rio this kind of service will come to be "good service!" The man had to spend enough time on the road to and from Del Rio to do at least seven jobs such as this one to say nothing of the cost of driving a company truck to and from Brackettville to Del Rio, Unless the people of Brackettville make themselves heard loud and clear we will soon become victims of poor electric service dictated by a manager living in Del Rio and caring less about the "small town" of Brackettville with some 800 plus customers.

## ENERGY-EFFICIENT HOME MEANS LOWER ELECTRICITY BILLS FOR UVALDE COUPLE

**M**r. and Mrs. Boots Moore have nearly 4,000 square feet of living space in their all-electric home on Highway 90 East in Uvalde.

Good insulation in the ceiling and walls helps keep heat out of the house during the summer and inside during the winter.

Since the family can turn on a system specifically for the zone in use, there is no need to heat or cool the entire house.

Chuch Synder, director of the Laredo Chamber of Commerce Convention and Visitors Council, is acting as host to the Englishmen while they take a brief tour of the Lone Star State.

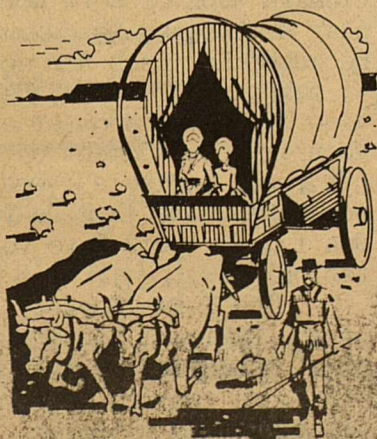
The tour included a visit with Governor Clements, and to Houston, Johnson City, Pleasanton, Fredericksburg and Castroville.

### TEXAS SOCIETY TO PREVENT BLINDNESS

Bryan Mauk, a five year old soccer enthusiast from Fort Worth, has been selected as the 1979 Prevent Blindness Child. He is one of the more than 36,000 Texas youngsters who were given vision tests last year by volunteers trained by the Texas Society to Prevent Blindness. When Bryan failed his screening, he was referred for a professional eye examination where it was discovered he suffered from amblyopia or "lazy eye!"

"In amblyopia one eye functions better than the other so that sight is gradually taken over by the strong eye while the weaker one becomes virtually useless," explained John V. Mumma, M.D. San Antonio ophthalmologist who is chairman of TSPB's Preschool Vision Screening Program.

"At the time Bryan was examined the vision in his left eye tested 20/400 But three months later with glasses plus the patching of his good eye to force the "lazy eye" to work, his vision improved to 20/30"

"This enormous improvement can only be attributed to early detection," he went on. "In that, Bryan is lucky. Too often amblyopia isn't caught in children until too late to be corrected because parents don't realize--as the Mauk's didn't--that children do not know whether or not they are seeing as well as they should and so don't complain."

"An estimated one in every 20 children has an eye problem that can be best corrected in the preschool years," he said, "For this reason we encourage parents whose children have never had a vision test to send for the society's Home Eye Test for Preschoolers. The test can alert parents if their child needs the professional eye examination that the society recommends all children have before entering school. For the free test, write Prevent Blindness, P.O.Box 2020, Austin, Texas, 78768.

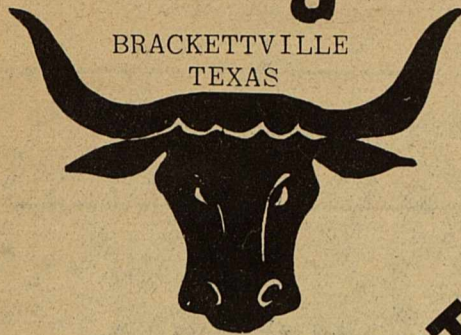
Bryan is the son of Dr. and Mrs. Richard Mauk of Fort Worth. He loves to play soccer and is proud of his glasses because they help him see things that "I never saw before," he says. He's also become a booster of vision testing. When friends comment on his new glasses his ready reply is "I wear them so I won't be blind. How do you know if you don't need them? Have you ever been tested?"

The Texas Society is an affiliate of the National Society to Prevent Blindness, established in 1908 to prevent blindness through service programs, education and research.

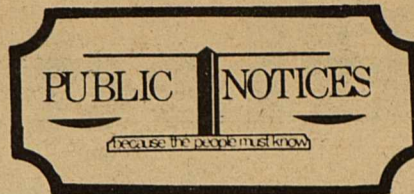
