viously the all-time high with 2,128 students, but this semester total enrollment reached 2,280, a 7.14 percent increase over spring 1979.

A breakdown of students into the campuses they are attending shows the Uvalde campus with 876 day students and 223 night students, and the Del Rio campus with 651, an increase of 83 students from the fall semester total.

Eagle Pass enrollment increased to 311 from fall's 305, and the Crystal City total rose from fall's 26 students to 67 for spring. Carrizo Springs had the greatest increase, from the fall semester total of 19 to the spring high of 71.

Dilley increased from 27 to 58, and Aserton has a total this semester of 23.



Miss Elvia F. Fuentes, Manager of the Eagle Pass Social Security Branch Office, reminds all employers that copy "A" of each Form W-2 they prepare for their employees, must be mailed by February 29, 1980, to the Social Security Administration, Albuquerque Data Operations Center, Albuquerque, New Mexico, 87180.

Form W-2 is a dual purpose report. It is used by the Social Security Administration to credit FICA wages to employees, and it is also used by the Internal Revenue Service for income tax reports. The FICA wages reported on Form W-2 determine the worker's future entitlement to Social Security benefits. Each employee is urged to review the W-2 to insure the name, social security number, and amount of wages is correct. Any error should be reported to the employer for correction.

we still do not meet are:1) a paid librarian, 2) \$5,000 per year minimum budget.

At this time the librarian and all library aides are working stictly on a volunteer basis. Our present budget is \$3000 a year--\$2,500 of this is Federal Revenue Sharing Funds and \$500 memorials and gifts. By law the county could appropriate \$16,000 of its county tax money to the library. That could pay a librarian and running expenses. Even so, there would still be a need for volunteer library aides. With the enthusiasm and growth of the Friends' membership, their voting power should be terrific. Four hundred or so Friends' votes might persuade some of the \$16,000 for a paid librarian. Had the county been paying these librarians since the library began, it would have spent around \$49,000 (minimum wage) for the two librarians. It doesn't seem like asking too much of the county commissioners to return some of the good faith and services of these dedicated women by providing enough finances for our county library to meet state requirements.

If you agree with us, then take a moment to write a letter to your county judge and/or commissioner. It's your library. You can choose to do nothing and watch it go down the drain, or you can speak out and watch it grow. The future generations of Kinney County are counting on you to protect our educational resources.

It is now time to trim trees. If you have an old tree with a great deal of dead wood in it, the most charitable thing you can do is to severly prune the tree. You may need to leave only short stumps of the major limbs. Almost all trees need to be trimmed. Mulberry trees need trimming more than most because they have a tendency to produce long ungainly limbs that spread widely and hang down. The shape of the tree is determined by the trimming. By all means all dead wood should be taken out of the tree. ny limb that conflicts with another limb should be removed. All cuts should be clean cuts entirely through the limb with care not to peel or tear the base remaining. All cuts opinion. should be at a slant, that is, not parallel to the earth. If the cut is clean and at an angle there is no need to paint or treat the wound. If done immediately, the wound should seal over before the sap beings to rise in the tree. In this area we do not get enough rain to cause the stumps to rot. Nor do we have enough insects and disease to endanger the wound. Nature will take care of the tree. Your tree will have fuller foliage and be much healthier if properly trimmed.

## Sheep & Goat Raisers' News

Indication from Interior Secretary Cecil Andrus' office are that Andrus' original decision to cancel further research into predacide 1080 will stand. There had been some optimism that positive research data recently brought to the Secretary's attention might reverse that decision.

At a mid-January "predator summit" meeting in Austin, Andrus told stockmen that his decision was the result of heavy public controversy over 1080's alleged environmental hazards, specifically claims by environmentalists that the toxicant posed a threat to animals scavenging its victim's carcasses.

At that same session it became apparent that Andrus was unaware of research that casts severe doubt on the secondary poisoning claim. His public information officer, Harmon Kallman, says however, that Andrus has



since been apprised of that data but has refused to alter his opinion.

The Secretary still maintains, Kallman adds, that emotional opposition would make public acceptance of 1080 a long uphill battle and that research funds could be better spent developing a new toxicant instead.

Considering all the evidence in favor of 1080 and the lack of any sound data supporting the charges against it, responsible biologists and stockmen insist that any controversy over the compound is either unfounded, intentionally fabricated, or both. Consequently, they question how any substitute toxicant can be expected to meet with

less opposition. Andrus has so far avoided a direct response to that question.

Another major but unanswered question is how Andrus can expect any new, probably so-far undeveloped toxicant can be researched, herded through the tangle of federal red tape and put into use more quickly than 1080, considering its 30-plus years of documented field use. Consequently, many observers suspect the real motive behind cancellation of further research is simply another attempt to avoid the use of an effective predator control toxicant. The research ban, coming as it does just when studies have begun to turn strongly in favor of 1080 and against the official federal policy line, is also seen as an attempt to stifle further embarrassing scientific revelations.

There is still at least one more unanswered question, and it is sure to fuel further controversy. When it was revealed at the Austin predator session that Andrus was unaware of the most recent 1080 research, some observers wondered how fully interior's staff was passing along information reflecting positive aspects of studies on the toxicant. It was pointed out that basic findings of the secondary poisoning research, cordinated by U.S. Fish and Wildlife Service biologist Guy Connolly, were available as early as September to those attending a Texas Sheep and Goat Raisers' Association meeting.

How, it was asked, could that information not have been made available to Andrus, engaged even then in final deliberations over 1080's future? Connolly has since stated that the findings were only part of what was to be a more extensive series of tests, and thus were not officially transmitted up the channels to Interior's hierarchy. That would probably have put the matter to rest, had it not been for what may yet prove to be an embarrassing slip by Interior staffers.

Interior's Kallman, when later asked by a reporter whether Andrus had yet heard of the study, volunteered that it "sounded like the same old story" that top-level staffers had been laughing about for quite some time. He was incorrect about some of the most basic details of the work, but nevertheless professed to have known of its existence.

That leaves at least three possibilities: 1. Andrus himself was aware of the secondary poisoning study but chose to act otherwise, probably the least likely possibility. 2. Andrus' office staff was aware of it but chose not to tell him. 3. Kallman, caught off-guard, felt that admitting ignorance of such relevant information would reflect badly on Interior and so attempted to present a more efficient picture of the agency.

Discounting the first possibility, this still leaves considerable doubt about the veracity of Andrus' staff; neither concealing the information from Andrus or attempting to mislead the public can be considered proper behavior.

The Texas Sheep and Goat Raisers' Association believes there are several questions that deserve much more complete and sincere answers.

On February 3, 1945, three years and six days after the capitol city of the Phillipines had been abandoned in the face of the Japanese onslaught, victorious American and Philippine forces hoisted the colors over Manila making good the promise of General Douglas MacArthur who swore, "I shall return!"

"We shall return" --- On January 31, 1980, a detachment of AMVETS will leave San Francisco International Airport and embark on an expedition to officially represent all American veterans at the two week long celebration of the 35th Anniversary of the liberation of Manila.

Led by National Commander Joseph R. Koralewski and his wife, the AMVETS delegation can Expect to be well feated with receptions, parades and tours hosted by the Phillipino Government. Wallace Sheppard, National V District Commander and Don E. Peavy, Sr., Commander of AMVETS Post #57 in Fort Worth, will represent Texas AMVETS during the tour.

"AMVETS is deeply honored to stand as the official representative of America's veterans organizations on this historic occasion," said Koralewski. "Many of us returning, were among those who liberated the city of Manila and once again we express our support of the aspirations and goals of the Phillipino people."

Commander Sheppard said that anyone wishing to send a message or a gift to the Phillipino government in honor of this auspicious occasion may do so by sending it to AMVETS, P.O. Box 14409, Fort Worth, Texas 76117 or tee on Dairy and Poultry of the by calling 817/834/3925.

"In view of surmounting international crisis, perhaps now, more than ever, is a time to renew and strengthen our ties with our allies. I call on all Texans to help us carry a message of love and best wishes to the Phillipino people as they endeavor to maintain the freedoms we Americans helped them to obtain," said Commander Sheppard.

5. The Beef Board must turn in a budget to the Secretary for his approval and must justify amounts spent for advertising, research, sales promotion and consumer information.

6. No funds collected by the Beef Board can be used to influence government policy or action.

7. Foreign meat cannot be assessed because foreign producers will not be represented on the Beef Board. Since imported meat makes up a large percentage of the beef consumed in the United States, American ranchers would actually be advertising foreign beef at their expense.

Roy Wheeler, ICA president, said that cattle producers who vote in favor of the Beeferendum are inviting the government into their private business.

An administrator with the USDA admitted at a hearing Oct. 16, 1979, before the subcommitCommittee on Agriculture in Washington, that producers who enter a promotion program of their products, enter into a partnership with the government.

The following is a direct quote taken from Barbara Lindemann Schlei, administrator, Agricultural Marketing Service, USDA, at the Oct. 16 hearing: Ms. Schlei: "While industries

would like to have the greatest possible alternatives available to them, they have a recognition that when they enter into a program such as this, in partnership with the Government, that that in turn does bring with it certain restrictions.

simple majority of those voting must favor the program.

After a thorough investigation of the pros and cons of the Beeferendum, the members of ICA at the 5th annual convention this past summer voted overwhelmingly to oppose the Beeferendum.

ICA opposition is based primarily on these points:

1. The Beeferendum would allow the U.S. Department of Agriculture as a bureau to grow larger, more unwieldly and unresponsive to ranchers' needs.

2. If the program is implemented, the Agriculture Secretary would be able to appoint members to the Beef Board from eligible organizations.



### Watching Washington

We all know the fable of the grasshopper and the ant. The grasshopper lived for the moment, spending all his time and money having fun. The ant, on the other hand, worked hard and set a little something aside.

When winter came the ant was able to get by on his savings while the grasshopper, who had saved nothing, was left shivering and hungry out in the cold.

For many years now, even as individual American parents told their children the story of the ant and the grasshopper, trying to encourage them to save, U.S. government tax policy has had the opposite effect.



A popular and prevalent theory among economists has been that one of the factors causing the Great Depression of the 1930's in this country was excessive savings.

According to this theory Americans were saving too much and spending too little and this helped bring on the hardships and dislocations of the depression.

The theory may, or may not, have been valid 50 years ago. In any event it most certainly has no validity today. Americans are assuredly not saving too much today, yet tax policies that discourage savings and encourage consumption continue in force.

Let's look at the record.

Last year we saved only 4.5 percent of disposable income. That was our lowest savings rate in 30 years.

By comparison, the Japanese are saving at a rate of 25.3 percent. The French save at a 13.1 percent rate. Even the British rate of savings, at 6.6 percent exceeds ours.

Inflation, of course, does make it difficult to save. Prices in this country rose last year by more than 12 percent. With savings accounts paying interest rates of only 5 or maybe 6 percent you can't make much headway in a time of double-digit inflation.

Yet, other countries are suffering the ravages of inflation, too, and their savings exceed ours, so inflation can't be the sole cause of our situation.

The problem is that on top of inflation the thrifty American must also pay an income tax on the 5 or 6 percent interest earned in a savings account.

As Chairman of the Joint Economic Committee of Congress I became convinced some time ago that it is vitally important that government come up with incentives to encourage Americans to substantially increase their rate of savings. It is important for two reasons.

We had a baby boom after World War II, but in recent years birth rates have declined. As a result, at some point fter the turn of the century the ratio of retired peoplepeople who depend on savings, Social Security and pensions-to people who are actively working, will increase substantially. It is projected that the ratio will jump from approximately one retiree to every 31/4 workers to one retiree for every two workers.



Because of this we need to see a large increase in the rate of savings, instead of the decrease that has occurred over the past several decades.

A second important reason to increase the rate of savings is that this can help dramatically in the fight against inflation. Increased savings means increased capital which means increased productivity; and productivity is one of the most important factors in our efforts to hold down the cost of living.

The Senate has approved, 94-4, the Bentsen small savers incentive bill which begins the process of reversing tax policies that penalize saving.

This legislation would exempt from taxes the first \$200 a year in savings account interest-and investment dividendsfor an individual; the first \$400 for a married couple filing a ioint tax return.

This bill was approved as an amendment to the windfall profits tax and while it may be cut out of the final version of that bill, its overwhelming approval by the Senate gives strong indication that in coming months, in some form or other, this incentive to save will be passed into law by the Congress.

The small savers incentive bill helps put government tax policy on the side of the ants instead of the grasshoppers. It will be an economic bonanza for America and for Americans.
