actually had the disease has never
survived.

According to our local
Veterinary, Dr. Zack Davis, it
is not only dogs that carry the
disease, but other animals such
as: cats; foxes; racoons; skunks.
In fact any warm blooded animal
can carry the disease and pass it
on to humans.

Lets hope that our County
Commissioners' not only adopt the
State's new law but ENFORCE IT!!

Laws are to be enforced--another
myth. Ther is now a great flap
about the demand that the Ameri-
can taxpayer pay for the education
of illegal aliens within the
United States. The very agency
that is charged with enforcing
the law is using taxpayers money
to try to gain judicial legisla-
tion to force this. It is a simple
problem with a self evident so-
lution. If there are illegal alien
in this country there are laws
that specifically state they are
to be deported. If they are known
why does not the Justice Depart-
ment arrest them and deport them
to the land of their citizenship?
By What Constitutional authority
can the Justice Department refuse
to enforce the law? By what legal
authority can they use money
exacted from tax paying citizens
to force an additional tax burden
in order to educate children whose
educational responsibility be-
longs to their native country?It
is a prime example of rule by
bureaucracy to try to gain votes
for politicians. If these illegal
aliens want their children to
benefit from the oportunties of
the United States why do they not
follow legal processes and become
legal aliens or citizens of the
United States? When we lived in
China, though we were legal aliens
we did not expect the Government
of China to educate our children
We assumed the full responsibility
ourselves. If illegal aliens
were people of integrity (of
course they are not or they would

not want some other nation to as-
sume the responsibility for edu-
cating their children. To see the
Justice Department parade an
eight year old girl before the
court to tell the judge she was
learning at home because her
parents wouldn't pay tuition
for her to go to school in a
foreign country. When it is brought
out she could have been legally
in school without paying tuition
it shows even greater mocking of
good ethics and morality. There
should in truth be no problem in-
volving education of children of
illegal aliens because if the
law were enforced the illegal
alien would be deported to his
own country--whether it be Mexico,
Iran, Salvador, Columbia or wher-
ever.

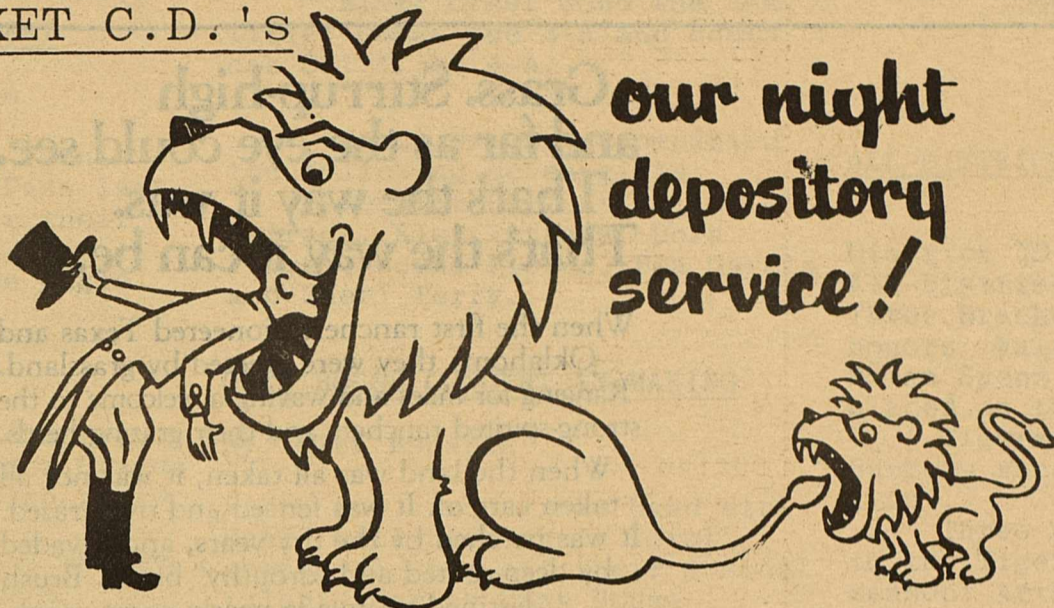

#### SOCIAL SECURITY NEWS

A victoria, Texas man was sentenced in Federal Court Thursday, on a charge of defrauding the Social Security Program, according to Miss Elvia F. Fuentes Manager of the Eagle Pass Social Security Office, Miss Fuentes said J.P.Young was sentenced in the U.S. District Court, Corpus Christi, Tx. to five years confinement and four years supervised probation.

The confinement was suspended on the provision that he refund the \$5,760.50 he illegally obtained. Young pled guilty on January 7th to a charge that he made false statements to the Social Security Administration in order to continue to receive Social Security checks on behalf of his mother, who was deceased, Miss Fuentes states. Miss Fuentes said the Young case was developed by a unit of full time investigators who are assigned the job of uncovering Social Security fraud in the five-state Dallas region.

Forecasting is always risky, but I see signs that we may have a general tax cut before the year is over. There are fears that such action now might feed inflation, but there are

prospects for tax reductions with enactment of the \$277.3 billion "windfall profits" tax that emerged last week from a House-Senate Conference Committee.

One element would be to exempt from Federal taxes the first \$200 received by a tax-

payers in interest or dividends. This, of course, would mean a \$400 exemption for a couple filing a joint return. The planners propose a total tax reduction of 60 percent of the "windfall" revenues, or \$136 billion, with the Congress to determine what other taxes would be cut.

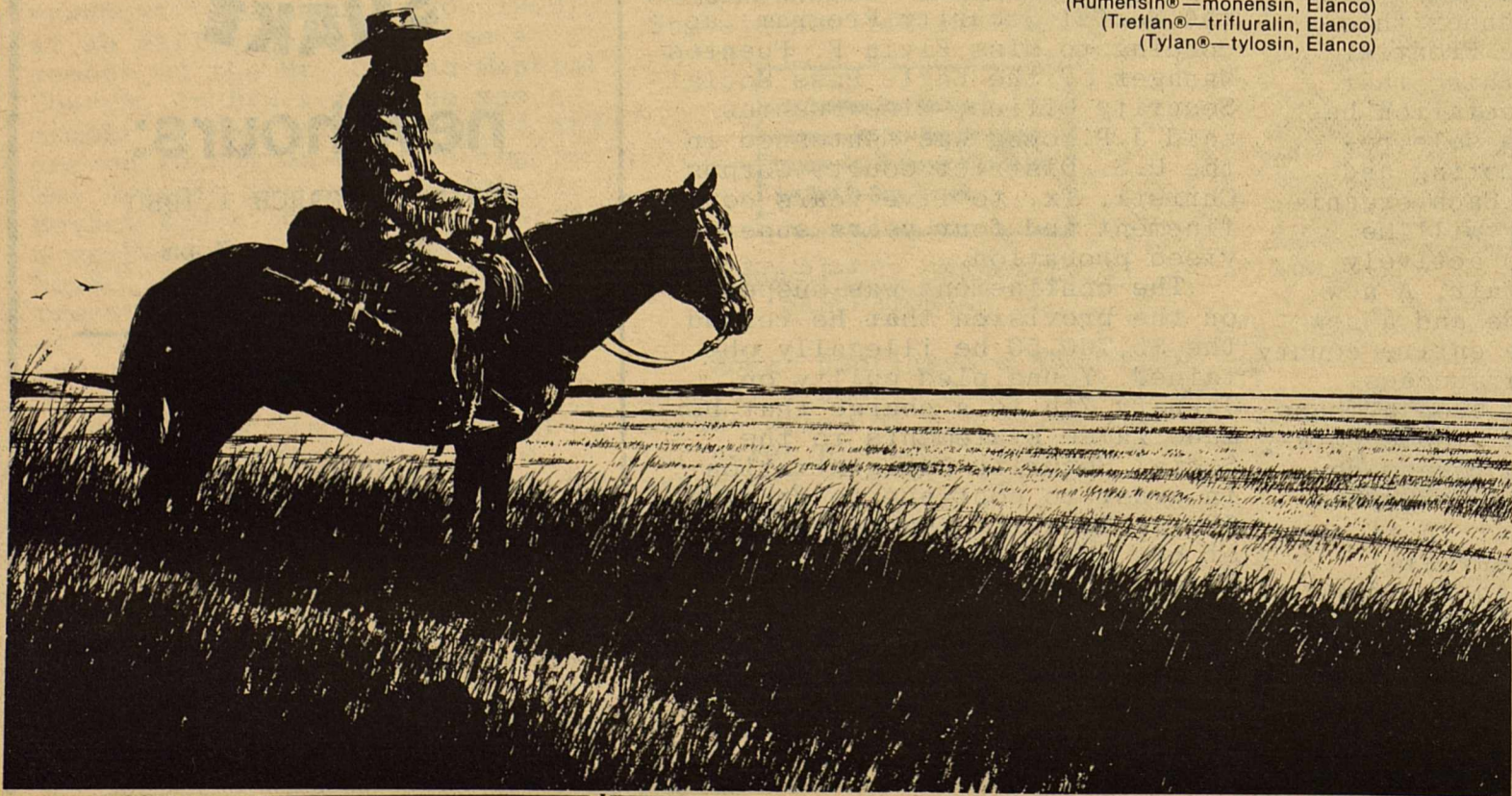

A 25 percent portion of the new revenues would reimburse lower-income persons for part of their higher fuel bills. The remaining 15 percent, or \$34 billion, would provide government grants or loan guarantees for unconventional energy sources and for improvement of the Nation's transportation system to reduce the use of private automobiles where possible.

### HELP 18 MILLION FAMILIES

The Conference Committee's experts estimate that 18 million families would get the aid on fuel bills. Early in discussions it was proposed to aid the "working poor", but instead the plan now is to help those families near the poverty line.

The Administration hopes to provide adequate stimulus for more domestic production of fuels by phasing our Federal price controls with accompanying decline of imports. I continue to believe that more domestic production is essential to the Nation's future.

In another action last week, President Carter maintained his strong personal opposition to wage and price controls, advocated by some as the best way to fight inflation. He said he believed any congressional action proposing to give him such authority would be held up for months by a Senate filibuster.

### SEES DANGER IN THREAT

The President and his advisors believe that if there is a prospect of such Congressional action, the result

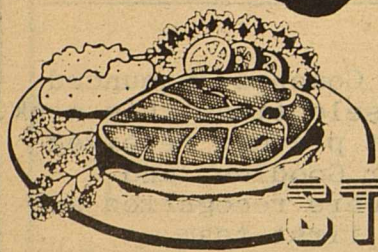

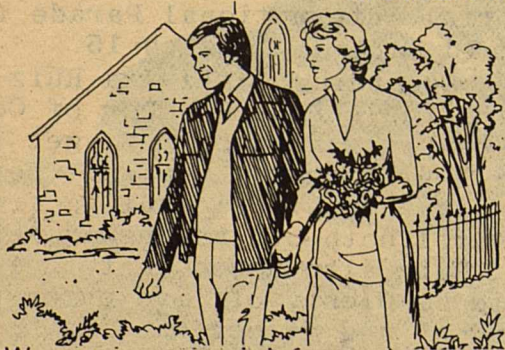

### KINNEY COUNTY 4-H SHOW CHAMPIONS AT HOUSTON AND SAN ANTONIO

Kinney County 4-H members have walked with many championship honors recently at the Houston and San Antonio Livestock Shows. Kinney County 4-H member Kevin Kaplan exhibited the champion lightweight finewool lamb at the Houston Livestock Show last Thursday. The lamb sold for \$80.00 a pound. Then just approximately one hour later another Kinney County 4-H member, Toby Frerich, exhibited the champion medium weight finewool lamb that sold for \$65.00 a pound. Both lambs were bred by Double R Ranch of Brackettville.

Kevin, a six-year 4-H veteran is the son of Molly Ardrey. Toby, his second year in feeding lambs is the son of Mr. and Mrs. Tony Frerich.

Also, Doug McCarty, son of Missy McCarty, of Brackettville, was the recipient of the Ruth Hilderbrand Memorial Lamb Scholarship given to the most outstanding graduating senior who exhibited a lamb at the Houston Livestock Show. The \$1,500 scholarship is awarded to the most outstanding senior in the lamb show based on leadership, character, and citizenship qualities.

Earlier in February at the San Antonio Livestock Show, Leisha Wardlaw, daughter of Mr. and Mrs. Hadley Wardlaw of Brackettville, exhibited the champion finewool crossbred lamb of the show. It sold for \$3,000. Also, at that time, Phillip Benites, of the Brackettville FFA Chapter exhibited the champion finewool lamb that sold for \$3,800.

Wednesday before last there was an executive committee meeting of Friends of the Library where participation at this month's County Commissioners' Meeting was discussed. It was decided to circulate a petition to the effect of requesting a suitable budget of the county to fund a paid librarian and maintenance expenses for the county library; also requesting follow-through action on provisions for completion of a new building. All county citizens and library patrons are requested to sign this petition in a show of support for their library's future. Let's not let the unthinkable happen! If we lose our library it will effect the adults and children who checked out 4,210 volumes of hardback books, 900 paperback books, 170 periodicals, the 471 viewers of multimedia kits, filmstrips, video cassettes, and puppet shows the 2,780 viewers of films, the 40 students whose reference questions for school papers were answered, the 1,231 persons attending library programs and the persons who used the library to request 130 Interlibrary Loan Books--all of which were used during the county fiscal year October 1, 1978--September 30, 1979. This does not include the additional people who will begin to use the library this and future years, nor does it include those who may be influenced to locate their families here with

the hope of furthering their knowledge and offering them a continued source of entertainment.

Recently Miss Sauer and Mrs. Golemon attended a Budget Workshop held at the San Antonio Public Library for District 10 Libraries. It was concluded at the meeting that, because of escalating costs, District 10 would have to cut their budget by \$9,000.00 in order to continue our Interlibrary Loan System. In support of this it was voted to do away with the free Speakers Bureau Service. Also, it was decided that the San Antonio District 10 System would not be able to replace those film projectors loaned out (such as the one our library has) but has contracted to have the system film projectors checked each 6 months and kept in full repair. This is the third workshop Miss Sauer and Mrs. Golemon have attended this year as a requirement for their temporary librarians license and to enable our county library to qualify (at least for now) for hundreds of dollars of state funds for the purchase of books and records. These ladies love their work, but will not always be able to perform. 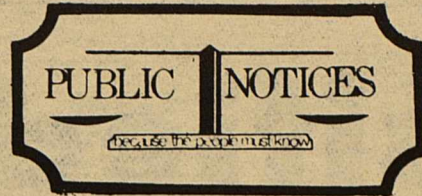

would be a wild turbulence of efforts to change labor contracts and product prices before the new authority could take effect, with great danger to our economy.

Selective credit controls are getting consideration by some major government economists. They advocate increasing the amount of down payments for installment purchases or shortening the time allowed for payment of consumer and business loans. One advocate is Alfred Kahn, the President's chief inflation fighter, who has said he would quit before he would help administer general wage and price controls.

I am pleased that the Budget Director, James McIntyre, told the National Governors Association last week that he thinks we should balance the budget as soon as possible. I have proposed

legislation to whittle down the debt and with it the present interest burden that costs us almost \$200 million a day in interest alone. I know that budget balancing cannot be achieved suddenly without disrupting government service and credit, but I wish wholeheartedly that a start could be made.

Kathy Gulick, tax assessor-collector for the Brackett ISD School District, today announced the availability of a new 12-page pamphlet which may help district residents save on their property taxes.

According to Ms. Gulick, the pamphlet explains how the property tax system in Texas operates, and highlights possible tax savings available to citizens.

The publication was developed by the State Property Tax Board in accordance with the provisions of Senate Bill 621, passed by the Texas Legislature in 1979.

Ms. Gulick noted that homeowners are eligible for a \$5,000 school homestead exemption, and that certain disabled persons and those aged 65 or older may qualify for additional exemptions from the value of their property.

Also, farmers and ranchers have the option of having their agricultural land taxed at its productive rather than market value.

To qualify for exemptions and productivity valuation, however, application must be made to the school tax office before the district's rendition period ends on April 1, 1980.

"District residents are encouraged to review the pamphlet and make application for all tax relief to which they are entitled before the rendition period ends," Ms. Gulick said.
