

KC RANCH TOUR/FIELD --OCTOBER 5TH

BRACKETTVILLE--A Range/Wildlife Field Day and Tanch Tour for area ranchers will be held Monday, October 5, in Kinney County according to Carl Esser, Kinney County Extension agent.

Esser says participants will have the opportunity to take a close look at range land that has been treated with combinations of roller chopping and Graslan herbicide applications. These pastures are used for livestock and wildlife production.

The tour begins promptly at 8:30 a.m. with coffee and registration at the Joe Kerr Ranch located about eight miles southwest of Brackettville off Ranch posted.

Parts of Kerr's ranch were roller chopped last spring and reseeded with different grass varieties. A comparsions of tandem and parallel roller chopping results can be observed.


Next stop on the tour is at the Hadley Wardlaw ranch where roller chopping plus effect of Graslan herbicide on tar brush can be seen. also be observed is the grazing land where Graslan was used in conjunction with roller chopping compared with land that was treated with the herbicide but wasn't mechani-

cally treated.

The tour then proceeds to the Clyde Earwood Ranch for a closer look as white brush and ceniza that was treated with Graslan. Brush control prac tices related to wildlife management will be emphasized at this ranch visit. Lunch will be served to tour participants at the hunting lodge on Earwood' ranch courtesy of Elanco Chemical Company and Pogue Seed Company-



Allamanda cathartica (golden trumpet) is a climber with yellow flowers, and it is best suited for plant windows. Glossy, dark green leaves are about 4-6 inches long and 1½-2½ inches wide, and the flowers consist of a 1 to 1½ inch long tube flaring into five petals that span 5 inches. There is a compact variety: Grandiflora and Henersoie, whose buds are reddish brown before turning yellow

Proper Care: Light--provide bright light, with three or four hours a day of direct full sun. Temperature--warmth (at least 60

degrees) and high humidity are essential. Watering-during the active growth period water moderately. During the winter rest period vater sparingly. Feeding-apply standard liquid fertilizer.

Special Note: In late winter cut plants back by as much as two-thirds.

Two new strategogies to inof the library facilities at Southwest Texas Junior College were recently announced by Mrs. Billie Noguess, new Library Division Chairman at the college.

"we have had many requests from students, particularly those who attend calsses at our off campus centers, to open the library on Saturday's", Noguess said. during the month of October will "we have also had problems with students failing to return books, which, of course, causes a shortage of materials available to other students.

"We will open the library on Saturday, October 3, from 10 a.m. to 3 p.m. in an attempt to determine exactly how many students would actually take advantage of l ibrary hours, and will declare the entire month of October "Amnesty Month" on library fines in an attempt to recover the overdue books," she continued.

Noguess "strongly encourages" students desiring Saturday library hours to show up on October 3, not only to take advantage of the extended hours but o demonstrate the need for Saturday hours in the future.

Inflation and cataloging costs have caused the "overdue books problems" to become a crisis.

"We have 450 books out," the library chairman asserted. "If

She continued to emphasize t hat the SWTJC library is very serious about reclaiming the misscrease the availability and scope ing books, pointing out that state law protects library property and that legal recourse will be used as a last resort.

"Students now possessing overdue books who are afraid to return them because of the fine or embarassmanet involved now have a golden opportuntity," Noguess said. "Over due books returned be acceeted with no questions asked.'

KINNEY **COUNTY LIBRARY**

Dear K.C.,

Wednesday night, Sept. 23, there was an open forum meeting where Mr. Quinton Etzel, attorney for Kinney County in the Library case, was present and available to the people of Kinney County to explain the trial process as it applied to our case and to bring us up to date on what has been -- and is being done to forward this process.

We were told that the Performance Bond addegedly supplied by Allied Fidelity Ins. Co. was, "not a bond--it was a piece of paper that looked like a bond--that felt like a bond, but, in fact, was not a bond." and that the agent who supposedly sold the bond to the contractor told our attorney he had never reported it to the company (Allied) and it was something he did as a matter of convenience for his friend the contractor. (The architect is responsible for seeing that proper bonds are filed.)

Basically, we have ended up with two law suits. The first, a Federal case filed by Kinney County in which it will be determined whether the Bonding Co. will be held liable; thus determining who can be suedfor damages in the District Court.

Mr. Etzel told us the depositions have been taken and the case is ready to go to trial; and that now it is up to the Federal Judge Shannon, our newly appointed judge, to get this on his dockett "when convenient".



they fear that the identities of agents and the degree of cooperation between our nations may be made public.

Legislation to protect the identities of our covert agents may hardly seem necessary to the great majority of Americans who would never consider harming our country or placing the lives of its agents in danger, but consider this:

----Former CIA agent Phillip Agee
has written two books which revealed
the names of over 1,000 alleged CIA
agents. A magazine, Counter Spy, iden
tified the CIA station chief in
Athens, Greece. This man, Richard
S. Welch, was subsequently murdered
in front of his home.

-----Covert Action Information Bulletin, which succeeded Counter Spy, claims to have disclosed the names of over 2,000 CIA agents. The home of a U.S.Embassy official in Jamaica was attacked by submachine guns and explosives less than 48 hours after the publication's co=editor charged publicly that the official was a CIA agent, according to information provided to Congress.

----In March of this year, several U.S.diplomats and their families were expelled from Mozambique following

charges of espionage. These expulsions came shortly after visits to four African countries, including Mozambique by the editors of Covert Action Information Bulletin and senior Cuban intelligence officers.

At this time, there is no criminal statute to specifically prohibit the unauthorized release of the names of our intelligence officers. The bill which I supported in the House of Representatives does not apply to casual discussion, political debates or legitimate journalism, but it is aimed at deterring the disclosure of the identity of covert agents by persons who have authorized access to the information or by anyone else who engages in a pattern of activities intended to expose the agents.

Penalities range up to ten years in prison and a \$50,000 fine, which should be high enough to make these people think twice before endangering more lives. If not, perhaps they can be locked away where they cannot do any more damage.

Our intelligence network is a very seirous business, and it must be treated with the same care as any other element of our defense system. The House bill was carefully drafted to safeguard the

One lesson this nation has learned through experience in recent years is that we need accurate and high quality intelligence information if we are to maintain an effective dedense policy.

The House of Representatives, through approval of the Intelligence Identities Protection Act, has taken a step which I hope will result in improving our worldwide intelligence system while providing an important degree of protection to our intelligence agents.

Our intelligence force constitutes an important weapon in the national defense system, and faulty or incomplete data can be just as dangerous as a weapon that misrires or an aircraft that won't fly. At the front line of this invaluable service is the individual agent, even in this era of high-technology information gathering devices.



rights of our citizens while recognizing the obivous need to protect our agents and our national welfare.

Former CIA Director William Colby recently pointed out that there are more than thirty statutes in our criminal code that punish governemtn officers for revealing information they learn in the course of their work, including provisions which govern Agricutlure Department employees and the dissemination of crop statistics.

Colby siad that our national secrets and the intelligence officers who serve their country deserve the same protection. I think that most of us agree, and we are doing something about it.

VAL VERDE WILDLIFE FIELD DAY UPCOMING

DEL RIO-A Wildlife Field Day has been scheduled for area landowners Thursday, October 15 according to Val Verde County Extension agent Rex Stultz. It will be held at Rancho Rio Grande, 20 miles south of Del Rio off Highway 277 beginning at 9 a.m.

Stultz says that the purpose of the activity is to acquaint Southwest Texas landowners with wildlife management practices which can improve the quality of deer herds and better balance food supplies with wildlife population growth.

Bill Moody, owner of the 65,000 were attired in light grey, as their acre spread which follows the Rio Grande River for several miles, begins the program by outlining the ranch's colorful history. Ranch manager Russ White will then relate their deer management objectives and developments since initiating

a full scale wildlife management

program about two years ago.

Dr. Dwight Guynn, Texas Agricultural Extension Service wildlife specialist, Uvalde, will outline various wildlife manage ment practices including deer census techniques and spotlight counts which help landowners better plan their harvests.

Dr. Larry White, Extension range specialist, also of Uvalde will discuss range management as related to wildlife nutrition and explain how fecal analysis can assist landowners in managing their ranges for plants that animals perfer.

Dolan Creek Ranch biologist JOhn Finegan then describes techniques in manageing hunters of trophy white-tail deer and hunting lease arrangements, after which a steak lunch will be served on the banks of scenic Pinto

After the lunch break, Mike Morris, Texas Parks and Wildlife Department District game warden will outline the game laws for Val Verde and surrounding coun-

Jim Simmonds, County Court-at-Law Judge, then discusses a problem common to many landowners especially during hunting season --how to make cases involving trespassing hunters stand up in court.

Stultz then closes out the pro gram with a report on Extension activities in the county. Area ranchers are invited. Stultz says the field day should conclude by 3 p.m.


