

Coyotes' Richey Gets All-Star Hoop Job

Borden County boys basketball coach Trey Richey was notified last week that he has been selected to head up the West squad in the 1995 Texas Six-Man Coaches Association All-Star Boys Basketball Game this summer at Wichita Falls.

The six-man all-star football game will also feature an area twist in the coaching ranks as 1985 Dawson High School graduate Joaquin Rodriquez will assist Amherst field general Jack Shely in coaching the West.

The former Dawson Dragon all-district defensive back, who played in the all-star football tilt back in 1985, coached the offensive backs and defensive secondary on Amherst's state championship ball club this past fall.

The football tilt will provide an interesting coaching matchup. Milford head coach Cliff Gilmore will head up the East squad after losing 30-20 to Shely and Amherst in the state championship game.

Borden County will about to now be represented in both Richey.


New Home's Nyles Fields has been selected to coach the West in the girls' all-star hoop tilt. Coolidge head Marvin Childs will coach the East.

Borden County head football coach Bobby Avery, who assists Richey with the Coyotes' boys basketball program, will also assist him in the all-star game.

"I just hope that he enjoys having me around as much as I have him the past three seasons. He's helped teach me a lot about this profession," said Richey.

The coaching profession is not anything new to Richey.

"My day (John Richey) coached for over 20 years. He told me to cherish this moment since it's something that he never had the opportunity to do,: said Richey. "That makes me feel even more excited since I've always sort of put him on a pedestal in this business."

Richey's selection marks a homecoming of sorts for the 1986 Jayton graduate. He was an all-state football player, who helped the Jaybirds win back-to-back state six-man championships in the mid 1980's. Richey played in the sixman all-star grid contest in 1986. He earned all-state honors at safety his junior year in high school and all-state at running back his senior year.

Richey added, "I just want to help the kids have as much fun this summer as I did when I got out of high school."

He said," we're 8-1 in junior high so it sounds like we've got a pretty good future ahead of us. Some of our older kids might not actually see the rewards, but they definitely will have played a part in it. Our high school players have been real supportive of our younger ones."

"We feel that if we make people play as hard as possible every time they take the floor against us, we're doing something right," said Richey.

Apparently, several of Richey's coaching peers already think that he's doing that.



CROP INSURANCE SALES CLOSING DATE EXTENDED

Growers of cotton, wheat, grain sorghum & nursery crops in Borden County are reminded of the MARCH 15 deadline to sign up for catastrophic crop insurance (CAT) in order to remain eligible for U.S. Department of Agriculture benefits commodity price support and production adjustment programs, certain Farmers Home Administration loans, and the Conservation Reserve Program (CRP). The deadline was recently extended from February 15 to give producers more time to sign up for the new program. The extended sign up is only for catastrophic coverage.

Nancy Condit, Acting County Executive Director of the Borden County Consolidated Farm Service Agency (CFSA) said CAT coverage for insurable crops is available through private insurance agents or the offices of the former Agricultural Stabilization and Conservatin Service (ASCS). CAT coverge will compensate producers for crop losses in excess of 50 percent of their actual production history at 60 percent of the expected market price for that crop. The coverage provides benefits comparable to those provided by disaster assistance programs.

Producers can obtain this coverage for a nominal administrative fee of \$50 per crop per county. The maximum cost for all insurable crops in a county is \$200 per producer, and the total costs for all insurable crops in a county is \$200 per producer, and the total costs for all CAT coverage is limited to \$600 per producer for all counties in which a producer has insured crops.

The sign up date for higher levels of coverage for cotton and grain sorghum is MARCH 15. "Additional" insurance coverage can be purchased through private insurance agents. A list of agents may be found in the local CFSA office.

1995 PAYMENTS LIMITATIONS

No program benefits, subject to limitation, may be provided to any producer until the necessary payment limitation determinations are made. The producers will remain ineligible until all required forms are provided to the county office.

Payments limitations and payment eligibility determinations may be initiated by the County Committee or requested by a producer. If you request a determination, the request may be filed anytime before the final date for submitted CCC-502's.

There are statutory provisions that require entities earning benefits subject to limitations to:

- * provided the name, address & ID numbers of the entities
- * inform the entities' members of the requirements for designating permitted entities

All payment limitation forms submitted by producers are subject to spot check through the end-of-year review will be required to furnish detailed information to the County Committee to prove their inputs used to:

- * determine significant contributions to farming operation
- * that contributions were commensurate with claimed shares of the farming operation,
- * contributions are at risk,
- * the 'person' determination was .correct,

- * land ownership was accurately reported,
- * any other pertinent factors used in the original determination were correct.

A determination of "not actively engaged in farming" results in the producer being ineligible for: deficiency and diversion payments, gains from marketing loans and loan deficiency payment (except honey), CRP annual rental payments wool and mohair payments, and any benefit requiring a determination of "actively engaged in farming".

Sign-up will continue through March 31, 1995 for the 1994 disaster program.

FOREIGN INVESTORS

Foreign investors are required by law to report to CFSA any purchases or sales of agricultural land. Failure to do so could result in costly penalties.

SIGNATURE AUTHORITY FOR SPOUSES

A husband and wife can sign documents on behalf of each other for CFSA and CCC programs in which either has an interest, unless written notification denying a spouse this authority has been provided to the county office. Spouses cannot sign on behalf of each other for powers of attorney (ASCS211 or ASCS211-1). Spouses must have power of attorney on file or sign personally for : WRP easements, CRP easements, or claim settlements.

FEDERAL CROP INSURANCE

CAT Insurance will replace the ad hoc crop disaster relief program that farmers have become familiar with over the past years. The disaster program as we have come to know it will end with the 1994 crop year. CAT coverage will compensate farmers for the crop yield losses greater than 50% at 60% of the expected market price. These coverage levels are comparable to disaster relief programs in recent years.

Producers must purchase crop insurance coverage at the CAT level or above to participate in Federal programs, FmHA loans and CPR. Farmers may choose to buy the CAT coverage either through a private reinsured company or through a USDA county office. Insurance policies greater than the CAT (catastrophic) coverage will only be sold by private insurers.

Producers must provide proof of insurance (at least CAT coverage) to stay eligible for USDA farm programs. This must be done prior to the final sales closing date. For Borden County, March 15 is the final sales date for spring seeded crops.

All harvested crops of significant value must be covered. If you participate in the cotton program, and not the wheat, but have some wheat harvested, it must have at least the CAT coverage on the wheat or you will not be eligible for the cotton deficiency payment.

Please call if you question whether a crop needs coverage.

1995 ARP SIGN-UP

Sign-up for the 1995 Acreage Reduction Program will be January 30, through April 28, 1995. The ACR provisions are 0% set-aside for wheat, oats, barley and cotton. For corn, the ACR requirement is 7.5%. Remember that the final sales closing date for crop insurance is before the final sign-up date for the program and that crop insurance is required for program participation.

CONSERVATION RESERVE PROGRAM

The Secretary of Agriculture has announced that USDA will take several actions regarding the CRP, including modifying and extending CRP contracts, targeting more environmental sensitive acres and using conservation easements on the most environmentally sensitive areas.

During 1995, USDA will consider requests from CRP participants to release their CRP contracts or to modify their current contracts to reduce the amount of acreage subject to the contract. USDA will also request and consider bids from producers to enroll new acreage in the CRP program subject to new 10 year contract. Regulations should be published this summer regarding this.




