FICUS BENJAMINA....Weeping Fig--Fig

The Ficus Benjamina are woody members of the MORACEAE family, an are native to India, Asia and Australia. The leaves are a deep green color, are slender and pointed. Varigated varieties are also available with cream and lighter green leaf markings.

This plant makes an excellent house plant, and is also good for sheltered patios or porches. It's branches droop gracefully as it grows in height.

Ficus trees can tolerate dry atmosphere, and can adapt to the reduced light in a home.

In the home, an east or west window would be the best spot for your tree. It thrives on warmer temperatures, and can tolerate as low as 45°.

Ficus trees like soil that is evenly moist, but not constantly wet. If the plant is kept too dry the leaves will burn and shrivel, so be sure to keep moist in hot summer weather.

Straggly branches can be pruned in spring to encourage branching and to maintain desired shape.
