### FLOWERING PLANTS IN CONTAINERS

Small yards, porches, patios,  
are all prime candidates for  
container gardening. Many flower-  
ing annuals, bulbs and vegetab-  
les grow well in tubs and pots.  
A container garden does require  
a little extra care. Watering  
has to be attended more fre-  
quently than plants in the  
ground, as containers do dry  
out faster. Plants in bloom need  
more water and can wilt if ignor-  
ed for a day or two container  
plants benefit from feeding  
every two weeks.

Use a good soil mix, free of  
weeds(good garden soil is suit-  
able.)

Petunias, bincas, impatiens,

Thank you for your consideration in this matter.

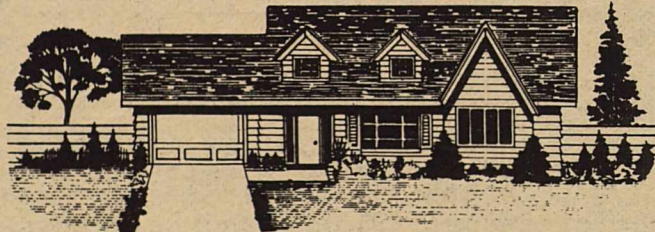

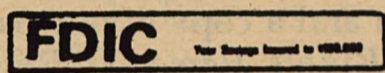

# KAZEN

In recent weeks I have been contacted by many concerned senior citizens who have asked me to review the Administration's 1983 budget proposals for older Americans, to study the effects of these changes and to do what I can to assist the elderly.

Congressman Claude Pepper of the Select Committee on Aging has issued a first look at the Administration proposals--and he is obviously concerned over cuts in entitlements and other programs as they affect older persons.

As I have said, I believe that we must find ways to reduce the close to \$100 billion deficit as projected under the Administration budget for 1983, but I am also dedicated to considering the problems of the elderly as we deliberate on economic issues this year.

## MEDICARE AND MEDICAID

The aging committee report points to a proposed reduction of \$2.4 billion in the Medicare program and \$1.9 billion in Medicaid. In this regard, I have recently co-sponsored a resolution opposing any further reduction in Medicare benefits that adversely affect the health of older persons and calling on Congress to take steps to change the health care reimbursement system.

In addition, I have co-sponsored legislation that would allow Medicare to reimburse the cost of caring for the terminally ill at home as an alternative to institutional care. The experience of existing hospice programs reveals that savings would likely result, and this home care would also reduce the emotional burdens and allow these patients to live out their days in peace and dignity.

## OLDER AMERICANS ACT

Chairman Pepper reports that funding for Older Americans Act programs would decrease from a projected \$986 million in 1982 to \$652.1 million in 1983 under the Administration's budget. He said these cutbacks include reductions in nutritional, senior center and social service funding, elimination of the program that provides jobs for older workers and cuts in older American research programs and in funding for State Agencies on Aging.

The chairman, who is 81, believes that proposed housing cutbacks would be particularly damaging to the elderly on fixed incomes, and reports that the Administration proposes to raise the current limit to 10 percent on rent increases to a 20 percent limit, while counting the cash value of an older person's food stamps as income in determining subsidy levels. He believes that a better solution would be to cut out the waste and fraud in such programs.

## ALTERNATIVES SOUGHT

Congress is certainly going to look closely at the issue of housing for the elderly and the handicapped as we examine the entire question of housing and the economy.

Chairman Pepper is the acknowledged champion of the senior citizens through his work on the Select Committee on Aging, and his influence means a lot in Congress. I will continue to work with him, as I have for several years, in the hope of finding an adequate solution to these problems.

# TAX RELIEF?

Texas law provides for a standard \$5,000 exemption off the market value of a residence homestead for school tax purposes. If you are 65 or over, you are entitled to an additional \$10,000 exemption off the market value of your homestead. And, if you are entitled to the 65 or over exemption, the school taxes on your residence homestead cannot increase after you apply and qualify for this exemption, unless you make improvements to your homestead.

It is important to remember that these tax relief measures do not go into effect automatically. You must file for the exemptions this year before May 1. # Sheep & Goat Raisers' News

It just goes to show that you can fight City hall--or a reasonable facsimile thereof.

When the Texas Sheep and Goat Raiser's Association passed a resolution at its recent winter director's meeting opposition planned changes in the Texas aerial predator control rules. some folks thought we were spinning our wheels. Now the Texas Parks and Wildlife Commission has ruled on those proposed cahnges, and it looks like we had plenty of traction after all.

Granted, the Association had opposed the changes in their entirety and some went through anyway, but the worst of the proposals bit the dust.

TP&W wanted, among other things to require the registration of all aerial predator gunners and to require 12-hour prior notificatoin of any predator control flights. Neither change survived the hearing.

They did get a whopping 20-fold increase in the annual aerial predator control permit fee an a number of lesser changes, but we think both fliers and stockmen came out of the affair in fine shape, allthings considered.

TS&GRA president I.W.Terry, STerling City, says the gunner and prior-notification rules would have crippled aerial predator control efforts, but the doesn't believe that's what TP&W had in mind when it proposed them.

"I Honestly think they never gave a thought towhat it would do to predator control," he explains. "They were so intent on catching aerial deer hunters that they overlooked the whole purpose of the rules."

Terry points out that the proposed rule changes didn't come up until the aerial control program was shifted from game management to the enforcement division.

Fliers, both commercial and private, often use ranchers or their family members or ranchhands as gunners. The idea is to have someone a paying customer will trust when it comes to verifying predator kills. It also helps to have a gunner who is familiar with the country; TP&W is very picky about aerial hunters staying within authorized areas, and one fenceline looks pretty much like another to an unfamiliar flier. The upshot is that gunner lists would stay in a constant state of change, and any delay in getting a new gunner registered could cost a bundle in lost livestock while a flier was forced to sit and twiddle his thumbs.

Faced with these practical objections, TP&W withdrew the gunner rule at the beginning of the hearing.

That left the 12-hour prior notification proposal, and it was tougher. TP&W had first required notification oflocal game wardens, but later offered to install a 24-hour "hotline" phone in Austin to cover for game wardens who couldn't be reached quickly.

They still weren't thinking like predator control people, and that became clear during the eharing through testimony from such rancher/fliers as Dr. Percy R.Turner, Water Valley, Bert Dennis, Gail, and G.R. Jackson, Midkiff.

These men, along with former Texas animal damage control state supervisor Milton Caroline pointed out that private rancher/fliers often spot coyotes while flying their ranches for other reasons. To make them cool their heels for 12 hours because of a red-tape technicality would be rediculous, they insisted.

That left TP&W with a clearer precention of the problem; there's no way to make such a delaying rule workable in a quick-response situation like predator control. They either had to withdraw the rule or pass it and drop any pretext of cooperation and fairness. The latter choice would be unenforceable, engender a lot of hard feelings and probably create a number of lawbreakers.

Faced with such a prespect, TP&W withdrew the rule.

Now if we could just have gotten rid of that \$100 permit fee.....

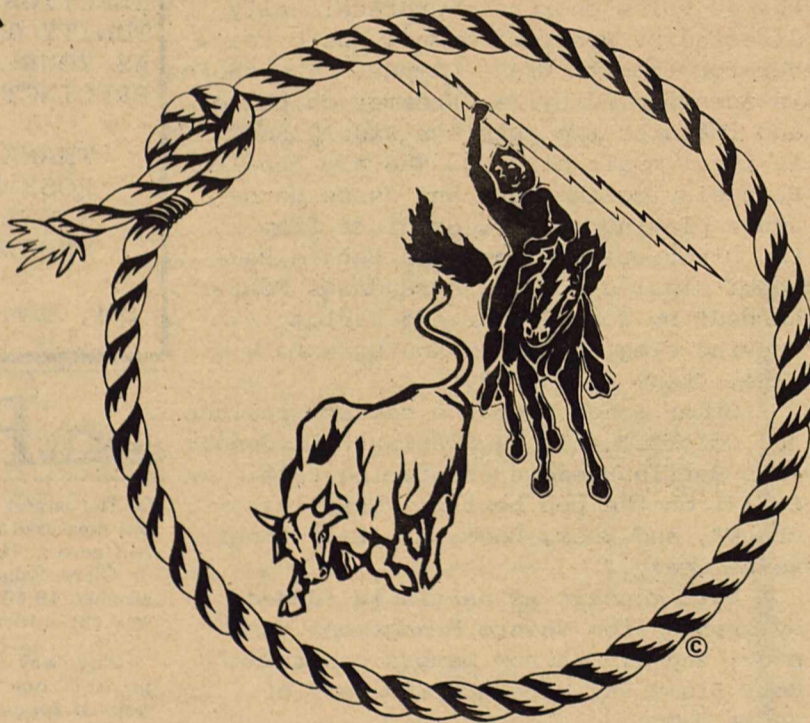

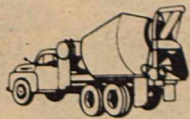

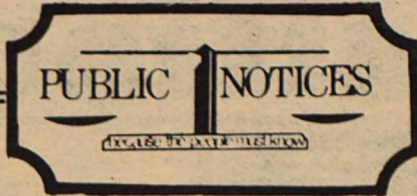
