64 ANGORA BILLIES AVERAGE \$600
TO TOP 1981 PERFORMANCE-TESTED
SALE

SONORA--Sixty-four head of per-
formance-tested Angora billies
average \$600 during the 2nd An-
nual Test and Sale held recent-
ly at the Texas agricultural
Experiment Station research
ranch located between Rockspings
and Sonora.

Over 200 producers jammed
the TAES sales arena for the
day-long field day and sale,
witnessing active, spirited
bidding throughout the auction.

The selling billies were
selected from about 200 head
on the test at the TAES Ranch.
The sale included the showing
of color slides of each selling
billie in full fleece just
prior to shearing. Buyers were
thus better to judge an animal's
fleecing ability.

Top seller of the day was
consigned by Bill McInnis, May,
Texas, and purchased by Joan
Gardner, Sonora, for \$1,200.

Two other billies broke the
\$1,000 barrier, selling for
\$1,050 each and 35 sold for more
than last's year's \$550 average.

This performance test, the
first of its size ever conducted
in the U.S. appeared to please
sellers, buyers and test-sale
sponsors.

"This test and sale showed
us a lot of things about the
Angora goat industry," said
Jack Groff, Texas Agricultural
Extension Service Sheep and
Goat specialist who served as
sale coordinator.

"We'll be working with some
of the genetic traits that need
magnification while trying to
de-emphasize others," Groff
pointed out. "Some of these
goats indexed very high. We have
fierce foreign competition in
the mohair industry so we must
improve our product to remain
competitive. This performance
test goes a long way in helping
us determine what direction to
take."

Sponsors include the Texas
Agricultural Experiment Station
Texas Agricultural Extension
Service and the 31 cooperating
Angora producers.

HOBBY ANNOUNCES \$130 MILLION
INCREASE IN HIGHWAY FUNDING

AUSTIN--The State Department
of Highways and Public Trans-
portation will receive an esti-
mated \$130 million in addition-
al funding for highway construc-
tion and maintenance through 1983,

Lt. Gov. Bill Hobby announced
Friday.

The Highway Cost Committee
provided the additional funds
by updating its method of cal-
culating the effects of infla-
tion on the costs of highway
construction and maintenance.
The Committee, comprised of
Gov. Bill Clements, Hobby and
State Comptroller Bob Bullock,
adjusted its calculations to
include a change in the process
by which contractors bid on
highway jobs and to give more
stress to highway maintainanc.

During the committee meeting
Hobby pinpointed a flaw in the
Highway Department's method of
calculating the Highway Cost
Index and suggested an alter-
native that will provide an
additional \$12 million for 1982-
83.

"I am pleased that the
committee saw fit to make these
changes," Hobby said. "For vari-
ous reasons, the Highway Cost
Index needed updating to pro-
vide a more accurate picture
of the effects of inflation on
highway programs."

Hobby said the additional
\$130 million is severely needed
to help upgrade the state's
highway system.

Several states have actually
suspended bidding for highway
construction due to a lack of
funds," Hobby said. "That is
not going to happen in Texas
because we have made long range
guarantees of funding for this
essential public service."

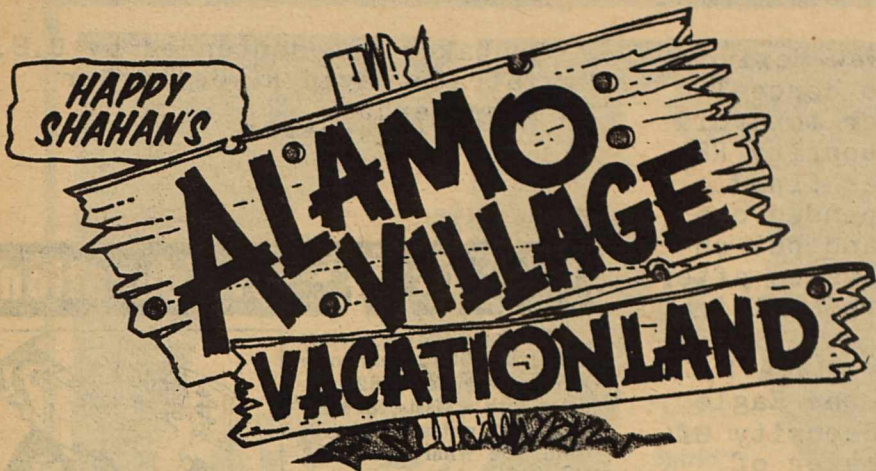

Elections Update

The results of an analysis of the May 1, 1982 primary election were released by the Secretary of State's Office and the overall impression is that **the registered voter in Texas in 1982 is clearly less than satisfied with our electoral process.**

Based on the fact that only 24 percent of the State's 6.6 million registered voters bothered to vote on May 1 at a cost of \$4.5 million which included \$1.7 million in candidates' filing fees and over \$29,000 in private contributions, this amounts to a cost of approximately \$2.80 per vote cast in the May 1 primary election.

Dr. Robert A. Peterson of the University of Texas at Austin was commissioned to analyze the factors impacting the behavior of the registered voter in Texas, voters' attitudes on the manner in which the May 1 primary was held, and registered voters' opinions on eight various electoral process issues. One thousand four hundred and forty-one registered voters were surveyed on the various election related questions. In 1982, registered voters across the state thought of themselves as 33 percent Republican, 45 percent Democrat, and 22 percent "other." Registered voters who did not vote in the May 1 primary thought of themselves as 37 percent Republican, 41 percent Democrat, and 22 percent "other."

The major findings of the study are:

★ Slightly more than one-third of the registered voters interviewed stated that they were either "strongly in favor of" or "somewhat in favor of" establishing an election reporting bureau in the Secretary of State's Office. Nearly one-fourth of the registered voters were uncertain as to their opinion on the issue.

★ A majority of the registered voters were in favor of holding primary elections closer to the general election in Texas. Support ranged from 57 percent of the nonvoters to 52 percent of the voters for this concept.

★ Fifty-six percent of the registered voters surveyed believed that statewide elections should be held on the same day as the Presidential election.

★ Approximately two-thirds of the registered voters interviewed thought that state judges should be elected without regard to political party affiliation, or on a nonpartisan basis. Fifty-six percent of the registered voters surveyed who voted in the Democratic primary, and 55 percent of the registered voters surveyed who voted in the Republican primary stated judicial elections should "definitely" be held in this manner.

★ Nearly eight out of ten registered voters interviewed responded that there should be legal penalties for candidates who make untrue statements or misrepresentations when campaigning for public office. Indeed, fully 67 percent of the registered voters who voted in the primary election said there should "definitely" be a state law that has penalties for political candidates who knowingly make such statements during an election campaign. Relatively more registered voters who voted in the Democratic primary, 68 percent, than registered voters who voted in the Republican primary, 58 percent, stated that there should "definitely" be such a law.

★ Approximately 52 percent of the survey participants agreed that current officeholders with more than one year remaining in their current term of office should be required to resign their current office when seeking election to a different statewide office.

★ Nearly three-quarters of the survey participants stated that state, local, and school board elections should "definitely" or "probably" be held on the same day, at a single polling place, with votes cast on a single ballot.

★ When asked their opinions regarding the establishment of a unitary primary election in Texas, 53 percent of the registered voters were either "strongly in favor of" or "somewhat in favor of" this election concept. Approximately 54 percent of the survey participants who did not vote in the primary election and 48 percent of the survey participants who did vote in the primary election favored the unitary primary concept. Sixty-two percent of the registered voters surveyed who did not vote in the May, 1982, primary said that they either "definitely" or "probably" would have voted if there had been a unitary primary. Fifteen percent of the nonvoters surveyed were uncertain as to whether they would have voted while 23 percent said they still would not have been motivated to vote even with a unitary primary in effect.

The results of the analysis overwhelmingly indicate that the registered voters in Texas favor major modifications in our current election system. The election proposals put before the registered voters would streamline various facets of the election system and would decrease the costs of holding the elections to the taxpayer, and reduce campaign costs to the

candidates while at the same time increasing voter turnout and voter interest in Texas elections.

The voters of today are in a sense suffering from "voter fatigue"—too many elections—too close together in time—in too many places—and on too many ballots. The "voter fatigue" syndrome is evidenced by the low voter turnout in recent Texas elections and perhaps significantly accounts for the favorable responses received from registered voters surveyed on proposed changes in Texas' election system.

The task of motivating registered voters to vote is not easy—but the favorable reception to the future election issues put to the registered voters clearly indicates that voter interest and increased voter turnout could be a logical result of their implementation. **Over one-half of the nonvoters surveyed stated they would have gone to the polls on May 1 had Texas had a unitary primary.** In addition, had the primary election been held closer to the general election and a consolidation of state and local elections held on the same day, voter turnout would have been significantly higher.

The 68th Texas Legislature should take serious note of the low voter turnout trend evident in recent elections and examine in detail the citizen preferences indicated for each of the eight election policy issues. The Secretary of State's Office, in the interim, will in turn examine the financial feasibility, practicality, and advantages and disadvantages of each of the policy matters and make appropriate legislative recommendations to the 68th Texas Legislature.

SOCIAL SECURITY NOTES

A Texarkana, Texas woman has been ordered to repay almost \$10,000 to the Social Security Administration as a condition of probation after receiving a suspended sentence for defrauding the agency.

Sentence was imposed by U.S. District Judge Wm. M. Steger, After Aline Kirk of 515 Bowie Street in Texarkana pled guilty to a federal charge of forging her mother's signature on social security checks negotiated after her mother's death.

According to Miss Elvia F. Fuentes, Manager of the Eagle Pass, Texas Social Security Office, the scheme was uncovered in a record matching project between the Social Security Administration and the Health Care Financing Administration to identify people who had died according to hospital medicare reports, but whose death had not been reported to SSA.

An Albuquerque, New Mexico, man who attempted to conceal his earnings in order to avoid losing any Social Security Retirement Benefits was fined \$1,000, given a suspended one year jail sentence and put on probation for three years after pleading guilty to federal fraud charges.

According to Miss Elvia F. Fuentes, Manager of the Eagle Pass, Texas Social Security Office, Robert D. Brubaker of 2912 Broadmoor, S.E. in Albuquerque had used his wife's social security number while working in order to conceal his earnings and avoid having his retirement withheld. Miss Fuentes said that one dollar of social security benefits is withheld for every two dollars of earnings in excess of \$6,000 for beneficiaries 65 through 71 years of age or in excess of 4,440 for beneficiaries who will not be at least 65 this year. The retirement test rule does not apply once a beneficiary is 72 years old.

Brubaker was sentenced by U.S. Magistrate David R. Gallagher in Albuquerque.

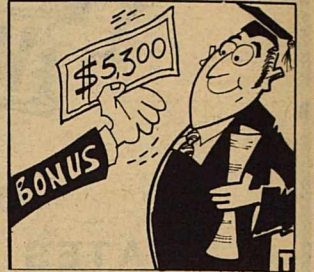
NEWS Of Education

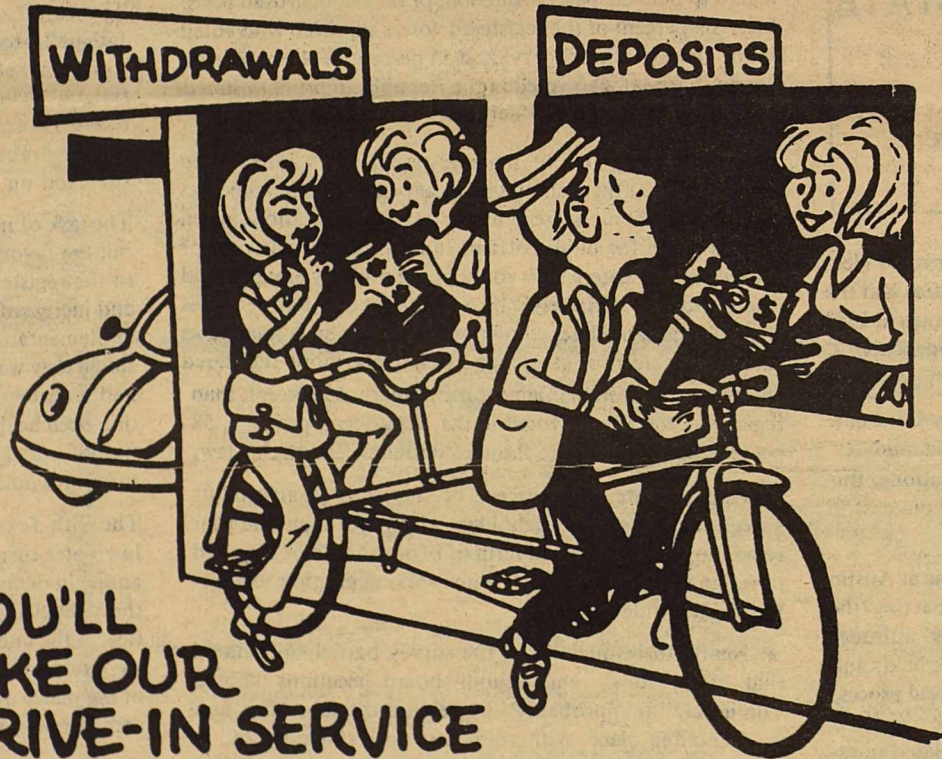

INNIVATIVE, PRACTICAL MANAGEMENT HELPS RANCHERS CONTROL DESTINY

DEL RIO Ranchers may not have direct control over market prices, interest rates or many other supply-demand factors.

But they do have control over various production-management concepts which can minimize costs and return working capital when used properly, according to a Texas Agricultural Extension Service livestock specialist.

There are a number of proven practices that ranchers can use to lower production costs and improve cash-flow situations," says Dr. LeRoy Hoermann. "Many of these methods will be discussed in detail at the International Ranchers Roundup (IRR) August 10-12 in Del Rio."

Hoermann says about two dozen of the Southwest's most successful ranchers will appear through out the three-day program describing how they handle certain situations effectively to remain profitable. He notes that 75 other ranching experts from 12 states, Australia and Mexico will present their expertise in the general and six concurrent sessions which cover every phase of the ranching operation.

Hoermann urges ranchers to ask themselves a few basis questions concerning their operations. Is your production system--breeding, stocker or combination--best adapted to your growing conditions and tax structure? Do you have flexibility to adjust to changing conditions? Is the timing of your breeding, birth and weaning matched to weather, feed requirements and available market? Have you optimized pasture and livestock management to reduce the amount of feed required? These and many others will be discussed during the Roundup with a variety of ideas for implementing solutions.

One notable general session speaker will point out how ranchers can effectively cut certain production costs and employ various measures to avoid being among the 100,000 American Beef Producers froced out of business this year.

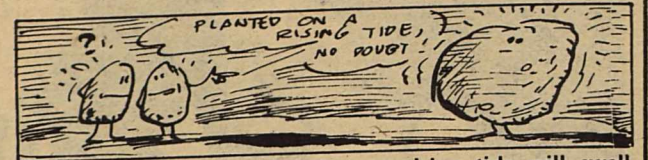
"There are many alternatives available to the rancher," Hoermann stresses. "Some are very innovative and require information that is available only from specialized sources. A primary reason for holding this Roundup is to 'pool' knowledge and information from experts around the world that any ranchers can use in their struggle to produce more food and fiber profitably at lower

coast."

The IRR coordinator says this conference could be looked upon as a "conference on rancher survival."

The Speaker Reports

AUSTIN -- It is a known fact that the first three years of a child's life are extremely important to his or her mental, physical, and emotional development. But to a handicapped child the first three years are crucial; special assistance and training are needed if the child is ever to lead a normal, productive life.

The 67th Legislature took an important step towards assuring that handicapped children receive this assistance and training with the passage of Senate Bill 630 during the last regular session.

This bill established the Interagency Council on Early Childhood Intervention Services whose goals are to see that developmentally delayed and handicapped children are identified and that they receive proper training services. In order to accomplish these goals, the council is required to create a statewide program and coordinate existing training services.

The council is composed of one public representative and one representative each from the Texas Department of Health, the Texas

Department of Mental Health and Mental Retardation, the Texas Department of Human Resources, and the Texas Education Agency.

Already the council has established the Early Childhood Intervention (ECI) Program. For children from birth to age three the program provides new and expanded services selected through a competitive proposal process. Services available include individualized instruction in developing cognitive, language/speech, social/emotional, and self-help skills; and related training such as physical and occupational therapy, etc. Parents are also served, through case management, training, and counseling.

For children from birth to age six, the statewide program provides for early identification of developmentally delayed children and for follow-up services by state and local staff.

To date the council has allotted \$3.1 million to 47 organizations throughout the state to locate and to provide services to children from birth to age three who

are handicapped or developmentally delayed.

The primary aim of this legislation and the council is to prevent long-term handicapping conditions. In cooperation, the member agencies seek to coordinate existing services, make the quality of the services more consistent, and to close gaps in services.

SOCIAL SECURITY NOTES

Two Shreveport, Louisiana residents are awaiting sentencing and a Lubbock, Texas resident has been sentenced in federal court action relating to fraudulent claims for Social Security Student benefits.

According to Miss Elvia F. Fuentes, Manager of the Eagle Pass, Texas Social Security Office, Coretha Williams of 1545 Milam in Shreveport pled guilty to two counts, and Eloise Cole Belton of 2527 Edgar Street in Shreveport was found guilty on seven counts of making false statements regarding their school attendance in order to receive social security benefits as children of retired, disabled or deceased parents. Miss Fuentes said such children, 18 or older, must be unmarried and must be attending school full-time to qualify for the monthly payments.

Williams and Belton face a maximum penalty of a year in prison, a \$1,000 fine or both on each count. Sentencing for both women was set for June 29.

Miss Fuentes also said Chris Cates of 1313 26th Street in Lubbock, Texas has been placed on a year's probation by a Lubbock Federal Judge under the Youth Corrections Act after pleading guilty to charges that he failed to let the Social Security Administration know when he stopped attending school and continued to cash student benefit checks. Prior to sentencing, Cates paid back more than \$3,000 of the amount he claimed illegally.

Miss Fuentes said that the Social Security Administration has stepped up its efforts to prevent payment errors and fraud, to detect false claims and to recover money that should not have been paid.
