CITY RETAINS TAX RATE BASE

The City Council at it's regular monthly meeting on Tuesday, 14 September, 1982, set the 1982/83 Tax Rate at \$.60 per \$100 market valuation. This rate applied to the certified tax valuation for the City of \$13,759,064.00, which compares to the tax valuation of 1981/82 of \$14,161,696,00 thus reduces Ad Valorum taxes to be collected by the City of \$2,415.80. The City Council felt that with the state of the economy, higher electric rates, telephone rates and gas charges the City would not increase the rate to correspond to the authorized level but with added organizational controls and deci sions we could also tighten our fiscal belts and not add an additional burden to an already overladen tax paying public.

The City Council was extremely pleaesed and proud to accept from the Fort Clark Springs Community Council a check for \$200 donated to the Brackettville Volunteer Fire Department. Mr. walter Moore representing the Fort Clark Springs Community Council presented the check to the City Manager on behalf of the residents of Fort Clark Springs. SOME FOODS MAY LESSEN ODDS OF GETTING CANCER

Although we have heard plenty about boods that appear to increase the chances of getting cancer, a recent study also cites foods that seem to reduce the odds, says the Texas Medical Association.

A scientific committee of the National Academy of Sciences says in a report that diets rich in fruits, vegetables and whole-grain cereals seem to reduce the chances of getting cetain kinds of cancer. The panel specifically urged daily consumption of produce high in citamin C and caro tene, which the body changes a vitamin A.

The committee noted that vitamin C in foods can inhibit the formation of cancer-causing substances. It said foods rich in vitamin C. such as citrus fruits, tomatoes, and peppers, appear to lowe the risk of stomach and esophagus cancer.

Foods high in carotene are associted with a reduced risk of many cancers, including lung, breast, bladder and skin. These foods include dark-green leafy vegetables and deepyellow fruits and vegetables, such as carrots, spinach and broccoli.

The study also cited vegetables in the cabbage family--cauliflower, kale and brussels sprouts -- for their na-

# SWTJC

The Creative Arts Society at Southwest Texas Junior College is urging all prospective entrants in the 1982-83 Creative Arts Contest to begin planning their entries immediately since the contest deadline has been moved up to December 14,1982.

The dealine has tradiationally been near the first of February, but recently, with increased participation from area schools, that date has caused problems," said David England, SWTJC creative arts sponsor.

"We moved the deadline up to December particularly to encourage teachers to develop entries during their fall semester classes," he continued. "We hope to involve as many English, creative writing, art and photography classes as possible."

The SWTJC Creative Arts Contest includes three literary divisions (poetry, shortstory and essay) that are open to entrants in eight age classifications (pre-school; grades 1-3,4-6,7-9 & 10-12; college; community; and retirement home).

Art divisions are pen and ink drawing, painting and ceramics in the same age groups. According to England, other categories will be created if a sufficient number of entries is received.

Both color and black & white photos will be accepted in thephotography division. Age classifications in photography are grades 10-12, college and community.

At least a 1st,2nd,3rd winner will be selected in each division and age classification, with honorable mentions or the equivalent awarded when a large number of quality entries are received.

"We've received some criticism about the honorable mention award. Some who have received it said they felt embarassed, "England said. "we're going to limit the honorable mentions this year, but I think if a large number of good entries are received, they should receive some type of recognition."

The art and photography divisions are particularly susceptible to honorable mention awards.

"We plan to have a display of winning art and photography winners this year, and it will hard to limit the awards if we receive a lot of good work,: England continued. "We may have three 'superior' winners and five or more'excellence' winners or something like that."

An awards ceremony and Creative Arts Fair will be held at the college on February 22,1983.

The Creative Arts Society is hoping to get William Barney, the recently designated "Poet Laureate" of Texas,

to give an oral reading of his poetry at the fair.

In addition to receiving an award, winners will see their work in print in the college's literary magazine, "The Palm's Leaf.

The most recent edition of the magazine, featuring last year's winners, is available by mail for \$4.50 c/o the jurnalism department, SWTJC, Uvalde, Texas 78801, or in person at the college bookstore for \$4.00.

TOO MUCH VOLTAGE

Constant excessive voltage, according to information now available is a leading cause of waste in electric utility bills in Texas Independent School Districts. TORA-TORA-TORA

Tora-Tora-Tora attacks over Hondo in September are becoming an annual affair as the fall skies once again will be filled with the likes of the B-25,B-24,B-29,B-17,Wildcats, Corsairs,Mustangs,Lightnings, and Texans(an assortment of some 50 different WWII aircraft in perfect flying condition) as the Alamo Wing of the Confederate Air Force stages its 3rd Annual Air Power Demonstration onSunday, September 26,1982, at 2 pm. Gates open at 10 am at the Hondo Air Base in Hondo,Texas(50 miles west of San Antonio on Hwy 90).

Col. Dave Smith of the C.A.F. reports that a wide assotment of aircraft from the San Antonio area and throughout the country will appear in the show that traditionally attracts young and old by the thousands from the Alamo area. "We expect to see the only flying B-29 in the world in Hondo, in addition to the P-38 Lightning, P-51 Mustang, F4U Corsair and one wach of the American bombers of WWII .: He continued, "The Tora-Tora-Tora group from Galveston will once again recreate the infamous attack on Pearl Harbor. This demon stration keeps fresh the memory of when American was almost too weak to react."

The Alamo Wing's own B-25 "Yellow Rose" will ake off as a vivid reminder of Doolittle's bomber response to Pearl Harbor just months after December 7,1945. Naturally, the B-29 will close the show.

"There shows are not to be missed and are just perfect for children to walk around and inspect a prior era of aviation," Col. Smith remarked, and closed with a caution,,," Bring a lawn chair and don't forget your hat, and you'll enjoy the afternoon."

tural cancer-inhibiting substances.

But the committee advised against taking large doses of vitamin and nutrient supplements. It cited a lack of proof that this is healthful and noted possible toxic hazards.

The study also urged people to cut back on foods that may increase the risk of getting cancer. They include: --Salt-cured and smoked foods such as bacon, bologna, smoked fish and ham, sausage and hot dogs.

--Foods high in fat such as fatty cuts of meat, cooking oils and whole milk sairy products.

Finally, the report urged moderation in drinking alcoholic beverages. It noted that heavy drinking has been associated with an increaded risk of cancer of the upper gastrointestinal and respiratory tracts, particularly when combined with smoking.

DENERAL ELECTION **NOVEMBER 2, 1982** 

#### PROPOSITION NO. 1 ON THE BALLOT

House Joint Resolution proposes a constitutional amendment that prohibits any state ad valorem tax. Receipts from previously authorized state ad valorem taxes that are collected after the effective date of the proposed amendment shall be deposited to the credit of the general fund of the county collecting the taxes and and individuals. may be expended for county purposes. #### PROPOSITION NO. 2 ON THE BALLOT

House Joint Resolution 2 as amended by Senate Joint Resolution 10 proposes a constitutional amendment that would eliminate the \$80,000,000 eiling on state welfare aid during any fiscal year.

The amendment would the state welfare spending limit at \$160,-000,000 for the 1982-1983 biennium.

The amendment further rovides that, for each subsequent biennium, the maximum amount spent for state welfare shall not exceed one percent of the state budget.

The proposed amend-ment will appear on the ballot as follows:

constitutional amendment to authorize the legislature to provide assistance through the appropriations process to needy persons and to place a ceiling on payments for needy dependent children at one percent of the state budget."

#### PROPOSITION NO. 3 ON THE BALLOT

Senate Joint Resolution 8 proposes a constitutional amendment that would exempt machinery and equipment used in the production of farm and ranch products from taxation. No dollar limits would be imposed and the exemption would apply to corporations and partnerships as well as to families

constitutional amendment exempting implements of husband-(agricultural machinery and equipment) from ad valorem taxation."

#### **PROPOSITION NO. 4** ON THE BALLOT

House Joint Resolution 77 proposes a constitutional amendment that would authorize the Legislature to set a four year maximum term of office for board members of certain water districts and conservation and reclamation districts.

The proposed amend-ment will appear on the ballot as follows:

constitutional amendment authorizing the Legislature to provide terms not to exceed four years for members of governing boards of certain water districts and conservation and reclamation districts."

#### **PROPOSITION NO. 5** ON THE BALLOT

House Joint Resolution 119 proposes a constitutional amendment that would authorize Tarrant and Bee counties to hold county-wide elections to abolish the county treasurer's office by majority vote.

Should the county treasurer's office be abolished, the duties, powers, and functions of that office would be transferred to the county auditor or the successor to the auditor's functions.

ballot as follows: "The constitutional

amendment to abolish the office of county treasurer in Tarrant and Bee counties.'

#### PROPOSITION NO. 6 ON THE BALLOT

Senate Joint Resolution 6 proposes a constitutional amendment that would raise the constitutional interest rate limit on state general obligation bonds from 6% to 12%. The new 12% ceiling does not, however, apply to bonds issued by the Veterans' Land Board.

The proposed amendment will appear on the ballot as follows:
