**BULLOCK ON 5-CENT-PER-GALLON GASOLINE TAX INCREASE**

AUSTIN--State Comptroller Bob Bullock said Tuesday President Reagan's suggested 5-cent-per-gallon gasoline tax increase would leave "Texas on the short end of the stick again."

The Comptroller explained a federal hike would preempt the talked-about increase in Texas' state gasoline tax, which has been at the same nickel-a-gallon level for the past 25 years.

"This is going to cost Texans \$480 million a year," Bullock said. "This is money that Texas Legislature won't be able to spend if it's needed because we'll be shipping those dollars out of the state."

"Historically, we Texans have only gotten about 70 cents back for every dollar in motor fuel taxes we have sent to Washington. We've got roads and bridges right here at home that need to be repaired. We could raise the money to pay for this work here in Texas if Reagan would

live up to his word to get the federal government off our backs. If this idea becomes law, it will hit every Texan right in the pocket-book."

Bullock also pointed out the President's top economic advisor, Martin Felstein, has said the President proposal will cost more jobs than it would create.

The Texas Highway Department has proposed increasing the Texas tax by the same nickel per gallon as suggested by the administration.

"We are being undercut by the federal government. If this proposal gets ramrodded through Congress, Texans can look forward to higher taxes and deeper potholes while their hard-earned money creates a piddling number of jobs somewhere else," Bullock said.

### NEWS FROM SOUTHWEST TEXAS JUNIOR COLLEGE

The Science and Math Division at Southwest Texas Junior College recently announced that the annual SWTJC High School Science Fair and Physics Olympics will be held March 18, 1983. Formal invitations were issued to 39 area high schools.

High schools interested in competing in the event should contact Mary Beth Todd Monroe, physics instructor, SWTJC, Garner Field Road, Uvalde, TX 78801, or call 512-278-4401, Ext. 224.

The public is invited to view the Science Fair, an exhibit of student-performed projects in four divisions--math, chemistry, biology and physics. As an added attraction Radio Shack will send a representative to the fair to display the TRS-80 line of computers and answer questions.

Details of the event's second competition, the Physics Olympics, have yet to be determined, but usually included contests based on

principles and concepts in physics.

First and second place awards will be presented in each of the four Science Fair divisions. The high school which each first place student represents will receive a gift donated by a participating scientific company or local business.

The high school which ammasses the highest number of points from among the individual winners will receive a \$200 scholarship for a student of their choice who will attend SWTJC and enroll in science or math.

Participation in the SWTJC Science Fair and Physic Olympics has grown steadily since its inception in March of 1979. According to Monroe, this year's event promises to continue that trend. In addition to local participants, two San Antonio high schools have expressed interest and received invitations.

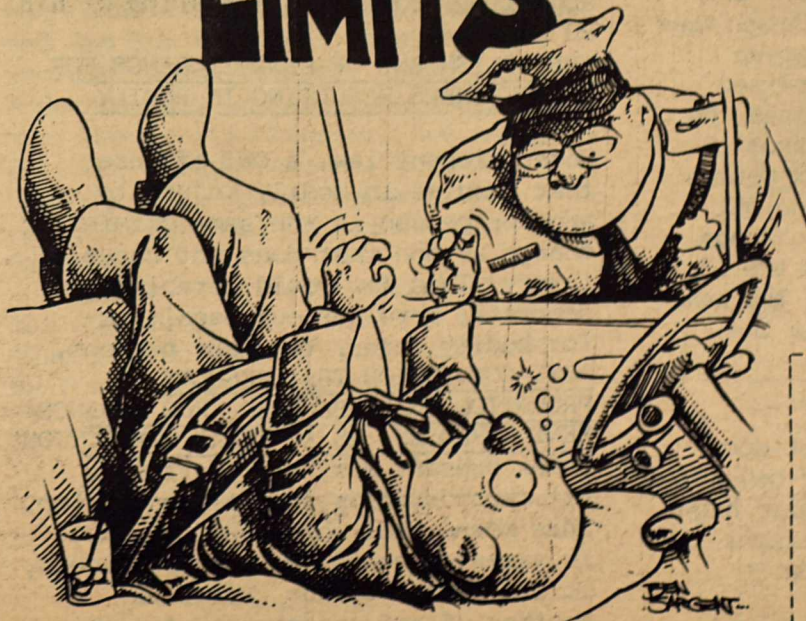

## DWI PROPOSED LAW CHANGES

The following article is a public service by the Kinney CAVALRYMAN through the cooperation of Tully Shahan, County Attorney and the Prosecutor Council. Its purpose is to make you aware of a prosecutor's role, of your responsibility as a resident of this Kinney and how we can work together to alleviate some of society's problems.

### SUMMARY OF SOME OF THE PROPOSED LAW CHANGES

Described below are some of the new DWI laws which will be considered by your legislature this January. Examine them and decide for yourself which ones you feel adequately deal with the problem.

#### \*RAISE THE DRINKING AGE TO 21

A 9-state survey of eastern states showed a 28% reduction in fatalities in the 18-20 year old age group when the drinking age was raised to 21. In Texas when we raised the drinking age last session from 18 to 19, during the first six months we saw a 16.7% decrease in night fatalities in the 18 year old age group, a 36.8% decrease in the 17 year old age group, and at the same time saw a 7.9% increase in the 19 year old age group.

#### \*OPEN CONTAINER LAW

This statute would prohibit open containers of an alcoholic beverage in motor vehicles upon public highways. It will prohibit citizens from drinking while driving.

#### \*PER SE LAW

This law would make prosecution of DWI's easier by establishing that

a person would be considered legally intoxicated if his breath test showed an alcohol content of .10 or more.

#### \*REFUSAL TO SUBMIT TO ALCOHOL TEST SHOULD BE ADMISSIBLE AS EVIDENCE IN COURT.

Under the present law when an individual refuses to submit to the alcohol test, that refusal cannot be admitted as evidence in court. The result can be misleading to juries. Jurors sometimes assume the individual was not offered the chance to prove he was not intoxicated, or that the arresting officer thought the test was not necessary.

#### \*AUTOMATIC (ADMINISTRATIVE) LICENSE SUSPENSION FOR 90-DAYS FOR REFUSAL TO SUBMIT TO THE ALCOHOL TEST.

A person's drivers license would be taken away at the scene by the arresting officer for failure to submit to an alcohol test. The individual would have the right to appeal by requesting a hearing within 20 days.

#### \*ESTABLISHMENT OF PENALTY RANGE FOR DWI OFFENSES RESULTING IN BODILY INJURY

Under present law, a DWI offense that results in bodily injury to another person is the same criminal charge as one that does not cause injury. This law would establish separate, more serious penalties for bodily injury to other persons.

#### \*DWI CONVICTION THAT RESULTS IN PROBATION SHALL BE USED, FOR ENHANCEMENT PURPOSES, AS A "FINAL CONVICTION"

Under present law, a probation is not considered as a final conviction. This means that when the individual is arrested again and possibly again, it is treated by the courts as another "first offense". Under this recommendation, the probation would be a final conviction.

#### \*EXCLUDE THE DRIVING WHILE INTOXICATED OFFENSES FROM THE COURT'S DISCRETION OF UTILIZING DEFERRED ADJUDICATION

Under Deferred Adjudication, the individual pleads guilty before a Judge; then the Judge defers an entry of judgement pending a probationary period. If the defendant completes the period (usually a year), then the offense is removed from his record.

#### \*REVISE CONDITIONS FOR AUTHORIZING "HARDSHIP" LICENSE TO MINORS

"Hardship" licenses would only be granted if refusal to issue a license would create a unusual economic hardship on the person's family. The license could be granted because of illness of a member of the family. The license would be restricted to a 25 mile radius of the person's address, valid only from 6:00 am to 9:00 pm and valid for a 6 month period.

#### \*REMOVE ALL JUVENILE DRIVING OFFENSES INCLUDING DWI AND DUID FROM THE FAMILY CODE AND PLACE IN APPROPRIATE STATUTES.

Under this proposal the penalties for committing DWI or DUID offenses would be the same for juveniles, as adults.

Although no action will be taken until the Legislature convenes in January, DWI bills have already been filed by some legislators. Those bills already filed differ; some do not seek to raise the drinking age to 21 or ban open containers. Some seek stiffer penalties than others.

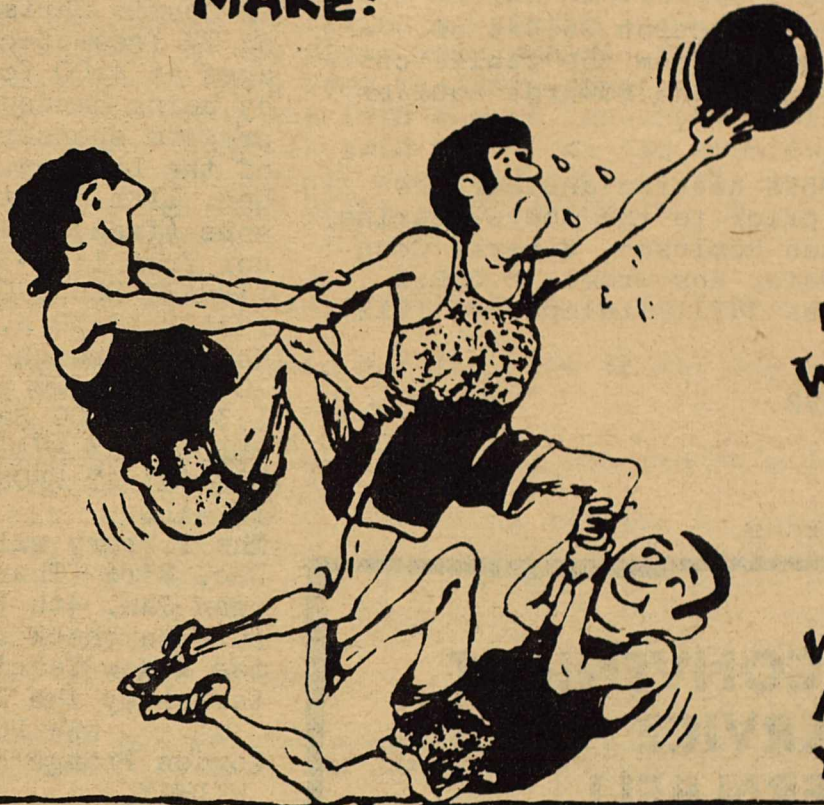
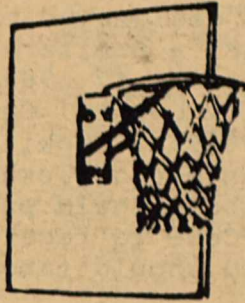

**Q. What does the word "viscosity" mean in describing the protective properties of motor oils?**

Q. What does the word "viscosity" mean in describing the protective properties of motor oils?



A. Viscosity refers to the ability of a fluid to flow at a specific temperature. The lower the viscosity, the easier the oil will flow. In and of itself, viscosity does not refer to protection, although, using a lubricant too "thin" for the application may cause metal-to-metal contact and abnormal wear. For this reason, say experts at Gulf Oil, motor oil of the viscosity recommended by the automotive manufacturer should be used in accordance with temperature charts usually provided.

## SHERIFF'S CORNER

This past week was another busy one. I was down with the flu a couple days and I want to thank Chief of Police Donnie Nance, Patrolman Sam Pat Ferguson and Game Warden Bill Lindeman for filling in for me and taking some of my calls.

We transported two prisoners to San Antonio early Friday morning (the 3rd) to catch the "chain bus" to T.D.C. in Huntsville. The "chain bus" is slang used to describe the circuit bus that the Texas Department of Correction sends out every couple of weeks on a big circle to pick up prisoners at pre-determined locations throughout the state.

These prisoners are those that have been convicted of felony offenses and sentenced to do time in the state penitentiary at Huntsville, Texas.

This program is beneficial to both the T.D.C. and the counties that use it. Time and money are saved and it allows T.D.C. to process several prisoners at one time instead of having them trickle in from all over the state at all hours of the day and night. The pick-up point nearest us is the Bexar County Jail in San Antonio. We had to leave at 2:00 am in order to reach San Antonio and have the prisoners processed and ready to leave on the bus at 6:00 pm.

One of the prisoners had been convicted of Felony Theft and Escape. He had stolen a car and other property from a local citizen and was

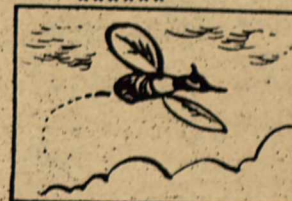
apprehended in Brookshire, Texas, the next day. I was Chief of Police at the time and Sheriff Sheedy and I went to Brookshire and transported the prisoner back to Kinney County. While he was waiting trial he and two other prisoners escaped from jail. They were captured later the same day and returned.

The other prisoner had been convicted of various narcotics violations and was in possession of approximately 50 pounds of marijuana when apprehended by DPS Narcotics Officers in the western part of Kinney County in December 1981. Both these prisoners received sentences totalling 4 years each on the various charges.

The inspector from the Jail Commission was here on the 7th and we received 9 citations on various problems in the jail. None of these were serious and with a little help from Commissioner's Court and a little time we will be in good shape. The inspector also approved addition of more bunks to add to our overall capacity. Therefore the contract negotiations with the U.S. Marshal's Service can be firmed up and the jail should start paying for itself and take some of the burden off the tax-payer.

I have other things I want to tell you about but they will have to wait until next week as we are running out of space.
