Regular commercial chili powder is permissible but complete commercial chili mixes are not. All chili will be cooked out in the open and with no beans, macaroni, rice, hominy or filler of any type. The head cook will prepare and cook chili in as sanitary a manner as possible and is subject to inspection by the judging com-mittee. There will be Trophies for the top 10 chilis and top 3 showmanship winners of the State Open Championship, "Border International Open," chili cookoff. 1st, 2nd, & 3rd, and 1st in showmanship qualify to go to the original World Championship Cookoff at Terlingua. Red and Happy Shahan, CASI officials will be fulfilling your wildest expectation in presiding over this great event.



For those brave enough to try you may enter the jalapeno eating contest or compete for cooking the largest round eatable tortilla (cooked at home).

McClure replaces Linden Kettlewell, who left the staff to become counsel to the chairman of the Republican National Committee.



BOB BULLOCK - COMPTROLLER

State Comptroller Bob
Bullock Wednesday called Govenor Mark White's proposed
use of bonds for highways "the
fast lane to nowhere" and said
he would suggest several state
finance proposals to the
Senate Thursday.

"I believe Texans expect
their Governor to present a
balanced budget, not a package
of service cuts and tax hikes
masquerading as 'alternatives'
the way Mark White did today,"
Bullock said. "But if the
Governor can't present a
balanced budget, it's up to
the rest of us in state leadership to take up the slack."

Bullock said he has proposals that could bring an extra 1.5 billion into the State Treasury over the next two years "without leaving the state in a New york-style financial mess."

Bullock will present the proposals during a Committeeof - tue Whole meeting of the Sate Senate Thursday.

Bullock pointed out that Texas is one of only 12 states that enjoy a topflight triple A bond ratings and the lowest available interest rates on the bonds they issue. Of these 12 states, only six use bonds for highways, and of these six, only New Jersey could be considered a major porrower.

"There are 26 more states that issue highway bonds but pay much higher interest rates. I don't want Texas in that category becauselosing that lowest interest rate is goint to cost millions,"
Bullock said. "Let's look very carefully at all these bond programs the Bovernor is proposing before we leap into something we'll regret later.

"If we float bonds for highways, somewhere down the line we'll be sacrificing maintenance for debt servicea New York syle financial mess.

U.T. CANCER CENTER NEWS

It's new. It's free. It's easy-to-remember--1-800-4-CANCER.

The University of Texas M.D. Anderson Hospital and Tumor Institue's Cancer Information Service (CIS), the statewide telephone line that answers Texan's questions about cancer, now has a phone number that spells its purpose.

This easily recalled number will help make the CIS more accessible to the general public, according to Jo Ann Ward, director of the M.D. Anderson CIS.

"T he CIS will still be providing the same kind of current, factual cancer information, but it is our hope that now we will be able to serve even more people who have questions about cancer-a disease which in some way affects two of every three families," said WArd.

"The M.D. Anderson CIS will share this phone number with 20 other CIS offices across the country, allowing Texans to pass it on to out-of-state Friends and relatives who automatically will be connected to the CIS office serving their area."

Only people calling 1-800-4-CANCER from within Texas will be connected directly to the M.D. Anderson office.

Established in 1975 as a public education program of UT M.D. Anderson Hospital, the CIS's goal is to enable people to have immediate access to the latest information about cancer. In addition to providing assistance over the telephone, the CIS also mails free, printed materials about cancer to callers who request it, serves as a source of referral to community services for cancer patients and their families and is a contact point for the latest information about cancer research.

Over the years, the CIS staff of trained volunteers has assisted more than 50,000 Texans with their cancer concerns.


The M.D. Anderson CIS is just one part of a nationwide network of offices, based at major cancer centers and funded by the National Cancer Institute. Included in this network are 21 regional offices serving 65 percent of the nation's population. The rest of the nation is served by an office operated at the National Cancer Institute, which also handles late-night calls until midnight (Eastern Time) and weekend calls. Since the program began these offices have fielded more than a million calls.





Taking aim on fraudulent calls

In recent months, you may have read that Southwestern Bell is beginning to take steps to cut down on the number of fraudulent long distance calls placed from public telephones and charged to an unauthorized 💀 third number.

Effective April 1, the company will begin a new procedure that is designed to eliminate fraudu-

On that date, all Southwestern Bell operators (as well as operators from independent phone companies) will start requiring approval from an individual at the third number before the call is put through.

While this new procedure may cause a slight inconvenience for customers desiring to place legitimate bill-to-third-number calls from public telephones. it will benefit everyone in the long run.

First, this will greatly reduce the burden on customers, who help shoulder the cost of fraudulent third-number calls through higher rates. And secondly, there will be less expense of having to investigate those types of calls, which also drives up rates.

Actually, the new thirdnumber verification will cause a delay of less than one minute. If the operator is unable to verify the charges, the caller will be asked to provide alternate billing (such as charging the call to his or her Southwestern Bell Calling Card or placing the call collect).







SENIOR CITIZENS TAX

Last summer, when Congress enacted new tax legistation, most of the attention was focused on the fact that this was the first election—year tax increase in history. In the ensuing months, however, the public has begun to take a look at some of the provisions Congress put into that law—provisions that affect them directly.

Perhaps the real "sleeping giant" of the tax bill is its provision that requires banks and other financial institutions to begin witholding 10 percent of interest and dividend payments next July 1.

Congress did place exemptions into the law--low-income citizens with a tax liability of \$600 or \$1,000 on a joint return, and senior citizens with a tax liability of \$1,500 on a joint return. The Treasury Department estimates that almost 90 percent of the 26 million senior citizens are afficially "exempt" for the law.

But a closer look at the bill's provisions show that, even if senior citizens are "exempt" they are none-theless directly affected by the 10 percent withholding law. Donald Ralston, President, The First State Bank, says "this exemption process is just another example of unnecessary government instrusion into our lives."

First and foremost, the exemption

process is not automatic. If, for example, a retired couple had five sources of interest or dividend income—a bank savings account, a sixmonth certificate of deposit for a savings and loan compnay, a money market mutual fund and stock in two companies from which they receive dividends, that couple would have to file five exemption certificates one at each income source.

Should this couple fail to file the exemptions forms, either because they didn't know they had to or because they were physically unable to do so, then 10 percent of their interest and dividend earnings would be withheld.


This raises serious implications. will have to swear to a to Not only would the couple lose 10

percent of their interest and dividen income each month—money that might otherwise go to pay for food, housing and medical bills—but they would have to file a tax return to get their 10 percent withholding back from the government. In other words, millions of people who have been outside the tax system for years might suddenly fined themselves back in the thick of it— all to receive money that they were entitled to all along.


