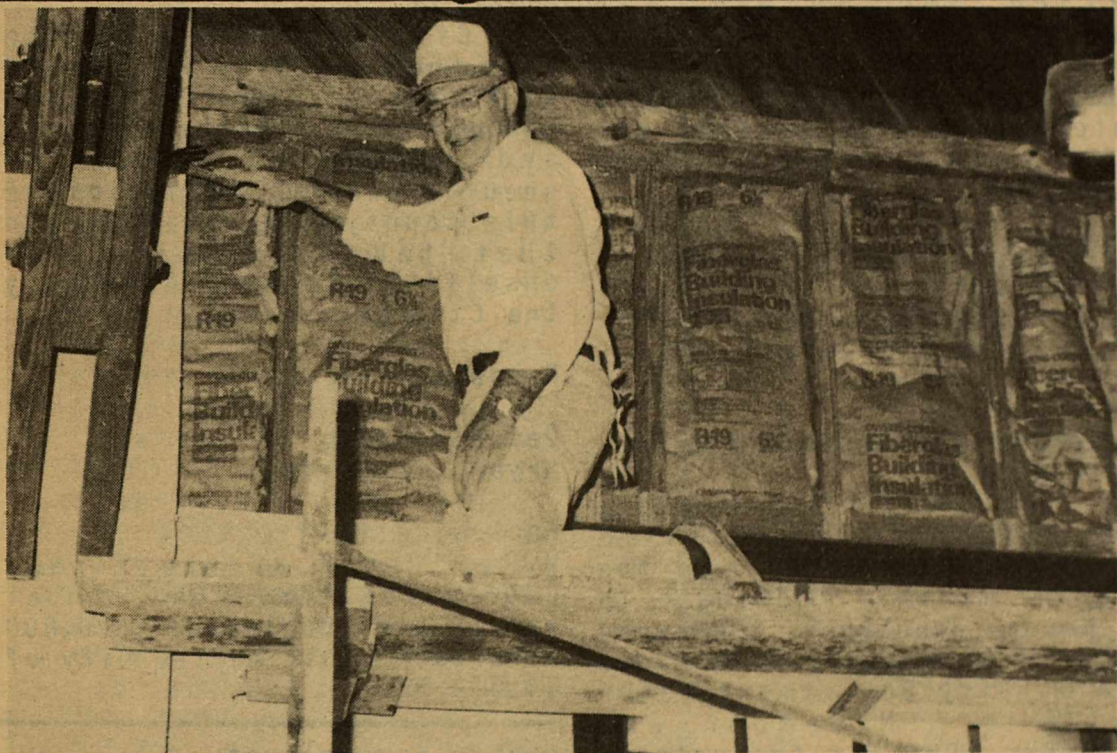

The City Council representing the City of Brackettville meeting in open session at the regular monthly meeting held on Monday January 9, 1984 were presented and duly considered the Utility Department Water Bills for November and December 1983 for the metered water delivered to the County Cemetery.

The City operations department has been paying to the Utility Department the Cemetery billings in accord with the 1967 City election that directs that under \$330,000 Enterprise Utility Bond Loan that no unmetered water or free water would be supplied from system and in turn no tax monies would be encumbered to back this 30 year amortized loan.

Enclosure (1) depicts 1983 water usage and billing costs at the County Cemetery. This billing indicates an extremely high rate of water usage and a shortfall of conservation measures.

It is therefore requested that the Court institute some plan to receive and pay for the County Cemetery water billings. The Utility Department will perform any and all tasks that the Commissioners feel will be beneficial to help alleviate this conservation and financial problem. The utility department stands ready to install and bill separate meters to each of the sections of the cemetery if so directed.

The City has been proud to help the County in its period of financial shortfalls. Now through your combined efforts and published financial security we ask you to assume this County financial burden that had previously and unselfishly been provided by the City Government.

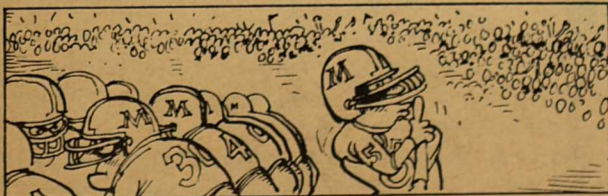
1983 PROGRESS REPORT / 63RD JUDICIAL DISTRICT

During 1983, this office secured 165 criminal convictions. resulted in 67 defendants placed in the Texas Department of Corrections and 84 defendants placed under supervised probation. An additional 14 defendants were prosecuted in the County Courts on reduced charges.

The State filed 11 motions to revoke probation. The defendants in those cases were also placed in the Texas Department of Corrections.

The prosecution of felony cases by this office in 1983 resulted in criminal defendants being ordered to pay \$60,445.44 in restitution to victims, and \$16,050.00 in fines. In addition, \$7,703.81 was recovered on bad checks, \$3,859.00 on bail bond forfeiture, and 20 firearms were forfeited to the State of Texas for use in destruction.

Our work in 1983 could not have been accomplished without the cooperation of the officials of our four counties, the City of Del Rio, and all law enforcement agencies. In this regard, I want to extend my appreciation to you for your encouragement and assistance.

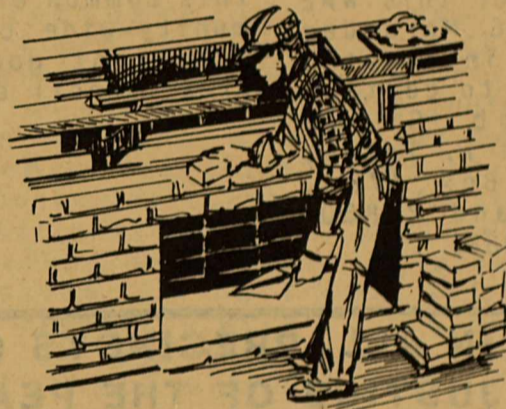

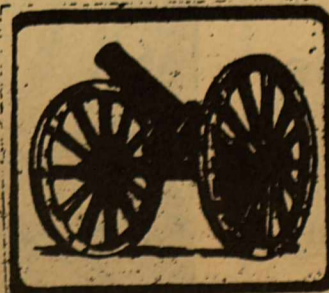

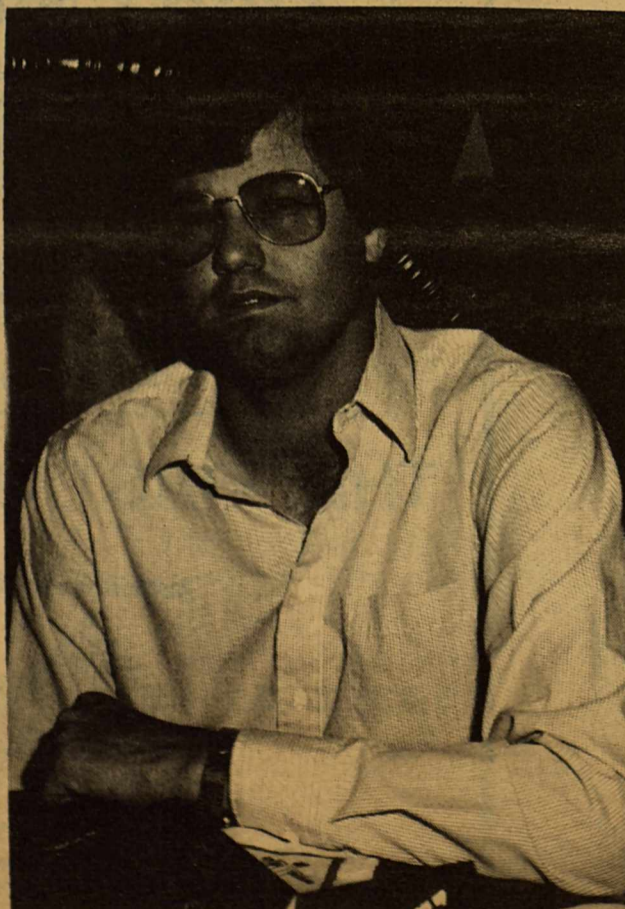

SHERIFF'S CORNER

Whew! This past week has been one of those that probably created the old saying, "I've enjoyed all of this I can stand!" I checked the moon every night and it wasn't full, just half full, but boy that half was FULL.

Family disturbance call were occurring at the rate of two, sometimes three, a night.

Two local citizens evidently decided to have a drinking contest and were booked into the jail on Public Intoxication charges three times each in 24 hours.

A burglar or burglars broke into Deason's Conoco on Hwy. 90 the night of February 9, by breaking a window in the rear of the building to enter a room containing a safe. Entry was not gained to the safe or other valuables and the burglar or burglars left through the rear door empty-handed. There are no leads in the case at this time, though a suspect is being watched.

Tuesday morning, about 4:00 a.m., I received a call at home from Jailer Jesse Garcia, who reported that "thumping" sounds could be heard in the jail or perhaps from outside the jail. Chief Nance and myself went to the jail immediately to investigate. After a thorough search of the jail inside and out turned up nothing we walked outside and Chief Nance said he could hear "thumping" noises coming from the vicinity of Davis Hardware. Through a pre-arranged plan, Chief Nance one way and I another, converging in front of Davis Hardware. There we discovered the origin of the "thumping" noises. A newspaper truck was parked in the street and the operator was unloading large bundles of newspapers into the bed of a pickup that was several feet lower than the bed of the truck. As the large bundles hit the bed of the pickup, there was a loud "thump" that echoed through the quiet night air. Chief Nance and I, with brilliant police work had solved the case of "The Thumping Noise".

Charges of Disorderly Conduct and Assault were filed against Martin DeHoyes, 19, of Brackettville Sunday night, February 12, after a disturbance and fight at a local tavern. DeHoyes was arrested by this officer at the residence of relatives shortly after the reported incident. He was booked into County Jail and the charges were filed in Municipal Court. DeHoyes was released the following morning on bonds totaling \$1,000.00. He was tried before Municipal Judge Louis Starzel Tuesday morning and was released after pleading guilty to the charges and paying fines totaling \$235.00.

The work on the outside exercise yard at the county jail is almost complete and most likely will be by the time you read this. I should have the total cost figures for you in time for next weeks column.

Monday, February 13, Commissioner's Court accepted a bid from Calhoun Electric Co. of Del Rio to perform the installation of the new Intercom system and security door at the county jail. This work is the last phase of the order we received from the Texas Commission on Jail Standards and **hopefully** will bring us into the standards required, at least until another court case is won by a prisoner somewhere to gain more comforts and benefits while in jail. The way things are going now I wouldn't be surprised to see the courts someday having us pay the prisoners while they are in jail for violating the law.

One of my old Texas Ranger friends told me twenty years ago that law and order through the courts was like a pendulum on a Grandfather Clock, it will swing one way for awhile in favor of the law abiding citizens and peace officers. Well, I've been waiting twenty years to see it start swinging back in "our" favor and it's still swinging in the favor of the criminals. I have not given up though. Someday, people will get fed up with all the "rights" of the criminal and start demanding "rights" for the victims of the crimes.

All of us want things to be better for the generations of children and young people who

will follow us. Our children are our future and our only legacy. I came across a poem the other day that touched my heart with it's meaning for what we learn in life and try to leave for our young ones. I would like to pass it on to you. Some of you may be familiar with it, I was not and the name of the author is omitted.

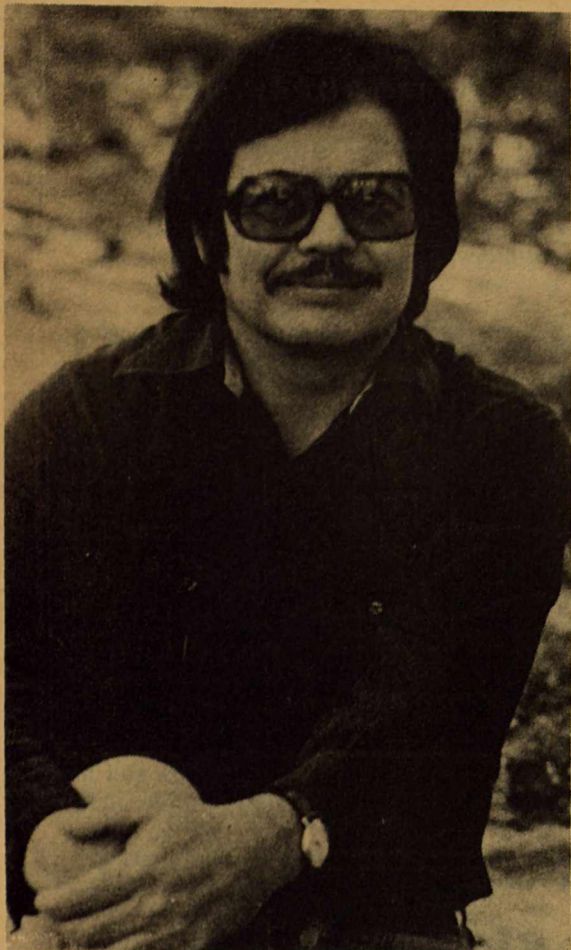



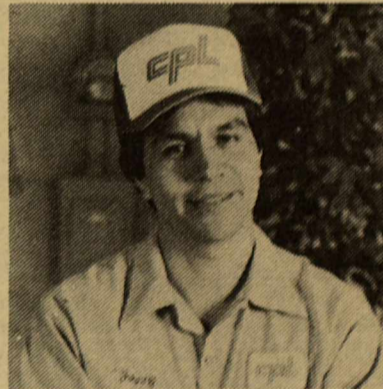
