Mrs. Charolette Corey Kinney County Librarian

This week of March "Texas Book Month" we are featuring "I Married A Soldier or Old Days in the Old Army" by Lydia Spencer Lane, a reprint of a book first published in 1893 as a "notable personal narrative concerning the history of the Southwest". Mrs. Lane spent much of her married life following her husband from one military post to another during the days of the "Old Army". One of the forts they passed through was Ft. Clark during July 22nd of 1856 where they lived during their breif stay in a "little shanty in the Chaparral".

Later she mentions her family being "Kindly entertained by General French who was in command of Ft. Clark at the time. Also covered are narratives about Ft. Bliss, Sante Fe, Taos, Ft. Union and famous characters such as Kit Carson, James Magoffin, and General H. H. Sibley. Written mainly as a dairy to leave to her children, Mrs. Lane sometimes speaks with humor and sometimes with awe as she recounts the local customs and manners. "One cannot help but admire the undertone of wifely pride found on every page as she faces the problems of keeping her family happy and properly fed and clothed".

Originally published in 1893 it was printed on a type of paper that rapidly deteriorates so rapidly deteriotes so the few existing copies of the original edition are seldom found in readable condition. This is why we are honored to have a 1964 reprint edition published by Horn and Wallace to add to your reading enjoyment and help all you "Texana" & Ft. Clark researchers out there.

In the Foreward of this book Mrs. Dwight D. Eisenhower acclaims Mrs. Lane's memoirsas a narrative of a "hardy, courages, and almost indestrutable people". For this reason Mrs. Jewel Robinson has donated it in memory of Mrs. Judy Loos.

Commissioner's Court Monday, March 12, approved and passed a RESOLUTION requested by me to raise prisoner care fees at the County Jail to \$25.00 per day per prisoner for outside agencies detaining prisoners in the County Jail. This increase was necessary to offset the recent expenditures necessary at the jail because of rulings by the lexas Commission on Jail Standards for the outside exercise yard and a new Inter-Com system. Had we not had to expend these funds the Jail would be showing a estimated \$12,000.00 profit at this date instead of the minus \$247.15. This rate increase should allow us to compensate for these

expenditures and get well into the black by the end of this fiscal year.

A suspected break-in at the Curcio in Ft. Clark was investigated by this officer and Richard Dempkowski, Ft. Clark Security Gaurd at approximately 4:45 a.m. Wednesday morning. A thorough investigation of the premises was conducted and as the owners were absent it has not been determined at this writing if anything was taken. It is believed at this time that the front door of the residence was secured and was blown open by the wind. The case is still under investigation.

All the girls who competed were winners and we should be proud to have young ladies of this caliber in our community. They all worked hard on their talent routines and dazzled the capacity crowd at the Civic Center with their beauty and poise. SHERI WHITE HOUSTON LIVESTOCK SHOW WINNER


Quality reigned in this year's Fine Wool division of
