

FORT CLARK DAYS - APR. 6-8



Pictured above is the 4th U. S. Memorial Cavalry Regiment. The unit was initially formed in 1971 and now consists of approximately twelve members from the San Antonio area. The Regiment will camp with their tents and horses in the manner of a Cavalry unit of 100 years ago, during the Fort Clark Days Celebration - April 6, 7 & 8. The Troopers will march in the parade, conduct drill exercises, firing and sabre demonstrations, as well as re-enact a patrol and skirmish action as it might have happened in the vicinity of Fort Clark in its earliest days.


Wayland D. Simmons

Hillcrest Funeral Home of Brackettville was in charge of arrangements.







The shooting incident which I reported to you last week is still under investigation. We have reached the point where nothing more can be done until lab reports from DPS in Austin are returned and more information can be obtained from those involved in the incident.

The stolen pistol that was involved in the incident has turned out to belong to the victim of the shooting. She had reported the automatic stolen in Bexar County in 1978 and evidently recovered the gun. She did not report the recovery or possibly there were other factors involved in

the original report.

Joe De La Graza, 31, of Eagle Pass, Texas turned himself in to the Texas Department of Corrections on March 22. De La Garza was convicted of Possession of Marijuana with Intent to Distribute in 1981 and was assessed a sentence of 2 - 5 years in TDC and a \$5,000.00 fine. He appealed his conviction and the Appellate Court upheld the original conviction. It is doubtful that the fine will be collected, but I intend to put a hold on him and attempt collection upon his release from TDC.

Most likely, by the time you read this, I will have returned from TDC in Huntsville with Gregoria Velasquez, the Mexican National who was convicted of burglarizing the ranch residence of Charles "Ford" Dodson. The court retained jurisdiction in the case for 180 days and though he received a 4 year sentence, he will, I am sure, be released on parole and deported to Mexico.

A murder occurred in Edwards County near Barksdale on Monday, March 26. Details are sketchy at the time of this writing, but it appears that robbery was the motive and the victim could possibly have been a smuggler of illegal aliens. Texas Ranger Tol Dawson of Del Rio and Sheriff Don Bates Rocksprings are the primary investigators of the case. The victim, an older Mexican male, was beaten to death with a .22 caliber rifle and a .22 caliber revolver ...

Work on the new inter-com system at the County Jail is progressing at a fast pace. It was anticipated that it would take 2 weeks to complete, but the installers are ahead of schedule and, hopefully, will complete the required installation early next week.

Our sympathy is extended to the Francis Hidalgo and Pedro Benites families. Anita Bemites, their mother, passed away on Sunday, March 25 in Sabinal. She was buried in Brackettville on Tuesday, March 27, with services being held at the Catholic Church.

THUNDERBIRDS TO VISIT DEL RIO



Other activities will include marching bands, static display aircraft and aerial demonstration from Laughlin and other Air Force units.



BLACK HOLES, RINGS, MOONS & STARS ...

... A FASCINATING PRESENTATION AT SWTJC IN UVALDE & YOU'RE INVITED!

Black holes, the rings and moons of Jupiter and Saturn, the birth and death of stars, the entire Universe itself ... such are some of the fascinating vistas unveiled by

modern astronomy.

The excitement of the modern astronomer's view of the cosmos will be available to the public, from elementary age students through adults, at Southwest Texas Junior College during a two-day program sponsored by the Harlow-Shapley National Lectureships in Astronomy on Monday and Tuesday, April 2 and 3.

Dr. William C. Straka, associate professor of physics at Jackson State University will present the program. His talk, that is open to the public, entitled "The Dark Night Sky," will be on April 2 at 7:30 p.m. in SWTJC's Tate Auditorium.

Straka will also give "An Overview of Astronomy and the Universe" talk designed for elementary age children for area school grades 1 - 5 on Monday, from 10 to 11 a.m. and from 1:15 to 2:15 p.m.

He will then speak to junior and senior high grades, SWTJC students and the college faculty on Tuesday, from 10 to 10:45 a.m. The Tuesday presentation is titled

"Supernovae ... The Stellar Spectaculars," which are, according to SWTJC physics instructor Mary Beth Monroe, exploding stars.

All Straka's seminars are supplemented with a slide

presentation.

Also according to Monroe, who is the coordinator of the event, letters have been sent to area schools inviting them to the programs. Two elementary presentations were scheduled because of an already enthusiastic response.

"Area students who are interested in the program should contact their teachers," Monroe said. "Teachers interested in bringing a group should contact me at SWTJC; 278-4401, ext. 224."

The visiting speaker will also be available to advise students on possible future scientific careers in informal discussions, and will discuss teaching and curriculum problems with faculty members.

In addition to his duties at Jackson State, where he teaches astronomy and physics from the introductory level through advanced studies, Straka is a consultant for Los Alamos National Laboratory, NASA/Goddard Space Flight

Center, and major industrial laboratories.

A member of the American Astronomical Society and former Executive Secretary of the Astronomy Advisory Committee of the National Science Foundation, he has authored numerous articles in astronomy research and teaching, as well as a physics laboratory manual.

Straka's research interests lie in the area of supernovae remnants, with observational studies involving image processing of radio and visible pictures, and theoretical studies involving studies of the hydrodynamics of the interstellar medium.

Supewrnova remnant nebulae are clouds of debris produced by the final explosions of massive stars. These explosions, flaring as bright as ten billion suns, expel a large fraction of the star's material.

This material in turn collides with the material in space, forming bubbles of thin filaments. In this way, the material processed by nuclear reactions in the star's interior is mixed back into the materials which become the next generation of stars.




