GLANDLESS COTTONSEED DEVELOPED


WASHINGTON - U.S. Senator John Tower (R-Texas) today announced that researach conducted at Texas A&M University and Texas Women's University indicates that a recently developed glandless cottonseed could have a dramataic impact on curbing world hunger.

Unlike its glanded counterpart, glandless cottonseed is safe for human consumption and contains 35 to 65 percent high quality protein. Extensive research has shown that the glandless cottonseed has the potential of meeting the needs of a burgeoning world population faced with a decreasing supply of animal protein and an increasing need for better nutrition.

"The utilization of this new source of protein will have a great impact on alleviating world hunger," Tower said. "Most underdeveloped nations have the capability to grow cotton and produce the glandless cottonseed."

This new strain of cotton has shown to be highly versatile. Researchers at TWU have tested glandless cottonseed flour in casseroles, quick breads, whipped topping, dressings, baked goods, snacks and candy. coagulated cottonseed protein curd product has shown great promise both as a cream chese alternate and as a meat. subsitute.

On Wednesday evening August 15, 1984 the residents of the area suffered a 100% blackout from electrical energy due to a transformer receiving a direct hit from lightning. At approximately 7:35 P.M. I received word from our utilities supervisor Frank Sanchez that our water supply pumps, our wells and our sewer lift station were not operating. As my home still had complete power we reported the outage to CP&L that part of town was out including city services.

At a little after nine the city crew was assembled and we

activated the city emergency water pump generator transfering emergency water from the ground storage tank to our elevated tank. This action alleviated any low pressure problem in the city and I suspect that most residences did not even notice any problems. At 10:25 the emergency CP&L crews that were dispatched temporarily repaired the main transformer and full power was restored.

The city lift station which the city crew was handling with our gasoline pump became operational and all was well with the sewer system. The water system was another story. The two booster pumps

SHAPE UP!

HOW TO CONTROL YOUR WEIGHT

Even athletes have to watch what they eat to keep their weight down. Here's the unstructured food plan that works for me. If your doctor says OK, maybe you'll find it helps you control your weight too:

•Eat a diet that's 50 to 65 percent complex carbohydrates (fruits, vegetables,

•Cut down on salt, substituting herbs and spices for

Make sure you have a good scale so you can know with certainty how you're doing. I take my Norelco digital scale along whenever I travel for longer periods because it's so important to have a weight


measurement I can trust.

• Drink six to eight glasses of water a day. Often we feel hungry when we are really just thirsty.

 Take vitamin and mineral supplements in case each day's diet isn't perfectly balanced.

Stay away from fad diets.
I reward myself for eating sensibly and training hard by occasionally having a sweet or dessert—home-made only!



YOUR FLOWERS **PAND PLANTS** Melpful Hints

Flowers are wonderful things to give, receive and buy for ourselves, but lots of us have trouble making them last as long as we'd like. FTD florists suggest helpful ideas.

The most popular flower gift is an arrangement of mixed cut flowers in a vase. so let's talk about that

type of bouquet



Arrangements should be wa-tered daily with tepid water, not

too hot and not too cold. They should be displayed in a cool place, out of sunlight but not in drafts, either. The top of the TV set is a bad place to put flowers because it gives off heat even when it's not on. Ledges and sills near heating and air conditioning units also should be avoided.

Some flowers in arrangements may droop before others and should be removed immediately so they don't affect the rest of the blooms.

Still another way to extend the life of cut flowers is to add a preservative to the water. Packets of commercial preservative are available from florists at low cost. You also can use sugar - a tablespoon to a quart of water. Aspirin dissolved in water, contrary to what you may have heard, isn't much help at all. As one florist said, "We recommend aspirin for headaches. not for flowers."



SHERIFF'S CORNER

The theft of a set of car keys from a car set the stage for further criminal action that finally occured between the hours of 2:00 a.m. and 6:00 a.m. Sunday morning, August 19th.

Betty Ward reported that she stopped at a local grocery store for a few moments late last week and placed her keys over the sun visor. When she returned to her car, the keys were gone. A thorough search of the immediate area and inside the store returned negative results.

Chief of Police Richard "Ski" Dempkowski was contacted and he also was unable to locate the keys. After questioning witnesses at the scene, he developed two suspects believed to have been near the car shortly before the keys were found to be missing. Chief Dempkowski contacted me and advised me of the incident and his suspects. He also advised that the vehicle had been towed, away to the Ward residence on Ann St.

It was suggested that the car be mechanically prevented from starting so as to prevent what we believed to be prospective car thieves from returning and stealing the car at a later time. As we had no positive identification of the persons who we suspected of taking the keys, all we could do was to attempt to keep them under surveillance. Our hope was to catch them in or near the Ward vehicle when what we believed would be an attempt to steal the vehicle.

Sunday morning at approx. 6:30 a.m., Roy Dyer, Senior Patrol Agent with the U.S. Border Patrol called to report that his vehicle, a white 1981 Oldsmobile, had been stolen between the hours of 2:00 a.m. and 6:00 a.m. that date. The vehicle was entered in the TCIC computer as a stolen vehicle.

At approx. 9:30 a.m. Mr. Billy Cashion, one of the owners of the Texas Youth Council Foster Home located on North Ann St. called to report that two of the youths being housed there were

missing and were last seen at a 12:30 a.m. bed check.

The two youths, one 16-years old and the other 13-years-old were the suspects Chief Dempkowski and I had in the theft of the car keys from the Ward vehicle. Their names, descriptions, and possible destinations were also entered in the TCIC computer and linked to the theft of the Dyer car as suspects. All area law enforcement agencies were notified and most roads and highways leading out of Brackettville and Kinney County were checked in an attempt to determine if the vehicle might have been abandoned after the theft. The results were negative.

At approx. 11:45 p.m. Sunday night I was called at home by jail dispatcher Pete Bland who advised that he had received a teletype message from DPS Texarkana. It advised that one of the suspects and the stolen vehicle had been apprehended and were in custody. A short time later, the second suspect, the 13-year-old, was also in custody.


I notified Mr. Dyer and he contacted the Texarkana authorities early Monday morning and made arrangements to fly there to recover his vehicle. Charges are pending against the two juvenile criminals.

Questioning of some of the remaining youths at the TYC Foster Home has provided information that the stolen keys were indeed taken by one of the youths involved in the theft of the Dyer car. Also, that the two offenders had been planning their escape/runaway from the foster home for several days.

This brings to mind several recent incidents involving the TYC Foster Home and those youths being housed in it. There have been several mass runaways and at least one other car theft involving these youths. They recently stole a van belonging to the First Baptist Church whose members have been active in trying to help these youngsters get their lives straightened out. Gratitude? The van was abandoned and recovered in South Texas and the offenders/runaways taken into custody. One of the youths involved in the latest auto theft was involved in other escape/runaway attempts and has been returned here every time. Perhaps tighter security would be in order and other measures should be taken into consideration by the owner-s/directors of the foster home.

Those of us in local law enforcement have worked long, hard hours to control criminal activity in the Brackettville, Kinney County area. There has been a marked decrease in the overall crime rate in our area due to this increased law enforcement activity. It is not appealing to me to have these efforts overthrown by importing problems from other communities and introduced into our community under, what appears to be, lax security and/or supervision. Should we continue to have criminal activity occur in our community that is directly linked to the foster home and its inmates or members I intend to have some serious conversations with, not only the local owners, but also the state directors of the Texas Youth Council. They contract on a monetary basis with the owners of the foster home here.

Sure, we want to assist young people who have strayed from the straight and narrow and make every attempt to assist them in getting their lives straightened out. That they will, in time, lead productive adult lives, but not at the expense of our local citizens who must suffer the expense of the loss of valuable property and constant worry of being burglarized or haveing their vehicles stolen.

Dear Mr. Loos:

With the exposure you have given to the city in regard to the taking of Mr. Huey's property, I trust you will give our response equal attention.

As the attorney representing Mr. Hawkins Huey, I participated in all of the proceedings that Mr. Thurber, your City Manager, described in the August 3, 1984 edition of the Cavalryman and I scarcely recognized what he described. Moreover, his victorious tone was a twist of the knife in the side of a very fine individual, Hawkins Huey.

Indeed we did lose. The city of Brackettville was able to take away the private property of an individual citizen. Now, a small fortune in money will be spent by the City of Brackettville to restore the building containing materials taken from Ms. Huey against her will. Across from the courthouse, I saw several old and magnificent buildings in decay, all more central to traffic routes than the one the city now owns, But the City of Brackettville decided to take what it wanted. And it did.

In years past, the government just couldn't come in an take a person's private

property. I guess things change. But I believe it is a very sad day for the constitution and I believe our personal rights have been tarnished.

Ms. Huey purchased materials from Dr. Moore. She has a bill of sale recorded in the courthouse for all to see. I can't understand how Mr. Thurber could describe that as a "tentative" purchase. Only after the purchase did the city act

Unlike Mr. Thurber, I do not attempt to interpret Dr. Moore's actions. From the very beginning, Dr. Moore told us he did not want to get involved and he did not. He only said he didn't want any activity at the building which would disturb him. That is why he sold the materials to Ms. Huey instead of selling the building intact. When the city condemned the property, he simply took no action to

It is unfortunate to me that the jury could not be asked whether or not the city had a right to take the private property of Ms. Huey. They were not. All the jury was able to decide was how much the property is worth. It was presumed that the government has the power to take. But Mr. Thurber didn't mention that. He only made it sound like this woman was out to destroy "this unique

architecturally sound"

structure. I guess that phrase was meant to make you feel better about the hundreds of thousands of dollars to be spent on the building. But what about the bank? And the

jail? Why not them?

Ms. Huey is a dedicated preservationalist who is not about to try to destroy an old building worth saving. Anyone who has seen the vintage homes she is restoring in town knows that. In fact, that is what she was going to use the materials for, restoration of two buildings which are becoming Brackettville landmarks without public money. And the "free materials offered" were no where near comparable to what the city took from Ms. Huey.

Two registered engineers at the trial testified the materials owned by Ms. Huey were worth thirty-five to forty-five thousand dollars. I don't think Ms. Huey can be faulted for turning down the city's offer of two thousand dollars, even if that is all she paid for them. We all expect to make a good bargain and sell things for more than we pay. And we don't expect to be forced to sell our property to the government.

All we learned from this is that government can take private property. And as the power of government grows, our rights decrease. Our property is not safe from the whims of government. What next? As Mr. Thurber gloats over the government's victory, I wonder what the founders of this country might say. They would never have tolerated such acts; in fact, they fought a revolution to prevent just this kind of governmental power.


