CITY MANAGER APPOINTED

CITY MANAGER APPOINTED

Bobby (coach) Slaughter was appointed City Manager for the City of Brackettville by the city Council to take effect today Feb. 1, 1985 relieving W.M. Thurber who served in that capacity for the past three years and was appointed the Municipal Court Judge.

Coach Slaughter was born in Roscoe, TX and his family moved to Quemado where he attended school and later graduated from Eagle Pass High School. Slaughter attended South West Texas State University at San Marcus obtaining a BS degree in Education with a minor in Business in 1961.

Slaughter was coach and athletic director at Brackett High from 1970 to 1978 and again 1980 - 1984.

Coach Slaughter is married to the former Emma Jane Smith from Eagle Pass and they have two daughters Lisa who graduated from Brackett High in 1983 and Rhea who is presently a junior in high school and participates with the girls basketball team.

The city Council expresses their respects and gratitude to all five highly qualified and capable applicants that applied and were considered for the appointment.

CENTRAL POWER & LIGHT COMPANY

Central Power and Light Company customers will soon be paying less for electricity. According to Bill Cranford, CPL local manager, the Public

Utility Commission has approved the Company's request to reduce the fuel cost factor, which accounts for the major portion of the electric bill.

In ruling on the company's request to lower the fuel factor, the hearing examiner concluded that the commission has exclusive and original jurisdiction in setting the lower factor for all CPL customers.

Early last December, we asked the commission's approval to lower the fuel portion of customer's bills by reducing the fuel cost factor applied to customers bills since October 1983, Cranford said.

The Company is also seeking to refund \$16.6 million in fuel over-recoveries, which have been collected through September 1984. Application of a commission prescribed formula caused the over recovery. The PUC hearing examiner took no action on the refund, but indicated the issue will be taken up during hearings in Austin scheduled for March 4.

The company had sought to reduce the fuel factor effective December 26, but the PUC staff considered the filing precedential, requiring additional time to study the request. We established a precedent because we did not request a simultaneous increase in base rates as other Texas utilities have done, Cranford said.

The current ruling allows CPL to implement the lower fuel factor on January 26 and will first be realized on customers February bills. The

impact on residential customers using 750 to 1000 kilowatt hours per month would result in a savings of \$3.34 to \$4.46 on their electric bills. That represents approximately a six percent reduction in the price residential customers currently pay for electricity. The actual savings will depend on the individual customer's total energy use. Other customer classes would realize similar decreases.

CPL, which has not filed for a rate increase since March 1982, told the commission it has no intention of filing for such an increase during the first quarter of 1985.

SOUTHWEST JUNIOR COLLEGE TO HAVE AN INCOME TAX SHORT COURSE

The annual Southwest Texas Junior College income tax short course will begin Wednesday, February 6, at 6 p.m. in room one of the college's Wagner building for registration and the first class period.

Taught by Debbie McDonald, C.P.A. for Coleman, Dalrymple, Schuler & Elley of Uvalde, the course will also meet from 6 to 9 p.m. on five subsequent Wednesdays, February 13, 20, 27, and March 6.

Cost of the course is approximately \$20, but is subject to change, according to Adolph Gottschalk, SWTJC business administration chairperson.

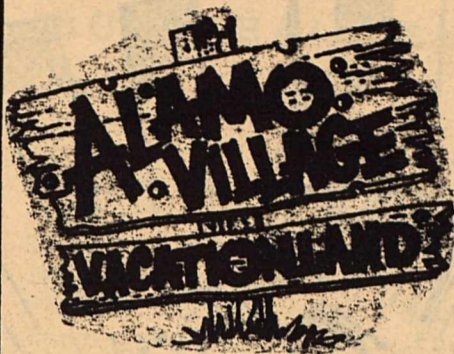
**THE
SHERIFF'S
CORNER**

I will use this week's column to summarize the county system of government in Texas, including the various elected officials and their basic duties.

County governments in Texas perform two basic functions: (1) they carry out the administrative and judicial responsibilities for the state and (2) they carry out local government responsibilities for county residents. Although the law confers corporate status on Texas county governments this does not mean that counties are municipal corporations nor is their status, scope of responsibility and power the same as that of cities, towns and villages. A county has no power or duties except those which are clearly set forth and defined by the constitution and state statutes.

In Texas, all counties, regardless of population or land areas, have exactly the same form of government except for minor differences in some urban counties where the state has allowed for additional offices and courts. The organizational structure is defined specifically in the state constitution. Every county has exactly the same structure for its Commissioner's Court. Each county is divided into four commissioner's precincts. In each of these, the voters of the entire county elect a County Judge. The Commissioners, so elected, with the County Judge as presiding officer, constitute the County Commissioner's Court. Commissioner's Courts have specific statutory powers but, in general, they have very limited legislative authority. The other major county offices provided for in the state constitution are County Clerk, Sheriff, County Tax Assessor-Collector, and County Treasurer. All constitutional offices are elective and have terms of 4 years. County statutory offices have different terms and methods of appointment.

COMMISSIONER'S COURT:

The most important governing body of the county is the Commissioner's Court. The County Judge presides over the meetings of the Commissioners Court and sees that the meetings are carried on in an orderly manner. The Commissioners Court is not really a court, but is an administrative body for the conduct of county affairs. The judge does have the authority to hold in contempt those who try to disrupt the proceedings of the court in the conduct of its business. The court may ask the Sheriff to maintain order and the Sheriff must comply. The law requires the Commissioners Court to meet at least once each month, and the regular meeting must be held the 2nd Monday of each month. The court can meet in special session at any time it so desires so long as the proper notice is given and there is the proper posting of such notice.

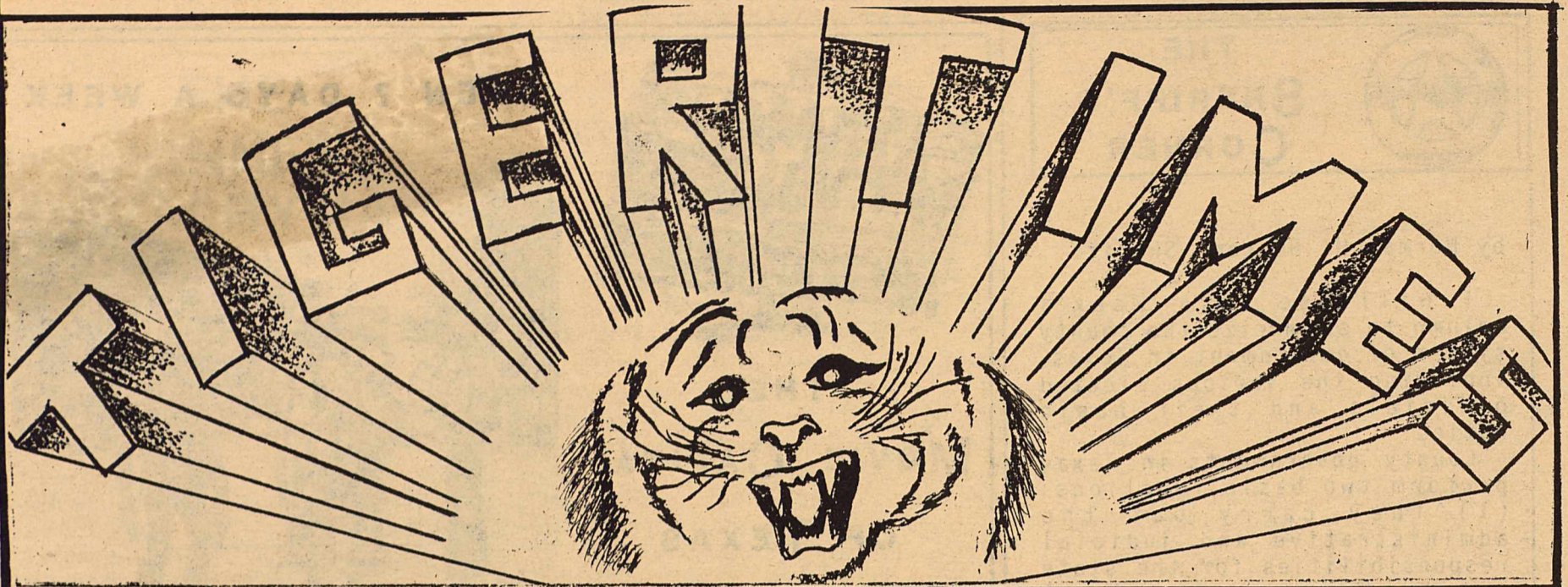
Any three members of the court may constitute a quorum for the transaction of all business. Therefore, any three Commissioners or the County Judge and any two Commissioners may transact all county business as a quorum. This includes the business of levying county taxes. In the absence of the County Judge, the Commissioners constituting the quorum select one from their number to preside.

The main functions performed by the County Commissioners Court are:

1. To supervise and control the county courthouse, county buildings and facilities.
2. To adopt a county budget.
3. To determine county tax rates.
4. To fill vacancies in elective and appointive positions.
5. To let contracts in the name of the county.
6. To build and maintain county roads and bridges.
7. To administer such services as libraries, county hospitals, welfare programs, parks and play grounds.
8. To make other decisions relating to county welfare such as county welfare, county hospitals, libraries, parks, relief to the indigent and civil defense.

Next week we will continue with a description of the various officials and their respective duties and responsibilities. Hopefully these facts will be of some interest to the citizens of this community and answer some of the questions you may have regarding just how and why your county government performs as it does.

Playing without the services of high scorer Maria Lozano the girls made a good showing by taking third place when they defeated Sabinal 23-20.

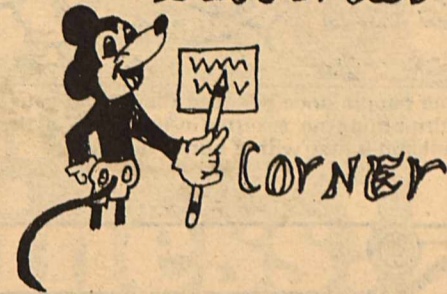

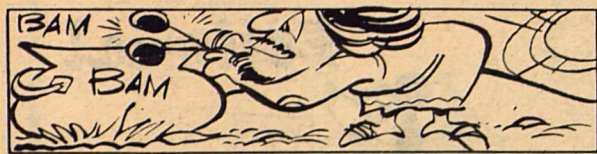

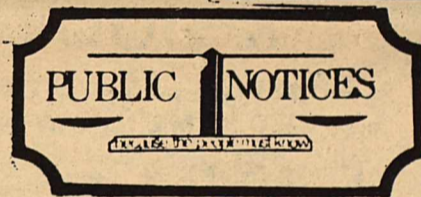
