REMEMBERING THE ALAMO

Today's Navy has nearly 600 ships in it. Within this number are ten that proudly carry the banner of Texas tradition. One of these ships is the USS ALAMO (LSD-33).

The ALAMO is a dock landing ship of the Thomaston class, a swift and powerful unit of the U.S. Amphibious forces in the Pacific. Commissioned in 1956, she was named for the Texas National Monument, the Alamo, in san antonio. she reflects the spirit of the Texas volunteers of 1836.

The ALAMO's primary mission is to transport and control loaded boats, landing craft, vehicles and tanks in early assault waves on enemy beached. she accompolishes this in a unique manner: the back. portion of the ship is lowered into the water a few feet so that the landing craft and other boats, or amphibious tanks, can be floated out and head directly toward the beach.

A seacondary mission of the vessel is to act as a boat haven, repairing amphibious craft of all sizes in its after portion (the back) of the ship. this versatility makes this ship much in demand by the fleet, by the Marine Corps, and by the Army. Her motto reflects this demand: "we deliver anything, anytime, anywhere."

The ALAMO was built by Ingalls shipbuilding Corp. in Mississippi. She is 510 feet long, and her well-deck of 395

feet by 48 feet can be flooded to a depth of 10 feet. The ALAMO is able to carry three very large landing craft, known as LCUs, or 20 medium-sized craft (LCM), or 40 smallercraftt (LCVP). As many as 100 two-and-half ton trucks used in combat, can be transported at one time. The ALAMO carries a crew of 21 officers and 384 enlisted personnel. she is capable of transporting a Marine Corps unit of 29 officers and 272 troops, plus nine staff officers, in- addition to the

ship's crew.
Navy ships have always played an important role in aiding victims of disaster, and the Alamo is no exception. In October 1962, she delivered emergency relief supplies to typhoon-stricken Guam.

Similiar missions throughout USS ALAMO's 18 -year career ensure that, like her namesake, the United States will "remember the Alamo". She continues her mission today serving in the Pacific Fleet from her homeport of San Diego, California

Meat is what nutritionists call a "nutrient dense" food. That is, it offers a high proportion of many essential nutrients for relatively few calories
The average American consumer just under four ounces of red meat per day, which represents 327 calories-only 16 percent of a 2,000 calorie diet. Those four ounces are composed of just under twothirds of an ounce of ground beef, about one and one-third ounces of other fresh beef, a third of an ounce of fresh pork, an ounce and a half of processed meats and about seven-hundredths of an ounce of veal and lamb combined. Meat is an important source of many essential nutrients, including protein, Bvitamins and minerals. Take iron, for instance. The iron in red meat actually increases the amount of iron absorbed from other foods eaten with red meat. And red meat is a much richer source of iron than chicken, turkey and fish. The thiamin in that average daily four-ounce serving of red meat equals 21 percent of a grown man's RDA (Recommended Dietary Allowance) and 30 percent of a woman's; it supplies 24 per-
cent of a man's and 33 percent n's RDA for niacin. Red meat contains less cholesterol than many people believe. Three ounces of cooked lean beef, for instance is slightly lower in cholesterol than the same size serving of roast chicken-without the skin. Cooked lean pork is only marginally higher in choles terol than roast chicken. The average four-ounce serving of all red meats combined con tributes less than one-third of what many doctors recon mend for maximum daily echo esterol intake ( 300 mg )
Individuals watching the fat in their diet should not cu out red meat. That average four-ounce serving of red meat contributes only 214 calories from fat. That's about 10 percent of a 2,000 calorie diet. Many nutritionists rec amend that fat contribute no more than 30 percent of daily calories, so it's easy to see that red meat fits in with om to spare
High in protein, minerals and B-vitamins and modest in calories, fat and choles terol, red meat is a valuable part of a balanced diet. This tasty American favorite is truly a nutrition bargain.

## CYTOTOXIC ALLERGY TEST

 UNPROVENCytotoxic testing has been advertised as a quick way to find out and cure what ails you by testing your blood for food allergies.
The catch is that there is no proof it works, according to the Texas Medical Assn

In addition, the U.S. Food and Drug Administration warns that newspaper ads inviting investors to get into the "profitable field" of allergy testing are misleading.

Promoters claim cytotoxic testing will cure a wide range of problems: asthma, arthritis, canker sorres, chronic cough, confusion, diarrea, depression, heart palpitations, headaches, anxiety, acne, baldness, back p.ain, bedwetting, constidation, crying,
conjunctivitis, eczema, fatigue, hearing loss, insomnia, learning disorders, obesity, rashes, stomachache, stress, and water retention.

But the FDA, the National Institutes of Health, and the American Academy of Allergy and Immunology disagree, saying there is no evidence that cytotoxic testing works.

Conducted at a cytotoxic clinic, the test involves placing drops of a person's blood on 200 microscope slides that have been coated with the dried extract of 200 different foods. If the white blood cells collapse or change shape, the patient is supposediy allergic to that particular food. The allergy results are used as evidence of almost any problem the person may have.

To correct this condition, the cytotoxic clinic generally offers a "personalized diet" that includes vitamins and minerals the clinic has for isale. Investors are told they will make more money on the products than on the testing itself.

Also referred to as Bryan's test, leukocyte antigen testing, and food sensitivity testing, the procedure is unproven since no studies have shown that white blood cells shrivel and die when exposed to foods a person is allergic to.

Cytotoxic testing costs from $\$ 200$ to $\$ 400$ for the usual series, plus additional charges for the vitamins. Patients apparently are not seen by a physician during the testing. FDA investigators note, however, that some products used in the testing can be legally ordered only by a medical doctor.

3 well-beaten eggs
1 pound ground beef

$1 / 2$ teaspoon cinnamon
$1 / 4$ teaspoon nutmeg
$1 / 2$ teaspoon salt
$1 / 4$ teaspoon pepper
1/3 cup butter
1/3 cup flour
1 cup dry Carnation nonfat dry milk
$23 / 4$ cups water
2 tablespoons butter
1 cup grated Parmesan cheese
Cook macaroni in boiling salted water 10 minutes. Rinse and drain. Stir eggs into macaroni. Brown ground beef, onion, and garlic in medium saucepan. Drain off excess fat. Stir in tomato sauce, parsley, cinnamon, nutmeg 1/4 teaspoon salt, and pepper. Bring to boil. Reduce heat and boil gently 15 minutes, stirring constantly. Melt 1/3 cup butter in medium saucepan over medium heat. Stir in flour, dry nonfat milk, and remaining $1 / 4$ teaspoon salt. Slowly stir in water. Cook, stirring constantly, until mixture just comes to a boil and thickens. Melt 2 table poons butter in $13 \times 9 \times 2$-inch baking dish. Box 526, Brackettville, Texas 78832 has applied to the Texas Department of Water Resources for renewal of Permit No. 10194-01 which authorizes a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 300,000 gallons per day from the wastewater treatment plant which is located approximately 0.8 mile southwest of the intersection of U.S. Highway 90 with State Highway 131 in the city of Brackettville in Kinney County, Texas. The effluent is discharged into Las Moras Creek; thence to the Rio Grande in Segment No. 2304 of the Rio Grande Basin.

The permit, if renewed by the Commission, will specify conditions and limitations generally the same as those currently enforced by the existing permit. The expiration date of the existing permit was March 26, 1984. It is proposed that the expiration date be specified as midnight, five yeras after date of Commission approval.
Legal Authority: Section 26.028 of the Texas Water Code, as amended, and 31 TAC 341 of the Rules of the Texas Department of Water resources.
No public hearing will be held on this application unless an affected person who has received notice of the application has requessted a public hearing. Any such request for a public hearing shall be in writing and contain (1) the name, mailing address and phone number of the person making the request; and (2) a brief discription of how the requester, or persons represented by the requester, would be adversely affected by the granting of the application. If the Commission determines that the request sets out an issue which is relevant to the permit decision, or that a public hearing would serve the public interest, the Commission shall conduct a public hearing, after the issuance of proper and timely notice of the hearing. If no sufficient request for hearing is received within 30 days of the date of publication of the notice concerning the application, the permit will be submitted to the Commission for final decision on the application.
