
The storage system is located on 3/4 block at the corner of Thorn and Seweeney streets in the city of



LAUGHLIN AFB, TEXAS -- the first of the Air Force's. newest aircraft, the T-46A Next Generation Trainer, rolled off the assembly line at the Firchild Republic Companies plant in Farmingdalle, New York recently.

The shiny new trainer was greeted with applause by more than 700 civilian, industrial and government officials, including secretary of the air Force Verne Orr.

Gen. Andrew P. Iosue, commander of Air Training Command was also present, representing the command that will ultimately become primary user of the aircraft.

The T-46A will replace the 28 year old Cessna T-37, currently used as the primary trainer for undergraduate pilot training conducted by the Air Force at six Air Training Command bases.

The first T-46 will be assigned to the Air Force Flight Test Center at Edwards AFB, CA where the first fllight is scheduled this spring. In mid 1986, Fairchild will begin delivering the new aircraft to the 47th Flying Training wing at Laughlin, where the first T-46 squadron will be formed. Air Training Command plans to begin using the T-46 for undergraduate pilot training in January 1988. A total of 650 trainers are expected to be built for the Air Force by 1992.

Although the new trainer resembles its T-37 predecessor in appearance, the T-46 can fly higher, faster and further.

Key features include a top speed of more than 450 mph, a pressurized cabin, modern avionics and an expended flight envelope, which will better prepare new pilots for graduation to high performance aircraft. A 400 mph cruise speed will reduce transit time to training areas, thus allowing more practice time per training flight.

The twin engine trainer has a service ceiling of 45,000 feet to permit safer training because it can be flown above the weather and general aviation traffic.

The T-46 is powered by two Garrett F-109 advanced turbofan engines, which provide maintenance, safety and operational durability. Each engine produces 1,330 of static thrust.

Fairchild officials estimate that the trainer will reduce fuel consumption by 60 percent compared to the T-37 and that, when requierd, engine replacement should take no more than 30 minutes. In addition the T-46s engine noise level will be below FAA noise polution standards, unlike the noise T-37.



Failure to pass this test can result the denial of graduation and diploma.



SHERIFF'S CORNER

In last week's column we summarized criminal activity in Kinney County for the calender year 1984. I failed to report the numbers of illegal aliens apprehended in Kinney County and the overall Del Rio Sector during last year. The importance of these figures is that a large perceantage of the burglaries and other rural crimes are linked directly to illegal aliens. this does not mean that we are using illegal aliens as a catch all on which to blame crimes committed in our rural areas when we have no other suspects. burglary or other crime reported is investigated and every effort is made to collect evidence at the crime scene that will lead to solving the crime and apprehending the offender. Some of the crimes committed

are border line cases in which evidence at the scene tends to lean towards illegal aliens, others are obviously committed by illegal aliens and others

are as obviously not.

At any rate, although the overall crime rate, particularly burglaries and criminal mischief cases, has decreased, the rural burglary rate has increased over the past year. Over 50% of the rural burglaries and criminal mischief cases reported in the county during 1984 are known to have been committed by illegal aliens. Officers of the local Border Patrol Station have been most helpful in assisting me at the scene of several burglaries. are not only trained and experienced in sign cutting and tracking, but have the man power and equippment necessary to locate and apprehend illegal aliens suspected of committing crimes in our county. The Border Patrol has never refused my request for assistance at a crime scene and for this I am, as the citizens of Kinney County shold be, most grateful.

There were 9,392 illegal aliens apprehended in Kinney County during 1984 and a total of 87,050 in the Del Rio Sector. Our country is literally being invaded at an alarming rate and this concerns me, not only as a peace officer, but as a private citizen. Apprehensions of these illegal invaders can be increased with the assistance of private citizens. if you will report sightings of suspected aliens to either the Border Patrol or the Sheriff's Office, giving the location, time, numbers, and direction of travel, this information will greatly assist in the apprehension of illegal aliens. Rest assured we must take every action possible to stem the flow or we may wake up some morning wondering what has happened to our economy

and country.
