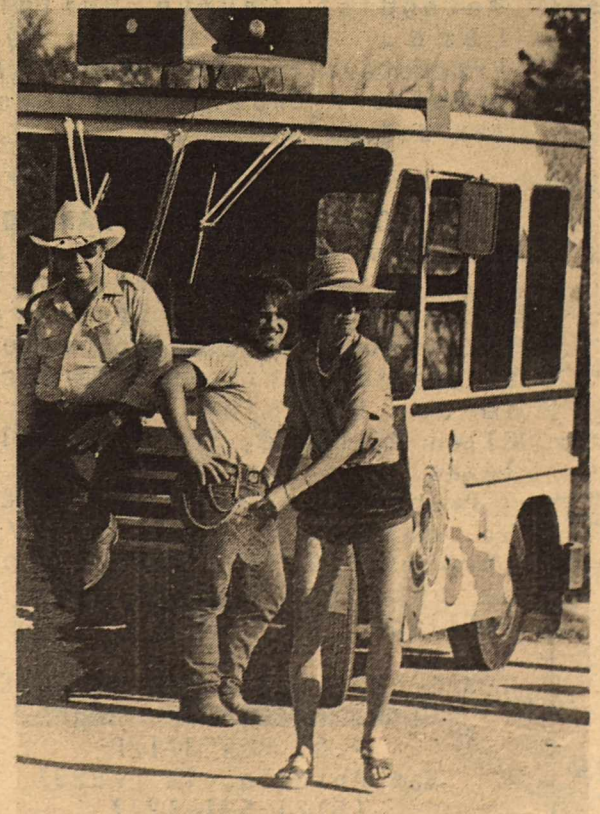

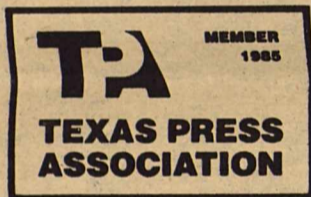

MEXICAN LP/GAS DEALERS

Austin, Texas - Mexican LP-Gas dealers, Transporters must meet commission standards. March 8 -- Railroad Commission officials confirmed this week that all persons and companies that transport and distribute LP-GAs (Propane or butane) for sale to consumers in Texas must comply with Commission safety standards.

Reports have apparently circulated in border counties that Lp Gas trucks operated by Mexican companies are exempt from state regulation because of their foreign ownership.

Officials of the Commission's Liquefied Petroleum Gas Division noted they have brought several successful legal actions in recent months against Mexican LP-gas carriers who were fined for failure to comply with Commission safety rules.

The officials said once inside the state border, all persons must comply with the provisions of the Texas Natural Resources Code and LP-gas Division Safety Rules, regardless of nationality.



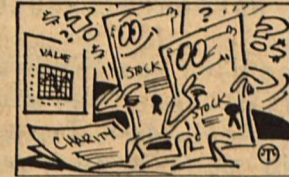

Tax Savings Ideas

Tax time can be a lot less taxing if you know how to keep your tax liability as low as possible. These four tax tips, taken from the 1985 H&R Block Income Tax Workbook may help:

1. If you are thinking of donating stock to your favorite charity because the security is currently worth less than you paid for it, don't do it. Instead, sell the stock and donate the proceeds to charity. If you donate the stock, your deduction is limited to its current value. If you sell the stock and donate the proceeds, your charitable deduction is the same but you can also deduct a capital loss on the sale. On the other hand, if your stock has increased in value, donate the stock. In most cases you can deduct the current value and not realize taxable gain. If you sell the stock and donate the proceeds, your deduction would be the same but you would be taxed on the gain.
2. If you cannot pay the tax you owe, file your return on time and ask that you be allowed to pay the balance due in installments. If you make a good-faith effort to pay your tax, the IRS should comply with your request.
3. The cost of professional help in preparing your return is deductible. So is the \$6.95

cover price of the H&R Block Income Tax Workbook, published by Collier/Macmillan and available at bookstores. Moreover, if after reading the book, you find that you still can't prepare your own tax return, a coupon on the book is worth \$6.95 worth towards tax preparation assistance at any H&R Block office.

4. When you buy or sell property, real estate taxes are normally prorated. Your portion will be shown on your closing statement. If you purchase property that is mortgaged, interest due from the date of purchase to the closing date will be shown. Your pro rata taxes and any interest charge are deductible. Taxes you pay for the other party are added to your basis.

THE SHERIFF'S CORNER

Most of us are aware of the fact that the wilder portions of frontier Texas were tamed and made safe for settlers and farmers by a band of gunfighters, ex-soldiers, and Indian fighters known as the Texas Rangers.

There was another band of rough and rowdy peace officers cut from the same cloth in another state who were just as effective in making that state a safer, fairly decent place to live.

They were the Arizona Rangers and they constituted as nondescript looking a bunch as you'd expect to find west of the Pecos. They were an unorthodox little band of peace officers, many of them ex-outlaws and jailbirds. They dressed like working cowboys, hiding their badges under their vests until they made their arrests.

The Arizona Rangers never numbered more than 26 at any one time and they came into being by authorization of the Arizona territorial Legislature in 1901. (creation of the group was first authorized in 1864). The main reason they were organized was the fact that the bad guys seemed to be taking over the territory. Banks were being robbed, cattle rustled, trains held up and people killed, all with increasing regularity.

Rustlers stole cattle on the Arizona side of the Mexican border, herded them across the line, and sold them in Mexico. Then, so the trip back wouldn't be a total loss, they stole Mexican cattle and sold them in Arizona.

There was widespread fear among law-abiding citizens that Arizona would never achieve statehood until it cleared out the killers, outlaws, and gunfighters, and that was where the Rangers came in. They were a pitifully small band of peace officers, 14 to begin with - a captain, a sergeant, and 12 privates. (a subsequent

legislature increased their number to 26). The captain got \$120.00 a month, the privates \$55.00, and they were expected to supply their own equipment and replace any horses lost in the line of duty. They were also expected to police an area as big New England, which meant that each Ranger covered an average of 400 miles a month, all on horseback. That was pretty hard on pants and what the pants contained.

The man appointed by the territorial governor to command this small band of Rangers was Burton C. Mossman, who was affectionally called Cap by his dedicated followers. Cap Mossman knew he had a tough job ahead of him and that it would take tough, hard men, well versed in gunplay and the wild country of Arizona. He put together what was later quoted as "the dangdest bunch of killers ever gotten together", but they got the job done and a softer bunch would soon have ended up as buzzard bait.

Mossman ran the Rangers with swagger and dash and also held a tight rein on expenditures appropriate to a territory which saw fit to pay it's Ranger force \$55.00 a month. He instituted a policy whereby no telegram sent on official business by any of his men could run longer than 10 words.

One day Mossman got a tip that a Tucson saloon and gambling hall known as the Legal Tender was going to be held up. He sent a new Ranger recruit, a tall young man from Texas, to stake out the saloon. The Ranger was to post himself against a wall not far from the front door and just wait. At 2:00 am, when the bartender was getting ready to stuff the night's proceeds into the safe, a man pulled open the front door, pulled a gun, and shouted, "Everybody put'em up!" Everybody did except the young Ranger, who fired a single shot. The bandit was dead when he hit the floor. Next morning at breakfast in Bisbee, the Ranger headquarters, a Western Union boy handed Cap Mossman a telegram that read: "One man holup Legal Tender two am inquest four pm". It was exactly 10 words long.

We will continue our story on the Arizona Rangers next week.

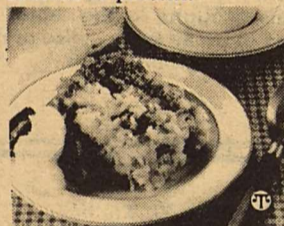

Rice Pudding

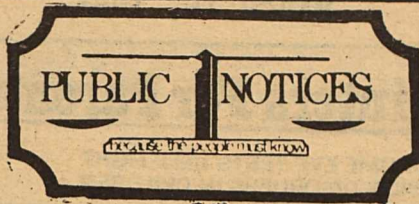
Pudding made from American-grown rice can be twice as nice with the addition of dates and nuts—all good sources of protein.



DATE NUT RICE PUDDING

- 3 cups cooked rice
- 3 cups milk
- 1/4 cup plus 2 table-
spoons brown sugar,
firmly packed
- 2 tablespoons butter
or margarine
- 1/4 teaspoon salt
- 1 cup chopped pitted
dates
- 1 cup chopped wal-
nuts, divided
- 1 teaspoon vanilla ex-
tract
- 1/2 teaspoon ground cin-
namon

Combine rice, milk, 1/4 cup sugar, butter, and salt in a 2 to 3-quart saucepan. Cook over medium heat, stirring occasionally, 20 to 25 minutes, or until thick and creamy. Add dates, 1/2 cup walnuts, and vanilla. Turn into a 2-quart dish. Combine cinnamon with remaining sugar and walnuts. Sprinkle over pudding. Chill. Makes 8 servings.

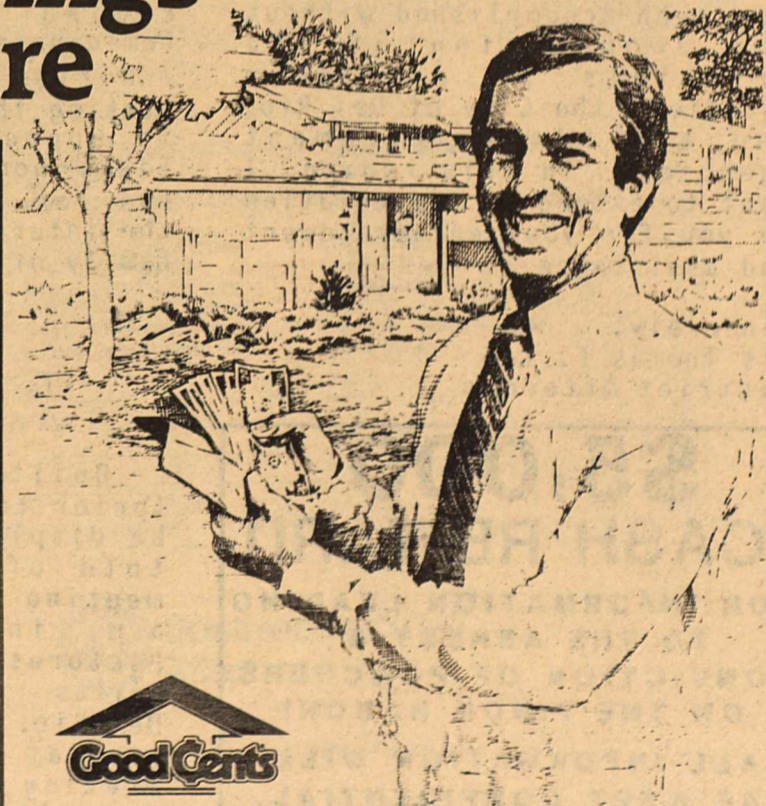

Dear Mr. Loos:

During 1984, this office secured 174 criminal convictions. Those convictions resulted in 73 defendants placed in the Texas Dept. of Corrections and 89 defendants placed under supervised probation. An additional 12 defendants were prosecuted in the County Courts on reduced charges.

The state filed 34 motions to revoke probation. In the revocation cases, 14 were also placed in the Texas Dept. of Corrections.

The prosecution of felony cases by this office in 1984 resulted in criminal defendants being ordered to pay \$76,535.32 in restitution to victims, and \$49,500.00 in fines. In addition, \$16,715.68 was recovered on bad checks, \$2,632.00 in bail bond forfeitures, and five (5) firearms were forfeited to the State of Texas for use or destruction.

Our work in 1984 could not have been accomplished without the cooperation of the officials of our four counties, the City of Del Rio, and all Law enforcement agencies. In this regard, I want to extend my appreciation to you for your encouragement and assistance.

REALTORS VOICE OPPOSITION TO HOMESTEAD CHANGE

Texas Assn. of Realtors president Robert F. Wertheimer warned of the disastrous effects any change in the homestead law could have on Texas homeowners during a Capitol press conference Wednesday, March 6.

Wertheimer joined representatives of the Texas Consumers Assn, the AFL-CIO, the American Assn of Retired Persons, the Gray Panthers, the Texas Senior Citizens Assn. and the Texas Farmers Union in support of the protections offered Texans by the current homestead law.

Wertheimer stated that the proposed changes would hurt the Texas economy which is already suffering from a downturn in the oil industry. Citing figures compiled by the Economics and Research Division of the National Assn. of Realtors, Wertheimer explained that the home mortgage delinquency rate in Texas would climb from its current record high of 5.91% within one year. This translates into over 4,000 additional potential foreclosures, which would result in a more than \$47,000,000 loss to Texas homeowners.

"Our interests have always been linked to those of the Texas homeowner and, quite simply, there is no hue and cry for change in our law coming from our state's homeowners," he said.

Wertheimer concluded by stating that TAR stands firmly in support of the current Texas homestead law, which has for 145 years protected the integrity of the home and family of every Texas.

Pointers For Parents

IN-HOME EYE TESTS HELP FIGHT
VISION DISORDERS IN CHILDREN

How sharp is your child's vision?

Life presents a blurry picture to nearly 700,000 children under the age of 17 with more than 500,000 new cases of eye disorders reported each year, according to information provided by the Bureau of Health Statistics.

Crossed eyes, amblyopia ("Lazy Eye") as well as near-sighted and far-sighted vision are among some of the most common eye problems in children.

Early vision screening provides doctors with a better chance of detecting these disorders which, if left untreated, could inflict permanent damage to your child's eyesight.

The National Children's Eye Care Foundation has launched a national vision screening campaign whereby eye charts and messages about eye care for children are being placed on milk and juice cartons around the country.

The carton illustrations feature the popular cartoon character "Annie" and her dog "Sandy", and were made available to dairies nationwide through the Ex-Cell-O Corporation—a major packaging supplier.

By holding the carton at a specified distance, the eye charts can help you determine how well (or how poorly)



your child sees the world around him.

Although the milk carton eye tests are a fun and simple way to detect possible vision disorders in your children, they cannot replace formal screening examinations by a trained professional.

If you haven't seen these special milk cartons where you shop, contact your local dairy and ask about them, or you can receive a copy of the "Annie" eye chart by sending \$1.00 with a stamped, self-addressed envelope to:

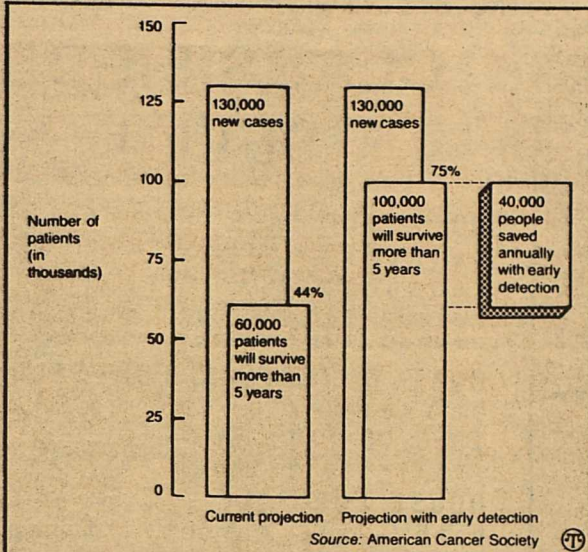

In 1984, 130,000 Americans will be diagnosed as having colorectal cancer and 60,000 will die from it. However, with the use of early detection techniques, we can increase the survival rate for patients with colorectal cancer from the current 44% to 75%. This means "100,000 lives can be saved this year alone," according to Dr. Sidney J. Winawer, Chief of Gastroenterology at Memorial Sloan-Kettering Cancer Center.

People must be aware that the incidence of colorectal cancer increases significantly after age 40—83 million Americans are in that age group—and that early stages of the disease are often present without obvious symptoms. Therefore, screening techniques are valuable in searching for disease in asymptomatic persons.

The three main screening tests are the digital rectal examination, the stool blood test and sigmoidoscopy. The stool blood test detects small

amounts of hidden (occult) blood in the stool, often an early sign of colorectal cancer and other gastrointestinal disorders. Until recently, the patient prepared the test at home and submitted it to the physician or laboratory for interpretation of results. Now, the Hemocult® stool blood test, a test used by physicians for over a decade, can be purchased in drug stores and performed at home. If the test indicates blood in the stool, a person should see a doctor for further evaluation.

Colorectal cancer is currently the second highest cancer killer in the U.S., second only to lung cancer.

These findings were brought to light at a recent symposium for medical and health communicators, "Colorectal Cancer: New Insights Into a Preventable Disease," kicking off a continuing multimedia campaign to inform the public about colorectal cancer and its diagnosis and treatment.

DID YOU KNOW ?

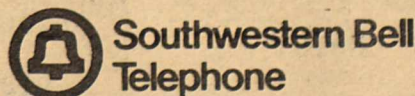
