SESOUICENTENNIAL ART CONTEST

Texas artists are keeping Southwestern Bell Telephone's mail room busier than usual these days.

Requests for entry forms company's the Sesquicentennial directory cover art contest are pouring in from all over the state.

"It started as a trickle, but we're now averaging over one hundred requests a day," said Gayle Hatchel, contest coordinator. "As word of the contest spreads, I'm sure we'll see that number increase rapidly.

The contest is to select artwork for a special Sesquicentennial cover to be used on 1986 Texas phone books. The winning artist will receive \$5,000 and have his or her work featured on some 158 Southwestern Bell directories with distribution of almost nine million copies in Texas.

DEADLINE FOR ENTRIES IS

JULY 1, 1985. "I think it's a positive sign that almost 2,000 people have asked for entry forms," said Hatchel. "We want to involve as many people as possible in an exciting Sesquicentennial activity-we're just proud to be a part of the excitement.'

Requests for contest entry forms have come from all

sections of the state.

"They're coming from professional artists, weekend painters and from teachers usning the contest as a class project," said Hatchel. "We've also had one request from a prison inmate-- if he wins, it

should be quite a story."
No actual paintings are to be submitted, since initial judging will be done from color slides of the artwork. An entry form and contest rules may be obtained by writing to Art Contest, One Bell Plaza, P.O. Box 225521, Dallas, Texas 75265.

According to Hatchel, the artwork should be appropriate to the Sesquicentennial, and there is only one restrictions on subject matter.

"The painting must have a Texas theme," she said. "A montage depicting 150 years of proud Texas history would be particularly appropriate -- or it could be a single subject that's especially identified

with Texas."

Any complaints from the mail room?

"None at all," said Hatchel. "Everyone's happy to be involved in such a positive project."

WOOL & MOHAIR SHOW SET

NATIONAL 4-H WOOL JUDGING CONTEST, WOOL 7 MOHAIR SHOW SET FOR JUNE.

SONORA, Texas-- the 48th annual Wool and Mohair Show and 1985 National 4-H Wool Judging Contest will be held June 11-13 in this West Texas ranching community in Sutton County.

The Wool and Mohair Show is open to all producers in the United State. All entries of wool and mohair must be in the warehouse of the Sonora Wool and Mohair Company by 5 p.m. June 11 to be eligible.

Categories in the open division of the wool and mohair show will be wool single fleeces, mohair single fleeces and bags, and bags of aged range ram fleeces. Categories in the junior division will be wool single fleeces, mohair single fleeces and bags and couny groups of single wool and mohair fleeces and bags of wool.

A judging contest for young people will held June 12 in conjunction with the wool and mohair show. Therre will be senior and junior divisions and contestants will judge livestock, wool, mohair and


range plants.

The National 4-H Judging Contest will be held the final day. A miximum of two teams may enter from each state, with the selection of teams to be made by each state 4-H office. Events will be wrapped up with an awards luncheon for all contestants of the judging contests.

All events are sponsored by the Sonora Lions Club, in cooperation with the Sonora Wool and Mohair Company and the Texas Agricultural Extension Service.

CPL TO REFUND FUEL CHARGES

Utility Public The Commission (May 7) granted Central Power and Light Company's request to refund over-collected fuel charges to its customers. The amount ordered refunded will approximately \$51.2 million, including interest, through February 1985. Additionally, an expected final order from the commission on a disputed \$28 million in fuel costs could increase the amount.



Checks will be sent to all customers receiving \$10 or more. Customers receiving less than \$10 will have a credit applied to their electric bill. CPL will make a good faith effort to locate customers who have moved out of its service area and are due refunds.

According to Bill Cranford, CPL local manager, it will take the company approximately two months to review customer records, calculate the refund due, and mail checks to the majkority of its 500,000 customers in South Texas. The amount refunded will be based on how much electricity a customer used since October 1983.

Using a method prescribed by the commission has caused the company's fuel revenues to exceed expenses. The method established a fixed factor for fuel charges which can be changed only with PUC approbal. The company has been able to take advantage of the softer fuel market and purchase gas at a price below its commission-prescribed factor.

CPL first requested the PUC's approval to lower the fuel protion of customer's bills in early December 1984. The company also requested authorization to refund fuel over-recoveries.

The company had proposed December 26 as the effective date for the rate reduction. A ruling by the PUC in January approved the lower fuel factor. As a result of that request, CPL customers saw a 6 percent drop in their electric

bill in February. Today, almost five months after the company's initial refund request, the commission ruled on the refund method.

Based on last year's average residential usage figures, CPL estimates customers who used between 750 to 1,000 kilowatt hours per month during the last 18 months will receive checks of approximately \$53 to \$71, respectively. "The figures are based on the best available information. They will be adjusted to reflect the terms and conditions of the commission's final order," Cranford said.

Central Power and Light Company continues its efforts to purchase lower priced fuel and pass the savings on to customers.




Parents can help their children achieve emotional maturity, according to a new book.

VALENTINO FAME SPREADS -LEAVES LITTLE TIME 'HOME'


"I'm real and I'm country, so don't let the name Valentino fool you!" says one of country music's most promising young talents. Valentino, who's booked solid for six months at a time, has opened shows for major performers. He has also been creating his own steadily growing audiences in clubs (like Gilley's and Billy Bob's, Texas) across the country.

The former RCA artist is currently recording for the High Voltage label. Performing, since the age of 12, the 25 year-old singer feels the past three years have provided him; "a chance to really grow, to write more songs and to become more versatile and confident on stage." Valentio and The Shahan Express Band (Johnny Shackleford, Rocco Fortunato and Roy Garcia) have become the number one draw in several club circuits, where their shows (featuring country, original material, blugrass, top 40 hits and hits of the '50s and '60s) have earned them an enviable reputation.

Valentino who expertly plays guitar, fiddle, trumpet, and bass received his first break at the age of 13, by winning the "Looking for Stars" television talent contest in Monterey, Mexico. At just 19, Valentino was taken under the impressive wing of Happy Shahan (of the famed Alamo Village movie location in Brackettville, Texas). Valentino performed at the Village cantina at Alamo Village for 3 years.

Immediately afterward, RCA signed Valentino and released one of his singles, which garnered much airplay and industry attention.

Along the way, Valentino somehow found time to perform in the theater (Stop the World I Wanna Get Off) and in four movies (including "Seguin", "Barbarosa", and "Code of Josey Wales"). A frequent television guest, Valentino has also appeared in several commercials and has been a popular subject for posters.

When first reaching a new town, the first thing Valentino and his band do is head for the local comic book store, where they load up on their favorite collectibles. "We put them in plastic, then file them in boxes and keep a catalog on them. We may buy up to 100 comic books in a month, and we read them all! They're in mint condition, and we even look them up in a comic book

guide. We've started going to flea markets too, and are even buying comic book t-shirts."

The handsome young singer's enthusiam for his hobby is only surpassed by his devotion to country music and his audiences.

"We really get close to them and develop a great rapport. A lot of the time, we'll stay for a week at the same club, Valentino explains. We're very entertainment oriented, and we go with the mood of the crowd. We're persistent, with a lot of drive, and we fit in anywhere. We've been preparing for another assault on the country charts!"

A lot of industry insiders- and his enthusiastic audiences- aare predicting there won't be any resistance to that assault.

Valentino's talent, good looks and charm are a winning combination.

SHERIFF'S CORNER

An act of vandalism in the Town House section of Ft. Clark resulted in damage to a water fountain in the plaza of that area. A suspect was seen running from the crime scene and the case is under investigation. As is usual in most criminal actions, and vandalism in particular, the person responsible for this act showed no respect for the property and rights of others.

A Guatamalan National was apprehended at the Port of Entry at Eagle Pass Tuesday attempting to enter the United States with identification papers of a Kinney County resident. Investigation into the offense led to the discovery of a theft incident on the Leona Ranch last Sunday. The incident had not been reported to the Sheriff's Department. Just another example of the increase in criminal actions by illegal aliens.

Pete Bland, an ex-Kinney County Jailer, will start to work at the jail on June 1st. Pete worked for us on the night shift his last year in high school and has been attending classes at Southwest Texas Junior College in Uvalde since his graduation. He will replace Mike Schlacter who is resigning effective May 31st. Pete is expected to work for us through the summer until classes resume in late August. Since he is already a licensed jailer certified by the Texas Commission on Law Enforcement, he will not be required to attend certification school.

The investigation into the burglary which occured at the Gabriel residence in Spofford on May 5th is continuing. Latent prints and other evidence recovered at the scene have been transported to the DPS lab in Austin. It is hoped that

further proof linking the suspect to the crime will be obtained as a result of the lab work.

We have been working short-handed at the jail for the past month or so. Both top level supervisors have been out with illnesses that required hospitalization. Special thanks is extended to Sgt. Dee Jordan and Sgt. Jesse Garcia for their hard work and long hours required to fill in for the absent supervisors. We hope to be back to full strength by June 1st.

Air traffic congestion: It's a major problem at many of our nation's busiest airports, studies show. Here are some facts you may not know about the issue, and what's being done about it:



- Business aircraft, planes that are vitally important to many industries and our nation's economy, are only a very small factor in the rush hour air traffic congestion problem, studies show.
- Banning business aircraft from major airports during rush hour would do little to solve the congestion problem, while weakening an important service, experts

 The National Business Aircraft Association (NBAA) has come up with a five-part plan to reduce the air traffic intensity problem. It includes having business aircraft fly around saturated areas and landing at reliever airports whenever possible, keeping the FAA informed of flight plans not less than four hours in advance of departure time, and starting a toll-free "hot line" for air traffic informa-
