You may recall that I reported to you in last week's column about Kenneth Cy Harding, the 29 year old black male from Houston known as the "Montrose Bandit" who was captured and arrested here in Kinney County on Monday, June 17th. Harding was believed responsible for at least 37 armed robberies and a known user and dealer of narcotics. He can now add another crime-' to his list of misdeeds, he escaped from the custody of Houston police on Firday, June 21st at approx. 5:30 p.m. He had already been identified in "line-ups" by at least 8 victims of his "blitzkreig" assault and robbery tactics. One of the Houston officers who came to pick him up and transport him back to Houston last week told me that Harding's nickname was "Slick" because he was so hard to catch, I guess the nickname will take on a new meaning now because he seems to also be hard to hold.

I certainly don't mean to glamorize the exploits of Harding, he is nothing but a callous, cruel thief who steals from his fellow man in

order to finance his \$500 a day narcotics habit. He will, in the end, get what he deserves, which will be at least a long stretch in he state pen. Let's hope he is apprehended and removed from society before he takes the life of one of his victims or a peace officer trying to do his duty.

Judge George Thurmond has set July 12th as the date for arraignment for the three illegal aliens being held in the County Jail on auto theft charges and Henry R. Salmon of Spofford who has been indicted on charges of Burglary of a Habitation. At this time the defendants will be advised again on the charges against them and if they cannot afford an attorney to represent them, one will be appointed for them at the expense of the county.

Charges of Criminal Trespass have been filed in County Court against Terry Lee Glynn of Uvalde and Walter Wade Salmon of Brackettville in an incident involving trespassing to fish on a ranch in north Kinney County last week. Warrants have been issued with bonds set at \$1,000 each. The case will be heard in County Court at a later date.



back to 1852 when a U.S.-Mexico boundary survey was made and the existence of Lajitas was reported. In the years that followed, a rail line was laid and this encouraged ranching in the area. A quicksilver find at Terlingua just a few miles away sparked some activity in 1890. A port of entry was established at Lajitas because of the increased mining and ranching going on across the river in Mexico.

The real growth began about 30 years later when the U.S. Cavalry under Gen. John "Black Jack" Pershing set up a post in Lajitas in an effort to halt the terrorizing regime of the Mexican revolutionary, Pancho Villa. When peace was finally restored, Lajitas became home for many Mexican families who raised their crops near the river and tended goats on the surrounding hills. For many years, the only developments that existed were a trading post, a schoolhouse and a saloon.

Nowadays, there is considerably more going on here. There are two motels, a hotel, condominiums and several housing developments. All are done tastefully and under strict architectural controls to insure that they blend in with one another and with the landscape.

The style of most of the homes and apartments is Texas ranch house or Spanish adobe style. The Badlands Hotel, the town's showpiece, has been constructed in classic western style and it even has a saloon sporting red flocked wallpaper and huge, mounted trophy heads of bison, elk and

One of the newer creations in town is the Lajitas Museum and Desert Garden, a \$1.2 million project of the Lajitas Foundation. The museum and garden have been built on a beautifully landscaped, 99-acre plot beneath towering Lajitas Mesa. The outside garden area features a comprehensive collection of native West Texas plants, lovely winding walkways and even such indigenous animals as desert tortoises and peccaries.

Inside the museum, elaborate dioramas depict the human history of the Big Bend region, as well as its rich and varied animal life. The taxidermy is very realistically done, showing animals in natural and believable settings. There is also a library, an art gallery, geological and archaeological displays, collections of memorabilia and artifacts of the area and a gift shop. Your visit to Lajitas would not be complete without spending some time at this excellent museum.

Lajitas boasts plenty of recreation for everyone. There is a 9-hole golf course, two tennis courts and a swimming pool. For the adventurous, there is some of the best river rafting anywhere with several guide services from which to choose. You may want to try your hand at fishing for trophy catfish in the Rio Grande or do same hiking on the mile

and miles of trails in the area.

Don't miss the historic Lajitas Trading Post. This establishment has actually been operating for over a hundred years and is still a favorite meeting place for many local residents. On any given day there will be a group of the regulars sitting under the shaded porch, drinking beer or playing a friendly game of pool.

Adjacent to the Trading Post is a large goat pen littered with hundreds of empty beer cans and bottles. This is the home of the legendary Clay Henry, the beerguzzling goat. If you don't believe the stories of this old goat's renowned drinking abilities, just pop the top off a Lone Star and hand it to him through the fence he'll make a believer out of you in about ten seconds.

Lajitas also has a liquor store, a drug store with an oldfashioned soda fountain, a mercantile store (you can find some nice cowboy hats and boots) a hardware store, a film processing service, a washateria and a restaurant offering - you guessed i

"Lajitas Fajitas," a variation of the grilled beef strips that have become a new Texas tradition.

Easily reached by car, bus, or train, Lajitas also has its own landing strip for air travellers. For more information, call 915-424-3471, or write "Lajitas", Star Route 70, Box 400, Terlingua, Texas 79852.

The good news about Lajitas is that, well ..., it's 100 miles from anywhere.

At least that's the Walter Mischer sees it. Mischer is the Houston developer and industrialist who is responsible for the current boom in this tiny, outof-the-way town on the western edge of Big Bend National Park. He began buying land around Lajitas back in the '50s, but it was only about nine years ago that he really began to develop Lajitas on the Rio Grande. An important factor in its development has been the retention of the Old West flavor which makes folks want to come here in the first place.


Mischer's ultimate goal in creating Lajitas on the Rio Grande is to have a resort in Texas similar to those in Palm Springs and Phoenix. Winters are generally mild along this stretch of the Rio Grande and it is not unusual when it is snowing in the Panhandle for Lajitas to be basking in 60-70 degree temperatures. And, since the humidity is usually very low, the summer heat is not as unbearable as the 90-100 degree readings would seem to indicate.

Laiitas is a rich blend of dramatic mountain and desert scenery, colorful history and folklore, and just the right amounts of modern comforts and conveniences.

NOTICE OF INTENT TO IMPLEMENT RATES

General Telephone Company of the Southwest in accordance with the Public Utility Regulatory Act and the Rules of the Public Utility Commission of Texas gives notice of its intent to implement new exchange access rates for the provision of shared tenant and tenant resale services.

These proposed rates are applicable to customers of General Telephone Company of the Southwest, excluding hotel/motel customers, who provide local exchange telephone service of General Telephone Company of the Southwest to their tenants or patrons on a resale or shared use basis. This resale or sharing arrangement is normally provided utilizing a customer-provided PABX or other similar stored control switch capable of common control processing or other features commonly associated with a PABX "Smart" switch.

These proposed rates are designed to recover costs on a usage basis for local exchange telephone service access and are identical to General Telephone's "Optional Measured Service" rates. The monthly access rate will be \$28.95 per trunk line and the usage rates are as follows:

As this is a new service offering, we are unable to determine the number of customers who may be affected. Currently, there are no known prospective customers. Until any customer utilizes this new offering, there will be no effect on the revenues of the telephone company, and in any event, the telephone company does not expect revenues to be affected by more than 2½ percent. These proposed rates, where applicable, will provide tariffed local exchange access to customers who then will provide shared or resale services to tenants.

These proposed rates have been suspended by the Public Utility Commission of Texas and will become effective as proposed or modified by order of the Commission on a date to be determined by the commission.

The proposed rate schedule is on file with the Commission for public inspection and is also available at any business office of General Telephone Company of the Southwest.

Persons who wish to intervene or otherwise participate in these proceedings should notify the commission as soon as possible.
