HERIFF'S CORNER Norman Hooten Sheriff

The Kinney County Grand Jury was called in on Tuesday, November 12th to hear evidence in the homocide of John Lee Titt who was killed by a shotgun blast to the neck on October 11th. George Joseph Barber, 27, the suspect in the slaying, was arrested the afternoon of October 11th by Texas Ranger Tol Dawson and myself after our investigation provided enough information for us to obtain a warrant for his arrest. He was released a few days later on a \$20,000.00 Surety Bond.

The evidence was presented to the Grand Jury by District Attorney Tom Lee, Texas Ranger Tol Dawson and myself. Grand Jury returned a True Bill on Indictment on Barber for Homocide. He remains free on the \$20,000.00 bond and his case will be called for trial at a later date which has not been set as of the time of

this writing.

Game Warden Bill Lindeman and myself have been subpoenaed to testify in the Aggravated Robbery trial of Kenneth Cy Harding in Houston that is scheduled to begin next week (November 18th). You may remember that Harding was arrested by Lindeman and I back in June of this year after he was spotted by Lindeman under suspicious circumstances around the business district of town along Highway 90. Harding known in Houston as "The Montrose Bandit" is believed to have committed at least 49 armed robberies in Houston and had been sought by Houston authorities for several months prior to his arrest in Kinney County. Harding had been nicknamed "The Montrose Bandit" because of his habit of lighting fast armed robberies along the business district of Montrose Blvd. in Houston.

While Harding was in custody here Lindeman and I obtained tape recorded confessions from him concerning several of the crimes he is believed to have committed in Houston. The Harris County District Attorney's Office feels the need of our testimony in one

of the more violent cases in which Harding "pistol whipped" an elderly man before robbing him. Hopefully convictons that will stand the test of appeales can be obtained against this dangerous, violent criminal and he can be removed from society for years



All performances are at 8:00 p.m. except the December 1 matinee at 2:30 p.m.





HOLIDAY FOOD PREPARATION

The traditional meal with turkey and dressing is a popular part of Thanksgiving and Christmas festivities. The Texas Medical Association suggests food preparation precautions that will make sure it is also healthy.

Food-borne illness is a common problem when large amounts of food are prepared in the home. Many food infections are cused by salmonella germs. Almost all species of salmonella organisms grow rapidly in such foods as eggs, meat, and milk from infected animals. The germs can survive for long periods of time, but proper cooking renders most foods safe.

Foods (especially pastries, custards, salads, salad dressings, sandwiches, meat and meat products) should not be allowed to stand at room temperature for long periods of time. Always keep hot foods hot and cold foods cold.

Thanksgiving and Christmas mean turkey and dressing in many homes. There are several specific rules for preparing both.

A frozen turkey should be deforsted for several days in the refrigerator. Defrosting at room temperature is not recommended because it encourages the growth of bacteria. Fresh turkeys should be pruchased close to the holiday and stored in the regrigerator no more that two or three days.

The internal cavity of a turkey should never bi filled with dressing until the fowl is completely thawed. Because some protions of the turkey could overcook before the dressing inside sustains a high enough temperature to destroy bacterial growth, authorities recommend that turkey and dressing be cooked separately.


Do not slow cook a turkey at a low temperature overnight or allow a turkey to stay in an unheated overn (such as for overnight holding after cooking). The cooking termperature of turkey should reach 165F in the thickest part of the breast to insure thorough cooking.

Never refrigerate cooked whole turkey for overnight sotrage without first deboning or slicing it. As soon as the cooked turkey

cools to a temperature at which it can be handled, debone and slice or cut the meat into small pieces. Pieces should be refrigerated in portions small enough to cool rapidly and thoroughly. Store turkey and stock in separate containers.

If you suspect food poisoning (symptoms are fever, headaches, nausea, vomiting, cramps and diarrhea), seek medical attention immediately.



Houston Lighting and Power (HL&P), in conjunction with Central Power and Light Company (CP&L), has filed a petition with the Public Utility Commission of Texas seeking a declaratory order regarding the South Nuclear Project. The petition has been assigned Docket No. 6325.

The Public Utility Commission has determined that the following issues will be considered in Docket No. 6325.

- 1. The reasonableness of the proposed settttlement of the litigation between the ownders of the STNP and Brown and Root;
- 2. The prudence and efficiency of HL&P and CP&L in the planning and management of the South Texas Nuclear Project during the Brown and Root period;
- 3. The reasonableness of the litigation expenses incurred by HL&P and CP&L in conjunction with the Brown & Root litigation;
- 4. The effect of the settlement o n investigation by the Commission into the prudence of continuing construction of Unit 2 of the South Texas Nuclear Project;
- 5. The appropriate accounting treatment of the proceeds realized by HL&P and CP&L from the proposed settlement; and
- 6. The final or nonfianl nature of the findings reached in Docket No. 6325.

The results reached in Docket No. 6325 may have an impact in future proceeding on the rates charged to the customers of Houston Lighting and Power Company and Central Power and

Light Company.

The Commission by and through the appointed Hearings Examinar assiged to Docket 6325 finds that it is expedient and necessary for the proper performance of the Commission's duties, and that is in the puclic interest, to conduct regional hearings for the prupose of collectin comments to be included in the record. At the regional hearings the examinar will hear protest and comments from

members of the public, and those members of the public desiring to make such statements under oath shall have that opportunity.


