SATELLITE SCRAMBLING DECLARED ILLEGAL

SATELLITE TV

WASHINGTON.....Responding to a recent inquiry from Rep. Robert Kastenmeier (D-Wis.), chairman of the House of Copyrights Ralph Oman said in a letter that once cable superstations are scrambled, satellite carriers may not charge home earth stations to descramble and receive those signals under copyright law.

carriers may not legally scramble superstation signals.

According to Oman, the Copyright Law of 1976 states that carriers may distribute television broadcast signals to superstations as long as they don't control who receives the signals. A carrier who sells scrambled feeds to dish owners is, in fact, controlling reception, and that action invalidates the carrier's copyright exemption status.

" In selling or renting descrambling devices to some earth station owners, the carriers would appear to exercise control over the recipients of programming," Oman said. "This result seems especially clear. where the carrier both encrypts the signal then purports to provide access through descrambling devices. But for the encryption, the satellite dish owners would be able to receive the signal with their own equipment.'

According to Oman, the 1976 Copyright Law clearly states that carriers lose their control of the signal beyond providing "wires, cables or other communications for use by others...." Licensing descramblers goes beyond passively providing the signal.

STRATEGIES FOR MAKING ENDS MEET....

The mortgage, car payment and utility bills still have to get paid, even when money is tight. So for most of us, that means " making ends meet " is a matter of reducing household living expenses for food, clothing, and home maintenance. There must be 1001 ways to cut these expenses, certainly more than could ever be listed in this space - or that you could remember. But there are some general strategies for cutting household expenses that you can apply to your own

situation. First, try trading time for money. Cut up your own chicken, make cookies instead of buying them, prepare a casserole from scratch instead of a box and use slow cooking methods to cook some less expensive cuts of meat. The same thing applies to many home cleaning products, substitute generic products or make your own all-purpose cleaner from vinegar and water, for amonia and water, at home. Trading time for money extends to careful shopping :: making lists, checking ads for the best prices, coupon clipping, comparison shopping and sticking to a budget. However be careful about using coupons to save money on things you don't need or using up more money on gas than you

saved by driving across town to get a "bargain". Another good strategy is to think in terms of recycling or repairing anything before you consider buying. If you sew, mend or update clothes that can be worn for another season or " handed down " to a

younger child. Rewire your old lamp, repair your own washing machine or fix the cracked plaster yourself. You can get step-bystep instructions on home repairs from Extension oudincations, library books and free phamplets on display at many hardware and home improvement stores.

Sharing is another excellent strategy for stretching dollars. Many families commonly share some items, such as baby furniture or maternity clothes, with

relatives or friends. But also think in terms of sharing other infrequently used items. For example, if you and your neighbor both garden, you could share the cost of a needed tool. Sharing applies to skills too. If you have a friend who knows how to change ' the oil on a car, you could babysit one evening in exchange for this service.

The last strategy is to simply cut back. If you've got two rented phones, take one back to the phone company. Turn the air conditioner up or the heater down and dress accordingly to cut down on utility costs. Try to work out carpooling arrangements so you won't need a second car.

Take a careful look at your lifestyle and hunt for those things you could cut out or reduce. You may be suprised how much money you can save by substituting time for money, recycling and repairing, sharing and cutting back, You may even enjoy some, if not at all, of a simpler lifestyle.

CONTROLLING CREDIT

The national debt may be in the news, but in many households, it's the family debt that's of greater concern. While most of us have to go into debt to buy a house and a car, installment or credit card spending is one area where we can control or even eliminate indebtedness. How?? Get started by asking yourself the following questions before making a credit purchase::

How much will the extra cost for credit be ?

It is worth the extra cost to buy on credit?

Is this something I need or simply want - right now ?

Will I be able to make the payments without seriously straining my budget ?

What if I get sick or have an accident, could I still pay?

Can I afford to spend my future income ? For how many months or years ?

Would it be wiser to save me money and but this later ?

Once you've answered these questions, you should have a pretty good idea of whether a credit purchase is a good idea or not. But you have to stop and think. If impluse buying is your weakness, try leaving your credit cards locked in a safe place at home when you go shopping. It doesn't cost a dime to say "no " to a credit.

THE GLORY ROAD

Fort Clark was activated in 1852 by Major Joseph M. La Motte on land long favored as campgrounds for Comanche, Mescalero, Apache, Kickapoo, Lepan and other Indians. The original site was a strip one and one-half to two miles in width extending from Las Moras (The Mulberries) Springs downstream about eight miles. It was a beautiful oasis shaded by huge oaks and pecan trees. Two companies of First Infantry and advance and rear guards of Mounted Rifles were part of the outpost protecting this section of the San Antonio-El Paso road----Fort Clark was never a walled or stockade fort.

With the onset of the Civil War and the secession of Texas, Federal troops left Fort Clark. Durning the Civil War, the Fort was occupied by the Second Texas Mounted Rifles, and served as a supply and hospital center for Confederate troops at Camp Wood, Hudson and Lancaster.

Fort Clark is also famous as the home of the Seminole-Negro Indians Scouts, under the command of Lt. John L. Bullis, and as the base of operations for Col. Ranald S. MacKenzie's raids into Mexico to punish renegade Indians, bringing an end to Indian depredations in Texas by the middle of 1881.

Many infantry units and virtually all cavalry units, including the Ninth and Tenth black "Buffalo Soldiers" and the Fifth Cavalry served at Fort Clark, as did Generals Wesley Merritt, Commander of the Philippine Expeditionary Forces in the Spanish-American War; George C. Marshall, U.S. Chief of Staff in World War II, and author of the Marshall Plan; Jonathan M. Wainwright, hero of Bataan and Corregidor; and George S. Patton, famous for his bold, highly mobile armored operations in North Africa, Sicily and across France and Germany. Many combat decorations and honors were earned, including four Congresional Medals of Honor awarded to black Seminole Scouts. The Seminole-Negro Indian Scout Cemetery, where all four of the Medal of Honor recipients are buried, may be visited on FM Road 3348. Durning World War II more than 12,000 troops and a Prisioner of War Camp occupied the 4,000 acres of Fort Clark.

In June of 1944, the closing

of Fort Clark was announced. In 1946, it was purchased by Brown & Root Company for salvage and for use as a guest ranch. In 1971, it was purchased by North American Towns of Texas, and Fort Clark Springs, a private recreation community came into being.

"THE GLORY ROAD " recaptures the color and adventure of that period when Fort Clark Cavalry Post was at the height of its glory. In this dramatization of the fort's history by the well-known playwright, Kermit Hunter, the songs, the dances and the personalities of the period live again under the live oak trees.

You will be transported to the times when the brave cavalryman rode forth to protect the rancher, and his sweetheart awaited his return, in the words of the old cavalry ballad, "ROUND HER NECK SHE WORE A YELLOW RIBBON FOR HER LOVER WHO WAS FAR, FAR AWAY."

Imagine answering a telephone 1,000 times a day, every day with each call lasting about 19 seconds. The Directory Assistance operators who answer calls to 1-411 for Southwestern Bell Telephone in Texas don't just imagine it, they do it with the help of high speed computers and their friendly voices. More than 2,100 Southwesteren Bell Telephone operators answer calls to Directory Assistance in the 214, 409, 713, 806, 512, 817, and 915 area codes. The operators handle 30 million calls a month, or 1.6 million calls per day; that's an average of 1,000 calls per day, per operator.

Lou Garza, local telephone company spokesperson said although the Directory Assistance operator work rapidly, they are also concerned about giving a personal and pleasant touch to each call. "Our operators usually answer a call by including their name. This way, customers realize they are talking to a real person. A voice with a smile is more than expression it's an image callers form of our business, said Garza. "The operators also use "please" and "thank you" to make sure those calls have a personal and courteous touch." Garza said sometimes an operator may suprise a customer with an unusual closing comment such as, "Have a nice meal," if the customer has requested the number for a restaurant.

help the Computers Southwestern Bell Telephone operators in their efforts to provide speedy and courteous service. Because of the volume of calls to 1-411, a computer functions to automatically rotate incoming calls to the next available operator station so that callers don't get a busy signal. After the caller provides the city and name and address for the number with the aid of another computer which stores the directory listings.

When the number is found, the operator thanks the customer for calling. Then, the operator activates a third computer. That computer, called Audio Response System, actually provides the number for the customer through a recorded voice. The voice repeats the number and informs the caller to remain on the line if further assistance is necessary. If the caller remains on the line, the call is directed from the ARS back to the automatic call rotation systems, repeating the cycle. #############################







A JP may hold inquests to determine if a crime has been committed, especially when the body of a human being is found and the circumstances of death are unknown. The JP may order an autopsy.

A JP may perform marriages and also notarize violations. If elected, I will listen to both sides, consider all evidence and render a decision, based solely on such

I will study extensively to be sure that the Court is being conducted legally and properly.


