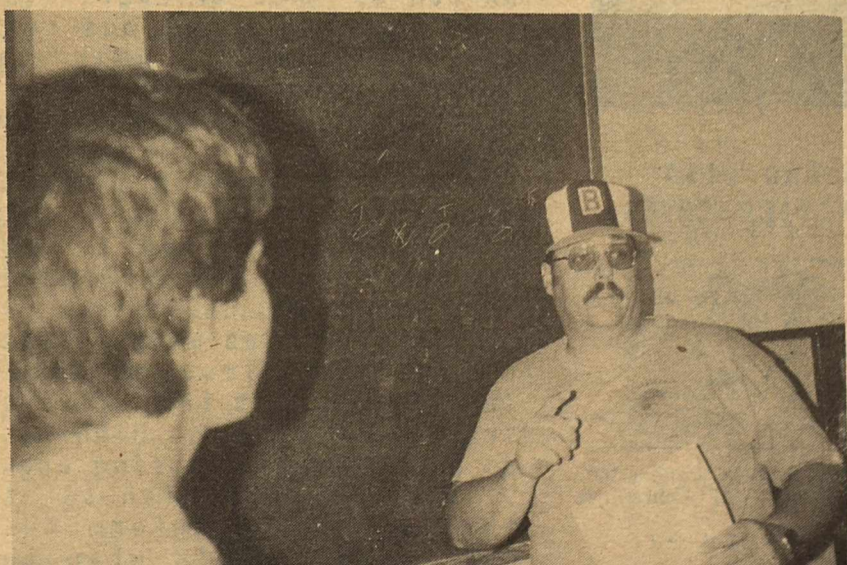

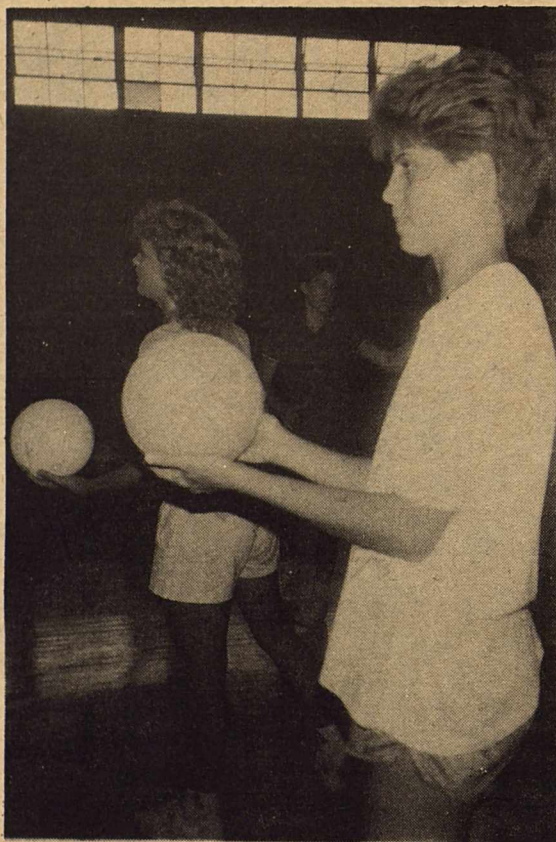

**NEW BUS ROUTE ESTABLISHED**

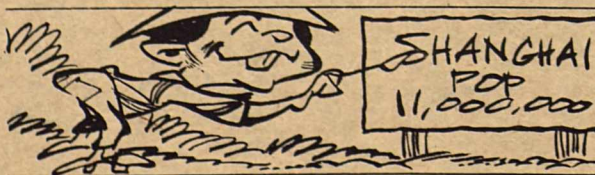
Superintendent Bob McCall announced that Brackett I.S.D. will operate a new bus route for the 1986-87 school year. The bus route will run to the entrance of the Oaks subdivision on Fort Clark Springs and return down the Ft. Clark Springs Road stopping at Airport Road, Scales Road, and McClerndon Road to pickup children.

The route was made possible by Board of Trustee action last March. At this time the trustees designated Highway 90 as a hazardous crossing area.

Students who wish to ride the bus should inform their campus principals when they register for the new school year. The bus will arrive at the Oaks turn around at 7:15 a.m. The afternoon route will be reversed with the bus leaving school at 3:35 p.m. and dropping the last student 3:50 p.m.

**SHERIFF'S CORNER**

Some of you may have noticed that this column did not appear in the local papers last week and I apologize to those who may have missed it. Those of you who wish it didn't appear at all should consider your good fortune in getting a week's rest. I was out of town on business and just couldn't get my act together in time to meet the deadline.

The Aggravated Sexual Assault case that has been under intensive investigation by peace officers including yours truly since it's alleged occurrence on July 21st has been cleared. The alleged victim, a 28 year old mother of three from Campwood, Texas refused to take a polygraph test offered her on Friday, August 8th. Investigators became increasingly suspicious of her statements during the investigation and follow up questioning. The decision was made to offer her the polygraph test after several discrepancies in her story developed. After refusing to take the test, the woman admitted to investigators that she had fabricated the story. No solid reason for the ruse has yet been given but indications are that she was attempting to gain sympathy from her estranged husband and other family members. It has been learned that the woman has a history of mental health problems.

Hundred of man hours and tax dollars were expended during the intensive investigation and several other cases were given the back burner while the investigation was going on. It is extremely frustrating and aggravating to have such a thing happen and is, in fact, a crime to make a false report to a peace officer. No decision has been made at this time as to charges being filed on the woman for the false report. That decision will be up to Uvalde County authorities as the offense occurred in that county.

Those of us involved in the investigation would like to thank all the concerned and interested citizens who

called and wrote in information that they thought might be helpful. The work done by peace officers in any investigation of this sort depends a great deal on such valuable assistance from the public. Without that assistance many crimes would go unsolved and unpunished.

Several vandalism cases have been investigated over the past several weeks in Ft. Clark and Brackettville. Some of the cases have been solved and restitution made to the victims. It appears that the annual summer cycle of these aggravating and sometimes costly crimes is in full swing. All efforts are being made to curb this type crime by seeking out the guilty and hitting them where it hurts and most, in their pocketbooks. Most parents of the juveniles apprehended are very cooperative, but surprisingly there are a few who take offense that their littledarlings could be accused of such a thing, even when we have eyewitnesses.

County and District Clerk Dolores Raney, Deputy Tax Assessor/Collector and Voter Registrar Martha Smallwood and yours truly attended a 3 day seminar on election laws held in Akustin, Texas on August 13 thru 15. The seminar is an annual affair hosted by the Secretary of State's Office each summer to assist voter registrars and county clerks in their duties concerning voter registration and holding elections. The information provided updates and changes in election laws and provides an opportunity for county officials from throughout the state to ask questions, discuss problems they might be experiencing, and to make suggestions on changes in the election code that might provide an overall smoother election procedure.

The seminar was very informative and we were able to meet with various county officials from throughout the state and discuss our particular problems and also ask questions of officials of the Secretary of State's Office on a one on one basis. Valuable information was obtained from the seminar and the question and answer sessions.

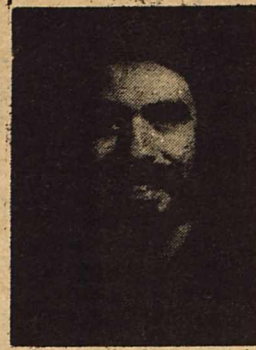

## Texas rates among nation's lowest

I recently came across a national survey conducted by the investment firm Smith Barney that shows residential rates for local basic monthly phone service in Texas are among the lowest in the country.

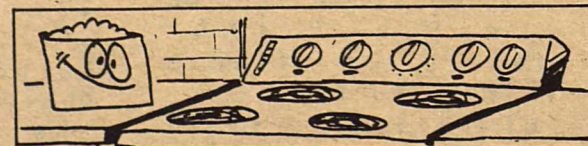

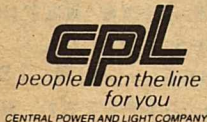
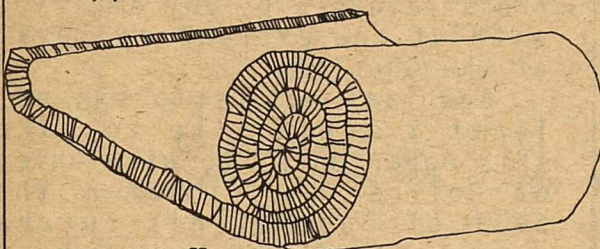

Secretary of State seminar I was surprised and disappointed to learn that the News-Post had printed erroneous information in last week's issue concerning the resignation of Deputy Sheriff Terry Fisher and the appointment of Reserve Deputy Sheriff David Luna to the vacancy. Fisher, who has been a deputy for less than one year and still on probation, was suspended from his duties as deputy and assigned to duties in the jail for disciplinary reasons. He chose to submit a voluntary resignation from the Sheriff's Department effective August 31st. There has been no final decision on his replacement though Reserve Deputy Sheriff David Luna is being considered along with several other applicants. Final selection of a replacement deputy will be made within 30 to 60 days. I would hope that in the future that the News-Post would be more cautious about printing information that has not been confirmed. We have enough rumors as it is. The Rules and Regulations Manual of the Kinney County Sheriff's Department prohibits press releases by any employee without the express approval of the Sheriff.

And last but certainly not least I would like to take this opportunity to wish Chief of Police Jim Lindeman the best of luck in his future duties as a State Game Warden with the Texas Parks & Wildlife Department. Jim is a fine young peace officer who has performed his duties as Chief of Police with maturity and good judgement far beyond his years and experience. An argument between two brother-in-laws Saturday night, August 16th, erupted into a fight that left one of them in the hospital with stab wounds to the left arm and the other in the county jail on charges of Assault with a Deadly Weapon.

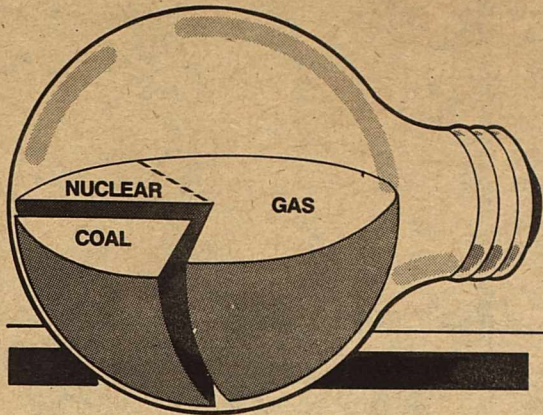
