DEER IN EXCELLENT SHAPE FOR ARCHERY SEASON

This year, archery hunters can expect to find whitetailed deer in excellent shape.

But the problem lies in finding them, according to Dr. Dwight Guynn, wildlife specialist with the Texas Agricultural Extension Service.

Guynn, who is headquartered at the Texas A&M Agricultural Research and Extension Center in Uvalde, said that excellent forage for deer will make it harder for hunters to attract deer to feeders.

"The rains have been early this fall in many areas and pastures have experienced a 'green-up' of succulent vegetation," Guynn said.

"While there may be more deer this year with larger antlers and in better condition, hunting may be more difficult than in dry years," he explained.

Above-average rainfall during the spring and summer have contributed to the excellent body condition and larger-than-average fawn crops, he said.

Archery season for whitetailed deer, mule deer and turkey is October 4 through November 2 this year.

Guynn recommended preseason scouting of hunting areas to determine the areas of heavy deer use and preferred travel routes, so that archery stands can be placed accordingly.

Additionally, quite a few areas of the Texas Hill Country have abundant acorn crops this fall and hunting in or near oak motts may be quite productive, he suggested.

ACCENT ON HEALTH EMS Week is September 21-27

Perhaps no other factor is as important following a serious injury or sudden illness as the time it takes to begin medical treatment.

According to the Texas Department of Health (TDH), any delay between the onset of trauma and the start of competent treatment increases the severity of the emergency and can needlessly lead to disability or death of the victim. Also, studies show that as many as 25 percent of victims of accidents or sudden illness underestimate the seriousness of their situation--they do not recognize that an emergency exists.

Texas Commissioner of Health, Dr. Robert Bernstein, said, "It is always up to the victim or a witness to decide if an injury or illness is an emergency. But if there is any doubt, the victim should get medical help immediately." He added that the fastest way to receive medical attention is to call an emergency medical service (EMS).

"Thousands of Texans owe their lives and current health to EMS teams, which ensure speedy medical assistance and special transportation to trauma victims around the clock," Dr. Bernstein said.

To honor EMS personnel and the services they provide daily, Gov. Mark White has proclaimed September 21-27 Emergency Medical Service Week in Texas. The observance coincides with National EMS week, sponsored by the American College of Emergency Physicians. A highlight of the Texas observance is the Statewide EMS Conference to be held in Austin September 26-27 at the Austin Hilton Inn.

TDH regulates more than 1,000 EMS firms in Texas. The department's Bureau of Emergency Management certifies EMS technicians and their trainers, develops tests, and approves EMS courses. It also licenses EMS vehicles, including ambulances, helicopters, and fixed-wing aircraft. The bureau currently certifies nearly 35,000 persons to practice emergency medical service, including about 20,000 members of EMS firms and about 15,000 law enforcement, fire, and other emergency personnel.

SHERIFF'S CORNER NORMAN HOOTEN SHERIFF

The war on drugs has picked up in tempo all across our state and nation over the past year or so and the pressure on smugglers and drug dealers in Florida has increased to the point where they have spread their drug dealing operations all along the U.S. - Mexico border with special emphasis on the Texas - Mexico

borderline.

Agents with the Drug Enforcement Administration (DEA) are being trained in new methods of detection and apprehension of drug smugglers and dealers, the U.S. Customs Air Patrol are being furnished with high tech equipment and hot new airplanes to assist them in the fight against drugs and the death merchants that smuggle the drugs into our country. The U.S. Border Patrol and even some branches of our military forces are being trained in drug detection and being given special authority and powers of arrest. Texas Department. of Public Safety narcotics. agents have also received more training and better equipment and more authority in some fields such as wire taps to assist them in the fight against drugs. The President of the United States has made several addresses to the public about fighting drugs and drug dealers, with special emphasis on our schools and The our young people. President recently spoke to a gathering of elementary school principals at the White House in Washington, D.C. A quote from his speech is as follows: "You know better than anyone else what drugs can do to our children's minds, bodies, and lives." Today there is every indication that our country is waking up to a problem that has been ignored, and denied, and buried away for too long.

The law enforcement agencies of the larger cities of our state have developed their own drug enforcement divisions using trained undercover agents as well as uniformed special operation units in an attempt to detect and apprehend drug dealers and drug users. The Bexar County Sheriff's Department, under the leadership of Sheriff

Harlon Copeland, has made several successful drug busts in and around San Antonio over the past 2 years. Large amounts of drugs, firearms, and money (the life blood of the drug business) have been confiscated in these busts. Many of the dealers have received stiff prison sentences upon conviction.

Now you would think that with all of the increased training, equipment, man power and money that is being made available for drug enforcement throughout the state and the nation that we could obtain assistance from at least one of these agencies in our local fight against drugs. Not so, all of the agencies have targeted certain areas and types of drug smuggling and drug dealing. They are primarily concerned with the "big" deals and large operations and rightfully so, the war against drugs has to start somewhere and the larger operations should receive primary consideration. But what about our community? What about our kids? Do we have a drug problem here?

Yes, we have drug smugglers and drug dealers in Kinney County, not the big time operators you read about in some areas, and not the Miami Vice type you see on T.V., but they are here just the "same. I have made several arrests of local citizens in possession of narcotics and drugs, mostly marijuana, since I have been Chief of Police and Sheriff. I have repeatedly requested the assistance of DPS Narcotics agents to help me work up cases on several known drug dealers and have received that assistance on only one occasion. Two misdemeanor cases and one felony case were made at that time. defendants were convicted, fined and probated by the There are still courts. several dealers and users in our county. I know the names of some of them and they know I know who they are. Well, you ask, why don't you do something about it? The answer is simple, the drug dealers know who I am and they also know all the local peace officers by sight and They certainly aren't name. goint to sell drugs to us and they certainly aren't going to come and turn themselves in. We have to go after them and basis, we have to have money with which to finance of operations.

During the recent budget hearings with the Kinney County Commissioners Court I requested \$5,000.00 be placed in my budget for the upcoming fiscal year to be used for Special Operations and Drug Enforcement. I explained in detail the reasons for my request and cited various cases where this type operation was used by Sheriff's departments over the state with good results.

The court listened to my request and all agreed that drug enforcement is needed in our county and advised that they would consider the request and advise me later. brought up the issue on several occasions and repeatedly advised the court of our local drug problems and what action would be necessary combat the problem successfully. Every member of the court agreed that the drug problem, no matter now small, should be controlled to the best of our ability.

Well, when the budget was finalized and approved for Fiscal Year 1986-87 the \$5,000.00 I had requested was cut. No further discussion on the matter was had, and no reason was given. The Commissioners Court simply let the request die on the vine. It's not because the money is not there; a \$200,000.00 cash surplus exists and I bring in close to \$200,000.00 a year in prisoner care fees every year.


I feel that we should make every effort to combat the drug problem in Kinney County, no matter how small it may be, and it does exist. I cannot get adequate assistance from outside law enforcement agencies because they have their own jobs to do on a much larger scale than we require. And as the commissioners court refuses to help me financially in this cause, I can only do the best I can with what I have to do with and hope for the best. If you have any complaints concerning the local drug problem I suggest you question your precinct representative on the commissioners court. I am sure they can justify their actions, they always do.





BRIEF EXPLANATORY STATEMENTS
OF PROPOSED

CONSTITUTIONAL AMENDMENTS GENERAL ELECTION

NOVEMBER 4, 1986

PROPOSITION NO. 1 ON THE BALLOT

Senate Joint Resolution 15 proposes a constitutional amendment that would permit the legislature to provide by general law for the apportionment of the value of railroad rolling stock among the counties in which the property of the railroad is located for purposes of property taxation, and would delete the re-quirement that the Comptroller participate in making the allocation. To comply with both statutory and constitutional law, the apportionment currently is being made by the State Property Tax Board in conjunction with the Comptroller.

The proposed amendment will ap-

pear on the ballot as follows:
"The constitutional amendment to allow the legislature to provide by general law for the apportionment of the value of railroad rolling stock among counties for purposes of property taxation."

PROPOSITION NO. 2 ON THE BALLOT

Senate Joint Resolution 33 proposes a constitutional amendment that would replace the constitutional requirement that the subject of a bill be expressed in its title with a mandate that each house of the legislature adopt rules of procedure that would require the subject of each bill to be expressed in its title in a manner that gives the legislature and the public reasonable notice of that subject. Determining compliance with the rule would be the responsibility of the legislature. Cur-

rently, a law is invalidated if a court finds its caption is defective. The amendment would provide that past and future enactments may not be held void on the basis of an insufficient title.

The amendment also would eliminate the suggestion that the state's laws be revised every ten years, and instead would provide for continuing revision of state laws.

The proposed amendment will ap-

pear on the ballot as follows:
"The constitutional amendment requiring each house to include in its rules of procedure a rule that each bill contain a title expressing the bill's subject, and providing for the continuing revision of state laws."

PROPOSITION NO. 3 ON THE BALLOT

House Joint Resolution 73 proposes a constitutional amendment that would permit the Legislature to authorize any county, city, town, or other political subdivision to use public funds or credit to pay insur-ance premiums on nonassessable life, health, or accident policies. Due to the prohibition in the constitution against the lending of credit and granting of public money, political subdivisions currently are prohibited from becoming shareholders in associations such as mutual-insurance companies, in which policy-holders are shareholders. A nonassessable mutual insurance policy does not allow a company to raise capital by assessing the policy-holder an extra amount on a pre-

mium. This amendment will allow mutual insurance companies and stock companies to bid for life and health group policies of political subdivisions. Public liability will be limited to the payment of premums

specified in the contract.

The proposed amendment will ap-

pear on the ballot as follows:
"The constitutional amendment allowing political subdivisions the opportunity to engage in and transact business with authorized mutual insurance companies in the same manner as with other insurance companies."

PROPOSITION NO. 4 ON THE BALLOT

Senate Joint Resolution 4 proposes a constitutional amendment that would repeal the prohibition against branch banking by state banks and would allow state banks and national banks domiciled in this state to establish and operate banking facilities at locations within the county or city where they are domiciled. The amendment would also authorize the Legislature to permit a state bank or a national bank domiciled in this state to engage in business at more than one place if it acquires a failed state bank or national bank domiciled in this state.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to provide that a bank may offer full service banking at more than one location within the city or county where its principal facility is located, subject to limitations and restrictions provided by law."

The pendulum swings back - sort of

When the man picked me up in his arms I was two feet long and six inches wide, the size of an expensive box of chocolates.

I turned out not to be too costly after all.

What happened, I got bucked off my horse, hit the ground on the back of my neck and spent the next two weeks in bed, at age 12, slowly elongating into my proper length of somewhere around 62 inches.

All without benefit of doctor.

Which is the point of all this.

Once upon a time in Texas you didn't go to a doctor unless your illness was serious.

Serious was when you sat down in the privy and a black widow spider indecently bit you in a place that once had been inconspicuous.

Serious was when your hand got caught in the hammermill, taking off half one finger and mangling three others.

Serious was when you were 30 feet in the air, intently fitting rafters on the biggest barn yet to be constructed in Wharton County, reveling in the speed and precision of the new 30-pound worm-gear twohorsepower Skil saw when you suddenly discovered you had sawed half way through your ring finger, left

Otherwise you simply did not go to a doctor.

Benjamin Franklin, in Poor Richard's Almanac, said, "God heals and the doctor takes the fee."

That's a base canard, of course. Doctors do a lot of

But a lot of them will agree that much sickness runs its course and we get well regardless of medication.

And when you were a long way from a physician, a basic consideration was, was the ailment fatal or would you eventually recover on your own?

By the time I was 18 and encountering Army medics, I had been to see a doctor twice in my entire life and had never seen the inside of a hospital. I think this was typical of the time in this part of the country.

But I cannot begin to remember the times my own children have been treated by doctors. Each time it seemed imperative that they go, often to the hospital

emergency room. Stitches to close open wounds were obviously good reasons. But look, if you dare, at someone with 50year-old legs. Chances are good that you will see puckered scars like miniature footballs attesting to

unstitched gashes. How did we survive the raging fevers that now are treated in emergency rooms, with doctors and nurses packing screaming infants in ice? How did we live over whooping cough, chicken pox, measles, mumps,

The truth is, we either did or we didn't, largely without benefit of ministrations from the medical fraternity. While researchers from that persuasion eventually found deterrents for most of those maladies, meanwhile it was basically a matter of letting the disease run its course.

And now, where a couple of years ago hospitals were crowded to bursting, when even the hallways often were parking lots for patients, the hospitals are cutting back on staffs because of a lack of patients.

Well, you see, the government does not pay as much of the medical expenses as it used to. So why in the world would a doctor insist that you go to the hospital. unless it was absolutely necessary?

I could go on and on, but I've got an appointment for my annual checkup.

DEALING WITH STRESS

Most people deal with daily stresses like traffic jams and work deadlines without too much trouble. But even people who are on a fairly even keel most of the time face occasional periods of great stress.

Bereavement, financial difficulties, ill-health, and worry are all part of life. According to the Texas Medical Association, it is when several such events occur together that mental health can suffer.

Since you cannot always avoid stress, learning to deal with it effectively helps ease tension that can build up. There are many ways to relax. Often the problem seems to center around finding the time to "get away from it all." The following exercise routine does not take very much time and can be done on your own, without going anywhere.

Try to do the exercises regularly, not just when you feel tense. A gradually acquired ability to relax may help you deal with occasional periods of great and unavoidable stress.

1. Loosen or remove any tight clothing. Lie on the floor, face up, eyes closed, either in a warm room or covered with a light blanket.

Tighten the muscles in your face and then let them relax.

3. Lift up your head and let it fall gently back. Keep your jaw and neck relaxed so that you can feel your the late opening.

4. Press your shoulders down onto the floor. Ten relax them.

5. Stretch out your ems and fingers. Hold them but for only a moment be ore easing the strain complet.

6. Lift your buttock and let them fall again, feeing your spine stretch and lax as you do so.

7. Keeping your hals together, stretch your ags and toes. Then relax them completely.

Continue these exercises, one after the other, for a few minutes until you feel totally limp and relaxed from head to toe. Rest with your eyes open or closed. Before standing up, turn and lean on your side for another two or three minutes. Repeat this routine every day.
