Dear Friends,

Yesterday, Fort Clark Springs lost a great friend and advocate, a man whose inspiration, imagination and creativity was largely responsible for moving this development from its sluggish standstill in 1981 to the lively, forward looking community it is today.

Jon Held's quiet demeanor and gentle approach to the projects he invisioned for the Fort insured their acceptance and approval. He never sought or needed credit for his accomplishments. For the benefit of the many newcomers, I would like to list a few of the amazing things I watched

Jon do:

1. He took the old roofless "Laundry Building", a mere shakey shell and made of it a good looking, comfortable, inviting, safe structure composing nine apartments and his and Charlotte's own handsome two-story home containing 4,000 square feet of living area.

2. Working with the Board always, he took Don Swanson's discovery of a potentially beautiful section of the Fort, just off Scales Road, a wilderness area which had beneath its dense undergrowth, old roads, curbs and concrete foundations - he took this area and developed it into



CITY COUNCIL REGULAR MEETING

The City Council met in regular session on October 14,

1986 at 7:00 p.m.

Minutes of the previous regular and special meetings were presented. Councilmember Agapito Saenz approved minutes as presented with noted correction to the figures on the bid for the slab at the clinic. Councilmember Manuel Fuentes seconded the motion. All ayes.

Financial and Operational Utility and Operating reports were presented. After some discussion, Councilmember Stan Cololy made a motion to accept the reports as presented. Councilmember Rick Hagler seconded the motion. All ayes.

Miss Elsie Sauer and Mrs. Earlene Thurber presented to the Council a request from the Garden Club. The Garden Club would like for the City of Brackettville to declare the City a bird sanctuary. Miss Sauer related that the City of Del Rio had passed an ordinance declaring their City a bird sanctuary in May 1985 and in the recent past, Fort Clark had done the same. She also presented Mayor Pro-tem George Burks with a copy of the Del Rio ordinance.

Council stated pellet and B-B guns' have caused a lot of damage in the past, not only to birds, but to the street lights and other City and personal property. The Council will check on ordinances against pellet and/or B-B guns within the city limits, and consider the ordinance on a bird sanctuary after all

information is gathered.
City Manager Charles Olsen informed the Council that the City had received their last Revenue Sharing check on September 25, 1986 in the

amount of \$1,955.00.

Olsen also informed the Council that he had received a letter from Texas Municipal League on City liability insurance coverage. The letter stated that the City could increase our liability coverage from \$500,000.00 to One (1) or Two (2) million dollars. Council discussed the matter and found that it would not be feasible to increase the coverage at this time.

Council discussed Ordinance #231. This ordinance fixes and establishes the monthly rates to be charged to all customers for water, sewer and natural.

gas. After lengthy discussion, Council decided that no changes were necessary in the ordinance.

City Manager Olsen announced that Mayor William Mendeke had appointed Raymond Aguilar as a new Housing Authority board member to replace Ralph Gonzalez who was appointed Housing Director of the Housing Authority.

Olsen then informed the Council that the City of Brackettville and Kinney County were now taking applications for J.T.P.A. employment for the Clinic

Project.

He related that the County, School and City were alloted funds by the M.R.G.D.C. for J.T.P.A. employment. The employees hired will be used for clinic project. All three entities discussed and agreed upon using funds for joint venture.

Ofsen read a letter he had written to Enrique Castillon, Middle Rio Grande employment and training specialist from Uvalde asking that funds be allocated to classroom training and on the job training to be transferred to OS work experience. The letter will be signed by Judge Albert Postell, School Superintendent Bob McCall, and City Manager Charles Olsen.

Patrolman David Lee Bohmfalk informed the Council of his activity since his employment in September. He talked with the Council on the enforcement of City ordinance #226 - Animal Control and ordinance #201 - Juvenile Curfew. Council asked Patrolman Bohmfalk to advertise in the newspaper that he will be enforcing these ordinances.



ORDINANCE # 226

Prohibiting animals from running at large in the city limits; providing for animal vaccinations; impounding, euthanizing, redemption and sale of animals; prescribing a nuisance and other controls of animals within the city limits; prescribing a penalty of a fine not less than \$1.00 nor more than \$1,000.00; and repealing all parts of ordinances in conflict herewith.

Passed & approved July 9, 1984

6-12 years old, Sunday through Thursday must be home by 10:00 P.M. Friday through Saturday must be home by midnight.

13-16 years old, Sunday through Thursday must be home by 10:30 P.M. Friday through Saturday must be home by 1:30 A.M. unless accompanied by parent or guardian. Exceptions will be made on special school event nights when at such time weekend hours will prevail. This ordinance supercedes any previous ordinance.

Effective November 10, 1978.

SHERIFF'S CORNER

NORMAN HOOTEN.

A burglary of the Gonzales store on El Paso street was reported on Saturday morning, October 11th by owners of the establishment, Ed & Mary Paiz. They discovered the crime at approx. 7:30 a.m. when they were preparing to open for business. The report was received by the Sheriff's Department at approx. 8:00 a.

Chief of Police David Bohmfalk was dispatched to the scene and after his arrival he called for the assistance of this writer in the on-scene investigation. It was determined from evidence at the scene that the burglar had entered the building through a side window after first using a large board to pry apart burglar bars covering the opening. Other evidence at the scene implicated a suspect and after questioning at the Kinney County Jail, Domingo M. Montoya, 32, of Brackettville was arrested and booked on charges of BURGLARY OF A BUILDING. Two trunkfulls of stolen property was recovered approx. 1/2 block south of the crime scene. It is believed that all of the property taken during the commission of the crime has been recovered.

A flash flood across a low water crossing on Highway 2523 near the intersection of Highway 3008 in northwest Kinney County late Saturday night is believed responsible for the death of a 35 year old Rocksprings man. The man had been reported missing since Saturday and on Monday afternoon his overturned 4wheel drive pickup was spotted by a Border Patrol plane in an arroyo approx. 1/4 mile downstream from the highway crossing. The deep, swift water of the flash flood had pushed the vehicle around a corner in the arroyo that prevented the vehicle from being seen by motorists on the highway.

It was first reported by the Border Patrol pilot that the vehicle was in Edwards County so officers from the Edwards County Sheriff's Department had responded to the call. Upon their arrival at the scene it was then

determined that the vehicle was actually in Kinney County and this writer was called to come to the scene. Trooper Robert Cano and myself responded to the call and upon Our arrival we assisted the other officers in the search for the body of the missing man. The body was found in heavy brush at the bottom of the arroyo approx. 200 yards south of the overturned vehicle where it had been washed by the water. After transporting the body back to the highway family members present at the search area identified the man as Robert Ruiz, 35, of Rocksprings. Justice of the Peace Rose Mary Slubar of Kinney County was called to the scene acting as coroner and pronounced the man dead by accidental drowning. The body was then

transported to Rocksprings for burial.

Jose C. Aranda, a 19 year old illegal alien from Mexico was stopped by Border Patrol Agents 13 miles west of Brackettville at 2:20 a.m. on the morning of Sunday, October 12th as a suspected smuggler. During their investigation it was discovered that he was in possession of a usable amount of marijuana and Reserve Deputy Sheriff David Luna was called to the scene to assist in further investigation. Aranda was subsequently arrested and transported to the county jail and charged with Possession of Marijuana. While the man was being booked it was discovered that he was the same man who had been arrested in January of this year by myself and Deputy Sheriff Johnny Sheedy on charges of Auto Theft. At that time he was using the name of Jose Hernandez-Hernandez. He was subsequently tried and arrested for Auto Theft and received seven years probation. He was then released to the Border Patrol and deported. After his release information was received from the Texas Department of Public Safety that identified him as Joe Aranda and showed that he was on probation for five years for a burglary of a habitation conviction in Travis County.

Mr. Aranda's tangled web of identification has a last been unraveled and it is anticipated that the District Attorney will file Revocation

of Probation proceedings against him he will, hopefully, at long last receive his just due and be sent to prison at the Texas Department of Corrections in Huntsville to contemplate his career of crimes against society.

Fred Buscher, 67, of
Brackettville expired at 2:15
a.m. Monday in a San Antonio
hospital. He had been
suffering from health problems
for several months. Fred was a
retired Navy man and had

worked for me as a jailer at the county jail a couple of years ago, before resigning his position due to health problems.

Jon Held, 69, of Ft. Clark Springs died Monday at approx. 8:45 a.m. from a heart attack as he walked with his dogs on a back road on Ft. Clark. Jon was a member of the Board of Directors of the First State Bank of Brackettville and was an active community leader who assisted in many ways in the advancement and improvement of Brackettville and Ft. Clark.

Both men were friends of mine and were highly thought of by friends and the people of their community and Kinney County. They will be sorely missed.


SUNSET COLORS..

TIGERS CLAW TEXANS

Friday night, the Brackett Tigers hosted the Wimberly Texans but showed very little southern Texas hospitality. Brackett scored five TD's and were successful on two 2 point conversions in breezing to a 34-8 victory. Robert Estrada opened the scoring in the first quarter on a one yard run. The extra point attempt failed. Later, in the same period, Hector Pena scored on a 20 yard run. This time Jesus Aguirre added two points on the conversion. The Tigers continued the scoring in the second period when Frank Morgan snared a 26 yard TD pass from Pena. The two point attempt was no good, and the half ended with Brackett ahead 20-0.

The third quarter saw Pena score again from 16 yards out. This time Estrada added the two points. 


