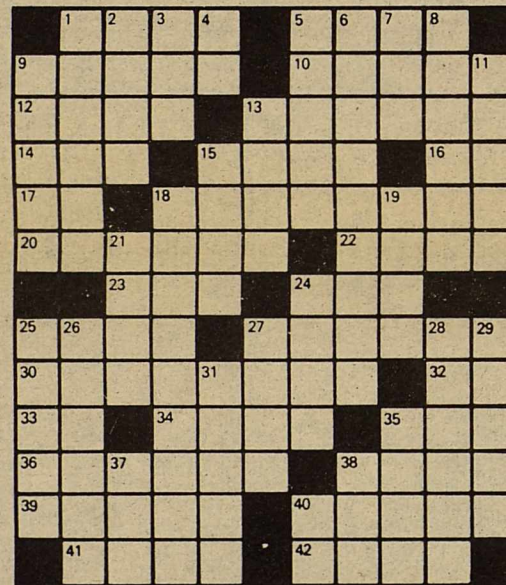

Brad's Car Care

A noisy muffler is the least of the danger. It's the exhaust gases that can leak into your passenger compartment which are the real menace. Since there's no way this problem will just disappear, it must be taken care of right away. Don't attempt to patch it. Have it replaced. (By the way, if you have to drive with a faulty muffler, keep a window open.)

When a warning light flashes on your dashboard, it indicates that you have a problem. If you continue driving without checking this, your problem will quickly escalate. Stop right away. Adding a quart of oil or tightening a fan belt is a lot less expensive than buying a new engine.

MOM'S KITCHEN

Oh Where, Oh Where, Has Herman Gone? A few years ago the "Herman" craze, (nobody seems to know exactly how it got the name), swept the country like a chain letter. Friends give the starter to friends, who nurture it and pass it on to their friends, usually accompanied by a coffee cake and the recipe. What is "Herman"? It's a "cultured" dough you add to new dough to give it distinctive flavor and texture it wouldn't otherwise have. But unlike other starters that require constant feeding, stirring and using, this one doesn't make a slave of you. You replenish "Herman" only after you use it. And if that's longer than 14 days, put it in the freezer until you're ready.

**** HERMAN**

2 C. flour
3 T. sugar
1 envelope active dry yeast
1 t. salt
2 C. warm water (105-115 degrees)

In large bowl mix flour, sugar, yeast, & salt. Gradually stir in water; beat or whisk until smooth. Cover with towel; set in warm (80-85 degree) draft free place—the kitchen or other warm room in summer, or in cold weather on top of a well insulated heater. Stir 2 or 3 times a day for about 3 days or until starter is bubbly and produces a yeasty aroma. Transfer to larger bowl, large jar or plastic container. Cover partially (tilt lid or punch holes in plastic cover); refrigerate. Makes about 1 1/2 to 2 cups starter, depending on thickness. It can be creamy or as thick as dough because of room conditions, the age of "Herman", and other variables.

CARE AND FEEDING OF "HERMAN"

The starter should be used within 14 days and replenished and fed immediately after each use. To feed "Herman" stir or whisk in 1 cup each flour and milk and 1/2 cup sugar; mixture need not be completely smooth. Wait at least 24 hrs. before using again. If you don't plan to use the starter within 14 days, cover tightly and freeze. Freezing slows the fermentation, so let stand at room temperature several hours or until thawed and bubbly before re-using.

**** "HERMAN" COFFEE CAKE**

1 C. flour
1/2 C. sugar
1 t. baking powder
1/4 t. each soda and salt
1 C. "Herman"
1/3 C. cooking oil
1 egg
1/2 C. raisins
1/4 C. chopped nuts

In large bowl mix flour, sugar, baking powder, soda & salt. Add "Herman", oil, egg, raisins, and nuts; stir to mix well. Spread in greased and floured 8 or 9" square pan, sprinkle with topping, (below). Bake in preheated 350 degree oven 30-35 mins. until tests done. Cool slightly in pan on rack. Cut in squares. Best served warm. Serves 9.

**** TOPPING**

In small bowl mix 1/2 C. packed brown sugar, 1 1/2 t. each flour, cinnamon, and sugar. Cut in 2 T. butter or margarine, at room temperature, until crumbly.

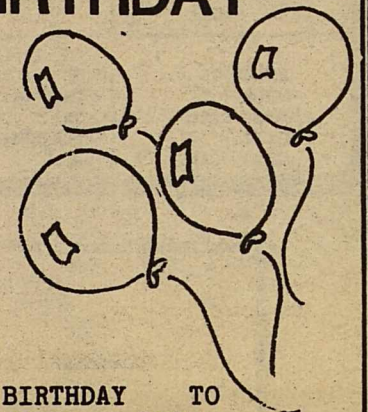
**** "HERMAN" PANCAKES**

1 C. "Herman"
1 C. flour
2 1/4 t. baking powder
1/4 t. each soda and salt
1 egg
2 T. cooking oil
1/2-3/4 C. milk (depending on thickness desired)

Mix well all ingredients. Using scant 1/4 cup batter per pancake, bake on well greased, pre-heated griddle or skillet about 3 mins. or until tops are bubbly and edges are brown. Turn; bake other side about 3 mins. or until golden. Makes about 10 large pancakes.

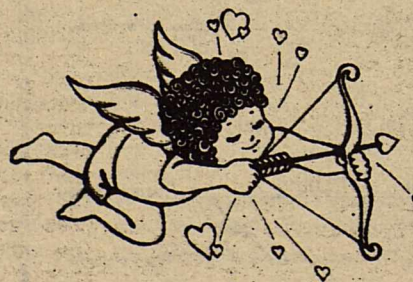

NUTRITION & AGING SERVICES

JOB DESCRIPTION

MIDDLE RIO GRANDE DEVELOPMENT COUNCIL

AREA AGENCY ON AGING

Project Director/Cook Manager/Site Manager - must be qualified individual employed by and responsible to the recipient agency and must be empowered with the authority necessary to conduct the day-to-day management and administrative functions of the project. One hundred percent of the Project Director/Cook Manager's time must be spent on the administration of the Title III project. The Project Director/Manager is responsible for:

- 1) Providing administration of the project.
- 2) Coordinating with other agencies who furnish services to the elderly to avoid duplication of services.
- 3) Providing leadership in the advocacy of issues affecting participants.
- 4) Providing monitoring and enforcement of all State, Federal and Area Agency on Aging regulations and guidelines.
- 5) Planning menus to meet nutritive requirements.
- 6) Purchasing food, equipment and supplies.
- 7) Employing and training kitchen and dining room workers.
- 8) Supervising food production and service.
- 9) Supervising record keeping and maintaining financial control.
- 10) Preparing budgets and financial reports.
- 11) Establishing and maintaining safe and sanitary procedures throughout the entire operation.
- 12) Having a current health certificate.
- 13) Knowledge of cooking techniques and food management.
- 14) Having a current Chauffeur's License, a knowledge of safe driving techniques and maintenance requirements.
- 15) Performs any duties required for the efficient operation of the Aging Program.

SITE MANAGEMENT ROLES, FUNCTIONS, AND PRACTICES

A recent national study of nutrition services showed that the factor making the greatest difference in meal quality and cost is whether the person in charge is a good manager. Management had a greater service impact than the size of the site, the site location (rural or urban), or the method of food delivery. The manager is the key element in achieving success at the nutrition site. Without the leadership, services, and atmosphere provided by a site manager, participants will not receive full benefits from the resources available.

This chapter describes the role of the site manager, management styles and five management functions: operational planning, organizing, staffing, directing, monitoring, and assessing. It concludes with a description of specific nutrition management practices, including handling contributions, reservations, and site comfort and safety.

I. YOU AS A MANAGER

Good management is necessary for a smooth running site that meets the needs of the participants. As site manager, you have an important and unique role. How you handle your responsibilities and coordinate site operations with the nutrition service provider will, to a large degree, determine the effectiveness of the site.

A. MANAGEMENT ROLES

The basic functions of nutrition directors and site managers are similar, but their specific duties and levels of responsibility are different. The nutrition director's job tasks are usually assigned initially by the governing body and are prescribed by a job description, personnel policies, and procedures. The director then is usually responsible for identifying site level responsibilities. Site management jobs may vary because of differences in individual ability, experience, organizational structure, agency size, central office requirements, and site location.

To function effectively, the site manager's job duties, areas of responsibility, lines of authority, and communication must be clearly defined. For example, the nutrition director usually reports to the nutrition providers governing body and works directly with the area agency on aging. The site manager usually reports to the nutrition director or assistant director and works with a site council if there is one.

The nutrition director is responsible for the overall effectiveness and efficiency of nutrition service operations. How

well the director meets these responsibilities depends, in part, on the service provider staff. As a key member of the management team, it is the site manager's responsibility to support the provider's goals through effective site operation. Site managers can expect to receive training, ongoing supervision, feedback, and performance evaluation from the nutrition director or other designated supervisory staff. Coordination, communication, and a clear understanding of the service provider's goals, job roles, and responsibilities will enable both the nutrition director and the site manager to best serve the community's older persons.

B. DOING VERSUS MANAGING

You were probably chosen as a site manager because you are a person who gets things done. Do you get things done because you do them yourself or because you are skilled at getting other people to do them? The truly successful site manager gets things done well by managing the resources available: paid and volunteer workers, money, time, community resources, building space, and so on.

Good managers spend their time and energy seeing that tasks are accomplished rather than actually doing the tasks themselves. If there is one common weakness among site managers across the country, it is doing tasks instead of managing tasks. Some site managers feel they must set the table, organize the program, fill out the reports, contact absent participants, and decorate tables, or those tasks won't get done. There aren't enough paid staff, volunteers, or hours in the day to get everything done. The irony is that there never will be until you, as site manager, begin spending your time and energy managing your resources instead of doing jobs.

Managers everywhere have the same basic responsibilities. They may work at different places, and they may have different amounts of authority; but if you closely examine what they do, you will find they are doing much the same things, including:

- * Planning. Managers decide in advance the best ways to achieve objectives set for their sites.
- * Organizing. Managers identify the people and things needed and to do a job and match them in the most efficient way.
- * Staffing. Managers hire and orient site staff, including volunteers.
- * Directing. Managers supervise and train site staff and provide ongoing support and periodic evaluation.
- * Monitoring and Assessment. Managers observe site operations to ensure maximum effectiveness and determine if work is going as planned and act accordingly. They also maintain appropriate program and fiscal records.

Think about these in relation to your own job. Aren't these your basic duties and responsibilities?

C. MANAGEMENT STYLES

As you fill a leadership role, you need to be aware of your management style. It determines how you approach new tasks, deal with problems, relate to other staff, etc. The three basic management styles are:

- * Authoritarian. The manager gives orders and does not accept suggestions. The authoritarian person makes and dictates rules and takes complete control over the group. Things can get done quickly when this style is used. This would be an appropriate style for a site manager during a crisis, such as accident, or for a brief period, perhaps if the site had lacked leadership before.
- * Laissez-faire. The manager is passive and lets individuals initiate and decide everything. Staff members are allowed to do as they please. This style tends to create frustration, competition, and friction, within the group although it usually leaves individuals feeling good about themselves.
- * Democratic. The manager encourages the group to suggest ideas, to identify areas of agreement, and to share leadership. This style produces the best results in terms of accomplishing group goals, working cooperatively, and maintaining high morale in the group.

The truly effective manager recognizes that different styles are appropriate for different situations. Most people are more comfortable with one style than another. You may be used to giving directions and telling others what to do, or you may be more comfortable listening to others ideas first and then getting the group to help you select the best approach to a situation. Whatever your usual style, it is helpful to be able to use all three in different situations. To do this, you'll need to practice new behaviors. If you usually direct, try listening at the next meeting of volunteers, participants, or the site council (if there is one). People will probably react differently to you. When would such reactions be useful? By practicing new styles, you will develop new skills and gain increased flexibility as a manager.

CROP INSURANCE DEADLINE NEAR

HONDO, TX--February 15 is the last day to apply for the U.S. Department of Agriculture's Crop Insurance Program for corn, cotton, and grain sorghum in Kinney County, according to Tom Jean, District Director with the Federal Crop Insurance Corporation (FCIC).

Crop Insurance covers unavoidable loss of production resulting from adverse weather conditions such as drought, excess precipitation, hail, wind, and freeze damage. Each year millions of acres of valuable crops are severely damaged or destroyed as a result of adverse weather conditions beyond the farmer's control. Sometimes losses are over a wide area and sometimes in isolated "pockets" of disaster. Adequate crop insurance can provide a barrier between crop disaster and financial disaster. High levels of farmer participation in this federally subsidized program, as a risk management tool, can reduce the adverse economic impact of an overall crop failure on individual procedures as well as the local community in which they live.

This year's insurance program offers three optional price elections for valuing production lost or damaged and includes a plan that can provide producers with higher yield guarantees on the basis of their actual production history. Rates have been adjusted to offer reduced premiums for producers with above-average yields.

To find out more about the 1987 Crop Insurance Program, producers should contact a local, authorized agent. To select an agent, producers may check the list of agents at their local ASCS office. February 15 is the final deadline for applications.

SHERIFF - TAX ASSESSOR/COLLECTOR DUTIES EXPLAINED

The principal law enforcement officer in the county is the Sheriff. The Sheriff has jurisdiction over the entire county to prevent criminal actions and to arrest offenders. In counties with a population under 10,000 and where there has been no vote to separate the two offices, the Sheriff may also be the Tax Assessor-Collector for the county. The Sheriff acts as Executive Officer of the County and District Courts, serving writs and subpoenas and processing lunacy warrants. The Sheriff also is responsible for sending out jury duty summons. He has the authority to appoint deputies and is in charge of the county jail and the prisoners.

The main duties of the County Tax Assessor-Collector, Deputy Tax Assessor-Collector and clerk, are to assess and collect property taxes for the county; to issue certificates of title and license plates for motor vehicles and trailers; to issue voter registration applications and certificates; and to compile election poll lists. In some counties, the County Tax Assessor-Collector may also serve as the Chief Appraiser for the Central Appraisal District.

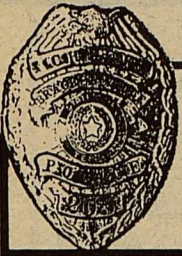

This was the first time this program was presented in our judicial district. It will continue to be presented to other schools in the near future.

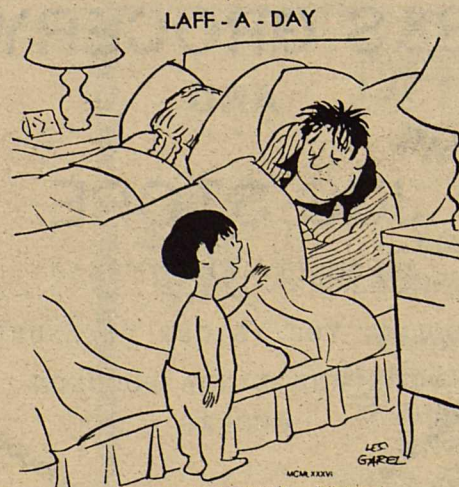

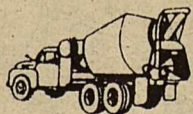

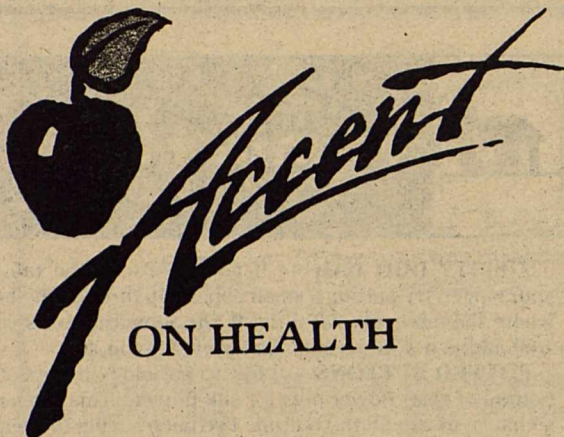

LEAD POISONING IS STILL A DANGER

Lead poisoning has a history as long as mankind's use of metal. As early as 6,000 years ago, people began to mine, smelt, and use lead in a variety of ways. Early peoples made containers, art, and religious artifacts of lead. The Romans added lead to wine to improve its taste--a practice which may have contributed to mental illness and sterility among the Roman aristocracy.

In the Middle Ages, cities using lead to carry drinking water suffered epidemics of lead poisoning.

Lead plumbing and old paint containing high lead levels were still in use well into this century in the U.S.

Today, lead is still an important and pervasive element in industry. Even the nuclear industry and medicine employ lead as shielding against radiation.

However, strict government controls, such as the 1970 Clean Air Act limiting lead in gasoline, have made lead poisoning less frequent. The average American's blood level of lead has been reduced by about 27 percent in the past two decades.

"As lead poisonings decrease, people may become less cautious, even ignorant that potential danger

exists," Dennis Perrotta, director of the Texas Department of Health's Environmental Epidemiology Division, said. "We don't want the public to grow careless out of ignorance. The number of poisonings may be down, but the toxicity of the metal is the same as it always has been." Perrotta added that children run the highest risk of lead poisoning.

A 1985 federal Centers for Disease Control report states that excessive absorption of lead is one of the most preventable children's health problems in the U.S. The usual lead sources for children are the dust and flakes of old paint, which often contain high levels of the metal. Effects of childhood lead poisoning can be retardation, and nerve, kidney, and gastrointestinal damage.

Perrotta advised that children living where lead paint, dust, or fumes are part of the environment should have a simple blood test yearly.

Adults in certain occupations also are likely to suffer poisoning unless they take precautions. Among these are welders, steel workers, smelter operators, and do-it-yourself painters, carpenters, and plumbers who work with old paint and lead pipes. Such workers should wear protective masks or respirators on the job.

Symptoms of excessive exposure are headaches, nausea, and neuromuscular abnormalities. For most lead poisoning, removal from the lead source and treatment of these symptoms allow full recovery. But extreme amounts of lead must be therapeutically reduced from the blood by a chemical process called chelation.

A 1985 law requires that all instances of lead overexposure on the job must be reported to the Texas Department of Health.

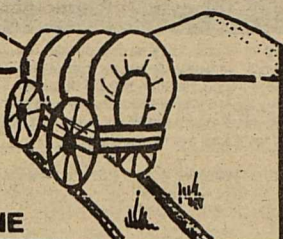

TRACKS ALONG THE TRAIL BY DORTHY PAYNE



Like the hub on a wheel, Fort Belknap was a center of a network of roads that led to Dallas, Preston, Fort Graham, Fort Worth, Camp Cooper, Camp Colorado, Fort Phantom Hill, Fort Chadbourne, San Antonio, and the Indian Agencies in Young and Throckmorton Counties. There was a stage line for mail and passengers operating between Fort Belknap and Dallas, and the Butterfield Overland Mail ran a stage line from St. Louis to San Francisco, with one of the important stops at Fort Belknap.

At first Fort Belknap was plagued with bad luck or so it seemed. Brevet Brigadier General Goldsmith Belknap, fresh from service as Commandant at Fort Gibson, Indian Territory, with the assistant, Captain Randolph Barnes Marcy, selected the site for the new fort on the salt fork of the Brazos, in present Young County, Texas. The site was about ten miles of the clear fork and a like distance below Marcy's California Road.

In June, 1851, Captain Carter L. Stevenson, first commanding officer, dug two wells, and failing to find water, moved Fort Belknap about two miles below the first location, where springs near the bank of the Brazos furnished water for the Fort until late in the year 1853.

The first project was the commissary store built of logs. In the subsequent years a new commissary store was built of native sand stone, along with the bakery, magazine, six infantry quarters, the corn house, Officers quarters, hospital, billiard room, and the company kitchen were built of poles covered over with adobe. The stable and saw mill were built picket style.

From the time Fort Belknap was established in 1851, it was to become a center of activity. Many famous military and others were to inhabit the Fort. On Dec. 27, 1858, Company F under the command more adept at stalking an enemy than bloodhounds.

In 1862 the Tonkawas were almost wiped out as a tribe when hostile Indians attacked their camp, killing 137 men, women and children, near present Anadarko.

With nearly half of the tribe killed, Chief Castile asked to be given a tribal home in Texas and

they were sent to Fort Griffin. They remained until 1884, when they were sent to a reservation in Indian Territory.

By 1859 Fort Belknap was abandoned for lack of water. During the Civil War state Frontier Regiment commanded by James M. Morris occupied the Fort. Some of these State troops took part in the Battle of Dove Creek. Later citizens lived in some of the vacant quarters and now and then buffalo took refuge against the elements in the cold winters.

Some of the stones were used to begin a town and the little village of Belknap sprang up near the fort. At one time three hundred people were to make the village their home. The village had a colorful history, here Charles Goodnight courted his bride to be, Mary Dyer. Millie Durgan lived here before being captured by the Indians, which is another story.

But by far the most interesting character who was associated with Fort Belknap was Robert Simpson Neighbors, who was the Superintendent of Indian Affairs for Texas when he was assassinated here in 1859. His assassin was an unimportant troublemaker who was supposed to have resented Neighbors' friendship with the Indians. But through his diligence he finally succeeded in bringing about the removal of the Texas Indians to a reservation in Indian Territory before he was assassinated. In the cemetery a memorial to Robert Neighbors still stands.

At the Fort the author spent of Albert Sidney Johnston, with his sparkling second United States Cavalry, marched through the fort on his way to the outposts in Texas.

In Feb., 1858, Company F under the command of Richard W. Johnson, took possession of Fort Belknap. Out of this regiment came seventeen Generals of the Civil War, most of them Confederates. One of the most celebrated of these was Colonel Robert E. Lee, who was stationed at nearby Camp Cooper.

During the Civil War the Comanches who were not on the reservation continually harassed the settlers on the frontier. Near the fort, on the Fitzpatrick Ranch, one of the most tragic raids took place. The raiders swung down Elm Creek at its confluence with the Brazos, and back, killing seven ranch workers, five confederate soldiers, and captured six women and children, and drove off ten thousand cattle from the ranches on the way.

Brit Johnson, a colored slave,

lost his entire family to the kidnapers. After the raid he somehow gained the confidence of the Indians and joined up with them. After biding his time he liberated the remaining members of his family, along with others. When his part in the liberation was discovered, the Indians caught him. He dismounted, killed his horse and dug in. After a terrific losing battle he was scalped and horribly mutilated.

The Tonkawa Tribe were valued friends and allies with the Confederates, and became scouts, both against the Federal Invasion and marauding Comanches.

They scouted from the Red River to the Rio Grande and the Commanders of the Confederate Army would feed them at their own expense when necessary. It was said a few Tonkawa scouts were more useful than two or three companies of regular infantrymen. They were several enjoyable hours roaming the grounds, and unlike most restored historical Monuments, Fort Belknap seems to be still alive, as if one would expect to hear the sound of marching feet on the parade ground or perhaps near the Butterfield stage rumble up.

HARRISON APPOINTED AGRICULTURE COMMITTEE CHAIRMAN

AUSTIN -- Texas House Speaker Gib Lewis, D-Fort Worth, has appointed State Representative Dudley Harrison to the Chairmanship of the Agriculture and Livestock Committee for the House of Representatives.

Harrison, a three-term Democratic lawmaker from Sanderson, was also appointed by the Speaker to the membership of the House Committee on County Affairs. He will serve on the committees for the 70th session of the Texas Legislature.

In making the announcement Lewis cited Harrison's knowledge on the issues likely to be considered by the two panels.

Lewis stated, "Representative Harrison has great insight and regard for those matters that affect the agricultural industry as well as those impacting the counties in our state."

He continued, "I look forward to Dudley's leadership during this session as he works to preserve the interests of the citizens in District 68 and the State of Texas."

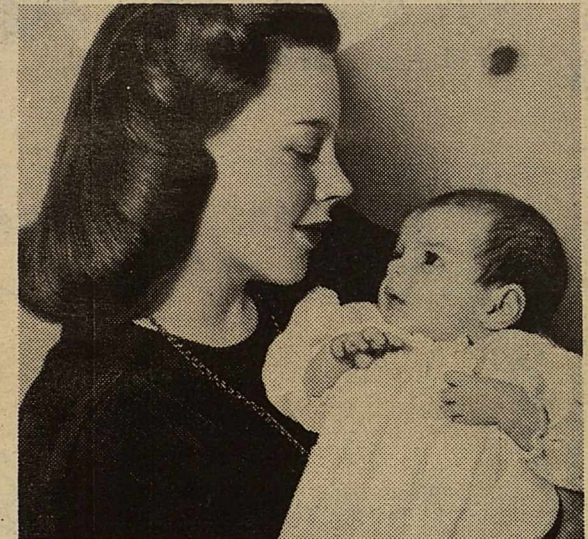

SHERIFF'S CORNER



The Kinney County Grand Jury met in the Kinney County Courthouse on Friday, January 23rd as scheduled and heard several cases. The results are as shown below:

1. Felony Possession of Methamphetamines- 1 suspect indicted
2. Unauthorized Use of Motor Vehicle - 2 suspects indicted
3. Aggravated Robbery - 2 suspects indicted
4. Theft of Vehicle - 1 suspect indicted
5. Tampering with Governmental Records - 1 suspect No Billed
6. Felony D.W.I. - 1 suspect indicted
7. Sexual Assault - 1 suspect No Billed
8. Theft of Livestock - 2 suspects - this case was not presented to the Grand Jury pending further investigation.

The trial date for those suspects indicted has been scheduled for sometime in April at the next docket for District Court. Four of the defendants were arraigned before District Judge George Thurmond on Monday, January 26th and requested court appointed attorneys which were appointed by Judge Thurmond.

Monday, January 26th was the date scheduled for District Court with several civil cases and 2 criminal cases on the docket. A jury panel was called in but was dismissed by Judge Thurmond shortly after roll call due to the fact that the civil cases had been settled out of court late Friday afternoon. One of the criminal cases was settled by a plea bargain and in the other case the defendant was in the Val Verde Hospital recovering from surgery.

The plea bargain case involved Jose Aranda aka Jose Hernandez, 19, a Mexican National who was arrested, tried, and convicted of Auto Theft in Kinney County in 1986. Aranda had received a 7 year probated sentence in that case and violated the conditions of the probation recently when he re-entered the United States illegally after deportation and was arrested in Kinney County once again and charged with Possession of Marijuana. The District Attorney,

Tom Lee, filed a motion to revoke his probation and Judge Thurmond did just that on Monday. In the plea bargain agreement the defendant received a 5 year sentence to the Texas Department of Corrections. He will be transported to the facility as soon as possible and when TDC is again accepting prisoners.

We welcome the addition of 2 new employees at the County Jail effective February 1. Jim Gass and Elida Estrada, both graduates of the Brackettville High School will replace Dee and John Jordan who resigned to accept other employment. Gass and Estrada will be classified as Jailer/Dispatchers.

A burglary of the Ft. Clark Springs Teen Activity Center and the theft of a car from a Ft. Clark man have both been cleared with the arrest of two juveniles by Sheriff's Department investigators.

The burglary, which was discovered and reported late Friday, January 30th, is believed to have occurred on Sunday, January 25th. The Teen Center had been closed between those dates, therefore the burglary had gone undetected for several days. Candy, soft drinks, and a large sum of money from pool tables and vending machines was taken during the crime. Entry to the building was through windows on the East side of the building.

The auto theft was reported at approx. 4:00 am on Sunday, February 1st and involved a 1978 Chevrolet belonging to Paul Shepard of Ft. Clark Springs. The car was located a short time later by Ft. Clark Security Officers near the Ft. Clark dump. The drive shaft had been broken, and the car abandoned.

Deputy Sheriff David Luna, who had been assigned to the case, linked the two crimes together by evidence collected during the investigation. After the arrest of the two juveniles statements of confession to the two crimes were obtained from the two. Most of the property stolen from the teen center has been recovered, including the money which had been buried on Ft. Clark. The case will now be turned over to juvenile officers for further action.

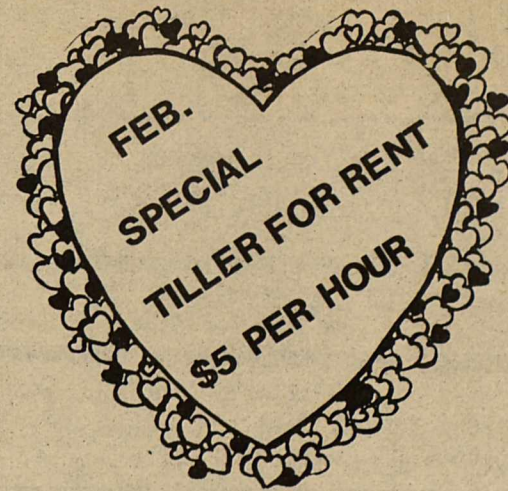
