


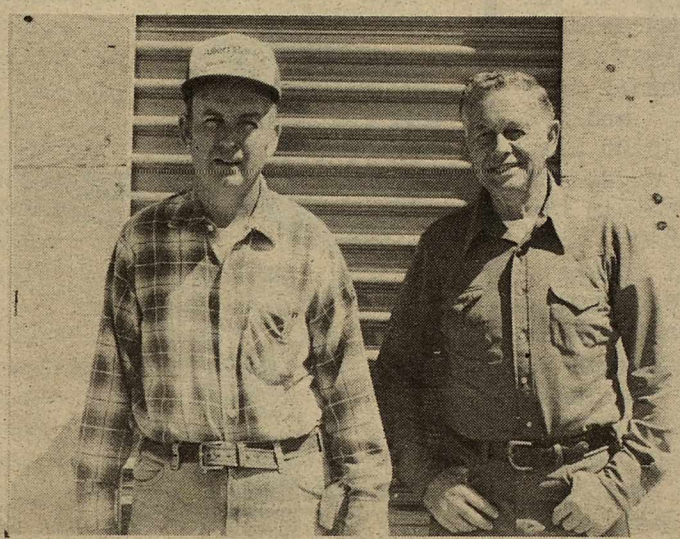

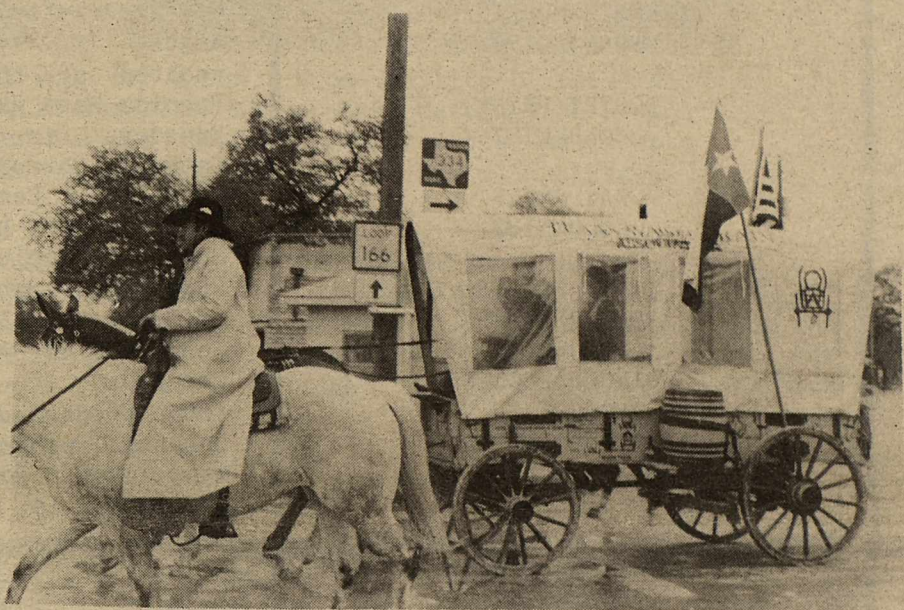
The units can be customized to whatever size desired, up to 10'x30'.

FRED RESCHMAN, SR.

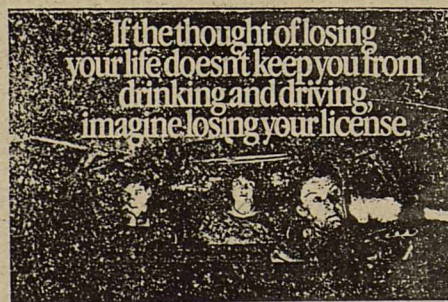

Services will be held Friday, April 3rd at 4:00 p.m. at the Frontier Baptist Church with Brother Joe Townsend officiating.



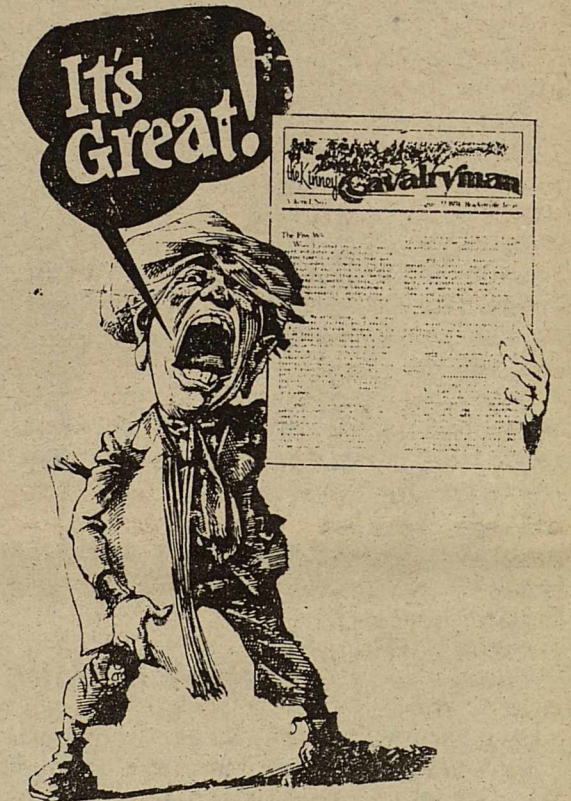

COMPUTER HELPS YOUNG TEXAN OVERCOME HANDICAP

LUBBOCK, Texas, March 25, 1987 -- It's a new term at Texas Tech University, and freshman Scott Tooke is knuckling down to the complexities of his accounting classes.

The work, often requiring sophisticated math, is tough. It could be even tougher for Tooke, a bright 19-year-old whose mobility and speech are seriously inhibited by cerebral palsy.

But thanks to a powerful, hand-held computer -- and some original thinking by technicians at Hewlett-Packard Company -- Tooke is keeping pace with the class.

Tooke, an honors graduate of Lubbock's Coronado High School, entered Texas Tech last fall as an accounting major. Using a wheelchair to get around and a Prentke Romich LIGHT TALKER communication board to "talk" and do his assignments, he has quickly adapted to campus life.

But math presented a problem. Tooke had little trouble performing three-digit multiplication and division in his head. But his college courses called for more complex calculations. In high school, a six-year-old friend had helped, punching calculator keys at Tooke's command. In college, without his young assistant, Tooke soon realized he needed a new computing tool.

He took his dilemma to Texas Tech's biocybernetics lab, which assists disabled people with mobility and communications problems.

Tooke suggested that the lab



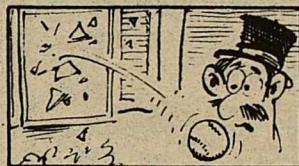

mount a calculator so that he could punch its buttons with his nose. But James Koerlin, Texas Tech lab's director, figured technology could do better than that. Koerlin called HP's calculator support group in Corvallis, Ore., and explained the problem to J. Lea

Bailey, an HP technician.

She was excited by the challenge. After contacting Prentke Romich for technical information about the LIGHT TALKER, Bailey and her team

NUTRITION & AGING SERVICES

FISCAL YEAR 1988 BUDGET

President Reagan has proposed critical cuts in the programs that affect the elderly and poor. Medicare cuts include the following:

- * Much greater hospital costs will have to be absorbed by beneficiaries;
- * Delays of one month in Medicare eligibility for all new enrollees;
- * Repeal of Medicare coverage for optometry, occupational therapy, kidney dialysis, and physician assistant services.

Medicare cuts to States of \$19.5 billion over five years would mean a significant reduction of coverage. Keep in mind that Medicare is the only source of long-term nursing home care for elderly poor.

Programs that freeze at FY 1987 levels:

- * Older Americans Act, nutrition and social service programs would be block granted (a single funding for all programs grouped together) and a funding freeze at current levels is in effect, a 3.6% reduction;

- * Senior Community Service Employment; and

- * Older Americans Volunteer Programs, Social Services Block Grant.

Programs the President wants to eliminate:

- * Congregate housing services program which provides meals and essential social services to residents of the Section 202 housing for the handicapped and elderly;

- * Community service block grants, provide funds for community services for the poor, including emergency food and fuel assistance; scheduled for elimination by 1991 and cut by \$58 million in FY 1988;

- * Housing, Weatherization Programs,

would end housing construction and rehabilitation, including Section 202 housing for low-income elderly and handicapped; and

- * Legal Services Corporation, provides legal assistance to low-income people; over 175,000 are elderly.

THIS IS WHAT YOU CAN DO: Contact your senators and representatives. Let them know what the proposed cuts mean to you, your program, and your community.

WRITING YOUR MEMBERS OF CONGRESS

Your letters can, and do, make a difference. Members of Congress rely on letters to find out what the people back home are thinking.

Most members of Congress count the number of letters that come in addressing a certain issue. Both quantity and quality matter; timing is also important.

Here are some guidelines to follow when writing to your members of Congress.

- * Spell your legislator's name correctly. To be absolutely sure, check under the United States Government in the phone book or call your library. If you know your legislator even marginally, use a first name. Your letter will receive more attention.

- * Write legibly or type your letters.

- * Please use your own words. Letters are more effective than postcards and more effective than petitions. Using your organization's stationery is most effective.

- * Make clear what you are writing about. Your position should be clear in the first sentence. ("I'm writing to urge you to oppose a freeze and to support an increase in the current funding for Title III of the Older Americans Act. This support will help to provide the continuation of meals for elderly adults through home-delivered and congregate meal sites.")

- * Stay on one topic; don't ramble and pack in other subjects.

- * Be thoughtful and give reasons for your position. Be certain your facts are correct. If appropriate, use illustrations and personal examples.

- * Raise questions and keep it short. One page is best.

- * Be polite, positive and constructive. Don't plead and never threaten.

- * Use your name and address on both the letter and the envelope.

- * Refer to the bill number whenever possible.

- * Always thank the member of Congress when they take action you agree with.

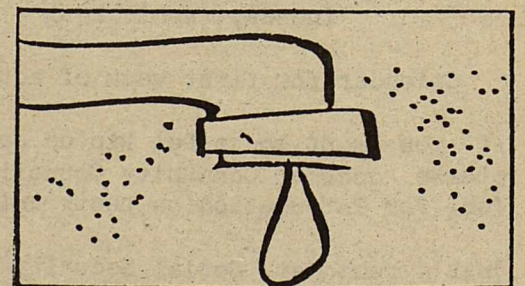


VIDEO VIEWER

BRACKETT - The Jr. High boys took the team championship at the Brackett relays last Saturday.

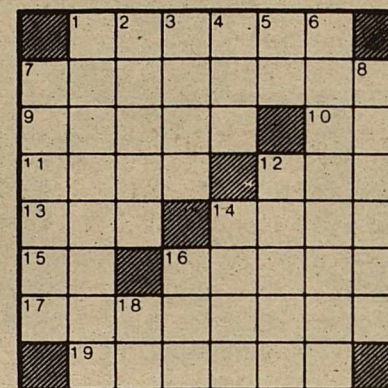

SHERIFF'S CORNER

Two burglaries that occurred in Brackettville on the night of March 25th were cleared up and solved in short order by Chief Deputy Sheriff David Luna.

The burglaries were reported the morning of March 26th by the owners of Lopez Bakery, located across from Jones Elementary School, and Games and Things located on West El Paso Street. Evidence discovered at the scene led Deputy Luna to believe that both crimes had been committed by the same persons and as the investigation continued evidence was linked to three local juveniles. The three were arrested by Luna the afternoon of March 26th and released to their parents pending a hearing by juvenile authorities.

The Sheriff's Department has recently cleared six (6) burglaries and one (1) auto theft that has led to the arrest of five (5) local juveniles and the recovery of several hundreds of dollars in personal property and cash.

Juvenile law being what it is today with tight, ultra-conservative restrictions placed on law enforcement officers, juvenile officers, and the trial courts, as to the way they can handle juveniles, many of those juveniles who are apprehended walk out of my office with smirks on their faces thinking the system is a big joke. And, the way things are right now, they may be right! The sad thing about this is that many of the juvenile offenders grow into adulthood with no respect what-so-ever for the lives and property of others and even less for the law and those of us who enforce it. So many times I think that with a little shock treatment the first time a youngster commits a felony crime he or she might be saved from years of heartbreak and sorrow in later life. I have had to haul too many young adult violators to prison over the years, many of them having been handled by me as juveniles. Could they have possibly been saved from a future life of crime had we been able to handle them differently? Well, no one will ever really be able to answer that question, but in my opinion from years experience in handling both juvenile and adult

criminal violators, I think some of them could have. In fact, I have been told by some of them as I was transporting them to prison that they wished that we had been harder on them when they were young, then maybe they would have been afraid to commit crimes later on.

District Court was held on Thursday, March 26th, with District Judge George Thurmond presiding. Three cases were heard with the first one being that of Domingo Montoya, 32, of Brackettville. Montoya was charged with the October, 1986 burglary of the Gonzales Store on west El Paso Street. He had demanded a jury trial which caused a jury panel to be summoned to appear. At the last minute prior to the start of his trial, he decided to accept a plea bargain agreement and pled guilty to the charges receiving a 10 year sentence in TDC. (NOTE: Montoya has cost the county over \$8,000 since he was arrested in October 1986 due to an operation for appendicitis, subsequent follow-up treatment, and expenses related to his defense).

The remaining two cases were tried together as they involved two illegal aliens who were charged with the theft of a pick-up from the Leo Frerich Ranch on January 7th this year. Jorge H. Villarreal, 27, and Antonio F. Muniz, 23, both Mexican Nationals, received a 6 year probated sentence on guilty pleas. They were turned over to the U.S. Border Patrol for processing and deportation following their trials.

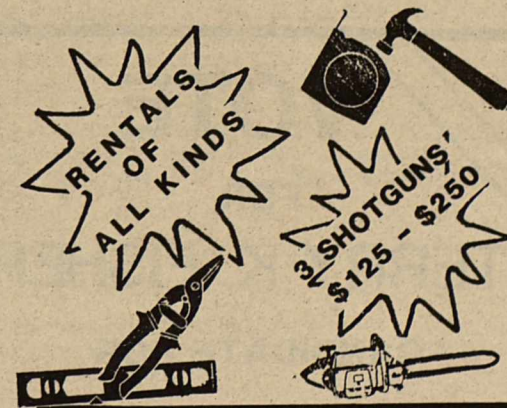

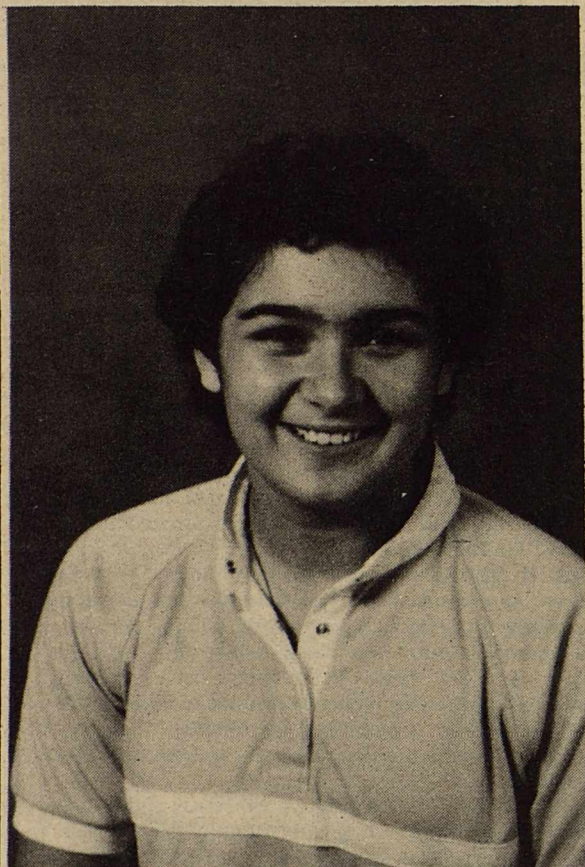

REPRESENTS B.I.S.D.

Pilar Lozano, a sophomore at Brackett High School, will represent the school at the West Texas Leadership Seminar, affiliated with the Hugh O'Brian Youth Foundation, on April 3-5, 1987. The Seminar will be held at Lackland Air Force Base in San Antonio. She will join 180 other outstanding sophomores from an area of Texas which will include schools from El Paso to Waco to Brownsville. The three-day Seminar is sponsored by Optimist Clubs, Kiwanis Clubs, Greater Federation

of Women's Clubs, and various businesses in the communities.

The purpose of these Seminars is to give sophomore school leaders a better understanding and appreciation of the economic system, the democratic process, and to encourage the student's active participation in designing their world of tomorrow. These three-day, all expense paid workshops bring together today's distinguished leaders in business, government, education and the professions with the leaders of tomorrow to explore the topic "America's Incentive System."

The Foundation was established 27 years ago by movie and stage actor Hugh O'Brian in the belief that America's greatest resource is it's youth. The purpose of the Foundation and the related Seminars is to seek out, recognize and reward leadership potential in sophomores.

Pilar has been involved in basketball and track for the past two years. She received Honorable Mention in basketball this year. She also played volleyball this past fall. Some of her academic accomplishments include Student Council Vice-President, President of both her freshman and sophomore class, Vice-President of the Youth Advisory Council, member of the Disciplinary Committee, and a UIL Extemporaneous speaker. She was chosen according to her leadership abilities which she has demonstrated during her first two years of high school. She will be participating in a program that very few youths ever receive the honor or the chance to experience.

MOTORCYCLE HELMENTS

By 1975, as a result of a federal requirement, all but three states had enacted laws that required helmets be used by motorcyclists. Texas established such a law in January 1968. In 1976, the federal requirement was repealed, and by 1982, nine states had no helmet law and 22 had amended theirs to require helmets only for teenaged riders--including Texas. Between 1976 and 1980, deaths from motorcycle accidents increased nationwide by nearly 50 percent.

Texas changed its law August 29, 1977. In the year that followed, nearly a third more motorcyclists died. Of the nearly 330 deaths, approximately 230 had not worn a helmet. Now, Texas is one of 24 states that have a partial helmet law. In Texas, only persons under age 18 must wear a helmet. In 1985, 364 motorcycle drivers and passengers were killed in Texas and there were 10,859 injuries. Drivers aged 20-24 were found to be most often involved in these accidents.

Since 1982, TMA has supported reenactment of legislation that mandates the use of helmets by all motorcyclists. Physicians are vitally concerned about the needless deaths and injuries that occur as a result of not wearing a helmet.

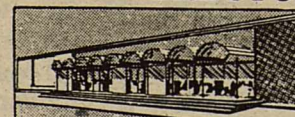

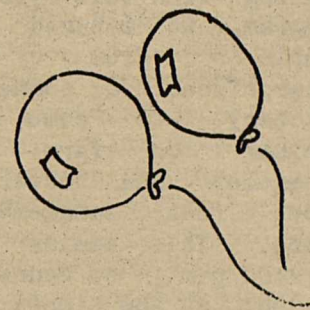
The period of one's later 30's is often viewed as a time of consolidation and satisfaction. Between 40 and 50, but not limited to this age range, what has come to be known as a "mid-life crisis" may occur. This is when one's past choices and present contributions are questioned, because the sober reality of life being half over may result in thinking about individual freedom versus security of a relationship, or career success as it relates to needed intimacy. This is often combined with new concerns and associated confusions about one's genuine identity. It is not at all unusual to see job changes and extramarital affairs emerging during this time, in an attempt to relieve the anxiety of a mid-life crisis.

In the case of the latter, such affairs actually inhibit intimacy and the ability of a married couple to communicate. Instead of putting their energies into talking and understanding each other's needs (which is not an easy task and certainly can be a bumpy road), they delude themselves and the relationship. 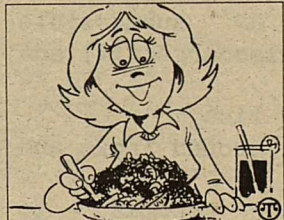

horsemen to place them on all of their correspondence," adds Russell. "We want everybody to know just how big an impact the 'horse dollar' has in Texas."

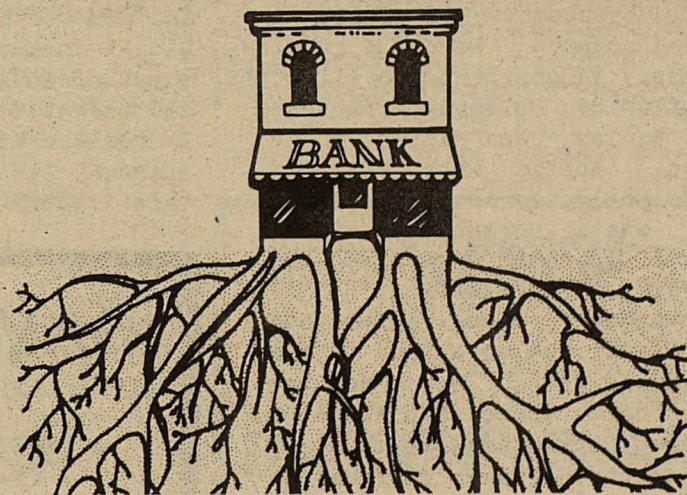
Russell is also the founder of the Texas Horseman's Credit Union, as well as the owner of 200 head of horses, including Lone Secretariat.

Ideas For Interior

Now that the holidays have come and gone, you'll probably want to get your house back in order, take down the decorations, clean up the pine needles, etc., etc. This might also be a good time to look around and see which rooms in your house need painting, fixing or just plain prettying up!

Winter usually finds us more confined to the house which can be quite restrictive if our surroundings are not pleasing to us. However, fresh paint, wallpaper, new curtains, etc. can do a lot to brighten up everyone's mood. In fact, tackling the redecorating together as a family is a good winter project.

Remember, also, that if you haven't painted recently, your walls and ceilings are paying the price for

that neglect. Before you paint, however, make sure all surfaces are prepared correctly to receive that fresh paint. That means thoroughly cleaning, spackling any cracks and scraping away any old, peeling paint. If you apply fresh paint directly on top of an unprepared surface, the results will be appalling and you'll only have to do the job over again correctly.

The same principle applies to wallpaper. If the surface isn't cleaned properly, that wallpaper is going to wind up falling down. By the way, it's a good idea to pour a drop or two of disinfectant into your wallpaper glue while mixing it to combat mildew building up between the wallpaper and the wall.

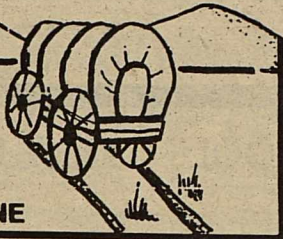

**TRACKS
ALONG THE
TRAIL**

Ever since the first mounted soldier came into existence in the United States, he has been written about, talked about in books, movies and television. The romantic haze around the Cavalry has never faded since the Rangers and Dragoons were merged to become the Cavalry.

Like the Indian, as soon as the soldier was mounted he became a threat or a protection, however the case might be. The Cavalry (motorized) is still very much in existence but in the 1800's the Cavalry as a mounted organization was the very backbone of the settlement of the west.

The front pages are full of the activities of the Cavalry as the air mobile as were their deeds in Viet Nam. But then the Cavalry is only doing the fine job they have been doing for more than one hundred years.

Ever since 1833, when it was decided to discontinue the Rangers and combine their six companies with the Regiment of Dragoons as authorized by Congress, the Cavalry began to come unto their own.

In 1831 the seventh Infantry was ordered to Ft. Gibson, Indian Territory, to take various expeditions into the wild Indian country for the purpose of negotiating treaties in order to protect the civilized Indian tribes.

On one such expedition, the Ranger Company under the command of Captain Jesse Bean were sent along as protection. A sort of police duty you might say.

While the Rangers were on duty with the 7th, Washington Irving, along with friends, arrived at Fort Gibson and decided to try to overtake the Rangers and get in on the excitement. From his months experience on this trip, Irving wrote his famous book, "A Tour of the Prairies."

On another expedition, two companies of the 7th under the command of Lieutenant Colonel James May, and policed by three companies of Rangers commanded by Bean, Ford and Nathan Boone, (son of Daniel Boone), went as far as the wilderness of the Washita, Red, and the Blue Rivers.

In 1834, perhaps one of the most successful trips for the

negotiation of treaties with the wild Indians was carried out by the Dragoons. The officers in command were General Henry Leavenworth, Colonel Henry Dodge, Colonel Stephen Watts Kearney, Major R.B. Mason and Lieutenant Jefferson Davis, fresh out of West Point. In fact, many of the West Point graduates who distinguished themselves in both the Mexican War and the Civil War served at Fort Gibson at one time or another.

In 1839, the Dragoons, commanded by Lieutenant James M. Bowman, went along for police duty on the famous Dr. Josiah Gregg expedition to Sante Fe and Chihuahua.

Up until the Mexican War, the first Dragoons policed the west against the wild Indians. And on August 3, 1861, they became officially the First United States Cavalry and fought with valor through the Civil War. So the Cavalry began at Fort Gibson as a mounted unit, and was to end at Ft. D.A. Russell in Marfa, Texas.

Marfa, Texas was a water stop in 1881, on the Texas and New Orleans Railroad, and was named by the wife of the president of the railroad for the heroine of a Russian novel.

This part of Texas, in the 1800's was wild and wooly, and to some extent still is. The Apaches, led by Victoria, were becoming a threat and of course the settlers needed protection, so the Cavalry was sent to the area on police duty.

After the Indian deparadations were under control, the Mexican Revolution poised a new threat, and in 1911, the War Department ordered Cavalry troops to the border near Marfa.

From 1911 to 1919, both the Cavalry and the Infantry served along the Mexican Border in what was called the Big Bend Military District. In 1920 the District was discontinued and Camp Marfa was established as headquarters of the Marfa command.

On January 1, 1930, Camp Marfa was officially named Fort D.A. Russell for David Ashley Russell, a veteran of the Mexican War. And in 1932, in December, the First Cavalry Regiment, under Colonel William Austin, held an impressive last review to mark the passing of the oldest Cavalry Regiment in the United States, as a mounted organization. "Louis", the oldest horse in the Regiment was given a special military review, and along with the other mounts was put out to pasture at Fort Knox, Kentucky.

The Field Artillery, in 1935, moved into Fort Russell, under the command of Colonel Robert H. Lewis. In 1938, the Cavalry again came to

the Fort for a month of Cavalry maneuvers, under the direction of General Ben Lear.

After a threatened abandonment in 1939, Marfa offered the Federal Government an additional 2,400 acres of land for enlargement of the Fort, and after adjacent property was also bought, the Fort under Colonel Burtram Frankenberger was improved.

After the passing of the Selective Service Law, the Cavalry moved in again and replaced the Field Artillery in 1944. The 81st and 85th Chemical Warfare Battalions also trained at Fort Russell. In November, 1943, a prisoner of war camp was established there, also a military police Escort Detachment under Lieutenant Harvey F. Bailey. Finally, in December, 1945, the Fort became inactive and in 1949 was privately owned.

The Mounted Soldier still rides in our stories and dreams and will not be forgotten.

got to work. Within days, they had designed software that would link Tooke's LIGHT TALKER to the HP-71B hand-held computer, using standard HP interface modules. By Thanksgiving, Tooke had his new equipment and was learning to use it.

The operation is simple. Tooke moves a light-tipped wand across the LIGHT TALKER's keypad, pointing to various numbers, letters or functions. The HP-71B performs the calculations without Tooke ever having to touch the computer's keys.

Koerlin, who has worked with Tooke through the project, praised the setup. "With the HP-71B, Tooke should be able to perform all the math he will need through college, at the graduate level and on into his career," Koerlin said.

Bailey said the new software is generic enough that it could be easily adapted to other, similar communication devices used by the disabled.

And Tooke? He looks forward to the new term, new classes and using his computer. Asked how things are going, he moves the wand across his keypad and his answer pops up on the HP-71B's display panel: "Busy!"
