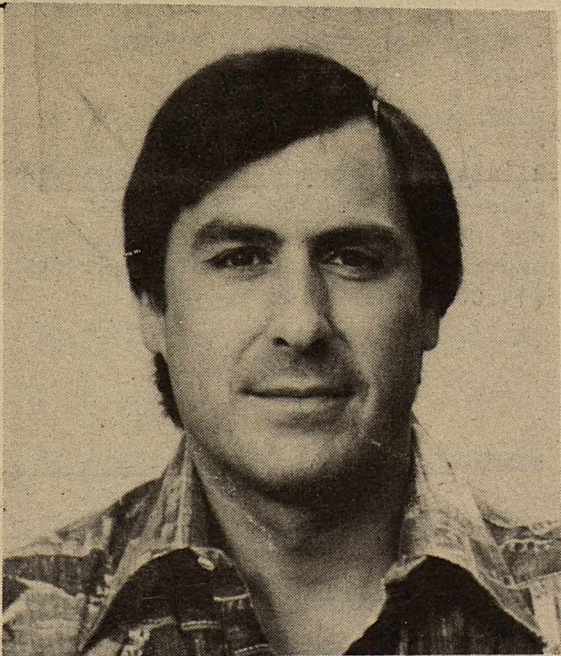
KNIGHTS OF COLUMBUS SELECT GOMEZ AS FAMILY OF THE YEAR

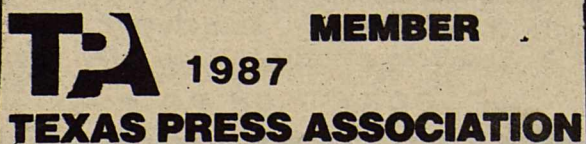

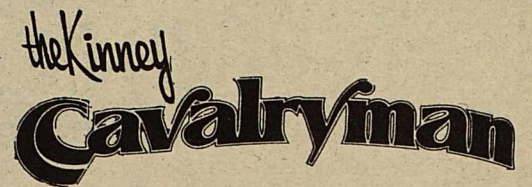

Brad's Car Care

As part of your pre-winter servicing, you should be aware of certain other "hidden" filters, too. The most common are carburetor-mounted fuel filters, crankcase breather filters (sometimes called "PCV air" filters), and transmission filters. Many cars also have replaceable filters in their fuel vapor canisters (often called "charcoal canisters").

Clogging of the carburetor-mounted fuel filter can be prevented by changing it every 10,000 miles or so. Check your owner's manual to see what kind of fuel filter you have. If your crankcase breather filter starts to clog, fuel mileage and performance drop, exhaust emissions get dirty, and the engine develops a rough idle. Lastly, in order to minimize wear on internal transmission parts, a replaceable filter is located inside nearly all automatic transmissions.

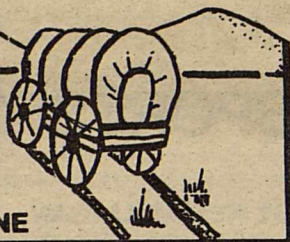

TRACKS ALONG THE TRAIL

On the East side of the Chisos Mountains in the Big Bend country of Texas is a draw called Glenn Springs Draw which runs for eighteen miles eastward until it ends at the Rio Grande.

Across the river in Mexico is the remains of San Vincente, and years before the white man came the country along this draw and across the river to San Vincente was the stomping grounds of Bajo del Sol, a comanche chief, who fought the Apaches and made friends with the Mexicans.

From the first, this region was to have its share of tragedy. The first white man to come here was a man named Glenn who raised horses, and dug out the springs in the draw for a better water supply. History has it that he was killed near the springs by either Mexican bandits or Indians. The little settlement was then called Glenn Springs.

From 1910 to 1918, Glenn Springs was a subpost for the Army who was engaged in keeping control on the Mexican Border. It acquired a Post Office in 1915, and things were just beginning to look up in 1916 when all hell broke loose.

It was Cinco de Mayo, 1916 to be exact, a Mexican holiday, probably the most celebrated of all Mexican holidays.

Officials of Mexico and the United States were in conference in El Paso, meeting for the purpose of ironing out the Border difficulties that had been plaguing both countries for some time.

Poncho Villa was going strong and his followers, the Villistas, and another political group, the Carranzistas joined together under their respective leaders, Rodriguez Ramirez and Natividad Alvarado, and moved out from Torreon gathering recruits all the way to the Rio Grande.

Their scheme was practically fool proof because under the cover of the Cinco de Mayo celebrations, they knew little attention would be paid to strangers coming and going across the Border.

It was common practice on this holiday for relatives and friends on both sides of the Rio Grande to get together to celebrate.

By eleven o'clock on the night of

the holiday several hundred of these bandits approached the little settlement of Glenn Springs.

There were only eight or nine soldiers at the garrison on duty, they were members of the 14th Infantry, in charge of a Sargeant Saythe. Three soldiers were sleeping inside, and on account of the heat, all the rest were sleeping outside the adobe quarters, where two dollars were on guard. They weren't on their toes, however, because they didn't hear the bandits, perhaps because the raiders had tied their horses and were creeping up under the cover of darkness.

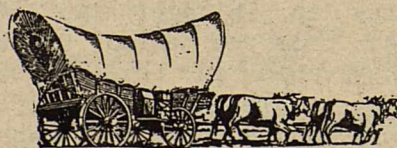
The attack was swift and for several hours it looked as if the soldiers might hold out. The bandits knew the adobe buildings were roofed with a thatching of candelilla, a plant from which wax is made and native to the area, the bandits also knew that this plant would burn like powder.

The buildings were soon blazing, set on fire by the kerosene soaked rags thrown by the bandits. Finally to escape the fire, the soldiers broke from their quarters. Two were shot and killed, one was seriously wounded and the rest were badly burned.

The Peace Conference was halted in El Paso when news of the raid was received on Sunday. Colonel Longhorne and the 8th Cavalry were ordered to follow the bandits into Mexico and to return the American captives and American property taken in the raid. but by the time the news had reached El Paso and the army could march to Boquillas, the bandits had four days start on them and were long gone.

The captives were abandoned in El

Paso because the bandits didn't want to meet with the United States Army while holding captives. Carranza raised sand about the army being on Mexican soil and President Wilson ordered Langhorne to return to the Texas side of the river. The bandits were never punished but most of the loot was recovered and the captives were returned unharmed. But the ladies hats and parasols remained in Mexico.

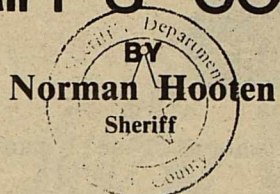

SHERIFF'S CORNER



Every once in awhile I try to give you a break from the usual gloom and doom of routine crime reports but there has been so much activity lately that I have felt compelled to stick with the crime reports so as to keep you informed of the basic criminal activity going on, in and around our county. Such is the case again this week, therefore the following report.

Thomas C. Kimble, 32, of Corpus Christi, Texas and a traveling companion were arrested at the Border Patrol check point Wednesday afternoon, April 15th on Possession of Marijuana charges. The subsequent investigation by this writer determined that the small amount of marijuana (4 joints) belonged to Kimble and his companion was released. Kimble was charged and booked and later released on \$1,500.00 bond set by Justice of the Peace Alvin Hall. His case will be tried later in county court as a Class A Misdemeanor.

A short time later I received a report from Nick Nixon who lives just west of town that two men believed to be illegal aliens had entered his home and took approx. \$27.00 in cash and loose change. They were apprehended a short time after the incident by Border Patrol Agents near the check point. Both men are Mexican Nationals in this country illegally. They have been charged with Criminal Trespass of a Habitation, a Class A Misdemeanor and will be tried in county court.

At approx. 1:30 a.m. the morning of Thursday, April 16th, I received a call requesting I come to the Border Patrol check point to take custody of two men who had been arrested there after they ran through the check point. after they had been apprehended by Border Patrol Agents a routine check on the men through NCIC computer indicated that both were wanted on felony charges out of the state of Oregon.

The two young men were brothers, Larry Dean and Tony Lee Smith, 23 and 20 years of age. The oldest brother was also wanted by Travis County, Texas on charges of Violation of Probation, DWI. The pair were transported to the county jail and booked on charges of Public Intoxication and Holds

placed on them for the outstanding warrants. The state of Oregon refused to extradite and they were tried on the Public Intoxication charges and were fined \$50.00 each by J.P. Alvin Hall. Tony Lee Smith was released after paying his fine and Larry Dean Smith is still being held for Travis County authorities at the time of this writing.

A seminar on Covert Methamphetamine Labs held at the Middle Rio Grande Law Enforcement Academy in Uvalde Friday, April 17th was attended by numerous peace officers from surrounding counties, including Deputy Sheriff David Luna and myself. The 10 hour course was conducted by DPS Narcotics Agents, primarily in an effort to make peace officers more aware of the extremely dangerous characteristics of, not only the labs, but of the people who are connected with them.

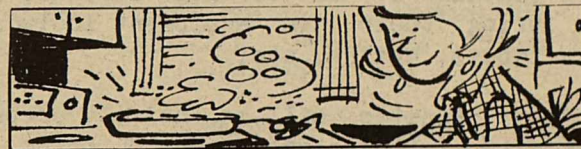
Meth Labs, as they are commonly called, are illegal drug operations that have been springing up in rural areas around the state over the past few years with a drastic increase in our area over the past year or so. The "speed freaks" who set up these operations are, for the most part, drug addicts who are extremely dangerous in nature. They are heavily armed and almost always set booby traps in and around their illegal operations that are designed to kill and maim anyone trying to enter their "territory" while they are not around.

The seminar was very educational and stressed the importance of cooperation between the various federal, state, and local law enforcement agencies in fighting these cruel, vicious criminals in the increased war on drugs.

At approx. 12:45 p.m. on Saturday, April 19th, we received a request from U.S. Customs Agents in Del Rio for assistance in making a felony stop and arrest of a suspect they had under surveillance for several days. The man was wanted on a felony warrant out of the State of Pennsylvania on charges of Attempted Criminal Homicide. Deputy Luna and I set up east of Brackettville to wait on the eastbound motor home being driven by the dangerous suspect and contact was made approx. 1 mile east on Hwy. 90 and the arrest made without serious incident. There were several law enforcement officers involved in the arrest, including Customs Agents, DPS Narcotics Agents, local Border Patrol Agents and Deputy Luna and myself. The man was then transferred to the county jail and magistrated by County Judge Tommy

Sergeant who denied bond at the request of the Pennsylvania authorities. He was later transferred to the Val Verde County Jail and the motor home he was driving was taken to Del Rio by Customs Agents for a thorough search for illegal drugs and/or money.

According to the Pennsylvania authorities, the man, Dennis Paul Eiler, 41, of Pottsville, PA and a cohort kidnapped another man because of a drug deal gone sour. They took their victim to an abandoned house in a rural area, tied him from the rafters and pulled out all his fingernails and toenails. They then shot him in both knees and beat him badly before taking him into some woods and hanging him from a tree, left for dead. Drug dealers are such nice folks!

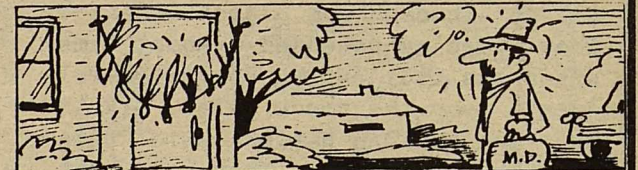
The training was conducted by a team of Adult Leaders and Extension Agents who attended the State Training in Brownwood.

MOSQUITO INCREASES EXPECTED

ON HEALTH

One of the factors Texans usually count on to control the harmful insect population is cold weather. Long periods of freezing, dry weather are best to kill millions of mosquitos and prevent others from reproducing.

But according to the Texas Department of Health (TDH), this year's unusually mild, wet winter may have fostered a population explosion of mosquitoes this spring. If so, TDH predicts at least an irritating increase in the stinging pests, and possibly outbreaks of mosquito-transmitted diseases, such as dengue and encephalitis.

Paul Fournier, supervisor of the Parasitology-Entomology Branch of the TDH's Bureau of Laboratories, said that the recent cold snap that briefly invaded Texas probably only slowed the reproduction of mosquitoes by a few days.

Fournier said that his laboratory receives, counts, and classifies mosquito specimens collected from some 43 mosquito surveillance programs throughout the state. "We counted 63,000 specimens last year alone, and we expect more this

year," he said. The number of samples, the species found, and the areas where they are collected are clues to their concentrations and whether serious health problems may develop. Fournier explained there are 83 mosquito species found in Texas, most of which are annoying, but not likely to spread contagious diseases.

"There are actually only four species out of 83 that alarm us when they are found in heavy concentrations. A few other species are able to transmit disease, but not as readily as those four species, and some species are not thought to be able to spread diseases to man," Fournier explained.

The four most serious disease carriers are: Aedes aegypti, a domestic vector of dengue fever; Aedes albopictus, the so-called "Asian Tiger Mosquito" which was accidentally imported to Texas from Southeast Asia in 1985 -- also a dengue carrier; Culex quinquefasciatus, the common household pest notorious for spreading St. Louis encephalitis; and Culex tarsalis, a transmitter of western equine encephalitis.

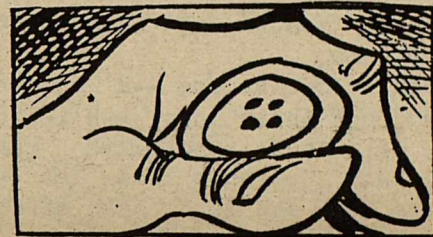
In 1986, TDH recorded 32 cases of St. Louis encephalitis for the state, including four deaths. Of those reports, 27 were from the Houston area, where both mosquito and human populations are dense. Only three cases of western equine encephalitis occurred, all in West Texas. Both types of encephalitis can cause severe brain damage or death, and no cure for the viruses

has been found.

Reports of dengue, also called dengue fever or "break bone fever," totaled nine indigenous cases, seven apparently imported from south of the border, and one case of undetermined origin. No deaths from dengue were reported.

The TDH mosquito surveillance program is a warning system against uncontrolled disease outbreaks like the ones early in this century, when thousands of people were stricken -- many dying -- by mosquito-borne illnesses. "With the warning we now have, we are able to advise local areas about their need for extra mosquito control programs when outbreaks threaten," Fournier said.

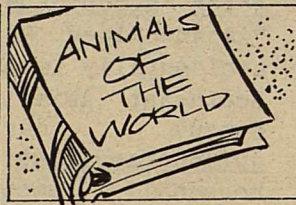

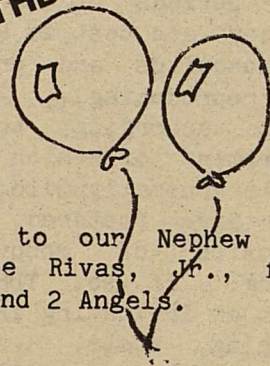

GARDENING TIPS

"Perennials"

A garden, large or small, should have a few Perennials planted. Perennials give you a wide range of colors, a choice of size, and a long blooming season. They can be made to live almost indefinitely by dividing and replanting them every third or fourth year. These plants are flowering plants which die to the ground each Winter and send up new growth in the Spring. You can plant Perennials anywhere flowers are needed such as in the shrub border, foundation planting or potted for indoor beauty. Most do well in a sunny location, but some need some shade. Prepare the soil the same as for other types of plants.

Most Perennial clumps will become overgrown by the third year. To renew vigor, lift, divide and replant. First, cut around the clump with a spade, then pry up. Phlox can be lifted in this manner. After lifting, divide clump into four or five smaller clumps and plant. Oriental poppies and chrysanthemums can be pulled apart, and daylilies need to be cut apart. Other Perennials are shasta daisies, dianthus, iris and many others. Perennials are quite sturdy and can survive most pests and diseases. If pests do appear, spray or dust every five days.

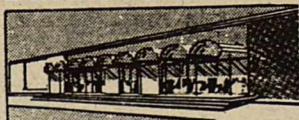
