"I love music," he states. "Leading congregational singing, conducting the church choir, and singing solos and group singing are some of my favorite church music activities. I feel that church music needs to move a person deep down on the inside - not just show movement on the outside." Taylor adds, "Many times the success of a sermon or time of commitment will depend upon the effectiveness of the music."
"I have a great interest in teaching the Bible," Taylor concludes. "I believe if one really wants to study the Bible, being a Bible teacher is one of the best ways to accomplish that."

GARDENING TIPS

## "YOUR AFRICAN VIOLET PLANTS"

African Violets are becoming very popular; they come in many lovely colors with single and double type blossoms. Adequate light is very important if you want lots of blossoms. Mild direct sunshine is beneficial, or you may use flourescent lights. Proper watering is very important, never use water that has been through a water softener, and only water when top of the soil is dry, and always use tepid water. Watering may be done from the top, bottom or by wicks, but by whatever method, about every third watering, water from the top to wash down accumulating salts. Too, mist the foliage, and the plants be given a full bath, but do this at night so the foliage will dry well. These plants need some humidity, and a simple way to supply this is to elevate plants on pebbles. Do not overfeed as this will burn the roots, and provide fresh circulating air at all times. The principle food of all plants is carbon dioxide from the air and hydrogen from the water. You can propagate African Violets by placing a leaf in water or in good potting soil, or divide the plant to have a single crown. These plants are easy to grow, and add to your indoor garden.

# CONSUMER FACTS 

SWIMMING POOLS

Summer is almost here, and in Texas that means the temperature will start to climb out of sight. The idea of having a swimming pool in the back yard starts to look better and better. What a way to beat the heat, and maybe get a little exercise too.

But having a swimming pool installed can sometimes cause enough problems to raise your temperature, not cool you off.
There are three basic types of in-ground pools: Custom-Built Poured Concrete, the oldest and most expensive; Fiberglass, which is increasing in popularity; and Metal, which has vinyl liners inside of steel or aluminum walls. There are also a number of types of above-ground pools which are less expensive.
A recent FEDERAL TRADE COMMISSION study found that the swimming pool industry has its share of shady operators. "Bait and switch" tactics, where they advertise a pool at one price and then highpressure you to buy a more expensive model is a common practice. So is offering a warranty that is so limited as to be meaningless -- guaranteeing a vinyl liner against defects in the seam only, for example.
And there are the perennial problems with fly-by-night contractors whose shoddy workmanship goes undiscovered until they are long gone. Ask your friends who have pools about their experiences and who they would recommend. And get at least three written estimates from reputable local firms before you sign a contract.

Swimming pools are what the law calls an "attractive nuisance" and safety is an important consideration, especially seeing that they are secured against small children using them when no adults are present. Many communities have ordinances requiring that pools be enclosed by locked fences. Check your local ordinances to see what safety features are required and add those expenses to your total cost for the pool. And safety is important, whether or not your community has specific ordinances about swimming pools.

If you have problems or questions about swimming pools, contact your local Better Business Bureau or the nearest Consumer Protection office.

10. Make certain your parents, brothers, sisters and children have their pressure checked regularly. High blood pressure tends to run in families.
"You can also help your doctor centrol your blood pressure by being honest and specific with him or her regularly about your treatment plan," advises Taylor. "The more your dector knows about your concerns and problems, the better he or she can adjust the plan to your needs."

TEN COMMANDMENTS FOR HIGH BLOOD pressure patients
(AUSTIN) -- An estimated 54 million American adults have high blood pressure, according to the American Heart Association. The association estimates almost half of these people don't know about their life-threatening condition.

Blood pressure is the push of blood against the walls of the arteries. High blood pressure indicates the heart is straining to pump blood through the arteries. High blood pressure is unhealthy because it can result in an enlarged heart (congestive heart failure), kidney failure, and increased hardening of the arteries and kidney disease. "These ailments can lead to a stroke or a heart attack, perhaps causing disability or death to the sufferer," indicates Addison A. Taylor, M.D., president of the Texas Affiliate of the American Heart Association.

The American Heart Association urges high blood pressure patients to control their condition and offers ten commandments to help:

1. Know your blood pressure. Have it checked regularly.

Charges of Assault Causing Bodily Injury have been filed against a 22 year old Brackettville man after a disturbance at a local residence left a man suffering from a broken nose and a woman with bruises, lacerations, and a knife wound on her arm.
The disturbance was reported at 10:08 a.m. Saturday, May 23 rd and the suspect was arrested at the scene by Deputy Sheriff David Luna at approx. 10:30 a.m. same date. The suspect was then transported to the County Jail and booked on the assault charges, he was later released on bonds totalling $\$ 400.00$ set by Justice of the Peace Alvin Hall. A large butcher knife and a recovered at the scene of the incident. The revolver belonged to the female victim. At the time of this writing no trial date has been set for the Class A Misdemeanor charges which will be tried in County Court.

Quite often we receive reports of crimes that are so destructive and senseless that we wonder what kind of people we have in our community who could commit them. Such was the case of a report we received Monday, May 25th. Mr. Richard Mountain came to the office to report that vandals had trespassed onto the Masonic Cemetery sometime over the week-end and had overturned at least 30 headstones on graves there. Some of the stones were broken and others are so heavy that a winch truck will be required to reset them in their proper place.

Evidence at the scene (footprints) indicates that the perverted vandalism was caused by a person working alone and every effort is being made by the Sheriff's Department to determine the name of the perpetrator.

Vandalism is at best one of the most senseless crimes that can be committed against society, but I think this scrapes the bottom of the barrel. Whoever committed this crime has a very sick sense of humor, or a very sick frustration and/or anger inside to stoop to this level. The very least we can do is to let our departed friends and neighbors rest in peace. Anyone hearing any street talk that might indicate the identity of the vandal who committed this senseless
crime is asked to please contact the Sheriff's Office as soon as possible.

Those of you who read my column regularly are aware that every once in awhile I bring you up to date on the latest assaults and shootings on police officers. This week I have summarized a few of the latest.

Bell County Sheriff's Deputy, Keith A. Graves, was the victim of gunshot wounds Sunday, March 15, 1987, at approx. 9:25 p.m. during a routine traffic stop of a suspicious vehicle.

The incident occured in a wooded area behind a grocery store in Morgan's Point Resort City where Graves had spotted a vehicle parked at the rear of the store. He followed it down an unpaved road where he made the stop. The driver, who was the sole occupant of the vehicle, opened fire on the officer shortly after the stop and Graves returned fire with his sidearm. Both Graves and the suspect received several gunshot wounds. The suspect then fled into a wooded area and Graves called for assistance. The suspect was apprehended shortly and both he and Graves were taken to the hospital. The suspect died at $12: 20 \mathrm{a} . \mathrm{m}$. on March 16, 1987 and after a short recuperation Graves returned to work on March 30, 1987.

A Travis County deputy sheriff was beaten and stabbed early on April 22, 1987, in western Travis County after the deputy stopped two people on a motorcycle for minor traffic violations. Deputy David Davis, 36 , was stabbed once in the left forearm and once in the left leg with a knife.

Davis was struck at with the knife six times as he attempted to search a male rider of the motorcycle, two of the stabs struck his bulletproof vest. The second rider, a female, fled the scene and then returned hitting Davis in the back of the head several times with her fists. During the struggle Davis managed to disarm the man by biting him on the hand causing him to drop the knife. At that point the attackers fled. Police are searching for the suspects and among other descriptions they list a bite mark on the right hand.

A year ago, someone shot at Plano Officer Richard Cole while he tried to pull over a suspicious looking vehicle during routine patrol.

Four months later, Cole was again the target of gunfire, this time while investigating a house under construction. During this incident, Cole was shot several times in the chest and once in the
leg. However, he managed to escape serious injury because he was wearing a bullet proof vest. Cole has been a police officer for six years and says that despite his unfortunate experiences that he likes police work and will continue in his chosen field.

Melvin Kenneth Drum, 57, Chief Deputy for Ochiltree County Sheriff's Department, was shot and killed March 28, 1987 after being hit by a shotgun blast while responding to a domestic disturbance.

Drum observed a car being driven by the suspect in the disturbance and after following the car several blocks attempting to stop it by using his red lights and siren he pulled in behind the suspect vehicle as it pulled into the driveway where the suspect's wife emerged from the car yelling at Drum to leave, apparently trying to warn Drum of the danger from her husband. The suspect then got out of his car with a 16 gauge shotgun and ran around the rear of his car to the left rear of Drum's patrol car and along the left side of the patrol car. The shotgun blast struck Deputy Drum under the left eye at close range. Deputy Drum died instantly. He was survived by a wife, a son, a daughter, and two grandchildren.

These are just some of the dangers faced by peace officers every day of their lives. Think about it!

In 1883-1884 Chester Arthur was President, Congress had just passed the Pendleton Act, improving the Federal Civil Service. Lewis Watermann was experimenting with the fountain pen which he perfected the next year. Buffalo Bill Cody' gave the first performance of his first Wild West Show. The Brooklyn Bridge opened in New York City, the cornerstone of the pedestal of the Statue of Liberty was laid, standard time was established. The first classes at the University of Texas were held in Austin, and the first American Historical Association was organized in New York.

In West Texas, Jay Gould had barely gotten his Texas and Pacific tracks laid in Sierra Blanca where he met the Southern Pacific. Pecos City had a population of onehundred to one-hundred fifty souls. Monahans Wells had the first water well between the Pecos River and Big Spring. Big Spring was the place where everybody and everything stopped for water,

including buffalo, coyotes, lobo antelope and wild mustang. The Comanche and Shawnee fought over the spring, and soldiers camped near its sweet water, and Midland had a handful of stores and saloons.

A state legislative act passed in 1881, had turned loose some of the vast West Texas lands at fifty cents per acre, with half to go to state public school funds and the other half into the general revenue fund. A partnership of Joe Gunter, W. B. Nunson, John W. Maddox, F.M. Maddox, and C.E. Anderson bought two-hundred, twenty eight thousand acres embracing what is now parts of Andrews, Midland, Ector and Martin counties. In 1883, these lands were transferred to Nelson Morris, a meat packer from Chicago.

Nelson Morris came from the southwest part of Germany when just a boy. He got off the boat and walked most of the way from Buffalo, N.Y., to Chicago, looking for work. He worked here and there in the small stockyard which preceded the building of the Union Stock Yards.

John Sherman, founder of the Union Stock Yards, took Morris under his wing and taught him the hog rendering business and after a few years he left the employ of Sherman and became a cattle tender in a small way. He would bid on anything and buy anything, usually at his own price, staying out of the market until late in the week when he would catch his competitors napping. Within only a few years he was shipping everywhere, even Trans-atlantic shipments. He secured contracts with the French and other European governments and also supplied the commissary department of the Union troops during the Civil War. By the year 1873, his company was earning more than eleven million dollars a year.

Morris and Company Plant covered some thirty acres and was one of the first packing houses to be opened in Chicago at the Union Stock Yards. Morris owned large cattle ranches in the Dakotas and in Texas and was one of the first to import rolled-Angus and Galloway cattle, feeding approximately seventy-five thousand head annually from his feedlots.

Angus cattle are solid black and have no horns. The breed is a model of beef type. They are short of leg, broad and deep of body and very compactly built. They mature early and fatten well at any age. They have a high dressing per cent, and the meat is well marbled.

When Nelson Morris acquired his West Texas ranch he fenced it, stocked it with black muley cattle, dug wells under the management of H.C. Rogers, his first foreman, building a headquarters near what is now the town of Andrews in Andrews County.

He is credited with bringing in the first barbed wire and windmills in what is now Andrews County.

Clint Newlin, a gentleman who now lives in Crane, once worked on the "Chicago Ranch". Mr. Newlin saw Nels Morris in Midland and relates this amusing incident.
It seems there was a meat market in Midland where some of the cowboys hung out when they were in town. A drummer from Armour Packing Company was trying to sell the proprietor on the Armour products. One of the spectators in the market became interested in the drummers sales pitch and its proceedings with a twinkle in his eye. The market owner stated he would not buy anything but Morris Packing Company products because he considered it the best.

Upon the departure of the crestfallen drummer, the interested stranger stepped up to the proprietor, stuck out his hand and stated, "I'm Nels Morris and I'd like to shake your hand." The owner refused to believe him as Morris was not dressed as a well-to-do easterner but wore plain clothes, a white stetson and coarse boots. The market owner was only convinced when Nels Morris presented him with a new stetson hat later that day.
Clint Newlin went to work for the "C", ranch a few months after Morris died. He was the windmill man and looked after the seventy-nine windmills on the ranch. The equipment was the best and if anything new came out, Morris, and later his heirs, were willing to give it a try.
