## SHERIFF'S CORNER

A new Kinney County Grand Jury was sworn in on Monday, October 5th and heard evidence presented on four criminal cases. After consideration of the evidence on the cases, the Grand Jury returned three TRUE BILLS of INDICTMENT and one NO BILL. They are as listed below:

1. Sidney Ray Edmonson of San Antonio, Texas was indicted on Felony Possession of Methamphetamines. A warrant was issued for his arrest.

2. Roger Craig Knox, a San Antonio resident now living in Ft. Clark was indicted on charges of Burglary of a Building, a 3rd Degree Felony. Knox is currently out of jail on a \$1,000.00 bond.

3. Juan R. Martinez of Brackettville was indicted on charges of Felony Theft of a Vehicle. Martinez is currently in jail awaiting trial.

4. Federico Martinez of Brackettville was NO BILLED on allegations of Sexual Assault on a Child. In this case a thorough investigation failed to turn up evidence of sexual assault though Martinez was convicted on misdemeanor charges of Assault by Contact. This conviction was a violation of probation he received in an earlier conviction in federal court for Assault on a Federal Officer. He was arrested by U.S. Marshalls while still in custody in the county jail and transported to Val Verde County Jail where he is being held awaiting a hearing on the probation violation. Should his probation be revoked, which is most likely, he will be transported to a federal prison to serve the two year sentence he received in the earlier conviction.

Also on Monday, October 5th, Jose M. Esquivel, a Resident Alien from Oklahmoa, was tried in District Court before District Judge George Thurmond on charges of Felony Possession of Cocaine. He pled guilty to the charges and received a 2 year probated sentence with a recommendation by the judge that he be deported by INS. It is my understanding that this has been

done as he was picked up by the Border Patrol on October 6th for processing.

A dangerous incident occurred near a grocery store on Highway 90 Saturday night, October 10th, and quick action by Deputy Sheriff David Luna who was on routine patrol near the location and saw the disturbance in progress probably prevented the incident from becoming much worse.

In this incident a Brackettville man was attacked by at least 3 of 6 youths who came to his location to confront him in retaliation for an earlier incident between the man and one of the youths. During the attack the man was assaulted and took a shotgun from his vehicle to protect himself with. It was at this point that Deputy Luna arrived on the scene and stopped the action. Of the 6 young men arrested, 3 were charged with Assault, the remaining 3 were released after it was determined that they did not enter into the incident. No charges were filed on the man who had the shotgun as he was acting in self defense and no injuries were received from his actions.

The following case is a sad one that I would not ordinarily report on due to the nature of the incident. But due to the tremendous amount of false information and rumors being spread around town about the incident I feel it is necessary to at least give a basic report.

At approximately 5:00 a.m. on Sunday, October 11, 1987, 19 year old Juan Jesus Aguilar of Brackettville took his own life in front of a residence on Ross Street. I was assisted in the investigation of the matter by Deputy David Luna and Police Chief Johnny Fritter. Justice of the Peace Alvin Hall also assisted acting Coroner. Evidence at the scene indicated beyond any doubt that Aguilar died from a single 410 gauge shotgun blast that was self-inflicted through the mouth.

Rumors that there was more than one wound and that several shots were heard are unfounded. This is a sad case and we sympathize with the family on their loss. But rumors and false information should not be spread around, especially in consideration for the family. We are about 90% complete with the investigation and there will be no further reports of this case by me out of the respect for the feelings of the surviving family members.

## REFLECTIONS

The wife pleaded, "Sweet heart, it's going to be cold tonight. Please bring in my pot plants." A little green snake lay sleeping among the plants and it got carried inside, too.

When the small snake warned up, it slithered out of a pot and under a sofa. The man's wife screamed as she saw the snake run across the floor.

By this time the husband was taking a bath and he leaped out of the tub and ran to see why his wife had screamed.

She explained about the snake under the sofa. The man, dripping wet, got down on his knees to look under the couch. Then the dog put his cold nose to the man's posterior and the man thought the snake had grabbed him, and he fainted.

As the moaning man sprawled out on the floor, the wife thought he had suffered a heart attack, and she called an ambulance. Soon the still wet husband had been placed on a stretcher, carefully encased with a sheet to prohibit more exposure. Just as the stretcher guys picked up their load, the snake slithered from under the couch and they dropped the stretcher, and the fall broke the man's leg.

And now with the husband on his way to the hospital and a snake under the couch, the wife quickly yelled to the man next door to come kill the snake. The next door hunter-outdoorsman brushed under the couch with a newspaper and the scared snake rolled over the lady's foot that long since had lost her high heel shoes. The lady screamed, fainted, and fell on the couch.

The out-doors-man recalled a basic first aid technique and he started mouth to mouth resuscitation. That hunter's wife had just driven up when she heard a part of the commotion inside her neighbor's house, and she ran in to help seeing her husband giving that strange first aid treatment, she hit him over the head with a small sack of groceries she still had in her hand. Cans spilled every place.

The noise of the rolling cans awakened the woman who had fainted and she saw the hunter on the floor who had been knocked out by his wife and she knew the snake must have bitten him, too. She rushed to the kitchen and grabbed a small bottle of medicinal whiskey to pour down that poor man's throat.

The hunter's wife, now regretting

The Indians sign language is known all over the world, and it took the Indian to develop it to the fullest. He invented so many different gestures that regardless of the dialect the various tribes spoke, they could talk to each other with sign language.

The sign language was used by Indians from British Columbia to the Mexican border and from the Missouri River to the Rocky Mountains, anywhere the buffalo roamed. In this region, the buffalo hunting Indian lived.

Many tribes used such different languages, that a common form of communication became necessary, so the sign language was invented and the Indian could make their fingers, hands and arms speak and be understood by all the tribes.

Perhaps "Iron Eyes Cody" of the Cherokee kept the art alive in books and demonstrations. At one time, millions of Indians communicated with each other using the silent sign language.

Iron Eyes was a Cherokee, born on the family ranch in Texas. He would accompany his father, Thomas Long Plume, on his travels with a wild west show.

Thomas Long Plume had two good friends; Buffalo Man, a Cheyenne, and Two Gun White, a Blackfoot. From these two, Iron Eyes learned the sign language. Then he was able to talk to other Indians he met while traveling with his father. In his travels he met a great Chief named White Horse, an Arapho, who was an expert at sign language. In the three years they were associated, Iron Eyes became an expert too.

At sixteen, Iron Eyes had already been through the swamps of Alabama, through Texas, went to Mexico on a banana boat and on to South America. He toured with the 101 Wild West Shows where I saw him in Oklahoma where I talked to him, but not in sign language, since I was just a little kid. He traveled with the Al G. Barnes Circus through most of the United States and Canada. He was a classic dancer and very good with the bow and arrow. When traveling with the Circus he often took to the hills with his bow and arrow to put meat on the table.

In 1921, Iron Eyes went to

Hollywood and began a career in the motion picture industry. All that time he went by his childhood name of "Little Eagle", but when he met Chief White Horse his name was changed to Iron Eyes and he was adopted into the Arapho Tribe. Between pictures he traveled with the Buck Jones Wild West Show as the leader of the Indians and the star dancer.

In 1934 and 1935, he toured Australia and then performed in England for the King and Queen. In 1937, he came home and toured with the Ringland Brothers Circus.

He owned a television company and became interested in the Boy Scout work. He was married to the daughter of the famous Seneca Indian anthropologist, Dr. Arthur C. Parker of New York.

Sign language was invented by necessity. In this country in the early days, more than five hundred languages were being spoken by some seventy distinct stocks or families of the American Indian.

Today the old timers are passing on and their sign language will pass on with them but perhaps the youth of today will take on interest and keep means of communication alive. Perhaps the Boy Scouts could adopt this as a project to pass on.

**LETTER TO THE EDITOR**

Dear Editor:

We're only one month away from voting on numerous propositions in November. These propositions are major decisions. On November 3, 1987 the ballot will include twenty-five propositions which could result in amendments to provide for the abolition of the office of County Treasurer in Gregg, Fayette and Nueces Counties.

This amendment was proposed from joint resolutions passed by the Texas Legislature during the 1987 regular session.

Both the County Treasurer's Association and The National Association of County Treasurers are working strongly to stop the abolishment of any County Treasurer and to restore previous County Treasurers Post having been abolished.

Before examining the powers and duties of the County Treasurers it is necessary to understand the nature and legal status of county government in Texas. Today, in the rural areas of Texas and across the country, county government is the most important unit of grass-roots government available to the people. County government in the United States is local government. This is extremely important. The office of County Treasurer was set up by the CONSTITUTION. It is an elected position by the people.

Article 16, Section 44 of the Texas Constitution provides or states: The Legislature shall prescribe the duties and provide for the election by the qualified voters of each county in the state, of a County Treasurer and a County Surveyor, who shall have an office at the county seat, and hold their office for four years and until their successors are qualified; and

shall have such compensation as may be provided by law.

In county government the commissioners court is the administrative body for the conduct of county affairs and control the county courthouse, buildings and facilities. It is the most important governing body of the county. If Gregg, Fayette and Nueces counties have a problem with an elected official not performing the duties that they have been elected to do, then it should be resolved by the voters of those counties in the next election with the advice and support of the commissioners court. An amendment to abolish an elected position does not solve the problem.

Recently at our County Treasurer's Annual Conference held in Odessa, Texas we were honored to have seven out of eleven presidents of the Texas Association of Counties speak. Not one was in favor of the abolishment of any County Treasurer, including the President of The Texas Association of Counties, our honorable Bill Melton of Dallas, Texas. Also, to add that our Attorney General Jim Mattox stated at the conference that he could not support the abolishment of any elected position and that he and his committee were working on an Attorneys' General opinion.

In closing I professionally and personally ask the voters of Polk County and all Counties to strongly consider their decision on all these amendments proposed.

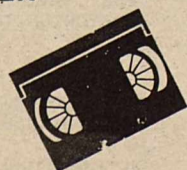

TAKE NOTICE that an election will be held in Kinney County, Texas, on November 3, 1987, in obedience to an order duly entered by the Commissioners Court of said County on September 14, 1987, which order reads substantially as follows:

AN ORDER CALLING A BOND ELECTION TO BE HELD IN KINNEY COUNTY, TEXAS, MAKING PROVISION FOR THE CONDUCT OF THE ELECTION AND RESOLVING OTHER MATTERS INCIDENT AND RELATED TO SUCH ELECTION.

\*\*\*\*\*

WHEREAS, the Commissioners Court of KINNEY COUNTY, TEXAS (the County) hereby finds that an election should be held to determine whether said governing body shall be authorized to issue bonds of said County in the amounts and for the purposes hereinafter identified; therefore,

BE IT ORDERED, ADJUDGED AND DECREED BY THE COMMISSIONERS COURT OF KINNEY COUNTY, TEXAS:

SECTION 1. An election shall be held on the 3rd day of November, 1987, in KINNEY COUNTY, TEXAS, which date is not less than fifteen (15) nor more than ninety (90) days from the date of the adoption of this Resolution, for the purpose of submitting the following propositions:

PROPOSITION NO. 1

"Shall the Commissioners Court of KINNEY COUNTY, TEXAS be authorized to issue bonds of the County in the principal amount of \$90,000 for the purpose of constructing jail improvements; such bonds to mature serially or otherwise not more than forty (40) years from their date; and any issue or series of said bonds to bear interest at such rate or rates (fixed, floating, variable or otherwise) as may be determined within the discretion of said Commissioners Court, provided that such rate of interest shall not exceed the maximum rate per annum authorized by law at the time of the issuance of any issue or series of said bonds; and shall the Commissioners Court of the County be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes on all taxable property in said County sufficient to pay the annual interest and provide a sinking fund to pay the bonds at maturity?"

PROPOSITION NO. 2

"Shall the Commissioners Court of KINNEY COUNTY, TEXAS be authorized to issue and sell bonds of the County in the principal amount of \$35,000 for the purpose of constructing courthouse improvements; such bonds to mature serially or otherwise not more than forty (40) years from their date; and any issue or series of said bonds to bear interest at such rate or rates (fixed, floating, variable or otherwise) as may be determined within the discretion of said Commissioners Court, provided that such rate of interest shall not exceed the maximum rate per annum authorized by law at the time of the issuance of any issue or series of said bonds; and shall the Commissioners Court of the County be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes on all taxable property in said County sufficient to pay the annual interest and provide a sinking fund to pay the bonds at maturity?"

PROPOSITION NO. 3

"Shall the Commissioners Court of KINNEY COUNTY, TEXAS be authorized to issue and sell bonds of the County in the principal amount of \$12,000 for the purpose of constructing improvements to the auditorium, to-wit: the Kinney County Civic Center; such bonds to mature serially or otherwise not more than forty (40) years from their date; and any issue or series of said bonds to bear interest at such rate or rates (fixed, floating, variable or otherwise) as may be determined within the discretion of said Commissioners Court, provided that such rate of interest shall not exceed the maximum rate per annum authorized by law at the time of the issuance of any issue or series of said bonds; and shall the Commissioners Court of the County be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes on all taxable property in said County sufficient to pay the annual interest and provide a sinking fund to pay the bonds at maturity?"

PROPOSITION NO. 4

"Shall the Commissioners Court of KINNEY COUNTY, TEXAS be authorized to issue and sell bonds of the County in the principal amount of \$10,000 for the purpose of making improvements to land and buildings for park purposes; such bonds to mature serially or otherwise not more than forty (40) years from their date; and any issue or series of said bonds to bear interest at such rate or rates (fixed, floating, variable or otherwise) as may be determined within the discretion of said Commissioners Court, provided that such rate of interest shall not exceed the maximum rate per annum authorized by law at the time of the issuance of any issue or series of said bonds; and shall the Commissioners Court of the County be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes on all taxable property in said County sufficient to pay the annual interest and provide a sinking fund to pay the bonds at maturity?"

SECTION 2. The County shall be divided into four (4) election precincts for this election and the polling places designated for each election precinct and the persons hereby appointed to serve as Presiding Judge and Alternate Presiding Judge for each polling place are shown in Exhibit "A", which is attached hereto and incorporated herein by reference as a part hereof for all purposes.

The Presiding Judge for each election precinct shall appoint not less than two (2) nor more than four (4) resident qualified electors of said County to act as clerks to properly conduct said election. However, if the Presiding Judge appointed actually serves, the Alternate Presiding Judge shall serve as one of the clerks. 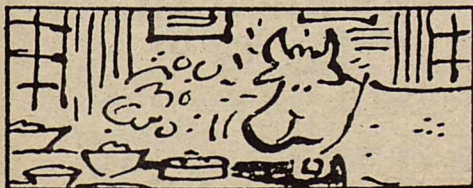

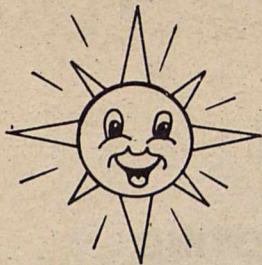

**DIABETES - DIET**

Diabetes - Hyperglycemia

As stated in an earlier article, people with diabetes are prone to developing serious complications. The economic toll for the nation is at least \$10 billion annually. The most common physical tolls for individuals are loss of limb, sight, kidney, nerve and heart function, as well as death. There is a tremendous emotional toll paid by diabetics and their families as well.

Prevention is the key for most diabetics. Most people can avoid or post-pone these serious complications by strictly following their diet plan, exercise regimen, by maintaining an optimum weight and taking their medications as prescribed. It is lack of control and long term elevations of blood sugar levels (hyperglycemia) that increases the damage done to the organs.

An individual can live for weeks or months with hyperglycemia, so often no attention is paid until permanent damage is apparent. However, the condition resulting from continuous high blood sugar, "ketoacidosis", is what causes severe and permanent damage to occur. Ketoacidosis is caused by a lack of insulin, which transports blood glucose into the cell to be used for energy, growth and development. If glucose is not made available for cell growth because of a lack of insulin, the body begins to burn its fat reserves, much the same as if the individual were a starvation victim. Ketones are an acidic by-product of this process. Our bodies maintain a delicate pH balance, and the Ketones build up in the body, making it more acid, and permanently damage critical organs such as the heart and kidneys. Blood vessels lose flexibility and clog as well, increasing problems with circulation. The damage begins insidiously, but before too long the diabetic individual experiences a host of serious complications that limit the ability to function normally.

Signs and Symptoms of Ketoacidosis:

1. Positive urine and blood tests
2. Excessive urination and thirst
3. Weight loss
4. Weakness and fatigue
5. Fruity odor to breath

More Serious Signs:

6. Rapid deep breathing
7. Abdominal pain
8. Nausea/Vomiting
9. Drowsiness
10. Coma

Unless reversed in its early stages, hospitalization is necessary. Insulin and intravenous fluids must be given in order to save the individuals life.

Prevention:

1. Follow your diet closely and take your medicine as prescribed
2. Exercise
3. Drink plenty of water
4. Have your blood glucose level monitored regularly, or learn to test it yourself. Urine testing is alright too, but blood tests are more accurate.
5. Report any illness to the doctor




