SCHOOL BOARD ADOPTS AIDS POLICY

The Trustees of Brackett Independent School District adopted a policy to allow the District to deal effectively with the possibility that an employee, or student might become infected with the Acquired Immune Deficiency Syndrome (AIDS), or Human Immunodeficiency Virus (HIV). The policy follows procedures recommended by the Texas Department of Health and the Texas Education Agency. Copies of the policy are available at the District Central Office.

In further action, the Board adopted a pay scale for substitute and extra-curricular bus drivers, and approved an amendment to the 1987-88 budget to pay for construction costs originally budgeted, but not expended in 1986-87.

The Board also signed an agreement with the American Red Cross allowing District facilities to be used as emergency shelters for refugees from natural disasters. The agreement will allow for disaster planning to be completed for Kinney County.

TIPS FOR A SAFE HALLOWEEN

Halloween evokes images of goblins, witches, and other cleverly-disguised children who go trick-or-treating each year. But it also can bring images of danger if parents, motorists, and homeowners do not take certain safety precautions, according to the Texas Medical Association.

Costumes, especially dark-colored ones, are difficult for motorists to see at night. Parents should include reflective tape or reflective liquid "paint" (available in hardware stores) on costumes and bags to improve a child's visibility.

Make certain the costume is not so long that a child can trip on it, or so loose that it may catch on bushes and other obstacles.

Cloth masks and entire head masks can block a child's vision or breathing. Instead, consider painting a mask on the child's face with cosmetics or grease paint.

Parents should review safety rules with their children, including walking on sidewalks or staying to the side of the road, and not eating any candy or fruit they receive until it has been checked at home.

Motorists must be especially attentive on Halloween. Slow down and drive with extra caution through residential areas.

Homeowners can help out by having outside lights on as a sign of welcome and so trick-or-treaters do not trip over stairs or other obstacles.

The Texas Medical Association suggests follow these easy guidelines and help make Halloween fun and safe.

Mose of the ones who "gamble for gain" will lose. Then the one who loses his money goes home broke. His family members have to face the loser's anger and frustration, and they are deprived of the love, happiness, and financial support which they deserve. For example, paramedic Moberg of San Antonio, raped his eight year old daughter and murdered his beautiful 20 year old step-daughter the day he got back into town from a \$10,000 gambling loss. Does gambling pay?

A pari-mutuel betting track opened in Birmingham, Alabama in August 1987. Operating losses are a staggering 10 million dollars after two months. Gambling that promised to turn Atlantic City into a "little paradise" has converted the area into chaos, disorder, and crime city, according to official reports.

Since the start of pari-mutuel gambling in Minnesota, the crime rate has jumped 45 percent and the burglary rate has skyrocketed 100 percent, according to police records.

Apart from any religious arguments, when a voter really becomes honest with himself or herself, this one knows that gambling does not pay.

GARDENING TIPS

"Plant Bulbs For Spring"

Fall will soon be here, and it is the time to plant bulbs for Spring. Buy the very best bulbs, those that are firm and still have the brown shin covering. There are so many to choose from, that you can have a very colorful Spring Garden. Tulip bulbs need to be in the ice box for at least sixty days before planting. In planting all of the bulbs, place a little bone meal in the holes or planting area. A long cold winter is not required to produce fine Daffodils and other narcissi, so they are suited for our area. For a natural setting, drop the bulbs where they are to be planted, and plant where they have fallen; this is better than planting in a straight line.

Ranunculus do well here, and they are very colorful. Plant them about two inches deep with their claws pointed down, and be sure to soak them in water for several hours before planting. Water thoroughly after planting, and do not water again until sprouts Another bulb that is appear. colorful is the Abemone, two kinds, the DeCaen which has single petal flowers, and the St. Bridget with double blossoms. These bulbs are small, so do not plant them too deep. Remember that a bulb is very unusual in the Flower World. Each large bulb contains a complete plant with its flower bud ready to bloom after only a short period of loving care and attention. Cut one in half, and see the perfect little flower ready to grow.

1ST GRADE TEAMS SCORES IMPROVE

First grade TEAMS scores were presented to the Board Monday night. Total mathematics scores showed a 37% increase over 1986 scores. Total reading increased by 26%, and total writing increased by 34%.

In National Percentile Rank, Brackett scores would have ranked in the top quarter of first graders (78%). Mr. Schermerhorn pointed out that only limited assumptions can be made based on two years of test data, but these results are certainly encouraging.





District Judge George Thurmond heard several criminal and civil cases in Kinney County District Court on Monday, October 19th.

Of the three criminal cases brought before the judge, only one went to trial, the other two were reset for November 3rd.

Enrique Lopez-Garcia, a Mexican National who has been in jail since July 3, 1987, on Burglary of a Vehicle charges, was tried and convicted on a plea bargain agreement. He received a 7 year probated sentence and ordered deported to Mexico. One of the stipulations of his probation was that he commit no crimes against the laws of Texas or the United States and particularly immigration laws. Should he re-enter the United States illegally and be apprehended his probation will be revoked and he will be transported to TDC to serve out his 7 year sentence. He was picked up at the county jail by U.S. Border Patrol Agents shortly after his court appearance, processed and deported.

Juan R. Martinez, a Brackettville resident charged with Auto Theft, Jackson, and W.C. a prior Brackettville resident in custody on Felony Theft charges, had their court dates set for November 3rd. Jackson, you may remember, was wanted by this department for several months before being apprehended in Arizona after a check through the National Crime Information Center computer indicated an outstanding felony warrant from this department existed. Jackson fought extradition and after a Governor's Warrant was issued he was transported back to Kinney County by U.S. Marshals to stand trial.

I would like to remind everyone that November 3rd is Election Day and there are several local option issues appearing on the ballot that deserve attention from interested and concerned voters and taxpayers. The most important in my opinion is the bond election issue concerning the county jail. We need this issue to pass by majority vote to enable us to acquire the funds necessary to make repairs and renovations to the county jail to bring it within the minimum standards required by the Texas

Commission of Jail Standards. If these minimum standards are not met within the time span allowed by the Commission the jail will be closed or at the very least downgraded to a 72 hour holding facility. This will have an adverse affect on the economy of the county in several ways. First we will no longer be allowed to house federal prisoners in the jail, thus the loss of thousands of dollars in income each year. Secondly, there would be a loss of jobs by jail personnel which would be devastating to those employees affected. Thirdly, all long-term prisoners that would ordinarily be confined in the be confined in the county jail would have to be transported to a certified facility at county expense for housing and medical expenses. In other words we would not only be losing income from federal prisoners, but having to pay other counties for the housing of our prisoners. In there would addition be transportation expenses involved, not counting travel time for law enforcement officers assigned to transporting prisoners to and from

I urge all voters to exercise their right to vote the way they want to vote decided by desires, but I also urge interested and concerned voters to vote FOR the various bond issues on the ballot, in particular the one concerning the county jail. If this issue should fail it would wipe out years of hard work and all the advances we have made in the county jail operation. I would also point out that the passing of these bond issues will not affect your taxes one bit. The bonds would tail-end on existing bonds currently being paid on by the county due to mature in 1990. The payments on the bonds should not increase over what is currently being paid on existing bonds and they should mature in 1994. Think

about it, contact various county officials for more information and then vote the way you feel is right for the county and you, but at least exercise your right to have a voice in the decision.



Every age has their stars and people who are in the limelight. In the twenties and thirties it was Babe Ruth, Tom Mix, Tim McCoy, Buck Jones, Red Grange and many others. But there was especially Jim Thorpe. He was a Sac-Fox Indian raised on the reservation in Indian Territory.

In those days there were schools for the Indian tribes. Jim's father would take him to school by horse and wagon but when Mr. Thorpe got back home his son Jim would be home waiting. Jim Thorpe became quite a cross country runner when he lived on the reservation.

James Francis Thorpe was born in 1888 and named the Indian name "Wa-Tho-Huck", which means "Bright Path" in English. When he was older he was sent to Institute, an Indian Academy in Lawrence, Kansas and on to the Carlisle Indian school at Carlisle. There his athletic abilities in football and track caught the attention of Glenn Scobey "Pop" Warner who was head coach at Carlisle at that time.

Thorpe was brilliant on the team that year. Later in 1909 he left Carlisle and went to North Carolina, there he worked on a farm and played semi-professional baseball. He returned to Carlisle in 1911 and played the position of halfback on the Varsity eleven who was victorious over some of the most powerful teams in the country.

In 1911 and 1912 he made a new scoring record of 198 points. He made the All-American Team, the honorary College eleven chosen by the American authority, Walter Thorpe, in this period, Camp. excelled also in track, baseball, lacrosse, basketball, swimming, tennis and archery.

Thorpe took part in the Olympic Games in 1912, he was the worlds greatest athlete, winning both the Pentathlon and the Decathlon. But in 1913, the Amateur Athletic Union voided his amateur status and disallowed his Olympiad records and forced him to return his awards and medals because he had played semiprofessional for the one time at North Carolina.

From 1913 to 1919 he played professional baseball with the Boston Braves and the New York Giants.

In 1915, he organized the Boston "Bulldogs" a professional football club at Canton, Ohio. After several seasons there with other teams, he retired from the sport in 1929-

He was a supervisor in the Chicago Park System, an actor in the movies, a lecturer on Indian Culture and during World War II, a seaman in the Merchant Marines.

In 1950, nearly four hundred Sports writers and American Broadcasters selected Thorpe as the greatest all-around athlete and football player of the first half of the 20th century.

Together Thorpe and T.F. Collins wrote a book called, "Jim Thorpes History of the Olympics". The book was published in 1932.

I didn't ever see Jim Thorpe in person but was raised near the Sac-Fox Indian Reservation. He was a very big hero of the period and gave everyone a thrill just hearing or reading about his exploits. Later his medal and awards were returned with honors.

Speaking of thrills, the Junior Varisty football game with the Cole JV's gave everyone who was it some unexpected thrills and excitement. The score was 14 to 13 in favor of Brackett, who won in the last' few seconds of the fame. My hands are still sore from applauding the teamwork our boys exhibited.

4-H IS DISTINCTLY **AMERICAN**

4-H is as American as baseball or the U.S. apple pie--or Constitution, now 200 years old.

4-H, an American educational program for youth began around the turn of the century, points out Mr. Carl Esser, county 4-H program leader with the Texas Agricultural Extension Service, The Texas A&M University System. In fact, it followed on the heels of a Corn Club organized in Jack County, Texas, in 1908 and has flourished ever since.

The nation boasts a total of some 4.5 million 4-H youth between the ages of 9 and 19. More than 305,000 of these are Texans.

More and more 4-H'ers are coming from urban areas, notes Mr. Esser. In Texas, about 66 percent of the 4-H youth now come from larger urban and suburban areas. remainder of Texas 4-H'ers live on farms or ranches or in towns of under 10,000 population.

Adult volunteer leaders are a valuable asset to 4-H as they give freely of their time and talents in assisting in the educational efforts of the 4-H program. There are 620,000 4-H volunteer leaders across the country, and 30,000 of these are in Texas, says Mr. Esser.

The 4-H program also receives widespread support from various businesses, corporations and foundations all over the nation. The Texas 4-H Youth Development Foundation garners support from the private sector, both individual and business, to support many 4-H activities, Mr. Esser points out.

The 4-H program has enjoyed much success in the past, but groundwork must be laid now to face the challenges that lay ahead, Mr. Esser emphasizes. Challenges are plenty as 4-H strives to assist youth along the road of life and to prepare them to be the leaders of tomorrow's America.




